Like her many titles, accolades, fake doctorate and her assertion that she has been preparing to lead humanity for thousands of years the 'Royal Path' is just a catchy marketing phrase designed to suck the next batch of victims into the 'kill zone.'

Let us now review her 'WORK' to ascertain just how 'PURE' that work is. This would be what Patton West calls 'WORLD SERVICE' or the 'GREAT WORK.' The clarion call around which she forces the members of her cult to fundraise for good causes. Good causes that were never intended to see the light of day but rather to fund her luxurious life style and to 'seed her financial transition' into multi millionaire status.

**(1.) THE PURITY OF HER WORK AS A 'CON ARTIST.'**

We strongly recommend that you review some of the [written statements](#) and [audio statements](#) provided by scores of victims she robbed, defrauded, extorted money from and mentally and physically abused in Montana. Most of them being employees or students to her unaccredited school for 'occult studies.' We also highly recommend that you review several excerpts of a conversation Patton West had with business consultant John Watson. Watson was one of scores of victims defrauded by Patton West. However, what made him different was his decision to sue her. He did so in spite of all the threats made by Patton West during a meeting between them in March 2003, which Watson recorded. If listening to Patton West's own voice does not convince you that this narcissist asshole is a con artist, then I do not know what will.

## **(2.) THE PURITY OF HER WORK AS A 'CULT / CRIMINAL RACKETEERING GANG LEADER.'**

What more proof do you need that Patton West sits at the head of a cult / criminal racketeering gang than her ability to force individuals in the cult / gang to make 'donations' which are used to fund her luxurious lifestyle? The following image depicts a statement she made to the members of her cult in 2005...



Yet more evidence that Patton West sits at the head of a cult / criminal racketeering gang comes in the form of her ability to mobilize those under her control to a) 'manufacture' statements of denial about crimes they know full well she had committed. Or b) Patton West's ability to persuade members of her cult to directly intervene in lawsuits brought against her. This involved her minions defaming the plaintiff from her website, directly threatening the plaintiff or, as in the case of John Watson, conspiring with Patton West to murder the plaintiff. What follows are two examples of this kind of behaviour.

**1. THE VICIOUS ASSAULT AND EXTORTION OF \$1.3 MILLION FROM DR. PAT COLE MD.**

Patton West viciously assaults a her business partner Dr. Patricia Cole MD, while in the process of extorting \$1.3 million from the victim. Patton West issues a statement to her cult mailing list admitting the assault, admitting it was severe but sought to justify it by asserting Cole was a NAZI in the WWII death camps. If the above named persons were 'normal' employees, they would never have got involved in their employer's personal life. In the case of Reynolds & Williams, these two also became involved in Patton West's legal dispute with John Watson.

## **2. THE ATTEMPTED MURDER OF FRAUD VICTIM TURNED WHISTLEBLOWER JOHN WATSON.**

Fraud victim turned whistleblower John Watson, issued a lawsuit against Patton West in 2003 (which he won in 2008). Patton West warned Watson in their March 2003 meeting that if he went to law, she would get so 'f\*cking down and dirty etc. Watson learned a few years later that one of the dirty tricks Patton West used was to force her employees, on pain of being fired, to manufacture totally fictitious damning statements about Watson that she intended to use against him in court. On October 1 2007, Watson's lawyer received an email from Anandra George, one of Patton West's employees, admitting she was forced to write the negative statement about Watson and asking that the statement be withdrawn. In 2005, cult member Dr. Julio E Williams inserted himself into the dispute by issuing a [defamatory statement](#) about Watson which he posted on Patton West's website. Williams sent Watson an [expletive laden threatening email](#) in 2007 and then, in 2010, put up \$2,000,000 of his own fortune so that his cult leader Patton West could launch [multiple frivolous lawsuits](#) against Watson to avenge Watson's win against her in court in 2008. However, the main purpose of Patton West's lawsuits against Watson was to force down his websites so that the public could not access information about Patton West's criminal activities in New Mexico and Montana, after her move to Arizona 2010.

*Above: Geoffrey Reynolds CPA & Dr. Julio E Williams MD both pathological liars, both directly involved in the attempted cover up of Patton West's violent assault on Dr. Pat Cole MD and the extortion of \$1.3 million from Cole by Patton West. Both involved in Patton West's 2007 conspiracy to murder whistleblower John Watson and when that failed both directly involved in the 2010 conspiracy to bankrupt Watson into silence. All this effort to stop the public accessing truth about Patton West's criminality.*

When Watson refused to withdraw his lawsuit against Patton West, senior cult member Geoffrey Reynolds, in what he thought was an 'off the record' conversation with a newspaper reporter on August 9 2007, announced Watson's impending murder by Patton West. The failed murder attempt took place a few days after Reynolds told the Bigfork Eagle newspaper reporter that it was going to happen. Three years later in 2010, as part of the conspiracy Williams funded, Reynolds made totally false statements to a Montana court as part of a \$10,000,000 extortion scam orchestrated by Patton West. This designed to 'silence' Watson where murder failed.

**What the reader needs to understand is this. Both Williams & Reynolds were total strangers to Watson and were not involved in any way with the legal dispute between Watson and Patton West. And yet, both willingly agreed to become complicit in Watson's murder. When the murder plot failed, both agreed to be complicit in a conspiracy to bankrupt Watson so as to force down his websites.**

Patton West's ability to mobilize others into committing serious crimes against a stranger proves she has control over them. The two options are that Patton West leads a religious cult criminal racketeering gang.

## **(3.) THE PURITY OF HER WORK AS A 'MURDERER.'**

As mentioned above, after Watson refused to drop his lawsuit against Patton West, Geoffrey Reynolds announced Watson's murder to Constance See, who on August 9 2007 was interviewing Reynolds on behalf of the [Bigfork Eagle](#) newspaper. The newspaper makes an interesting read because it shows Patton West to be a pathological liar, who described her businesses in court as being a [billion dollar concern](#) while in reality, she was deep in debt and being evicted from a two rental properties in quick succession. What Reynolds actually said was, "Watson will be dead within 12 months or in jail for reacting to what Patton West was going to do to Watson and his wife and children."



Reynolds was obviously not concerned about announcing a murder in the near future or the campaign of violent intimidation launched against Watson and his family – which is ongoing 14 years later.



What makes Patton West's 'WORK' as a murderer 'PURE' is that the weapon she uses to commit extra-judicial killings is not recognized as a weapon by legal statute. Patton West can murder at will with zero chance of being connected to the victim except by the loose lips of idiots like Geoffrey Reynolds. Watson describes his experiences when Patton West tried to murder him in a web page entitled ['The Secret Weapon.'](#)

**THE MURDER OF WATSON DID NOT OCCUR AS PLANNED. HOWEVER, IT IS POSSIBLE THAT PATTON WEST HAS SUCCESSFULLY MURDERED SEVERAL OR MORE VICTIMS WHO OPPOSED HER.**

**Let us review some other victims. Several threatened with murder, one attempted murder (that we know about) and one actual alleged murder by Patton West.**

They say the law is an ass and in this respect, it certainly is! Patton West, a criminally insane narcissist, has been allowed to run amok for 30 years with a license to kill. After three decades of organized crime which she refers to as the 'Great Work' or 'World Service' she understands that the 'law' will likely not be used to prosecute her for murder! Few victims and witnesses come forward because a) they do not think the police will believe what they are experiencing and b) they know that between the time they report the crime and the time it is heard in court, they will be relentlessly targeted day and night by Patton West. As was the case with Rebecca West (no relation to Devra West) Rebecca was a witness to the assault by Patton West on Dr. Pat Cole described here in the [Whitefish Pilot](#) news article.



*Above: Imagine giving a criminally insane narcissist the codes to a nuclear bomb. This is the equivalent of what Patton West acquired between 1990 & 1991 while attending the 'Robert Jaffe School for Energy Mastery.' Being criminally insane she has used this occult (hidden) knowledge for the past 28 years to feather her own financial nest at the expense of scores of others.*

Between the time the police were called in April 2006 and West was charged with assault and the court finding her guilty in April 2008, Rebecca and other witnesses were relentlessly targeted by Patton West whose intent was to intimidate them into withdrawing their statements against her. The following short excerpt from a harrowing email she sent the whistleblower in March 2007 entitled '[Help Me](#)' makes clear exactly what is happening to Rebecca.

*I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. **I need support in how to deal with her shamanic witchcraft.** Can you tell me more?*

**NOTE TO FBI & POLICE IN ARIZONA - Not every murderer uses a gun, knife, club, poison or rope.**



*Above: To successfully prosecute a murder or crime of violence the police need to produce a weapon that they can link to the perpetrator and the victim. The occult (hidden) weapon that Patton West has used for 28 plus years to facilitate crime is not recognized as a weapon under legal statute. A fact that Patton West and her accomplices have relied upon for 28 years.*

Patton West has one advantage over other murderers and serial killers. The weapon she uses is not regarded as a weapon under legal statute, so those she murders appear to die of 'natural causes.'

**Julio Williams, a 20 year student of Patton West's and a senior member of her cult and Geoffrey Reynolds who announced Watson's murder, know what Patton West is doing and were / are willing accomplices in Racketeering & Murder. After 30 years of literally getting away with murder, Patton West believes she is a God and she dresses accordingly.**



*Above: The multiple personas are created out of the mind of a deeply disturbed psychopath who believes that she is entitled to prey upon the 'sheeple' and use the millions of dollars obtained from organized crime to fund her delusions of grandeur. She wants us to believe that she is on a mission to save humanity even though she has left behind a trail of abused and ruined lives.*

#### **(4.) THE PURITY OF HER WORK AS A 'SUSPECTED SERIAL KILLER.'**

In 2002 while employed as a business consultant by Patton West's charity, John Watson was told by Jack West (Patton West's then husband) that those who opposed his wife had a habit of dying suddenly. That was in 2002. The word 'those' infers 2 or more. According to Jack West; he, Patton West, and their young daughter Anna West, were chased out of New Mexico in the middle of the night in 1995 by one gun wielding victim who realised that the police could not help him with 'occult' attacks. We have evidence that Patton West was a small time con artist before she [elevated herself to the Godhead](#) in 1991. We know this because in 2007, John Watson received two emails from victims that pre dated 1991. The first was [Jeremy Samuelson](#) who was conned out of \$10,000 and the second was [Satya](#) who was conned out of \$6,000.



*Above left to right: Patton West used her secret weapon to relentlessly target her daughter in law Kendal Haywood so as to subvert a child custody case in favor of her son. Lisa Swidler, a young mother of two small children under age ten, was allegedly murdered by Patton West to keep her from talking. Lisa knew where a few of Patton West's skeletons were buried!*

In 2005, Patton West allegedly murdered Lisa Swidler, a student of hers who witnessed Patton West defraud another student [Dave Kershaw](#) out of \$30,000. In the same time frame, Patton West allegedly kidnapped, falsely imprisoned and beat another student, [Marion Cantwell](#), shortly after she sold her home. Marion was only released after making a sizeable 'donation' to Patton West's good causes. Marion was told that she would be killed if she went to the police. In 2006, employee Carlida Finch overheard Patton West talking about the murder of Dr. Pat Cole MD. Patton West said that she did not care if she murdered Dr. Cole MD because as an 'enlightened being' Patton West could just as easily live in a 6' X 6' jail cell as in a \$6,000,000 mansion. **Patton West has, over three decades, used her [secret weapon](#) to subvert several court cases. She does this by targeting victims and witnesses with a hidden campaign of violent intimidation. We give some examples in [this bulletin](#).**

In 2007, after Rebecca West refused to drop her damning witness statement against Patton West in respect of West's assault on Cole, Rebecca received an email from Patton West which stated it was a good day to die. Of course strangers will just say that comment was just a metaphor. However, if you read the [harrowing emails](#) Rebecca sent John Watson, you'll see the truth of the matter which is that Patton West is a dangerous psychopath, a murderer and quite possible a serial killer.




