



In 2002, business consultant John Watson was defrauded by Patton West. 

In 2006 fraud victim Watson turned whistleblower, put up a website to counter the lies, propaganda and [defamations of Watson](#) that Patton West was posting on her website. Watson's website included details of the many crimes that Patton West had or was in the process of committing in Montana.

In April 2008 Patton West is found guilty of assaulting Cole. In October 2008 Patton West is found guilty of defrauding John Watson. Patton West denies all wrongdoing.

In 2007, the [Whitefish Pilot](#) newspaper published a detailed list of some of the crimes being committed by Patton West at that time and led with Patton West's vicious assault on her business partner Dr. Pat Cole MD. This was followed a month later by a similar news article published by the [Bigfork Eagle](#) newspaper which showed Patton West to be a pathological liar. A pathological liar masquerading as a billionaire, while being evicted from two rental properties in quick succession. This in turn was followed by a newspaper article published by the [Ravalli Republic](#) newspaper which focused mainly on Watson winning his fraud lawsuit against Patton West.

The publicity resulting from Watson's revelations to the public and local newspapers meant no one in Montana believed the 'divine being' routine currently being used to target Sedona AZ. 





They say the law is an ass and in respect of Patton West, it certainly is! Patton West, a criminally insane narcissist, has been allowed to run amok for 30 years with a license to kill. After three decades of organized crime which she refers to as the 'Great Work' or 'World Service' she understands that the 'law' will likely not be able to prosecute her crimes especially for those she has murdered! Few victims and witnesses come forward because a) they do not think the police will believe what they are experiencing and b) they know that between the time they report the crime and the time it is heard in court they will be relentlessly targeted day and night by Patton West. Rebecca and other witnesses were relentlessly targeted between the time the assault was reported to the police in April 2006, and the time Patton West was found guilty in April 2008. Rebecca and several others being targeted by Patton West actually reported the intimidation to the Flathead police and although believed, were told that they could not help.
