

The Rishi AKA Con Artist Devra Patton West.

We shine a spotlight on accomplice Geoffrey Reynolds CPA. Guilty of fraud, extortion, false pleadings to court, complicit in attempted murder and ongoing violent crimes.

Patton West was chased out of New Mexico in 1995 by one victim at the point of a gun. Was forced to leave Montana in 2010 after multiple appearances in court as the defendant in fraud related lawsuits, two arrest warrants and a conviction for assault. She was also forced to sell all her assets at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest. After fraud victim John Watson turned whistleblower, put up a website about Patton West's crimes in 2006 and successfully sued Patton West for fraud she conspired with Williams & Reynolds to murder the whistleblower. Reynolds actually announced Watson's impending murder to the local press a week before Patton West's failed attempt on Watson's life. After the 2007 murder plot failed Patton West, Reynolds and Williams put Plan 'B' into effect. This involved outspending Watson in court by issuing multiple frivolous (without merit) lawsuits against Watson whose main objective was to obtain an injunction to force down Watson's website. Reynolds' role in Plan 'B' was to make totally false statements to the court about Watson which earned him a default (undefended) summary judgment in the amount of \$5,000,000 which he immediately signed over to his cult / gang leader Patton West.

After removing the truth of Patton West's criminal activities from the internet, Patton West was able to relocate to Arizona where she is currently masquerading as the 'Sanctified Regent of the New Americas' and the 'Revered Executor of the Divine Plan.' Apparently, Patton West has been planning to lead humanity for thousands of years!



In 2003, John Watson launched a fraud lawsuit against Patton West in 2003, which he won in 2008. However, in 2007, Patton West and the cult made a concerted effort to derail Watson's lawsuit. In January 2007 cult member Williams sent Watson an expletive laden email, whose objective was to intimidate Watson into dropping his lawsuit against Patton West. When Williams' threat failed, cult / gang member Geoffrey Reynolds got involved. One of the articles Watson caused, was published by Bigfork Eagle newspaper. On August 9 2007, while being interviewed on behalf of his gang leader Patton West, Geoffrey Reynolds announced in what he thought was an 'off the record' conversation, that Watson would be dead within 12 months.



What Reynolds actually said was that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his wife and children. The campaign of intimidation launched by Patton West against Watson and his family continues to this day. A fact Reynolds is well aware of as he has received 500 emails from the victim about the ongoing campaign of intimidation. Reynolds was alluding to Patton West's use of occult knowledge to intimidate and murder those who oppose her, go to the police, go to court or go public.

Clearly, Reynolds was well aware of the weapon and its intended use against Watson and his family. How else could Reynolds announce Watson's impending murder only a week before Patton West made a failed attempt on Watson's life? Perhaps Reynolds knew about Patton West's murder of Lisa Swidler, which may be the reason Reynolds was so confident that Patton West would deliver the murder and get away with it?

When the murder plot failed, Reynolds doubled down on his treachery by making totally false statements to a Montana court that netted him a \$5,000,000 default undefended summary judgment in the amount of \$5,000,000, which Reynolds immediately signed over to his cult / gang leader. What Reynolds did was submit a carbon copy of Patton West's pleadings to court which alleged that Reynolds had been defamed by Watson between 2002 & 2006. This was impossible because Reynolds did not travel from California to take up his 'employment' with Patton West's cult / gang until September 2006. The impression she is trying to give, falsely, is that the injunction was awarded to her and applies to everyone on the planet. In other words, NO ONE is allowed to tell the truth about her or contradict her version of reality. However, the false claims posted online by Patton West that allege she was the subject of a cyber-fraud scam are now unraveling (see link below). Claims Reynolds helped put in place.


