

The Rishi AKA Con Artist Devra Patton West.

We shine a spotlight on her accomplice of 21 years Dr. Julio E Williams MD. Guilty of funding organized crime, directly involved in fraud and extortion and complicit in attempted murder.

Patton West was chased out of New Mexico in 1995 by one victim at the point of a gun. Was forced to leave Montana in 2010 after multiple appearances in court as the defendant in fraud related lawsuits, two arrest warrants and a conviction for assault. She was also forced to sell all her assets at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest. After fraud victim John Watson turned whistleblower, put up a website about Patton West's crimes in 2006 and successfully sued Patton West for fraud, she conspired with Williams & Reynolds to murder the whistleblower. In chronological order, we list some of crimes that Williams willingly participated in. In 2005 Williams was asked to show his 'loyalty' to cult / gang leader Patton West by defaming a total stranger (to him). In January 2007, Williams was asked by Patton West to show his loyalty to her once more by writing an expletive laded email to Watson whose objective was to intimidate Watson into dropping his fraud lawsuit against Patton West. The cult had to wait for their revenge until 2010. 
