

Dear FBI and local law enforcement please add this information to your file on Devra West, Geoffrey Reynolds, Julio Williams and Jack West i.e. the cult. This episode focuses on Devra West's attempt to pervert the course of justice in the matter of two custody hearings involving two infant female children. She did this by supplying members of her cult to give false witness statements and by terrorizing the mothers of both infant children in the hope that they would give up custody to her son. In the last two bulletins about this vile creature, which is currently embedded in the Cave Creek / Carefree AZ community, I gave a list of 30 past examples of her previous so called **'world service'** efforts in Montana. These examples showed beyond doubt that this occult thief / suspected serial killer is simply masquerading as a 'do-gooding' guru, for the sole purpose of recruiting the next batch of victims. In this bulletin, I am going to provide credible evidence that shows even her own relatives (by marriage) are not immune from the 'divine embrace' of this serpent. The three victims I am going to focus on, in reverse chronological order are:-

1. Carol Patton – Devra West's stepmother who married her father.
2. Jamie Haywood – the second wife married to her son Chris Haywood.
3. Kendal Strnad – the first wife married to her son Chris Haywood.

As stated above, no one, repeat no one, is immune from the lies, deceit and treachery of Devra West, an Occult Master who believes herself to be totally beyond the reach of the law.

Victim 1. Devra West's stepmother, Carol Patton.



On October 6, 2009 the whistle-blower's lawyer received a rather unexpected email from Devra West's stepmother, Carol Patton, asking him if he could help her recover \$30,000 that Devra West owed her. Carol had been following the regular updates about the whistle-blower's fraud lawsuit against Devra West which he had won in 2008. Carol was aware that Devra West was being deposed by the whistle-blower's lawyer, in an attempt to ascertain where Devra West had hidden all of her money including, the millions of dollars' worth of assets (artwork and valuable) stolen from her charity.

The email below is self-explanatory.....

I would like to know why Devra West if she had so much money and so much jewelry and so many artworks and artifacts found it necessary to con her father out of \$30,000 supposedly to buy land. Why do I ask? I was married to Devra's father for 38 years. He passed away January 2007. He had been in very poor health for many years. He had also been retired for 20 years and we didn't have much money left from his retirement.

I have known Debbie (yes that is what I call her and still do) since she was 15. When she moved to Colorado with Bob Meador we spent a fortune helping her and Bob and then Tomas and then whomever all those years. She knew John (her father) didn't have a lot of money and that is why she paid for his tickets to come to visit her in Colorado and Montana.

She told us she would be receiving \$33,000,000 (yes million) from an investment that was supposed to come through and she would return the money to us. Because of her I cannot pay off my house. In reading John Watson's dialog on the web I found it interesting that the amount of \$30,000 was mentioned several times. If Devra West has all this money, I would like my money returned. Actually I would like \$64,000 since that is what I owe on my mortgage. And make no mistake about it. John and I spent a fortune on her from the time she was 19 and living in Gardner, Colorado. I am not going to go into detail about her past life, but it hurts me to find out she had all these assets and took from her father.

Note the mention of the \$33,000,000. This was the amount in CPEA government grants that Devra West and Geoffrey Reynolds fraudulently applied for. I say fraudulent for two reasons; the first being that neither Devra West nor Geoffrey Reynolds CPA, when applying for the grant money, shared the true nature of Devra West's criminal business model. Secondly, it is unlikely that Devra West or Geoffrey Reynolds declared that at least \$2,500,000 of the CPEA grant money was to be diverted to pay off Devra West's debts which included \$2,000,000 in court fines and interest owed to creditors which in 2008 became the subject of a [Sheriff's Sale](#).



Rebecca West, (no relation) Devra West's office manager in 2007, wrote extensively about Devra West's criminal business operation and also touched on the application for the \$33,000,000 in CPEA grant money and pondered whether it was fraud and clearly stated that some of the grant money, if received, would be diverted to pay off Devra West's extensive debts. Here is an excerpt from one of her emails.

"Please be advised that the CPEA \$'s obtained with Dr. Cole's funds are due into the bank account this week. These monies were supposed to be available over a year ago and if the transaction is not a fraud then \$30M will be deposited in increments. I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available."

As for all the artwork and valuables (all paid for by public donation) that Carol Patton references in her email, these would be \$4,000,000 (as valued in 2002) in artwork and valuables stolen from a Montana charity that was [struck off](#) the register for fraud in

November 2003. These items were probably hidden in a lock up for 10 years until the statute of limitations on theft had passed? Of course, Devra West lied from start to finish while giving [her statement](#) asserting that [list of assets](#) owned by the charity (the \$4,000,000 in artwork and valuables) did not exist, or if they had existed they were stolen and most in any case were not hers.

In 2014 hundreds of times exactly matching the description of those stolen from the charity appeared at auction in Cave Creek AZ and for sale from the her website; you can review these items by following this link to the '[Art Gallery](#)' page on her website the illustration above lists a small part of her statement denying these items ever existed.

IF YOU THINK THAT DEVRA WEST'S TREATMENT OF HER STEPMOTHER WAS BAD WAIT UNTILL YOU READ WHAT SHE DOES TO HER TWO DAUGHTER IN LAWS!

Throughout the [statement](#) Devra West gave in October 2009 she insisted that all of her money matters were managed by [Geoffrey Reynolds CPA](#) (why waste a good opportunity to state in court documents that Reynolds was to blame) and that she was currently living in his back garden in an RV (see above) because she was penniless! Here is a link to the full [statement](#) given by Devra West while being deposed.



Shortly after making that statement in October 2009, Devra West moved from being penniless and out of Reynolds's RV, into a \$7,000 a month mansion in Cave Creek AZ; proving yet again that for Devra Patton West, crime really does pay!

Before we get into the details of the next shocking and sordid example of ['world service'](#) from the occult thief / suspected serial killer Rishi Devra it is worth reminding to readers of two important facts:-

(1). Devra West has been running a cult for decades. She is clearly able to manipulate weak minded individuals into doing her bidding and once under her control, she uses them to bear false witness against the victims of crimes she has committed and those witnesses who are hostile to her. She has the senior members of her cult author / post defamatory statements of denial on her websites and when necessary she also uses these morally bankrupt minions stand between her and her adversaries.

So for example in 2005, some 18 months after the whistleblower announced he was going to sue Devra West for fraud, the 'Master Manipulator' got three of her then cult members

Williams, Cole and Cornell to author a [defamatory statement](#) about the whistleblower, which was posted on her website.



The purpose of the statement was to a) character assassinate the whistleblower and b) attempt to persuade the rank and file of her cult that she was in the right and the whistleblower was in the wrong. Devra West needs to do this because the **guru / cult / extortion business model** only works if the public and the brainwashed members of her cult swallow her lies, deceit and propaganda. The problem Devra West and the senior members of her cult have is that with [tens of employees and students](#) leaving each year claiming that they were mentally and physically abused, no one believes her bullshit except the most brainwashed members of her cult; the rest keep quiet for fear of becoming a target.

Fast forward to July 12, 2007 when, on the very same day that the [Whitefish Pilot](#) newspaper issued a story about Devra West's one person 'crime wave' in Lakeside MT, she, the Ascended Master Surya Ma was in court giving 'evidence' on behalf of her son, Chris Haywood, who was in a custody battle for his infant daughter against his estranged wife, Jamie Haywood. Long story short, the resident cult member / [liar for hire](#) called to duty to give false witness in court at the custody hearing for Devra West (and her son) was Geoffrey Reynolds CPA.

(2). **Devra West uses occult knowledge as a weapon.** That Devra West's 30 year criminal conspiracy is entirely predicated on her use of occult (hidden) knowledge is not in doubt. While posing as a Goddess, she uses to commit crimes ranging from theft to murder. Here is how Rebecca West (no relation to Devil West), a hostile witness to Devra West's vicious assault on Dr. Cole MD, described what was happening to her and her friend Dr. Cole MD. This from a harrowing email entitled ['Help Me.'](#)

"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?"

And this ...

"I was completely appalled and disgusted at Devra's abuse of Patricia. The beatings and mental abuse occurred over an extended period of time and repeatedly. Last week I saw police photographs, which were taken of Patricia's injuries sustained from only two of the beatings. I very much have the support of

local law enforcement as the photos of Pat's beatings candidly show the truth and which she calls **Core Impacting and/or Shamanic Blows!"**

Dr. Pat Cole MD was another victim of the **'world service'** efforts of Devra Patton West, but one of the three we are reviewing today!

Now that we all understand that the occult thief / suspected serial killer Devra Patton West:-

1. Uses **'liars for hire'** like Geoffrey Reynolds CPA to provide her with false statements.
2. Uses her occult knowledge as a **'weapon'** to launch a campaign of 'under the radar' violent attacks against victims and hostile witnesses to terrify / intimidate them into backing down. Or in extreme cases, as with the whistleblower attempt to murder them or as suspected with Lisa Swidler actually murder them.

We can proceed on to the next victim....

Victim 2. Devra West's daughter in law, Jamie Haywood.



A day before the court hearing was to happen on July 12, 2007 Jamie Haywood reached out to the whistleblower via his website in an email, which I post in full below here; the highlights are mine for emphasis.

Subject: **Another victim/ fighting for my life and my 11 month old daughter!**

Hello, my name is Jamie Haywood, Chris Haywood's ex-wife. And Devra West's ex daughter in law. Well actually I am in the middle of the divorce.

I finally found this website and have been searching for you and Pat Cole due to the fact that my daughter and I have been subjected to this nasty woman. I thought that I was going crazy and thought there was something wrong with my daughter. Until my mother took me to see a true 'guide' and this wonderful woman told me that **I had a spell put on me**. She then started to test where it was, lo and behold in the left front side of my brain. **Yea something to make me go crazy and**

whatever else! And that's not all; she also put one in my 11 month old daughter's internal organs. So this 'guide' took some time and finally removed these wicked spells off of me and my daughter then she told me that I would be protected.

This woman (Devra West) is now involved in the divorce case and in some way or another has been able to take my daughter from my possession. Chris has our daughter and is living in our so called home (Pat Cole's house) which they will be evicted from shortly. Pat's house was foreclosed by Wells Fargo Bank and they have to be out in 15 days. Devra West is also living with Chris at Pat's house because Ms. West was evicted from her 2.6 million dollar home on June 29, 2007.

Between the 2 of them, they have tried to break me down and all the way down. From verbal abuse to physical abuse. I have been with this wicked family for 6 years now and am so happy to get out alive and with my mind intact. Now, John, I'm not too sure if you can remember a day when you and Devra were in her kitchen at the Nakashalla having some sort of meeting, when Chris and Sondra (his daughter), along with myself came in. and she stood up and told me to get the fuck off out of her home. Now that was the first day that I'd ever met her and it's been a fight ever since.

Please John, I may need your and Pat Cole's help with getting my daughter Sasha back where she belongs and along with my normal life back. So I am going to leave a phone number and an email address for you and would cherish it if you would call me as soon as possible. I am going into the district court tomorrow and I am going in there with all of your wonderful info and I am going to fight for my daughter to come back to my possession.

[Devra West and her son Chris Haywood hoped, by using overt and covert violence, to repeat of what they had achieved several years earlier when, using the same tactics, they managed to obtain custody of an infant female daughter from Chris Haywood's first wife, Kendal.]

A couple of important factoids to hold onto from Jaime Haywood's email are:-

(1). Surprise, surprise Jamie Haywood is also the victim of sustained occult attacks from Devra West and believed that Devra West was also attacking her baby. She also states as much in court. In other words, the occult thief / suspected serial killer was using her knowledge of shamanism to intimidate her then daughter in-law (Chris Haywood's second wife) into handing over custody of her infant daughter to her son, Chris Haywood. Yet another example of how this serpent, this vile creature, uses the occult to commit crimes and or intimidate witnesses into changing their stories.

(2). The other aspect worthy of note is that, according to Jaime Haywood, Devra West was in the process of being evicted from two rental properties in quick succession. This is relevant because as we shall see from her testimony, Devra West describes herself to the court as being the owner of a 'multi-billion dollar enterprise!'

I am going to focus on the statements made by Devra West, Jaime Haywood and last but not least 'liar for hire' Geoffrey Reynolds CPA. I will quote statements made by witnesses and reference the page numbers and line numbers as they appear in the transcript which can be viewed by following these links.

What follows are statements made by Devra West under oath, a witness appearing for her son, Chris Haywood. A good rule of thumb with Devra West is that, you know when she is lying – her lips are moving!

Page 6, Line 7 – At the time she was speaking she had only one company in good standing as is evidenced by the [Bigfork Eagle](#) newspaper article published August 9 2007 therefore **her statement was untrue.**

Page 7, Line 13 – By any definition Devra West was and has been running a cult for decades as this email entitled ["Help Me"](#) from Rebecca West (no relation) shows therefore **her statement was untrue.**

Page 7, Line 17 – Within days of making this statement, and following the publication of the Whitefish Pilot newspaper article covering the assault on Dr. Cole and many other crimes, every 'employee' of Devra West's came out in unison all posting statements of denial on West's website. There were four statements from Geoffrey Reynolds CPA. Two statements from Julio Williams MD. One from her masseuse Dani Osborne. One from employee Bret Jauhola. And one from her ex-husband Jack West. You can review these statements by following [this link](#).

Normal employees of a corporation do not come forward 'as a man' and all in unison, on the same day, post statements of denial from their employer's website after their employer has found to have committed a serious crime – members of a cult do! **Her statement was obviously untrue.**

Page 10, Line 19 – In answer to the question, "Is it fair to characterize your company as a multi-billion dollar enterprise?" Devra West answers, "Correct." This is untrue, as evidenced in the newspaper article published by the [Bigfork Eagle](#) on August 9, 2007 which reports that Devra West was in the process of being evicted from two rental properties in quick succession, had a lien against her for \$2,287 and had bounced a large deposit check on a property she was negotiating to buy. **Clearly her statement was obviously untrue.**



Page 10, Line 23 & Page 11, Line 6 – There is absolutely no evidence at all that Devra West has given a single penny to charity; on the contrary, there is a lot of documentary evidence that Devra West has stolen hundreds of thousands of dollars and perhaps millions of dollars from the charities she has run. **Clearly her statement was untrue.**

Page 12, Line 16 – Once more the Master Liar refutes the idea that she is running a cult, when all the evidence points directly to that fact. **Clearly her statement was untrue.**

Page 13, Line 8 – In answer to the assertion that Devra West is about to be evicted she states, and I quote, “I’ve heard these stories they are absolutely not accurate.” We know from Jaime Haywood’s email above and from the [Bigfork Eagle](#) news article that Devra West was evicted, twice in quick succession! **Clearly her statement was untrue.**

Page 14, Line 3 – While occupying this property, Devra West got into a water rights dispute with her neighbor, Michelle Fetveit. Michelle also contacted the whistleblower via his website and reported that she too was the victim of **occult attacks** and that she was awakened at 3.00 am each morning as a result of the ‘shamanic visioning’ (occult attacks) directed at her by Devra West.

Page 16, Line 16 & Page 20, Line 8 – Devra West describes her son as one of the most “beautiful fathers” and later as an “exemplary father.” As we shall see later in Jamie Haywood’s testimony, Devra West’s assessment of her son’s ‘parenting’ abilities is clearly a lie. **Clearly her statement was untrue.**



Page 20, Line 25 – Counsel refers to Chris Haywood’s other daughter by his first marriage to Kendal Haywood. This daughter was successfully wrested from her mother by Devra West and her son who used the same tactics then as they are using now on Jaime, Chris Haywood’s second wife.

Page 22, Line 17 – As for having headquarters in Lakeside MT Devra West’s ‘corporate’ activities came to an abrupt end shortly after this hearing following the publication of two news articles by the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers. These publications showed that Devra West was the head of a criminal gang that had been committing crime on an industrial scale; both against members of her own cult and the public. This publicity forced her to move her guru / cult / extortion business model out of Montana to Arizona where it currently operates. Therefore, her statement that she was going to remain in Lakeside MT **was clearly untrue.**

Page 23, Lines 3 to 23 – Devra West denies that her son, Chris Haywood, has been violent towards his current wife, Jamie Haywood and his first wife, Kendal Strnad. Devra West also denies that she and her son have been violent towards each other and denies that he grabbed her by the throat. The evidence, both actual and circumstantial seems to indicate that **her statements were untrue.**

Page 23. Line 24 to page 24, Line 7 – Counsel refers to the whistle-blower’s website wherein there is a statement “Warning – This Woman is Dangerous.” Counsel states that it is about Devra West and she agrees that it is but goes on to say that the people mentioned on the site (her ex-employees) are fabricated and fictitious. This is a link to the [list of ex-employees](#), many of who alleged being mentally and physically abused by Devra West, which appeared on the whistle-blower’s website and below here is an image of West’s guru /

cult / extortion business model that contains a photograph which includes many of those ex-employees that Devra West denied existed!



Page 24, Line 14 – Devra West asserts that the statements on the whistle-blower’s websites are fabricated and then doubles down on her lies by further asserting that that one of the whistleblower past professions was to work for a London based tabloid newspaper. The whistleblower has never worked for a newspaper tabloid or otherwise! **Both her statements were totally untrue.**

Page 24, Line 24 to Page 28, Line 11 – Counsel refers to the fact that there are a number civil of lawsuits pending against that Devra West currently. Counsel starts to list several to which Devra West tries to assert they are all the fault of the plaintiffs who brought them against her (and in the case of one of them her and her son Chris Haywood)!

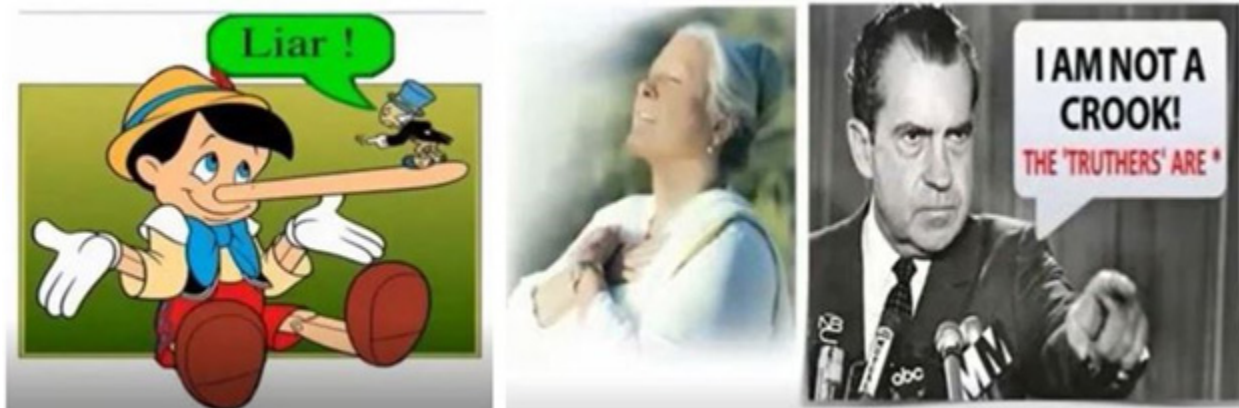
Page 28, Line 12 to Line 25 – Devra West is asked the question what is ‘The Circle of Divine Unity?’ Instead of telling the truth that the charity was formed by her as a vehicle for her guru / cult / extortion business (see above image) using brainwashed and conditioned members of her cult as officers / board members Devra West instead distances herself from her own creation, so she can blame others for the fact that she bankrupted the charity then stole several millions of dollars in assets from it! If as she says she only served on the board of the charity how come both she and her husband were receiving tax free income as ‘ministers’ of quasi-religious school that they both ran? **Clearly her statement was untrue.**

Pages 29, Line 1 to Line 6 – Under questioning from counsel Devra West denies that she has a propensity for violence and yet all the evidence is to the contrary, as before the assault on Dr. Cole MD there was an assault on student [Beatrice McGuire](#) in 2002 that left her needing plastic surgery to repair her ear that Devra West had partially ripped off. Before

that in 2000 there was a vicious attack on ex-employee [Susannah Felder](#) who, after challenging Devra West about an \$80,000 donation that she had stolen from the charity to pay for her son's legal fees in an earlier custody battle with his first wife, was attacked and partially scalped. **Clearly her statement was untrue.**



Page 29, Line 16. Counsel accuses Devra West of assaulting Dr. Cole MD to which Devra West replies, and I quote, "Absolutely not – no way no how absolutely not." Clearly this was a bare faced lie (like all the others) as Devra West, shortly after assaulting Dr. Cole MD (as part of a campaign to 'harvest' one of the wealthier members of her cult) wrote on 17 April 2006 a missive entitled ['The Law of Severity on the Path to Purification,'](#) wherein she admits the following: _

1. Assaulting Dr. Cole MD.
2. Admits that the assault was severe.
3. Asserts that though severe the beating meted out was administered with grace.
4. Sought to justify the assault by asserting that the victim was a Nazi in the WWII death camps in another lifetime!

This admission of guilt was posted on the whistle-blower's website for all to see at the time of this court hearing. Senior cult member, Geoffrey Reynolds was later tasked with claiming copyright over the missive in an attempt to force it off the whistle-blower's website – so there is no doubt who authored this admission of guilt. **Clearly her statement was untrue.**

Now let me move on to the testimony of Jamie Haywood; I do not propose to analyze it line by line, as the reader can do this by reviewing the full transcript of the court hearing (links provided above). However, I do want to counter once and for all, the mountain of lies, deceit and propaganda as contained on Devra West's latest website that she is a 'divine being.' After reviewing Jamie Haywood's testimony about the 'home life' she experienced with Devra West and her son, Chris Haywood, it will become obvious to all that Devra West is a vile, despicable creature that considers anything that moves as prey.

Page 86, Line 9 – Jamie is asked how old she was when Chris Haywood got her pregnant, to which she replies just 18 though it is alleged that it happened when she was 17.

Page 86, Line 12 to 25 – Jamie relates how Chris Haywood put pressure on her to have an abortion because, as is stated later, getting his underage girlfriend pregnant while he is in a custody battle would not go well for him!

Page 87, Line 1 to 21 – Jaime relates that Chris Haywood used alcohol and illegal drugs.

Page 87, Line 24 – Jaime responding to the question was he abusive towards you answers yes.



Page 88, Line 1 to 20 – Jamie relates how Chris Haywood broke her nose because he felt she was 'hitting on other men.' Jaime was pregnant with his child at the time. Apparently Chris Haywood was convicted for that assault (like mother like son?).

Page 89, Line 9 & Lines 14 to 16 – Jaime is asked if there were other incidents of violence towards her. She replies that Devra West, Chris Haywood's mother did not like her around because of her young age. Therefore her relationship with Chris Haywood had to be kept secret because Chris Haywood was, at the time, going through "quite a custody battle."

Page 89, Line 21 – Jamie asserts that Devra West is still fully supporting her son, Chris Haywood meaning he did not have the wherewithal to support an infant child on his own.

Page 90, Line 2 to Line 14 – Jamie alleges that she has seen Devra West mentally and physically abuse her employees and witnessed Devra West assaulting Dr. Cole MD.

Page 90, Line 17 to Page 91, Line 8 – Jamie alleges that she saw Devra West and her son, Chris Haywood, get into a physical fight. Long story short, according to Jaime, Devra West licked her son's face from top to bottom (how sordid is that) to which he held her by her throat up against a wall; he told her to knock it off and she then pointed out that he could not go to his doctor's appointment because his face had been scratched during the altercation!

Page 92, Line 22 to Page 93, Line 14 – Here Jaime alleges that she received a call from Chris Haywood at one in the morning asking her to pick him up from a bar; when she arrived he was very belligerent, so much so, that Jaime stopped the car and got out at which point Chris Haywood jumped in the driver's seat and drove off leaving her, eight months pregnant, standing alone at the side of the road. Jaime goes on to say that the cops drove her to her mother's home.



Page 94, Line 5 to Line 22 – Jaime is asked by the court to describe what happened on the night of June 21st. She responds that Chris Haywood was not happy with her driving after leaving Geoff and Leslie Reynolds’ home. Chris started to scream at her to which his daughter by his first wife, Kendall, told his father to ‘knock it off.’ The row escalated to the point where Chris Haywood violently slapped Jaime across the face and when he went to hit her again, Jaime hit him in the mouth to which he responded by hitting her on the side of the face causing a gnarly bruise that she still had when appearing in court.

Page 94, Line 4 – In what can only be described as a carbon copy of what his mother does, Chris Haywood, the following morning after the altercation, tried to convince Jaime that she had beat herself up. In the case of his mother Devra West, she never admits to hitting others she says that God does it not her! Again another example of like mother like son.

Page 103, Line 9 – Jaime is asked if she is comfortable with Chris Haywood’s mother, Devra West having access to her baby to which she replies “Absolutely not!” Jamie then refers to the police photographs of Pat Cole taken immediately after the beating administered by Devra West. This is described fully in the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspaper articles.

Page 108, Line 1 – Counsel asks Jaime if Chris Haywood has a temper – she responds that he has a very short fuse like his mother!

Page 108, Line 24 to page 109, Line 20 – Jaime is asked if she has any concerns about Chris Haywood’s sexual habits having a daughter around to which she alleges that Chris Haywood is into pornography and likes to “jack himself off in front of the telly” and does so even when there is company in the house and hints that one of her girlfriends saw him.

Page 115, Line 13 to Line 23 – Jamie admits to lying under oath and explains that she had no choice as she was being physically beaten and has the photos to prove it.

This concludes my analysis of the evidence given by Jaime Haywood about her then husband, Chris Haywood however I would like to share one other similarity between mother and son which is that Chris Haywood has a criminal record with the FBI for forgery, Multiple drug busts, and traffic offences this much was entered into evidence in the first custody hearing between himself and his first wife Kendall.




Above is Kendall with her three other daughters (minus her daughter by Chris Haywood); this photo given by Kendal to the whistleblower who was trying to help her at the time.

She founded the non-profit organization Open Fields, whose mission is to align the best concepts of conventional and complementary alternative medicine. She serves currently on the American Board of Holistic Medicine. Her academic interests are spirituality in medicine and cross cultural medicine.

Kendall could not possibly keep pace with the cost of the legal fees (Devra West had unlimited funds to outspend any adversary; she simply stole what she wanted from the public donations being made to her charity). Added to which the daily / nightly 365 days a year occult attacks, were taking their toll on Kendall and, exactly as intended by Satanist Devra West, she made Kendall look, for all intents and purposes, as though she were having mental health problems.

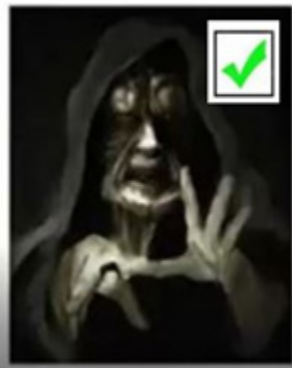

The following examples, in reverse chronological order, occurred during Devra Patton West's incarnation as the Ascended Master 'Surya Ma' in Lakeside Montana between 2005 and 2011.

1. Arrest Warrant for [Felony Theft](#) December 16 2009.
2. Judgement against Devra West (and son Chris Haywood) [for fraud](#); both had ignored the court proceedings brought against them by 'Top to Bottom Construction.'
3. Arrest Warrant for [Criminal Check](#) Fraud April 16 2008.
4. Conviction for Assault April 2008; Newspaper article [announcing conviction](#), Devra West's [written admission](#) of April 17 2006 that she had assaulted Dr. Cole MD, West's denial and subsequent [clarification by newspaper](#) that West was guilty.
5. [Judgment](#) handed to the whistleblower in October 2008 by a Montana court finding that Devra Patton West had defrauded him; newspaper article in [Ravalli Republic](#) announcing judgment.
6. On 20 May 2008, Devra West became the subject of a [Sheriff's Sale](#) to force her to pay \$2,000,000 in court fines and interest to her creditors arising from her earlier [world service](#) efforts as the Ascended Master Devra Ji between 1995 and 2004.

7. In 2007, Devra West's criminal activities became the subject of two newspaper articles published in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. While these two articles are informative, they do not truly show the scope of West's criminality, most of which is hidden inside the cult.

8. The fraudulent depiction of a multi-million dollar lakeside property on her website and in her brochures as belonging to her; this property described as 'Surya Ma's Abode' in reality, belonged to Robert & Tabby Ivy, who over a two year period repeatedly asked Devra West not to use images of their property. See July 12 2007 [Whitefish Pilot](#) news article for details.

9. Also on July 12 2007, Devra West appeared in court as a witness for her son in his attempt to get custody of his infant daughter from his estranged wife. During her appearance in court, Devra West described her businesses as [multi-billion dollar enterprises](#) even though at the time, she had a lien against her for [unpaid employment insurance](#) and was in the process of being evicted from two rental properties in quick succession.

10. While in court, she was asked by counsel about the many ex-employees that had posted statements on the whistle-blower's website, alleging that they were mentally and physically abused by her. The Master Liar's response was to say that many of those mentioned on the whistle-blower's site were [fictitious or fabricated](#). Below is a graphic which shows how her 'business model' works; the photograph contains most of the employees (and some students) that Devra West says do not exist!

11. Devra West, with the aid of senior cult member [Geoffrey Reynolds CPA](#), had fraudulently applied for \$30,000,000 in CPEA grant money; when the grants were denied Devra West, owing millions in court fines, decided to 'harvest' one of the wealthier members of her cult – Dr. Pat Cole MD.

12. Devra West is a vicious and violent criminal who uses her occult knowledge to terrorize both victims and witnesses into silence. Here is a short excerpt from a harrowing email [entitled 'Help Me'](#) that Rebecca West (no relation to Devra West) sent to the whistleblower in March of 2007 – Rebecca being a friend of Dr. Cole's and a witness to Devra West's brutality towards her.

"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?"

Clearly, the con artist Devra West could not allow news of her brutality towards members of the herd trapped inside her cult to escape into the public domain it might interfere with her multi-million dollar a year ~~fraud-seam~~ ['world service'](#) efforts!

Also in 2007, the whistleblower was contacted via his website by Michelle Fetveit a Lakeside MT neighbor of Devra West's after she got into a 'water dispute' with Devra West. As with Rebecca West (and countless other victims) Michelle reported being the subject of 'occult' attacks and was also woken up at 3.00 am each morning. The whistleblower has never met either of these women and yet they both report being subject to the exact same phenomena – the common denominator being Devra West. 13. Around this time Devra West, already a Master in what she calls the malleable fluidity of reality (lies, deceit and propaganda) announced that she was single handedly [holding open the gates of time!](#) This in addition to an earlier statement to her students insisting that her two doctorates were [presented to her by the Christ](#) in person.

14. On or around the 14 April 2006, Devra Patton West viciously assaulted Dr. Pat Cole MD who was both a 'student' and business partner of Devra West's. The assault was part of a well-orchestrated campaign of violence aimed at extorting \$1.3 million from Dr. Cole, which Devra West succeeded in doing. In 2005, after her Victor MT charity was struck off, desperate for funds and owing \$2,000,000 in court fines and interest to creditors Devra West, still posing as the Ascended Master Devra Ji, [wrote to her mailing list](#) in an attempt to bully the individual rank and file cult members into giving up to 66% of their net worth to her. Within that missive she made the following statement:-

"It will be your privilege to seed my financial transition."

17. In 2005, some eighteen months after issuing legal proceedings against Devra West for fraud, the whistleblower became the subject of a campaign of defamation, character assassination and dirty tricks at the hands of Devra West and her cult. This took the form of a [defamatory statement](#) posted on Devra West's website by three of her cult members amongst them Dr. Julio Williams MD. He also received a [threatening email](#) from Julio Williams MD, stating that he was personally going to fund Surya Ma's legal expenses to the tune of \$2,000,000 and that the whistleblower should not "fu*k with him or else."

The whistleblower was also advised by a friend still in the cult, that Devra West had ordered her employees to 'manufacture' false statements about the whistleblower or be fired for refusing! [This link](#) leads to an email from a member of the cult, who later retracted her false statement.

18. Ingrid Bayer, a teacher at Devra West's unaccredited school, wrote to the whistleblower stating that her 6 year old son had been abused by Devra West; here is a short excerpt from Ingrid's statement which can be read in full by following [this link](#). **"I am a firsthand witness to the physical and emotional abuse from Devra as I experienced it myself, as well as witnessing the abuse of my 6 year old son by Devra."**

Perhaps Ingrid's 6 year old son represented a threat to the beast's **'world service'** efforts?

19. Lisa Swidler, student and confidant to Devra West, died suddenly and mysteriously of 'natural causes' after witnessing two serious crimes that were committed by Devra West against two other students to West's unaccredited school. Lisa broke away from the cult and died shortly after, leaving behind two small children under age ten. The whistle-blower believes she was murdered by Devra West to keep her quiet.

20. Sometime in 2005, Devra Patton West without a business container to run her fraud scam from and heavily in debt, allegedly kidnapped student **Marion Cantwell**, held her captive, beat her and only released her after Marion agreed to 'donate' tens of thousands of dollars from the sale of her home to Devra West. I suspect this money was not for **'world service.'**

21. **Dave Kushner**, a student of Devra West's, was defrauded out of \$30,000 by Devra West this money supposed to be a two week bridging loan. Dave Kushner never got a penny back and Devra West refused to ever speak to him about it. Rather than become a murder victim Dave Kushner decided not to go to the police or to court for restitution even though he had a signed agreement from Devra West in respect of the loan! As Devra West made clear to the whistle-blower in 2003 **her agreements are worth nothing!**

22. In 2004, student Mike Hendrickson was defrauded out of \$200,000, as after signing a note at the bank to guarantee the charity's overdraft of \$200,000, Devra West emptied the bank account and put the \$200,000 in a personal trust fund for herself and her eldest son, Rob Meador. Mike is mentioned in the **Whitefish Pilot** news article; he too chose to walk away rather than become a potential murder victim.

23. At around this time, the whistleblower received **an email from Judy Morris**, an ex-student / cult member, that was part of Devra West's European group of students informing him that many of the European students had taken out loans and mortgages to give money to Devra West. They were told, and I quote, "The more they gave the more God would love them."

24. Around this time, according to another student, Elaine, who wrote to the whistleblower in 2009 about a conversation in 2004, Devra West bragged about her ability to attract wealth - no mention of 'world service' here is an excerpt from Elaine's email.

While Devra is obviously a pathological liar, she unwittingly reveals herself quite frequently because she can't keep her own mouth shut and so loves to brag. This was more than five years ago -- in the course of bragging about her ability to attract wealth, she explicitly stated she doesn't have any bank accounts because she didn't need them in order to be wealthy. She then pointed out that at that very moment she was wearing \$250,000 worth of emeralds. And she implied she had a lot more than what she was wearing. She's so sure she's smarter than everyone else, I doubt the jewels are very far away and I strongly suspect she has at least a million in jewellery.

Maybe the jewelry, precious metals and the millions in artwork and valuables stolen from the Montana charity will be combined to fund her **'world service'** efforts?

25. In 2004, having had her charity, The Circle of Divine Unity, struck off for fraud in November 2003, Devra West perpetrated a massive fraud on that charity which resulted in

her stealing a property from the charity paid for by public donation worth \$1,250,000 (2003 valuation) which she put into a personal trust fund for her and her son Rob Meador. Former board member of that charity [AJ White](#) describes the theft of \$80,000 from that charity by Devra West and the conversation she had with Devra West about the charity's finances during which Devra West stated that all the money belonged to her!

26. At the same time, Devra West stole \$4,000,000 (2002 valuation) of artwork and valuables and hid them in a lock-up until the statute of limitations on theft passed, at which time in 2014, these items appeared at auction in Cave Creek AZ and as for sale from her website. In a statement given under oath (she is a compulsive liar) while being [deposed in October 2009](#) Devra West stated that the art work and valuables on a list shown to her by the lawyer did not exist, were not hers and if they did exist were stolen.

These are the very items that were being auctioned by her in 2014 or as for sale from her website; many of these stolen items they are still being advertised for sale as the 'Rishi Collection' from her website under the ['art gallery'](#) tab. Who says organized crime does not pay.

27. On November 23, 2003, Devra West's charity 'The Circle of Divine Unity' was struck off the Montana charity register after rampant fraud was discovered by Devra and Jack West who were found to be using public money given as donations for certain projects being used to fund their lifestyle costs including the purchase of jewelry by Devra West.

28. In March of 2003, Devra West asked for and was given an opportunity to meet with the whistleblower in private at his property in Victor MT. Notionally the meeting was to see if they could settle their differences without going to law; fearing some kind of trick or stunt by Devra West the whistleblower made an audio recording of their encounter which turned out to be nothing more than Devra West threatening him if he went to law. 29. In 2002, while attending a function held in Montreal by Devra West, student [Beatrice McGuire](#) was viciously assaulted by Devra West to the extent that she needed plastic surgery to repair a torn ear. The reason for the attack was that Beatrice challenged some of the obvious lies being spouted by Devra West. Although the attack took place in front of scores of witnesses, Devra West later stated that her recollection of the incident was different to that of the victim's. None the less, Devra West had her charity pay the medical costs of repairing Beatrice's ear.

30. In 2000, employee [Susannah Felder](#) was viciously attacked by Devra West with the result that Susannah was partially scalped by Devra West. Apparently Susannah had challenged Devra West about an \$80,000 donation that Devra West had stolen from the charity to pay for her son's legal fees. Ex-board member, AJ White's statement deals with this, the theft of the \$80,000 and the assertion that all of the money raised publicly was for Devra West's personal use and not for the stated intentions given when the funds were raised.
