

Subject: Rishi Devra aka Devra Patton West – This Woman is Dangerous, Avoid at All Costs!

Dear FBI and Local Law Enforcement. What follows is a further chapter about the Occult Thief / Suspected Serial Killer Devra Patton West who has used her knowledge of the occult to facilitate a crime spree that has lasted at least 25 years. Mention of the word 'occult' immediately brings to mind crackpots, a fact that Ms. West has relied upon during her many appearances in court. However, if we were living on a different part of the planet, say South America or Africa, no one would doubt that this could happen. If we were living in the West a century or more ago, no one would doubt that this could happen. In fact, so fearful were people of occultists like Devra West that they put them to death by drowning or burning.

While Devra West's use of the occult may be a matter of contention with yourselves, it is not with her many victims including the whistleblower, who I have known for more than forty years. Let me make this perfectly clear, we are talking about an ex-marine, a helicopter pilot and a management consultant – not someone given to flights of fancy; so when he says this is happening and it is corroborated by other victims that he has never met, I believe him. If you are still skeptical of Devra West's modus operandi, then perhaps take a close look at some of her crimes which I can assure you are very modern in nature.

Theft, Fraud, Extortion, Money Laundering, Violent Assaults, Threat of Murder, Attempted Murder (of the whistleblower) and Suspected Murder of Lisa Swidler, a witness to two serious crimes. Then there is the fraudulent application for \$30,000,000 in CPEA grant money. This application in some way indirectly linked to International Financial Crimes / Money Laundering through an associate linked to a well-known international criminal known as the 'General' based in Hong Kong; review this [court document](#) for details. While Devra West may have appeared in the above document as a 'victim' there may be more to this than meets the eye. One thing for sure is that immediately after this fraud occurred Devra West in turn defrauded Cole, Hendrickson, Kushner and Cantwell [all members of her cult] out of nearly \$2,000,000.

What follows below is yet more examples of Devra West's domestic crimes and how she uses stooges like Geoffrey Reynolds CPA and Julio Williams to both market her to the public as something she is not and then use the same stooges to cover up her lies / crimes. What separates Devra West from the 'General' is merely a matter of scale. What follows is this week's bulletin on Devra Patton West and the senior members of her cult.

Here is this week's email.

Rishi Devra, AKA dangerous psychopath, Devra Patton West seen below here, has an occult weapon (occult means hidden from view) which she has used to facilitate crime on an industrial scale over the past 25 years or so. Because the weapon she uses is not recognized by legal statute as a 'weapon', she has been able to literally get away with murder.

In a nutshell, Devra West has a 'license to kill' which I suspect she uses on a regular basis.

Most of the crime is financial in nature (theft, fraud and extortion) and involves the transfer of wealth away from scores of victims to her. Devra West may be evil personified, and perhaps criminally insane, but she is not stupid. She has created a cult around her 'abilities' projecting herself into the community into which she is embedded (like a parasite) as an Ascended Master. Her website, full of lies, deceit and propaganda, is designed to attract 'spiritual seekers' like moths to a flame, and often with the same result!

Her pitch to the public is that she is an awakened Master, who at age seven received the call to **'world service.'** Devra West is to **'world service'** what Hitler and Pol Pot were to world peace!

Rishi Devra's path of awakening has moved from an enriched epic of life experience that has encircled the globe. Regarded as a 'Lotus Born Soul' by gurus, yogis and elders, she retained her sense of divine presence from birth and even as a toddler was cognizant of incarnating into a physical body with a higher destiny to fulfill. The senior members of her cult, also aware of her ability to cause pain, suffering, injury and even death (and not be prosecuted for it) are used by Devra West to both 'market' her to the public as a do-gooding guru and to provide her with false witness statements when victims go to the police or law courts for restitution.

Victims who mention to the police, law courts or media that they are subject to a campaign of 'under the radar' violence, (and there have been many) are met with skepticism or disbelief, which is something that Devra West relies upon. For this reason most victims choose to walk away empty handed, understanding that the authorities, even if they did believe their stories, are ill equipped to mount a criminal case against Devra West who, though linked to all the victims, has 'plausible deniability.'

Like all psychopaths, Devra West is a compulsive liar. In fact, it would be accurate to say that when her lips are moving she is probably telling lies! To see just how big a liar Devra West is, let's review the answers she gave under oath to two questions she was asked while giving 'evidence' on behalf of her wife beating, porn loving son, Chris Haywood, at a custody hearing in court on July 12, 2007. First Question - Did you assault Dr. Pat Cole MD?

Devra West's response was, and I quote from page 29, Line 16 of the transcript, "Absolutely not. No way, no how - - absolutely not."

On April 17, 2006, just a day or two after committing the assault, which resulted in the police being called and Devra West being charged and subsequently convicted of the assault against Dr. Cole, the Master Liar then calling herself the Ascended Master Surya Ma, pretended to 'channel' a message from a long dead fellow Ascended Master 'El Morya.' This missive, entitled '[The Law of Severity on the Path to Purification](#)' was sent to every member of her cult mailing list and sought to justify the assault by, amongst other things, asserting that the victim was a Nazi in the WWII death camps in another lifetime! Yes, you cannot make this stuff up.

But before we review 'The Law of Severity on the Path to Purification' let us put the assault on Dr. Cole MD into context with what was happening to Devra West at the time. Here are just a few of the events that happened to Devra West in the 2003 to 2005 time period.

- (1). Her charity was struck off for fraud in November 2003 – see '[Revocation Certificate.](#)'
- (2). She stole a property worth \$1,250,000 (as valued in 2002) from the charity that was paid for by public donations. This was later sold at a Sheriff's Sale to pay her creditors the \$2,000,000 she owed.
- (3). She stole \$4,000,000 (as valued in 2002) worth of artwork and valuables from the charity, also paid for by public donations. These assets were hidden until the statute of limitations for theft passed.
- (4). Devra West owed her creditors \$2,000,000 in court fines and interest which, as mentioned above, would become the subject of a [Sheriff's Sale](#) in 2008. The only place she could get this money from was by thieving it, defrauding it and by extorting it from the members of her cult which is what her 'business model' is all about – converting people into cash.



- (5). In 2005, Devra West extorted \$30,000 from student / cult member Dave Kushner.

(6). In 2005, Devra West kidnapped, falsely imprisoned, beat and extorted tens of thousands of dollars from student / cult member, Marion Cantwell. After Marion handed over part of the proceeds from the sale of her home, she was told by Devra West that she would be murdered if she went to the police.
(7) In 2005, Devra West defrauded student / cult member Mike Hendrickson out of \$200,000.

But all of this was small beer. And after the fraudulent application by Devra West and Geoffrey Reynolds for \$30,000,000 in CPEA grant money failed, she needed some real money desperately and to get it she targeted Dr. Pat Cole MD a student / cult member / business partner, an alleged heiress of the Whirlpool family. After a campaign of vicious assaults by Devra West Dr. Cole MD gave up her entire net worth estimated at \$1.3 million at a cost to Devra West of a \$500 fine and a 6 month suspended jail sentence for misdemeanor assault!

In the outside world. The assault on Dr. Cole and other crimes being committed at the time by Devra West, became the subject of two news articles published in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers in July and August 2007 respectively. What was not mentioned in the news articles, was the fact that Devra West had successfully extorted \$1.3 million from Dr. Cole and that Devra West was overheard by one of her employees Carlida Finch planning Dr. Cole's murder.

Inside the cult. What Devra West's students and employees are allowed to think is strictly managed by Devra West; so inside the cult, the narrative was quite different! In order to counter gossip (and the truth), from those present when Devra West repeatedly hit Dr. Cole over the head with the heel of her shoe, causing blood from the wound to run down her face onto her blouse, Devra West issued a statement to the rank and file of her cult.

Below is the first page of '**The Law of Severity on the Path to Purification**' which was Devra West's attempt at justifying the assault on Dr. Pat Cole MD. I have added numbers to the paragraphs to tie into my comments which I will list below the piece, but suffice to say, that this missive is from the mind of a deeply disturbed psychopathic person personality who should be locked up in a mental institution with the key thrown away.

The Law of Severity on the Path of Purification

Response to the Call of Master Surya Devi for Review

1.

April 17, 2006 From Master El Morya of the Shamballa Counsels

Dear Ones,

2. We offer our compassion during this dark night of the soul passage that sets the stage for the possibility of group formation around the Master Teacher Surya Devi, or in contrary and in inadequate measure fails to meet the requirements than can allow this most essential embodiment to transpire. This advent is given our full illumination and direction of wisdom and is a major aspiration to which all who seek liberation are advised to serve.

3. We are called today to deliver our determination on the altercation that has taken place that is the cause of both pain and concern and to make clear to you the higher laws that are brought into effect as we have come together to review and consider the matter. We have gathered in response to Surya Ma's request for an overview that the record be set straight in the case of the challenges that disciples often make in their refusal of the Law of Severity as a necessary and governing element within the greater influences and causal factors of creation. In all instances of our considerations, we are regulated by the Christ Universal and therefore our overview represents this wisdom as well.

4. What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

5. At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul and has offered her flesh to our purposes and to the purposes of the Christ, as a form of testament to the existence of the higher realities, should that be required to achieve the planetary transition that is underway and to which she is assigned. Her generosity to Dr. Cole has been boundless, for which Dr. Cole has given little due and therefore remains wanting in her own accounting of right and reciprocal relationship, not only with The Master Teacher Surya Ma but with humanity as a whole

And part of the second page.....

Dr. Cole has made minimal sacrifices during her intensive engagement with Surya Ma despite her belief to the contrary and has been problematic at every turn in her willingness to risk all, in the saving of her vices of pride and jealousy. The lack of vigilance and the indulgence in neglect has also been resultant of a substandard effort befitting a disciple that is being made privy to the inner workings of an executor of the Divine Plan. We therefore do not look favorably on the circumstance that has surrounded Surya Ma, through no fault of her own. The circumstances have been untenable for some time and it is this that we seek to aright. The force with which Surya Ma has sought to bring Dr. Cole into realization of the pain which she has so consistently caused members of the human family is in right reflection and is solely designed to spare Dr. Cole of the otherwise karmic cycles due her that would occupy some twenty to thirty years of her earthly time to bring into balance.

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

My comments to the listed paragraphs are as follows:-

(1). West asserts that the long dead Ascended Master, El Morya, is responding to the call of another Ascended Master i.e. Master Surya Devi. She also asserts that this dead ascended Master is going to review her actions in the matter of the conflagration with Dr. Cole MD.

(2), (3), (4) & (6). Self-aggrandizing and delusional remarks from a criminally insane mind, seeking to justify their authority and right to rule and administer 'justice' over Dr. Cole MD (everyone else)

(5). At no time while beating the crap out of Dr. Cole MD was Surya Ma's intentions rooted in anything but the highest of grace, despite the severity that was meted. No mention of the planned extortion of \$1.3 million from Dr. Cole MD?

(7). Dr. Cole is long overdue in the sound arighting of her soul with its creator. Says raving lunatic Devra West, posing as an Ascended Master while channeling a message from some more long dead Ascended Masters.

So, dangerous psychopath Devra Patton West admitted in writing that she had assaulted Dr. Cole MD, but in so doing, seeks to justify the assault by asserting that Dr. Cole MD was a Nazi in the WWII death

camps in another lifetime and that the beating she Devra West, Surya Ma gave her, was not only justified but - long overdue!

Second Question - Are you running a cult?

Devra West's response was, and I quote from page 12, Line 16 of the transcript, "I think it is utterly far-fetched and I'm – I am really sorry and embarrassed that such an allegation would even be conceived."

Devra West gave her response in court on July 12, 2007. However, beginning in March of that same year, the whistleblower started to receive a series of harrowing emails from Rebecca West (no relation) who at the time was office manager for Devra West. It is clear from what Rebecca West is saying, that Devra West was running a cult. It is also clear that this dangerous psychopath, believing that she is totally beyond the law, uses fear, the threat of violence (both overt and covert) and murder as a weapon to get what she wants from those corralled inside her cult.

Here is one of Rebecca's first emails to the whistleblower; this one sent on March 7, 2007 and entitled 'Help Me'. The others can be read by going [here](#). This, sent just four months before the Occult Thief / Suspected Serial Killer Devra West, denied running a cult in court while giving evidence under oath. The comments in square bracket are mine.

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I

incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

[Devra West had a revolving door policy towards employees in 2002, when the whistleblower was hired as a consultant. Put simply, she would advertise non-existent jobs knowing that 90% of the employees she hired would refuse to 'surrender' to the will of the Master Teacher and join her cult and, as a consequence, would be fired before the 90 days were up after which she would have to pay employment insurance. One of those employees, and a contemporary of Rebecca West's in 2007, Carlida Finch, gave evidence to the authorities that she was given the option of joining Devra West's cult or be fired. Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

As you can see from the above, **killing people** plays an important part in this enlightened being's 'world service' efforts]. Back to Rebecca's email....

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! I have been hiding in my home for many days now, afraid to go anywhere. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass!", what are you so afraid of?" This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass!

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

[Shamanic witchcraft is the occult weapon that Devra West uses against her victims. She relies upon the fact that because it is not recognized by 'legal statute' as a weapon, she can a) commit serious crime including murder with impunity and b) elevate herself to the Godhead.]

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available. Again the crux is finding a law firm that is willing to take the case without a hourly payment of services. With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her.

I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds CPA] is out of money), is [senior cult member] Dr. Julio Williams and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

[The artwork and valuables stolen from the Victor MT charity were hidden in a lock up until the statute of limitations for theft passed – these items reappeared in Cave Creek in 2014 at auction and for sale from her website.]

Tanmayo's (coca-cola heiress) son contacted the finance controller [Geoffrey Reynolds CPA] yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.

You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles from her! I am more than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated.

I know that unless the \$30M comes in this week, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

[The \$30 million was the fraudulent application by Devra West and Geoffrey Reynolds of CPEA grant money.]

*I just spoke with the finance controller [Geoffrey Reynolds CPA] this morning, and he is telling me that unless I talk to Devra today, **I can forget about the monies owed me.** I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that **several other people have taken her to the labor board** and I would be no different. I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter. It is obvious that she is afraid of me or she would have fired me already! I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.*

***Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it!** Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims, including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit and corruption of innocent people. Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).*

***I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us.** If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil.*

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid upfront. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

*If you align with **Hendrickson's Attorney** instead, would he be willing to help us? I have the ability to bring to you **30+ former employees and with your 40 former students/employees statements** maybe we can stop her! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people!*

But there is much, much more. Note that the email which was sent by Rebecca, was on 7 March 2007.

Some four months later, on the 12 July 2007, the [Whitefish Pilot](#) newspaper published a story about Devra West's criminality; the main feature of which was the assault by Devra West upon Dr. Cole MD.
