


# Rishi Devra AKA Con Artist Devra Patton West – Menu of Services Offered and Method of Payment

Prior to 1990, Debbie West and her husband, Jack West, were just your average con artists defrauding individuals [Jeremy Samuelson](#) out of \$10,000 and [Satya](#) out of \$6,000. However, after Debbie's jewelry business went into bankruptcy, she decided that a career change was in order, so Debbie decided to become an Ascended Master! While attending the 'Robert Jaffe School for Energy Mastery' (itself a cult) between 1990 & 1991 Debbie acquired the occult (occult means hidden) knowledge she needed not just to change her life but the lives of scores of victims that she has preyed upon since then.

Satya was a fellow student of Debbie West's at the 'Robert Jaffe School of Energy Mastery' and, in addition to being conned out of \$6,000 by Debbie while on the course, described Debbie as being a

deeply disturbed psychopathic person / personality. Let's now look at how Debbie used the occult knowledge that she learned while attending that course to defraud and extort millions of dollars from those she has preyed upon over the past 26 years since declaring herself to be an Ascended Master!

First, let's read what Debbie had to say about herself when interviewed by the [Whitefish Pilot](#) newspaper in July of 2007 after she viciously assaulted her business partner, while in the process of extorting \$1.3 million from her – which to Debbie's credit, she totally succeeded in doing at a cost of a 6 month suspended jail sentence and a \$500 fine. Who says crime does not pay? Here in Debbie's own words:-

**West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.**

## SACRED KNOWLEDGE

Now let's hear what her victim, Dr. Pat Cole, had to say to the newspaper:-

**Cole was the director for one of West's ventures, The Sacred Archives Institute. They worked together for several years. In her statement to the county sheriff's office, Cole claims West abused her verbally and physically. "She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement.**

**Cole claims Ms. West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." 

To come to the point, Debbie West attended the Robert Jaffe School for Energy Mastery between 1990 & 1991 where she acquired secret knowledge which enabled her to move from defrauding and extorting tens of thousands of dollars from individual victims to defrauding and extorting hundreds of thousands of dollars from individual victims which she has done on countless occasions since then. She admitted

to the Whitefish Pilot reporter that she has the knowledge and one of her employees, a witness to one of her crimes, attests that she is the victim of 'shamanic' attacks!

Not only has Debbie acquired the knowledge which enables her to induce pain, suffering, illness and injury where none existed before her intervention, Debbie also acquired the means to intimidate victims and witnesses into remaining silent about the crimes and where necessary, murder them to keep them quiet! For example, after causing two newspaper articles to appear about her criminal past and her then, current crime wave in Montana, the whistleblower became the subject of a murder plot. You see, the giant fraud multi-million dollar a year scam can only work if the public remain ignorant of what and who Debbie West really is, and Debbie is quite open and frank about the lies, deceit, propaganda, fake life journey and fake testimonials on her website.

Debbie West is an occult thief and a suspected serial killer. Of course the 'serial killer' charge maybe hard to prove because as Debbie West knows all too well (as do her victims that go to the police) the weapon being used is not regarded as a weapon by legal statute so Debbie cannot be prosecuted however many of her victims suddenly die of "natural causes." Geoffrey Reynolds CPA (a senior member of Debbie's cult) was so certain that she would get away with the murder that while being interviewed by the [Bigfork Eagle](#) newspaper he actually confided to the reporter, in what he thought was an 'off the record' chat, that the whistleblower would be dead within 12 months or in jail for reacting to what she was going to do to him and his family!

Similarly, a student of Debbie West's, Lisa Swidler, suddenly and mysteriously died after she witnessed Debbie defrauding another student, Dave Kushner, out of \$30,000 and the kidnapping and extorting tens of thousands of dollars out of a third student, Marion Cantwell.

**Here is how the con works!**

Having attended a 'private' session, intensive or audience; the targeted victim (normally a wealthy female) is told one of the following:-

- 1. She has a non-existent Brain Tumor or a non-existent cancer which Debbie can cure for a large fee.**
- 2. That Debbie and the target were sisters in another lifetime and that during that lifetime the target (normally a wealthy female) betrayed Debbie and that the Ascended Masters have brought the two of them together so that the 'target' can make financial reparations and clear her bad karma.**

Of course even with Debbie's Oscar winning performance, not every victim is convinced straight away; which is where the occult skills that Debbie acquired 26 years ago come into play. This hidden occult knowledge is what sets Debbie apart from all the amateur medium / psychic con artists. Debbie would have told target (1.) that they could start to expect feeling symptoms of the non-existent tumor or cancer in the near future and sure enough, if they do not pay up, that is exactly what happens. Whether Debbie sends them migraine headaches, heart palpitations or symptoms mimicking partial paralysis, they quickly become believers and pay up –very shortly afterwards, the totally nonexistent ailment disappears!


Similarly in example (2.) Debbie would have told the target that the Ascended Masters will send them proof that her story about being betrayed in a past life is true and that as evidence that this is so, if the target does not pay up and take the opportunity to erase their non-existent bad karma, they will end up on the receiving end of a campaign of worsening health conditions (as above in example 1) until they pay up!

## THE DIVINE EMBRACE

*The Royal Path with Rishi Devra*

Debbie has been doing this for 26 years, so her criminal business model runs like a well-oiled machine. For instance, the occult (hidden) weapon used by her to cause pain and suffering in those she targets is not regarded as a weapon by legal statute, so Debbie is unlikely to be prosecuted either for

conning victims out of millions of dollars or by using her occult weapon to intimidate victims and witnesses into not going to the police. I'd say virtually zero! If one assumes that for someone to acquire enough wealth that they could give away \$500,000, one must presume that the donor has a reasonable IQ and would want to research Debbie's background of course once they learn she is a con artist the chances of that large donation shrink to zero.

But Debbie's 'DONATIONS' page is not just there for donors it is all part of the fraud scam! Once targets have been convinced by Debbie (and the Ascended Masters) that they have a brain tumor, cancer or have wronged her in past lives they simply make a donation via her website and once that donation has been confirmed the targeted individual is immediately cured of their totally non-existent illness and or their past life indiscretions are forgiven. If ever investigated by the FBI Debbie will simply say that the targeted person just made a donation to her 'good causes.' That is what the 'Sustaining Endowments' section is for to facilitate payments between \$100,000 and \$500,000!

Now you understand why Lisa Swidler died suddenly of 'natural causes' and why Debbie tried to murder the whistleblower – a criminal business generating millions of dollars a year is motive enough for murder!

The whistleblower recounts a conversation he had with a couple of Debbie West's employees in 2002, wherein they overheard a telephone conversation Debbie was having with an attendee of a 'private' session. 


