Devra Patton West AKA The Ascended Master 'Rishi Devra' AKA The Ascended Master 'Surya Ma' AKA The Ascended Master 'Devra Ji' - The Occultist Beast Unmasked!



The above image is a composite which represents three fake / delusional / narcissistic identities used by Devra Patton West in Montana, between 1995 and 2010; and more recently in Arizona, from 2011 to present day. Devra West understands that as long as her criminal / racketeering business model is disguised as a quasi-religious entity, she can tell as many lies about herself as she wishes in the knowledge that under 'religious freedom laws' she is unlikely to be prosecuted for mail and wire fraud.

Above left (1) West portraying herself as a Greek Goddess, (2) a staged photo shoot of West posing as a guru with a bunch of dried flowers; clearly an attempt to convey to the public (and her cult) that she adored by others. (3) The truth is that Devra West is a Satanist, an occult thief and quite possibly a serial killer though because the authorities do not regard the weapon she uses to commit murder as a 'weapon' those who die suddenly around her are though 100% dead cannot be said to have been murdered.

(4) A mug shot of Devra West taken for her 2009 arrest warrant for felony theft. (5) Devra West masquerading as the Ascended Master 'Surya Ma' in Montana between 2005 and 2010. (Between 1995 and 2004 she was masquerading as the Ascended Master 'Devra Ji' until, her charity was struck off for fraud causing her to have to change her identity.) (6) Devra West in 2007 claiming to be holding open the gates of time.

Devra West, a small time crook / fraudster / pot grower / bankrupt declared herself to be an Ascended Master after attending the '[Robert Jaffe School for Energy Mastery](#)' between 1990 and 1991. Below is an image of Beatrice McGuire who, after criticizing Devra West at a public venue in Montreal in 2002, had part of her ear ripped off by Devra West in front of the gathering. West later denied the incident but paid for the victim to have plastic surgery!



Of course it did not matter that everything the whistleblower had said about Devra West was true, or that Geoffrey Reynolds' pleadings to the court were a total pack of lies; as his employment with Devra West commenced in September 2006 - some three and a half years after the whistleblower had left West's employ after being defrauded by her. Long story short, Devra West had persuaded / blackmailed Geoffrey Reynolds (who was totally unaware that the whistleblower existed until September 2006) to go before a court and perjure himself by stating that he was defamed by the whistleblower between 2002 and 2006! Devra West warned the whistleblower in a meeting they had in March 2003 that if he took her to court she would get so f**king down and dirty - huge expenses coming out of his pocket but not hers (as cult member Julio Williams was prepared to give \$2,000,000 to fund her legal expenses). However, nothing illustrates the criminal nature of Devra West’s criminal / racketeering business model more than a series of harrowing emails sent by one of her employees Rebecca West (no relation to Devra West) in March of 2007, some three months before the two news articles, mentioned in the bulletin above, were published by the [Whitefish Pilot](#) & [Bigfork Eagle](#) on 12 July 2007 and 9 August 2007 respectively. The information contained in this email below, which we shall break down point by point, leaves little doubt that Devra West is a deeply disturbed psychopathic person / personality who was at the time running a cult hidden inside a quasi-religious organization which was a front for a well-oiled criminal / racketeering business model netting her millions of dollars a year.

Here is that email [the contents of the square brackets are my additions] which should be read alongside the above three bulletins and the material found on the website whose URL is at the bottom of this email.

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. (1) Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. (2) I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. (3) She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant) (4).

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself (5). My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! (6) I have been hiding in my home for many days now, afraid to go anywhere. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass," what are you so afraid of?" (7) This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA] whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children (8), yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass!

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more? (9)

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. (10) Dr. Cole was severely beaten on several occasions and proof is available. (11) Again the crux is finding a law firm willing to take the case without a hourly payment of services.

With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her. (12)

I am aware that the only person still financially supporting Devra (the finance controller is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. (13) Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts (14) and in addition I contemplate how much money/jewels she has stashed (15) in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

Tanmayo's (coca-cola heiress) son contacted the finance controller [Geoffrey Reynolds CPA] yesterday demanding the monies his mother contributed be returned. (16) This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000. (17)

You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles from her! I am more than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated. (18)

I know that unless the \$30M comes in this week, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his

wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. (19) My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month. (20)

I just spoke with the finance controller [Geoffrey Reynolds CPA] this morning, and he is telling me that unless I talk to Devra today, I can forget about the monies owed me. (21) I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that several other people have taken her to the labor board and I would be no different. I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter. (22) It is obvious that she is afraid of me or she would have fired me already! I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.

Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it! (23) Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims, including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit and corruption of innocent people. (24) Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).

I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us. (25) If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil. (26)

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid upfront. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

If you align with Hendrickson's Attorney instead, would he be willing to help us? (27) I have the ability to bring to you 30+ former employees and with your 40 former students/employees statements (28) maybe we can stop her! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people! (29)

Before analyzing the above email, please take a good look at the image below here which clearly sets out graphically what Devra West's business model is all about.



The above photograph was the 'class of 2002.' Many of the above, employees or students in her cult, ended up being victims of theft, fraud, extortion, violent assault and one sudden death of a witness (student Lisa Swidler) to two serious crimes. As one can see from Rebecca West's email dated 7 March 2007 nothing had changed between the time this photograph was taken in June 2002 and March 2007 and why would it Devra West is not a guru she is an occult thief and quite possibly a serial killer to boot.

Let us now analyze Rebecca West's harrowing email.

(1). Devra West had a revolving door policy to employees; she advertised what appeared to be attractive positions, promised them healthcare, enticed them from all over the US to move to Montana to non-existent jobs. When they arrived many were told there was a misunderstanding about wages and they were given the choice of accepting a 20% pay cut or returning home. In the first three months of their tenure they were brainwashed and conditioned into surrendering to the will of the Master Teacher or be fired before the 90 days were up after which she would have to pay employment insurance. Her is a statement made to the labor board by one employee, [Carlida Finch](#), who resigned rather than be forced to join Devra west's cult as a low paid / no paid slave.

(2) & (3). Yes this was common place Devra West literally funded her lifestyle by forcing her employees to pay her bills. This, on top of emptying her corporation's bank account to fund her lavish lifestyle. Below are some excerpts from employees who worked for Devra West in the 2002 to 2003 timeframe when the whistleblower was present as a consultant (he never got paid after 6 months work). (4) It is illegal for Devra West to demote someone and reduce pay. However since Devra West was running her own cult local, state and federal laws did not apply. Devra West ruled by fear, as both employees and students alike knew that if they went to the police or law courts for restitution, they would not be believed. They would not be believed because 'officialdom' refuses to accept that the occult exists. They would not be believed because Devra West would counter the victim's claims of mental and physical abuse by sending senior members of her cult to be false witnesses at any hearings. In the case of the whistleblower, Devra West forced several of her employees to 'manufacture' false witness statements on pain of being fired if they refused. One such false witness forced by West to fabricate a statement [wrote to the whistleblower's lawyer](#) recanting her statement after leaving the cult.

(5) As stated above Devra West believes herself to be totally above the law and behaves as though she is a medieval baron who holds the lives of her peasants (cult members) in her hands. After all Devra West realized decades ago that she can use her occult weapon with impunity to commit all sorts of crimes from theft to murder.

(6) A letter of 'No Contact' is useless against an Occult Master who can terrorize, injure and kill you wherever you are on the planet. It was made clear in the [Whitefish Pilot](#) newspaper article published in July 2007 that Dr. Cole MD had a restraining order against Devra West:-

A temporary restraining order against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection.

However, as pointed out above, of what use is this against someone who can terrorize you at a distance cause illness, injury and death? These abilities and the occult knowledge that make them possible for Devra West to prey on her fellow citizens are the basis upon which she claims to be a god!



(7). Devra West, her husband Jack West and their young daughter Anna West were allegedly chased out of New Mexico in the middle of the night by a gun wielding victim who decided to take the law into his own hands. I am not advocating anyone takes the law in to their own hands but short of doing so it is very difficult to get justice as Devra West hides behind a gated community, and can target victims and witnesses relentlessly over the years it takes to get her into court. Long story short, the weapon she uses is not regarded as a weapon by legal statute, which leaves her to intimidate and even murder those who oppose her.

(8). It is likely that Geoffrey Reynolds was manipulated into loaning Devra West his life savings of \$300,000 shortly after commencing his employment with Devra West in September 2006. Just like with the whistleblower and Mike Hendrickson before him and others, since Devra West views every consultant / employee as a potential victim and Reynolds was no different. Once he had handed over his life savings to Devra West Geoffrey Reynolds CPA was on the hook and agreed to do anything he was asked of by Devra West including being complicit in the plot to murder the whistleblower. And when that failed, Reynolds joined with and took the lead in a criminal conspiracy to bankrupt the whistleblower. These actions were against a total stranger who he did not know existed until after he commenced his employment in September 2006. Below is an excerpt from another email sent to the whistleblower by Rebecca West, which clearly shows that Reynolds is under the total control of Devra West. To view these emails [go here](#).



Rishi Devra has been guiding my life for many years. I am honored that she allows me to help her global awakening move forward.
Geoffrey Reynolds CPA 2014

He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the forth time

yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job.

Devra dangles the carrot and since he has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.

(9). Rebecca West asks for help with Devra West's "Shamanic Witchcraft." There is no point in Devra West denying that she uses Shamanism and the occult against victims and witnesses of financial crimes. As we have seen in previous bulletins she has used the occult to target her daughter in law's wanting to divorce her porn loving / wife beating son and she has used it against the whistleblower for the past 11 years and doubtless scores of others. However no better confirmation can come from none other than the occult thief herself who, during an interview with the [Whitefish Pilot](#) newspaper made the following statements:-

West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

Note 'ego masturbation' in the last line of her statement, "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby."

(10). These statements by ex-employees and ex-students who attest being mentally and physically abused by Devra West are posted on the [documents](#) and [audio statement](#) sections of our website.

(11). Yes, Dr. Cole MD was severely beaten by Devra West, of that there is now doubt; not least because Devra West admitted the beating in a letter she wrote to her cult mailing list on April 2006, just days after the police arrived and charged Devra West with assault. In the letter entitled, '[The Law of Severity on the Path to Purification](#)' Devra West, pretending to channel a long dead Ascended Master by the name of El Morya, states the following:-

1. That the victim was a Nazi in the WWII death camps in another lifetime therefore the beatings were both justified and long overdue.
2. That though the beatings were severe they were administered with grace by Surya Ma AKA Devra West.

I cannot emphasize here just how dangerous this women is and how it is quite likely that this deeply disturbed psychopathic / person personality maybe a serial killer.

Of course the truth is bad for business, so once a copy of the above missive found its way on to the whistleblower's website in 2007 and once the assault went public when the Whitefish Pilot published its story, Devra West started denying that she had assaulted Dr. Cole MD. While at the same time employing stooge Geoffrey Reynolds to try to force a copy off the whistleblower's website by claiming copyright of the letter. It also beggars belief that liar for hire Geoffrey Reynolds would, while claiming copyright of her admission of guilt, issue four statements of denial himself on Devra West's website when the story went public in July of 2007.

Below are the four statements of denial that Geoffrey Reynolds published from Devra West's website in July of 2007 while claiming copyright of her admission of guilt.

Here are a few of Julio Williams' outstanding contributions to his occult master's criminal / racketeering business model.

1. In 2005, Williams, along with two other cult members were co-opted into [publishing a statement](#) on West's website designed both defame and to vilify the whistleblower because he had decided to sue Devra West for fraud.
2. In 2007, when it looked like the whistleblower's website was gaining traction Williams sent a [threatening email](#) to the whistleblower designed to intimidate the whistleblower into withdrawing his website. Below here is a short excerpt from that email.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down.

Mr Watson, You will have your date in court. You fuck with me and you will meet your match.

3. When the Whitefish Pilot newspaper article appeared in July of 2007, Julio Williams, like Geoffrey Reynolds and Jack West, all senior members of West's cult, also published two statements of denial on Devra West's website even though he knew full well she was guilty and had received her written admission of guilt over a year earlier.

4. Julio Williams is well aware that Devra West is a Satanist and an Occult Master, who uses her knowledge of the occult to prey on others. However, Williams grew up in the Dominican Republic, where voodoo was one of the religions so using black magic against others will seem quite normal to someone like Julio Williams. He is aware of Devra West's two arrest warrants, one in 2008 for criminal check fraud and one in 2009 for felony theft. He is aware of her conviction for assault against a fellow physician Dr. Cole MD. He is aware that Devra West was the subject of a Sheriff's Sale to force her to pay her creditors \$2,000,000 in court fines and interest. He is aware of her multiple appearances in Montana court houses as the defendant in frauds related lawsuits.

However, having no volition of his own, Julio Williams can only do as he is told which explains why in 2007 he posted a gushing testimonial for Devra West on her website; below is a short excerpt from that statement.

5. And then when Devra West's 'divine being' bullshit was seen for what was in Montana, forcing her to leave for new hunting grounds, Julio Williams MD was there selling his cult leader as a 'divine being' to a brand new set of potential victims in Carefree AZ. [Here is a link](#) to a 2014 posting on her website asking for donations for the 'Divine Feminine' even though he knows Devra West has a long history of violence towards other women.
6. Below is a posting in 2017 showing that Williams actually rented a property close to Devra West's bullshit 'Abode of the Master's' in order to host a venue for new potential victims of Devra West's latest fraud scam i.e. 'Divine Grace Healings' selling at \$500,000 a go!


(14) & (15). Yes, it is well known that Devra West converts the proceeds of organized crime / racketeering into jewels and precious metals. Here are some statements that seem to indicate this to be true.

1. [Statement from ex-student Elaine](#). Here is an excerpt:-

While Devra is obviously a pathological liar, she unwittingly reveals herself quite frequently because she can't keep her own mouth shut and so loves to brag. This was more than five years ago -- in the course of bragging about her ability to attract wealth, she explicitly stated she doesn't have any bank accounts because she didn't need them in order to be wealthy. She then pointed out that at that very moment she was wearing \$250,000 worth of emeralds. And she implied she had a lot more than what she was wearing

2. As for 'her' artwork and artifacts these went missing sometime after her charity was [struck off](#) for fraud in November 2003. We know that the property owned by the charity and paid for largely by public donations and valued at \$1,250,000 in 2003, was stolen from the charity as part of an elaborate fraud and put into a trust fund by Devra West for her and her eldest son Rob Meador. We know now that artwork and valuables valued at \$4,000,000 in 2003, and largely paid for by public donation, were hidden away in a lock up until after the statute of limitations had passed and reappeared in 2014 for sale both from Devra West's website and at auction in Cave Creek AZ.

When questioned about these items in 2009, while being deposed under oath by the whistleblower's lawyer, Devra West acknowledged seeing [the list of valuables and artwork](#) that, the whistle-blower had compiled in 2002, but stated that she had walked away from all possessions and that these items must have been stolen or lost. 
(16). Once Devra West gets her claws into a victim, she continues to bleed them until there is nothing left. In the case of Tanmayo (Corinne Coffin) a Brazilian national, Devra West has been bleeding this one dry for decades with 'donations' perhaps amounting to tens of millions of dollars. No wonder Ms. Coffin's son was demanding the money back.

(17). Reynolds would be used by Devra West to money launder the funds stolen / extorted from Dr. Cole MD after his predecessor resigns rather than be forced to 'manufacture' false invoices. No problems of conscience for Reynolds who stood to lose \$300,000 if he did not carry out West's instructions. Reynolds, not the brightest bulb on the Christmas tree, more or less admits that he money laundered \$463,750 from Dr. Cole when being interviewed by the [Bigfork Eagle](#) newspaper on August 9 2007. Here is part of his statement to the reporter Constance See:-

"Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843."

Note the extortionate (pun intended) fees charged by occult thief / suspected serial killer Devra Patton West just as mentioned in the above referred to video about fake gurus!

On the subject of serial killers Geoffrey Reynolds CPA, no doubt desperate to earn his \$300,000 life savings back, told the [Bigfork Eagle](#) reporter in what he thought was an 'off the record comment' that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him.



Geoffrey Reynolds CPA is now working for [McSwain & Co.](#) a firm of accountants based in Olympia Washington – I am sure his criminal / racketeering skills were not declared to his new employer when he was hired! For his actions on behalf of Devra West, Geoffrey Reynolds has earned the title of 'scum.'

Scum (adj.) *Possibly the worst word you can have your name associated with. It is hard to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life.*

"Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often just referred to as genitalia.

(18). Any employees who take Devra West to the labor board for unfair working practices or claiming that they are working in a hostile working environment, are met with a wall of lies from the remaining cult members. This was the case with Carlida Finch who during the same time period took her claim to the labor board. Below are her three statements to the labor board:-

(19) As reported earlier, Devra West was fined \$500 and given a 6 month suspended jail sentence for the assault but she was not prosecuted for extorting Dr. Cole's entire net worth amounting to \$1.3 million and which included forcing her out of her home so that Devra West and her son could move into it!

(20) All too late, Rebecca West realized that her role was to fund Devra West's lifestyle not her own. The role of cattle is to enrich the farmer not themselves! However Rebecca West is one of scores of victims of theft, fraud and extortion at the hands of Devra West these victims include, for example, the whistleblower (several hundred thousand dollars), student [Mike Hendrickson](#) (\$200,000), student Dave Kushner (\$30,000), and student Marion Cantwell (tens of thousands of dollars) with countless other private victims. Then there are state and federal agencies such as the Montana charities and the IRS who have doubtless been defrauded out of tens of millions of dollars in assets that should have gone to other charities or in unpaid taxes.

(21) & (22) Again there are no laws that apply inside Devra West's cult; no due process she does as she pleases so threatening not to pay Rebecca West wages is nothing new.

(23) Rebecca West acknowledging that she might lose her life if she stands up against Devra West's tyrannical rule. Rebecca knows that Devra West uses murder as a tool and that her murders are ruled as 'death by natural causes' because the dumb authorities do not acknowledge the occult as a weapon. Though by now there should be more than enough evidence to lock Devra West away based on intent to cause harm to 30, 40, Or 100 past victims!

(24) Rebecca and Dr. Cole realize that there are many more victims (see the bottom of this email) and that they have a duty to come forward and stop Devra West's tyranny.

(25) There is little doubt that the application for \$30,000,000 in CPEA grants was fraudulently applied for by West & Reynolds. Here are some omissions they forgot to mention when applying for these grants:-

1. West's relationship to the organization applying for the grants; i.e. it was not a normal corporation, there were no boards of directors in a real sense as the whole operation was run by West as a cult leader / dictator with none of the other officers of the company having any discretion in decision the making process.
2. West probably failed to declare that Devra West was at least \$2,000,000 in debt and intended to use part of the grants to pay off her debts. This is evidenced by Rebecca's comments and also by Devra West's stepmother Carol Patton whom West owed \$30,000 to. Below here is a short excerpt from [Carol Patton's email](#) to the whistleblower's lawyer asking if his lawyer could recover the \$30,000 from Devra West for her!

"I would like to know why Devra West if she had so much money and so much jewelry and so many artworks and artifacts found it necessary to con her father out of \$30,000 supposedly to buy land. She told us she would be receiving \$33,000,000 (yes million) from an investment that was supposed to come through and she would return the money to us. Because of her I cannot pay off my house."

It seems that no-one is safe from the occult predator.

(26) Yes the Ascended Masters are Devra West's 'get out of jail free card' which she uses to explain away acts of violence ([The Law of Severity on the Path to Purification](#)) or to extol the cult members to fund raise ([Financial Form Building](#)). My favorite sentence in the latter is "do not hesitate to fill your financial coffers." Both these missives allegedly channeled by long dead Ascended Master El Morya.

(27) Unfortunately Mike Hendrickson, like many victims in the cult, feared that if he went to law he too would become the victim of dirty tricks, occult attacks and maybe murder so like 95% of victims he walked away from the \$200,000 Devra West had defrauded him out of.

(28) Rebecca West refers to the 30 plus victims she can bring forth which added to the 40 or so from the whistleblower's time around 2002 makes a total of 70 or so victims of theft, fraud, extortion and mental and physical abuse. The murder of Lisa Swidler and the attempted murder of the whistleblower are harder to prove but after investigators have interviewed many of the victims may end up being believed.

(29) Yes, as is clear from Geoffrey Reynolds's willingness to be complicit in a murder plot to kill a total stranger, and when that failed, be a party to a criminal conspiracy to bankrupt him not to mention money laundering the proceeds of crime it is clear that Devra West is also a Master Manipulator. This ability apparently goes back to the 1970's & 1980's as witness Jeremy Samuelson asserts in his email to the whistleblower in 2007 wherein he refers to Devra West 'overwhelming his land partner Jack West whom she was seen to be 'running.' 
It is clear that Devra West is not a Guru. It is clear that the senior members of her cult AKA [Geoffrey Reynolds](#), [Julio Williams](#) MD and [Jack West](#) are willing accomplices in a multi-million dollar a year criminal / racketeering business model.


to members of her admin staff talk about overhearing a phone conversation which Devra West claims to have just earned \$500,000!


1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
