

Subject: Master Liar and Narcissist Devra Patton West AKA 'Rishi Devra' claims to be senior to Jesus and the other Ascended Masters.

*West, who has since changed her name and location, the third time for both in 15 years, is currently operating in Arizona offering 'Divine Grace Healings' to those who can afford \$500,000. She claims to be the 'Regent of the Spiritual Hierarchy for the Western Hemisphere.' One ex-employee referred to her as a dangerous psychopath and another a narcissist asshole with no soul.*



While we wait for the authorities to question the 'Rishi of the West,' the 'Regent of the Spiritual Hierarchy of the Western Hemisphere' about:-

**1. The murder** of Lisa Swidler, a member of her Montana cult and witness to two serious crimes.

The above image is just the header from her latest blasphemous propaganda piece. If you follow the link above the image you will be able to review the piece in its entirety. Devra West is a narcissist occult suspected serial killer who, surrounded by weak 'yes men' and having drank her own 'Kool Aid' for the past 27 years, lives out her delusions / psychosis with no check and balances from authorities who are ill equipped to deal with someone this evil. Here are some of the choice phrases in this idiotic piece of propaganda.

**"As the light that stands behind leaders and world servers across the globe." And. "As planetary regent her auspicious presence offers the rare opportunity for private mentoring etc." And "A conveyor of the holiness of spiritual initiation."**

**Now let me define the word 'Regent.'**

*Noun: **regent**; plural noun: **regents**. 1. A person appointed to administer a country because the monarch is a minor or is absent or incapacitated. 2. North American a member of the governing body of a university or other academic institution.*

*Adjective: **regent**. 1. Acting as regent for a monarch. "The queen regent of Portugal"*

**In 1995**, Devra West was chased out of New Mexico in the middle of the night, with only the clothes on her back, by a very angry gun wielding victim. **In 2010**, after several newspapers published in depth articles about her criminal racketeering business in Montana, she was forced to leave that state for Arizona.

This clears up two points that many of us have been confused about for years:-

**1.** Devra West told her students that the Christ gave her [two doctorates in person](#). Now we know she is Jesus's boss it makes total sense!

**2.** After viciously assaulting Dr. Patricia Cole MD and extorting \$1.3 million from her the then Ascended Master 'Surya Ma,' AKA Devra Patton West, asked El Morya to condone her criminality which according to Devra West, sorry the Ascended Master 'Surya Ma,' he allegedly did. El Morya asserted through a channeling (that came through Devra West!!) that the victim was a Nazi in the WWII death camps in another lifetime. El Morya also allegedly asserted that though the beating meted by fellow Ascended Master 'Surya Ma' was severe it was administered with grace. Of course West's claim to be an Ascended Master is all lies and propaganda and part of her well-oiled criminal racketeering business model that she has run for 27 years since attending the ['Robert Jaffe School for Energy Mastery'](#) between 1990 & 1991. Fellow pupil at the school [Satya](#) described Devra Patton West as follows:-

*"I lost many friends/colleagues who remained under her spell for many years-many of whom were bright sensible evolved people who had no idea that they were dealing with a **deeply troubled psychopathic person/personality.** (Devra had earlier convinced me to give \$6,000- to a scheme she either invented or was involved with.) In retrospect- Devra is/was a brilliant, powerful, **manipulative, delusional psycho/socio path** and it saddens me to see that her illness and her destructiveness and manipulation of others has escalated over the years. She is a powerful and charismatic personality- **as most psychopath's are and is it very tragic that she abuses her power to abuse and victimize others. This is what they do and how they survive.**"*

The 'power' that Satya refers to was the knowledge Devra West acquired at the school; occult (hidden) knowledge that she then went on to use against fellow human beings to feather her own financial nest at the expense of everyone she met. To be clear, Devra West, who according to [Jeremy Samuelson](#) was already a small time crook before acquiring occult knowledge, went on to use that knowledge to commit acts of theft, fraud, extortion and when necessary to keep victims and witnesses from going to the police, commit murder as was the case with Lisa Swidler in 2005, and the attempted murder of the whistleblower in 2007.

In this bulletin we share 20 actual examples of Devra Patton West being 'called' out by the authorities and others for 'serving herself' (at the expense of others). These 20 examples are just the tip of the iceberg but none of this is found in her totally fake '[history / life journey](#)' as featured on her website because Devra Patton West is a pathological liar.

And remember this idiot told her 'followers' / cult members that she was:-


- [1. Single handedly holding open the gates of time.](#)

- [3. She stated that the more money her 'followers' give her the closer to God they would be!](#)

**Here are 20 real life events where Devra West was actually 'called' (to account)!**

**1.** She was 'called' to a Montana court in 2010, to see what the court was going to award the whistleblower after she had appealed the earlier court's judgment against her. The court upheld the previous court's judgment but reduced the financial award based on West's lies and appeal court's refusal to listen to an audio recording of West's admission of guilt which contained [several profanities](#). While waiting to go into court, Devra West and Geoffrey Reynolds CPA had the whistleblower served for defamation for telling the truth! As can be seen from [Reynolds' pleadings](#) to the court his statements were a pack of lies on account of the fact that Reynolds only joined West's employ in September 2006 from Arizona and yet, he was alleging that the whistleblower had defamed him between 2002 and 2006!

After the 2007 murder plot failed, Geoffrey Reynolds CPA was either blackmailed / manipulated into making false statements to the Montana court in 2010, to both avenge the whistleblower's win in court against her for fraud and to shut down the whistleblower's websites so that Devra West's multi-million dollar a year '**divine being**' fraud scam could proceed without the truth or facts to contradict her lies and propaganda.

2. She was 'called' to a Montana court in October 2009, where she was deposed by the whistleblower's lawyer to find out where all the money was hidden that she had previously acquired from organized crime / racketeering. During her statement she repeatedly lied about her finances, stating that all the money was handled by accomplice, Geoffrey Reynolds. One of the biggest most obvious lies told by Devra West was about the whereabouts of an estimated \$4,000,000 (as valued in 2002) of artwork and valuables. In the [deposition statement](#) she asserts that while she recognized the list of artwork and valuables shown to her, she insisted that she had given up all of her possessions and that the items mentioned on the list must have been lost or stolen. Some ten years after they went missing, and after the statute of limitations on theft had passed, all of these items showed up on her website for sale, or as being auctioned for sale by her.





3. She was 'called' to a Montana court in December 2009, after an arrest warrant was issued against her for [Felony Theft](#).
4. She and her son, Chris Haywood, were 'called' to attend the Supreme Court of Montana in February 2009 to hear that they had [upheld the lower courts verdict](#) that they had jointly defrauded 'Top to Bottom' construction company.
5. She was 'called' to a Montana court in 2008, after an arrest warrant was issued against her for [criminal check fraud](#).
6. She was 'called' to a Montana court in April 2008, where she was [convicted of assaulting](#) student / business partner Dr. Pat Cole MD while in the process of successfully extorting \$1.3 million from her! Here is an excerpt of what the victim had to say to the [Whitefish Pilot](#) newspaper.

***"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims Devra West threw a lamp at her and hit her with a briefcase, cell phone and her hand.***


***"She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.***

West was overheard discussing the murder of Dr. Cole by employee [Carlida Finch](#). However, Pat Cole was allowed to live after emptying her bank account into Devra West's bank account, and after signing over her home worth \$750,000 to Devra West. [This email](#) from another cult member gives details.

- 7.** She was **'called'** to a Montana court in May 2008, where she was the subject of a [Sheriff's Sale](#) to force her to pay \$2,000,000 in court fines and interest to her creditors.
- 8.** She was **'called'** to a Montana court in July 2008, where judgment was handed down against her for [defrauding the whistleblower](#) out of pay and shares. At a subsequent hearing, the whistleblower was [awarded approximately \\$760,000](#) in costs and damages. Here is a [news article](#) about the award.
- 9.** On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper, senior cult / gang member [Geoffrey Reynolds CPA](#), in what he thought was an 'off the record' conversation, let it be known that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to the whistleblower and his family. Devra West made an unsuccessful attempt to **murder the whistleblower** a few days later.



And here...



**MURDER** is a weapon used by Devra West against those who go public about her criminality or refuse to empty their bank accounts fast enough. Clearly, Geoffrey Reynolds was aware that Devra West was intending to **murder** the whistleblower (how else could he blurt it out to the reporter before the attempt was made) and was probably briefed about the recent **murder** of ex-student [Lisa Swidler](#) by West in 2005, and the intended **murder** of Dr. Cole MD if she did not make a 'donation' of \$1.3 million.

Geoffrey Reynolds incriminates himself in the interview with the [Bigfork Eagle](#) newspaper by suggesting that Cole's injuries were not caused by Devra West but by an earlier fall, even though he was not present in April 2006 and did not start his employment with Devra West until September 2006. Reynolds goes on to incriminate himself further in the interview by admitting money laundering hundreds of thousands of dollars that West extorted from Cole through her business even though his predecessor had resigned rather than be forced to 'manufacture' false invoices for West. Here is part of Reynolds' statement to the [Bigfork Eagle](#) newspaper.

*Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven*

months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.



**10.** She was 'called' to a Montana court on July 12 2007, to give evidence on behalf of her porn loving / wife beating son, who was in a custody battle for his infant daughter against his estranged wife Jamie Haywood. During the hearing she was 'called' to answer certain questions about her own criminality chief amongst them:-

**a.** Did you assault Dr. Pat Cole MD? Answer No. This in spite of the fact that on 17 April 2006 she wrote to her entire mailing list admitting she had in a missive entitled '[The Law of Severity on the Path to Purification](#)' wherein she sought to justify the assault on the victim by saying she was a Nazi in the WWII death camps in another lifetime. Devra West, then calling herself the Ascended Master [Surya Ma](#), also stated that though the beating that was meted on Dr. Cole was severe it was at all times administered by her with grace!

**b.** Would you describe your business as a multi-billion dollar concern? Answer Yes. This in spite of the fact that she had been evicted in quick succession from two rental properties and had a lien against her for over \$2,000 in unpaid employee insurance contributions. See [Whitefish Pilot](#) & [Bigfork Eagle](#) newspaper articles for details. As part of her criminal racketeering business model in Lakeside MT at the time, Devra West was projecting herself as a wealthy

business woman by [using images](#) of a multi-million dollar lakeside property that was owned by someone else. As mentioned in the [Whitefish Pilot](#) news article, the real owners had repeatedly asked Devra West over a 2 year period not to use images of their property in her brochures and on her website.

**c.** Referring to whistleblower's website which contained a statement that asserted that Devra West was **'Dangerous to your Wealth and Your Health'** and additionally contained scores of letters from ex-employees and ex-students who alleged that they had been mentally and physically abused by Devra West; counsel asked if the website referred to her. Devra West acknowledged that it did refer to her but stated that the [employees mentioned](#) were mostly **'fictitious and fabricated'** (go to page 24 of the transcript) and that the whistleblower had worked for a London tabloid newspaper which was a lie.

**d.** Jamie Haywood, the estranged wife of Devra West's son, Chris Haywood, made it clear in [an email](#) she sent to the whistleblower and in [the statements](#) she gave in court on July 12 that she and her infant daughter were the subject of a campaign of occult 'under the radar' violence being directed at them by Devra West. The purpose of these attacks was to intimidate Jamie into giving up her infant daughter. These tactics had been used a few years earlier against Chris Haywood's first wife, [Kendal](#), though on that occasion they had worked with the result that Chris Haywood, a porn loving wife beating low-life with an [FBI record](#) for forgery, substance abuse and vehicle issues (DUI's?) [gained custody of his daughter](#) from his clean living, respectable wife who, as a result of the attacks was viewed as having psychological issues!

Please review this email entitled ['Help Me'](#) from Rebecca West (no relation to Devra West) who explains how she and others, trapped inside the cult, were the subject of a campaign of occult attacks against them in March 2007 intended to intimidate them into not proceeding as witnesses against Devra West in the matter of her assault against Dr. Cole MD.

**11.** She was **'called'** to a Montana court on 11 July 2007, where she entered a ['confession of judgment'](#) in failing to honor a promissory note to plaintiff's Larry Brazda, Steven Life & Connie Life.

**12.** She was **'called'** out by ex-senior student / cult member, Lisa Swidler in 2005, after Lisa witnessed Devra West defraud ex-student / cult member [Dave Kushner](#) out of \$30,000 14 day bridging loan that Lisa had brokered between Devra West and Dave Kushner. Devra West refused to repay the loan or even speak to Dave Kushner, even though West had signed an agreement promising to repay the money.

**13.** She was **'called'** out by ex-senior student / cult member Lisa Swidler in 2005, after Lisa witnessed Devra West kidnap, hold prisoner, beat and extort money from ex-student / cult member [Marion Cantwell](#). After handing over tens of thousands of dollars from the proceeds of the sale of her home Marion was freed and told that if she went to the police she would be killed.

**MURDER?** As a result of **11** & **12** above Lisa escaped from the cult but she did so knowing where lots of Devra West's skeletons were hidden. Shortly afterwards in June 2005, this young mother of two children under the age of ten, died suddenly and mysteriously of internal bleeding having been 'murdered' by Devra West. The coroner, finding no bullet holes, blows to the body etc. ruled no third party was to blame and ruled her death as death by 'natural causes.' Because the weapon used against Lisa and the

whistleblower is not regarded as a weapon under legal statute, these murders or attempted murders would better be classified as executions by 'natural causes.'

- 14.** She was '**called**' out by ex-student / cult member [Mike Hendrickson](#) in 2004 who, having signed a promissory note to the cults / charity's bank account run by Devra West, lost \$200,000 when Devra West emptied the bank account and put his money in a personal trust fund for her and her son Rob Meador. The trust fund containing Mike Hendrickson's \$200,000 plus a property (worth \$1,250,000 in 2002 that West stole from the charity) was 'broken' open in 2008, with the contents being used to pay \$2,000,000 in court judgments and interest that Devra West owed her creditors.
- 15.** She was '**called**' out by the Secretary of State for Montana in January 2004 who, after receiving evidence from the whistleblower that Devra and Jack West were stealing cash donations being given to the charity, struck their charity off the Montana registry of charities. Follow [this link](#) to review the 'Revocation' certificate.
- 16.** She was '**called**' out by Beatrice McGuire who, while attending a seminar held by Devra West in Montreal in 2002, challenged several lies Devra West was spouting to her audience. West's immediate response was to violently assault Beatrice who needed reconstructive surgery to repair the tear to her ear. West denied the attack even though there were plenty of witnesses but paid for the victim's plastic surgery! Ex-student, Debra Coffey, explains in [her statement](#) to the whistleblower how she took part in 'sessions' organized by Devra West designed to brainwash and condition new cult members. Mental and physical abuse was used in these sessions and when Devra West assaulted someone she blamed the assault on God not herself!
- 17.** She was '**called**' out by employee and ex-board member of the charity, AJ White, who explains [in her statement](#) to the whistleblower how, in 2001 employee Susannah Felder accused Devra West of stealing \$80,000 from the charity to pay for her son's legal fees, Susannah was then subject to a violent assault that saw her having part of her scalp ripped off by Devra West.

In late July 2001, while I was on a business trip to Denver, Susanna Felder, a committed assistant for over 9 years and editor of Devra's writing, called me. She called me in severe distress as she had gotten into a heated discussion with Devra on whether or not I should be put on the BOD – there was no Foundation BOD at that time. Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head.

**18.** She was 'called' out by Dr Pat Cole MD, who explained that Devra West had a long history of violence and mental and physical abuse against others dating all the way back to her time in New Mexico. Pat went on to say [that records](#) that she held about these incidents, that occurred before Devra West moved to Montana in 1995, were stolen by Devra West from her storage unit.

**19.** She was 'called' out by Satya who in 1990 to 1992 was attending the 'Robert Jaffe School of Energy Mastery' as a student with Devra West. Satya reports being defrauded by Devra West out of \$6,000 and also that at the conclusion of the course in 1991 Devra West declared herself to be an Ascended Master and that anyone not agreeing was "blocking the energies." Satya, [in an email](#) to the whistleblower, referred to Devra West as a deeply disturbed psychopathic person / personality.

**20.** She was 'called' out by Jeremy Samuelson who remembers both Jack West, his land partner, and Devra West from the 1970's & 1980's. Jeremy in [his email](#) to the whistleblower, describes Jack West as a timid man with little experience of woman who Devra West was soon 'running.' He remembers that they were pot growers and that they defrauded him out of \$10,000.

[Lisa Swidler](#) – Student / Teacher probably murdered by Devra West to keep her quiet about two serious crimes she witnessed against other students.


