

Subject: The Many Lives & Many Lies of Con Artist & Violent Convicted Criminal Devra Patton West - Currently Masquerading as the Ascended Master Rishi Devra.

Dear FBI, IRS Sedona & Scottsdale Police Departments,

If I understand the process correctly, when you build a file on a suspect you look for patterns of behavior which when confirmed, become the M.O. (modus operandi) of the target of your investigations. Below we set out a pattern of criminality that has repeated itself for at least three decades, perhaps longer. Prior to 1990, there is compelling evidence from at least two victims who were defrauded out of several thousands of dollars each that Devra West was a small time crook, drug grower and drug dealer.

Between 1990 & 1991, Ms. West attended one of the finest 'energy' schools in the world, acquiring occult (hidden) knowledge that enabled her to leverage her criminal activities; to the point where through numerous acts of theft, fraud, extortion sometimes occasioned with violence, she was raking in millions a year. The M.O. (pattern of behavior) is always the same. Move into an area, infiltrate the spiritual / metaphysical communities, declare her divinity to all and prey on the sheeple (those who cannot tell the difference between a card carrying Satanist and a divine being). Each time Ms. West wears out her welcome, or is the subject of too much negative publicity about multiple arrest warrants, convictions for assault and the many visits to court as the defendant in fraud related lawsuits, she simply moves to another area and reincarnates herself complete with a new name, new identity and new fake 'life journey.'

Below is an examination of several of Devra Patton West's most recent 'lifetimes.'

Each 'lifetime' is more grandiose than the previous. In each successive lifetime, she awards herself ever more ridiculous titles and accolades, such as in the most recent lifetime where she declared herself to be the 'Regent of the Spiritual Hierarchy of the Western Hemisphere.' In 2002, Ms. West defrauded the whistleblower, in 2007 she tried to murder him, in 2010 she and her accomplice Geoffrey Reynold CPA, a senior member of her cult, made blatantly false statements to a Montana court in an attempt to bankrupt him with what were frivolous lawsuits that he could not afford to defend as he had emigrated abroad. Motive? Force down his websites so that Ms. West could move to Arizona without any evidence of her sordid past on the internet. In 2005 Devra West murdered Lisa Swidler, a friend of the whistleblower. Motive? To keep her from going to the police to report the serious crimes being committed against two other cult members.

We will continue to bring forward this information until a criminal investigation is launched into what is obviously a murderous criminal racketeering gang which has operated in three western states over as many decades.

The Sedona and Scottsdale Abodes... As a spiritual guardian of the western region of the United States, her presence in both Sedona and Scottsdale is a blessing for all souls and especially for those who seek spiritual enrichment and the ultimate awakening of enlightenment. Her path of awakening has moved from an enriched epic of life experience that has encircled the globe. Embraced and recognized by spiritual heads and enlightened masters of multiple traditions, she is regarded as a 'Lotus Born Soul' by pundits and yogic masters.

- 1.** Previously it was the "Surya Ma' of the New Potential' in Lakeside MT (lifetime (4) and before that, it was "Devra Ji' of the New Potential' in Victor MT (lifetime (3). The only 'potential' in the previous lifetimes / aliases was for organized crime!
- 2.** "A Spiritual Guardian and a Blessing for all Souls." Like all card carrying Satanists, everything is the opposite of what it seems. Based on the evidence from her past lives / past identities, Devra Patton West has been a Curse for all Souls (see below).
- 3.** The main constituent parts of her "epic of life experience" at best, consists of mental and physical cruelty towards her fellow human beings seeks to dominate and control the lives of others herding individuals into her cult who after brainwashing and conditioning are harvested, one by one, to finance her delusions and visions of grandeur. At worst, there is evidence that her cult / criminal racketeering business model is predicated on her ability to use occult (hidden) knowledge to commit serious financial crimes like theft, fraud, extortion and if necessary, to cover up these crimes murder both victims and hostile witnesses.
- 4.** This psychopath has many delusions of grandeur, including that she is recognized by the "heads spiritual traditions" along with she is "holding open the gates of time" and "the Christ gave her two doctorates in person" etc.

A review of her four previous ‘lifetimes’ and the current ‘lifetime’ reveal a well-oiled criminal racketeering business model that Devra West calls ‘World Service.’ As with all Satanists, everything is the opposite of what it should be. Lies. Lies & More Lies.

Let me reveal, using witness statements, newspaper articles and legal documents, the lengths that she, and the senior members of her cult, have gone to in an attempt to convince you the public that Devra West is a ‘divine being.’ The ‘divine being’ routine being the ‘front’ for a criminal racketeering business model hidden inside a cult which masquerades as a quasi-religious organization.

Life (1.) 1970’s to 1990.

A closet psychopath, small time crook, drug dealer and ex-bankrupt.

Witness [Jeremy Samuelson](#) reveals that Devra and Jack West were pot growers / dealers who defrauded him out of \$10,000. Jeremy Samuelson describes Devra West as a powerful personality, who was running Jack West, who had little experience of women. Devra West in some versions of her bio alludes to her jewelry business, but does not mention that it went into bankruptcy. In 1990, while attending energy classes at the Robert Jaffe School for Energy Mastery, fellow class mate [‘Satya’](#) attests that Devra West defrauded her out of \$6,000. Satya also referred to Devra West as a “deeply disturbed psychopathic person / personality.”

Another piece of evidence that affirms that Devra West made a long term career out of organized crime, is that her son [Chris Haywood](#) has an FBI record for forgery, multiple drug busts and road traffic violations (DUI?).

Key Notes: ***A drug dealing fraudster and bankrupt willing to cheat and manipulate others to serve her own selfish and narcissistic ends.***

Life (2.) 1991 to 1995. Self-proclaimed Ascended Master (alias unknown).

Devra West forms a personality cult around herself based on her occult knowledge, and claims of being a ‘divine being.’ She proceeds to mentally and physically abuse those around her for her own selfish ends.

It is clear from witness statements that Devra West was a both a dealer in drugs and a prolific user of pot, weed and perhaps harder drugs. It is possible that these drugs opened up opportunities to explore altered states of consciousness. With the failure of her jewelry business and finding it rather tedious defrauding individual victims, one at a time, out of several thousands of dollars each Devra West

decided to 'up her game' by first acquiring occult (hidden) knowledge. This was done to leverage her natural criminal tendencies (psychopathy) and allow her to commit much larger crimes with little fear of prosecution.

Accordingly, between 1990 & 1991, she attended the ['Robert Jaffe School for Energy Mastery'](#) after which, based on her new found ability to commit serious crime with plausible deniability, she declared herself to be an Ascended Master.



Giving a deeply disturbed psychopathic person / personality occult knowledge is like giving a crazed gorilla a loaded machine gun – you just know that this combination of circumstances is not going to end well.

Very quickly after elevating herself to the status of a minor deity, Devra West started to build a personality cult around herself – the cult built entirely on the basis of her ability to cause pain, suffering, illness and murder using the occult knowledge that she acquired between 1990 & 1991. Devra West is criminally insane but not stupid. She has three things going for her that continue to make it difficult for victims or the authorities to get a successful prosecution against her.

- 1.** *Religious Freedom laws allow her to tell as many lies about herself as she wishes with little fear of prosecution hence her ability to keep reincarnating herself after being forced to leave an area.*
- 2.** *The 'weapon' she uses to commit serious crimes like fraud, extortion and murder is not recognized as a weapon under legal statute therefore she is unlikely to be prosecuted for the murders (termination of her adversaries by apparent 'natural causes') even if the murder she planned and executed was announced ahead of time by one of her accomplices. This is what happened in 2007 when Geoffrey Reynolds announced the impending murder of the whistleblower to the press two weeks before she made her failed attempt.*
- 3.** *The ability to recruit, manipulate and corrupt weak minded sociopaths into becoming her accomplices either in committing the crimes or helping her cover them up. These 'lairs for hire' also provide her with false witness statements and fake testimonials when required.*

Unfortunately for Ms. West (alias unknown between 1991 & 1995 in New Mexico) one victim of occult attacks realized that the police and the courts were not going to be any help, so he took the law into his own hands. This resulted in Devra West, her husband Jack West and their young daughter, Anna West, being chased out of New Mexico in 1995 by a gun wielding victim who chose to respond with Devra West's shamanic witchcraft with a weapon of his own.



Devra West's view of reality is that as a 'superior being' she is entitled to herd, rule over and occasionally cull members of her cult to fund her grandiose and expensive lifestyle. For 99% of the time victims of theft, fraud, extortion and violent assaults walk away unfortunately for Ms. West occasionally the prey animals bite back!

There is documentary evidence that shows that Devra Patton West, while operating her first cult in New Mexico between 1991 & 1994, mentally and physically abused those around her. The records allege a regimen of systemic abuse by Devra West as part of her belief that she, as a divine being, had the right to treat lesser beings with utter contempt. Key Notes: *Evidence of psychopathy, egomania, visions of grandeur, narcissism, the manipulation and mental and physical abuse of others for her own selfish ends - all traits of a 'service to self' entity.*

Life (3.) 1995 to 2005. The Ascended Master 'Devra Ji.'

After a short apprenticeship running her cult in New Mexico Devra Patton West a pathological liar, commits acts of theft, fraud, extortion and murder in Victor Montana while masquerading as the Ascended Master 'Devra Ji.'

The whistleblower decided to attend meditation classes in Victor MT in November 2001. He was unaware at the time, that Devra West existed or that she was running a cult. In January of 2002, Jack West, who was running the meditation classes, decided to introduce the whistleblower to his then wife, believing that the whistleblower's expertise as a management consultant might be beneficial to her plans to set up a series of for-profit and nonprofit corporations. Accordingly, the whistleblower was recruited for a period of 6 months, on the promise of pay and shares in the for-profit corporation. However, after the six months had ended and the work was done, Devra West refused to pay him what she had agreed. This resulted in a fraud lawsuit that the whistleblower launched in 2003, and won in 2008.

The whistleblower learned, while researching his lawsuit, that he was one of scores of victims of theft, fraud and extortion often occasioned with violence at the hands of Devra West. Put simply, there was a criminal 'conveyor belt like operation' where prospective victims would be recruited as employees, students and, as in the case of the whistleblower, professional consultants, who would then be ripped off either through theft, fraud, extortion or in the case of many employees forced to join West's cult and become low paid or no paid slaves.



The above image illustrates Devra West's criminal racketeering business model which took in students to her unaccredited school and employees / consultants to work in her 'business.' Very quickly each was subject to a campaign of brainwashing and conditioning designed to force them to 'submit' to the will of the Master. Those employees and consultants working in her business who refused to submit to her tyranny were fired before the 90 day period was up after which she would be forced to pay employment insurance.

The top left photo in the image above was taken in the summer of 2002. Within that photo are students (to West's unaccredited school for occult studies), employees and the whistleblower. As evidence that West's activities have nothing to do with 'world service' and more to do with organized crime let me give you a head count of those that were present in this photo who went on to be **individual** victims of one sort or another.

[Mike Hendrickson](#) – defrauded out of \$200,000. [Dave Kushner](#) – defrauded out of \$30,000. [Marion Cantwell](#) – defrauded out of tens of thousands of dollars after being kidnapped and threatened with murder. [Lisa Swidler](#) – murdered by Devra West after she witnessed the two crimes against Dave Kushner and Marion Cantwell and tried to leave the cult. [Susannah Felder](#) viciously assaulted and partially scalped by Devra West after calling her out on an \$80,000 contribution West stole from the charity. [Beatrice McGuire](#) viciously assaulted in front of an audience after calling out West on her lies. Beatrice needed plastic surgery to repair a torn ear lobe. The [whistleblower](#) defrauded out of \$760,000 dollars in pay and shares. [Joseph Costantino](#) – defrauded out of \$20,000 in pay and overtime. Lucy – and elderly cult member the victim of extortion after meeting the whistleblower after he 'left' the cult. Cult members were forbidden to speak to those 'expelled' or who left of their own accord. One reason for this is that no one remaining in the cult can then challenge Devra West's false account of the reason for their departure. See [Barbara Costantino's](#) explanation of this.



Above left: psychopath Devra West would show no more concern about snuffing out the life of a human being than she would an insect. Lisa's ~~murder~~ termination and sudden mysterious death of 'natural causes' ended the possibility of this witness sharing the many skeletons in Devra West's expansive closets.

After the whistleblower was defrauded, and after realizing that Devra West was running a criminal racketeering gang disguised as a religious organization, he shared what he had learned with the Secretary of State for Montana who removed Devra West's charity 'The Circle of Divine Unity' and its school the 'Sacred Arts Institute' from the charity register. 
Above, I list some of the individual victims of Devra West's 'world service' efforts. However, the State of Montana and the IRS were also huge victims of her criminal racketeering business model.

With civil lawsuits against her from past victims of fraud and extortion coming to a conclusion, Devra West decided to commit one last huge crime against the state of Montana by defrauding the state out of millions of dollars in public donations, by asserting falsely, that the charity was in debt when in fact it was Devra West who owed money to the charity. Long story short, she claimed the charity's main asset, a log mansion on 20 acres worth \$1,250,000 in 2002, in lieu of fake loans she had set up for just that purpose. She then placed the property in a personal trust fund for her and her eldest son, Rob Meador.



At the same time, approximately \$4,000,000 worth of art work and valuables (as valued in 2002 and also largely gifted to the charity or paid for by public donations) went missing only to turn up in Arizona ten years later in 'lifetime (5), her current lifetime (see below), where she attempted to sell the items at auction after the statute of limitations had passed on theft. There is no doubt in any one's mind that these items were stolen; especially as Devra West, in a statement to a Montana court in 2009,

clearly stated under oath that a) they did not belong to her b) she had given up all possessions and c) that they were likely stolen with all of her other belongings! With 'lifetime (3) as the Ascended Master **'Devra Ji'** coming to an end, and with \$2,000,000 owing in court fines and interest to past victims of fraud and extortion, Devra West, rather than announcing her impending bankruptcy for the second time instead announced to the members of her cult that she had moved from the **5th dimension to the 7th dimension** and that the Masters had prepared a new home for her in Shamballa! Shamballa happened to be approximately 100 miles north of Victor MT in Lakeside MT (Flathead Lake). Desperate for cash to fund her expensive lifestyle (servants, cooks, cleaners and massages) and debts, Devra West AKA **Devra Ji**, announced that she only had room at Shamballa for 12 disciples and only those prepared to commit **66% of their net worth** to her and her good causes!


Life (4.) 2005 to 2010. The Ascended Master ‘Surya Ma.’

Building on her experience gained in the previous two lifetimes, Devra Patton West continues to expand her criminal activities - which include the threatened murder and extortion of \$1.3 million from one victim and the attempted murder of the whistleblower, who had the nerve to sue Devra Patton West successfully for fraud and go public about her criminal activities in Lakeside MT.

There is far too much material to cover in her short lifetime as the Ascended Master ‘Surya Ma.’ Here is a short list of her criminal activities during the time she masqueraded as a ‘world server’ in Lakeside MT. Three newspaper articles expose some of her activities during this time period they are the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#).

The major overt crime during her time as the Ascended Master ‘Surya Ma’ was the threatened murder of Dr. Cole MD, which employee [Carlida Finch](#) overheard Devra West talking about to another employee. The murder was averted after the victim signed over her home worth \$750,000 and

transferred a further \$470,000 from her lifesavings / IRA into Devra West's bank account. Prolific liar and psychopath, Devra Patton West then sought to justify the campaign of vicious assaults on Dr. Cole MD to the rest of her cult by asserting that the victim was a Nazi working in the death camps in WWII in another lifetime. In April 2008, Devra Patton West was found guilty of assaulting Dr. Cole and was fined \$500 and given a 6 month suspended jail sentence.



Devra Patton West convicted of assault, fined \$500 and given a 6 month suspended jail sentence. As per normal West did everything she could to derail the court proceedings and did not even turn up for the sentencing hearing claiming to be filming a documentary on the Mayans in the Yucatan! No such documentary ever aired!

Days after the above newspaper article appeared in the Whitefish Pilot newspaper, Devra West published the following statement on her website:-

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

Devra West is clearly at the head of a criminal / racketeering business model and is also clearly coordinating the actions of the senior members of her gang / cult in an attempt to deny / cover up her crimes. Why else would senior cult members [Geoffrey Reynolds CPA](#), [Julio Williams MD](#) and ex-husband [Jack West](#) all issue statements of denial on Devra West's website within days of her conviction for assault being made public in the local newspapers?

Business partner of Victor Guru wins lawsuit by JOHN CRAMER - Ravalli Republic

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court. Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment. The case was heard in Ravalli County because West's home and business operations - the Divine Unity Foundation and the Sacred Archives Institute - were in Victor, where Watson also lived. Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines.

West did not attend Thursday's hearing. Her business manager, Geoff Reynolds, attended but declined to comment and said West would not comment. Watson said West was a "crook" who operated a "cult." He said she "brainwashed" people into giving her money - in part by falsely claiming to have a doctor of philosophy degree and a doctor of divinity degree - and turned them into "slaves" who did menial tasks at her bidding.

Within days of the above newspaper article appearing in the local press, the following statement was published on West's website:-

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Devra West states that no business contract between her and the whistleblower was ever agreed. If this is so, then why would West's ex-husband have [written a letter](#) to the INS on behalf of John Watson in 2002, confirming that he was working for Devra West on several projects and was being paid for his work! Additionally, and after defrauding the whistleblower out of the wages and shares promised, why would Devra West write to her lawyer [Mr. Taberachi](#) asking for him to sever their business relationship? And this statement below from her website in 2007, which purports to convince us that Devra West is controlling the 'gates of time' whatever that is. I have added the statement about Hitler's use of indoctrination.

On July 12 2007, Devra West appeared in court as a witness on behalf of her son, Chris Haywood, who was seeking custody of his infant daughter from his estranged wife, Jamie Haywood. A reading of the transcript of Chris Haywood's attempt to get custody of his infant daughter from his estranged wife, Jamie Haywood, reveals the sordid home life of the West family, with Devra West as the strong willed matriarch. Read [Jamie's email](#) to the whistleblower asking for help. It is clear that Devra West used her occult knowledge to try to intimidate Jamie into giving up her infant daughter. 

Devra West made an unsuccessful attempt to **murder the whistleblower** a few days later.



Reynolds also incriminates himself in the interview by admitting money laundering hundreds of thousands of dollars that West extorted from Cole through her business even though his predecessor had resigned rather than be forced to 'manufacture' false invoices for West. Here is part of Reynolds statement to the [Bigfork Eagle](#) newspaper.

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.

With the attempt to murder the whistleblower failing, West & Reynolds bided their time until they could implement 'Plan B' which they did in 2010. While attending court to see how much he was to be awarded for [winning his fraud lawsuit](#) against Devra West in 2008, the whistleblower was served for

defamation by West & Reynolds - for telling the truth. It shows how committed to West's criminality Geoffrey Reynolds was, that he was prepared not only to go before a Montana judge and make totally false statements about himself and his relationship to the whistleblower, but that having done that, he was then perfectly willing to 'front' the pair of frivolous lawsuits while Devra West could remain in the shadows.

It should be noted that Geoffrey Reynolds traveled from Cave Creek AZ to join West's employ in Lakeside MT in September 2006, and yet in Reynolds' pleadings to the Montana court below, he states clearly that he was defamed by the whistleblower between 2002 and 2006? As one can see from an excerpt of Reynolds' resume taken from his own website (full copy available [here](#)), at the time he made these false claims to the Montana court in 2010, Reynolds did not join Devra West's employ until September 2006, and so did not know that the whistleblower existed until he was briefed about West's vendetta against the whistleblower after September 2016.


*"Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often **just** referred to as genitalia.*








The current con works like this. Devra Paton West AKA the Ascended Master 'Rishi Devra' announces a series of seminars like the ones listed below.


Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee. In reality Devra West, having identified a wealthy target, induces the symptoms of a serious illness in the victim using the same occult knowledge she uses against those who oppose (see above).
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for those nonexistent wrongs). If the target does not agree to pay the target becomes the subject of a campaign of occult attacks designed to convince them to pay!

Devra West has been perpetrating this extortion racket for at least two decades. Two of her admin staff who worked for in 2002, overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Step 3. The victims go to the Sage of Sedona’s [‘Pay Portal’](#), recently updated, which is now set up to receive single donations of \$500,000 or more by pressing one or a combination of buttons and empty your bank account into hers. Note her standing there with her hands out saying “give me, give me.”



This well-oiled criminal / racketeering scam has been going on for 27 years right under the noses of the FBI and the IRS. At the very least, it is wire and mail fraud! At the very least, it is illegal for a lay person, even if they are claiming to be a ‘divine being’ to be able to cure / heal someone. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.

Pattern of racketeering activity requires at least two acts of racketeering activity, one of which occurred after the effective date of this chapter and the last of which occurred within ten years (excluding any period of imprisonment) after the commission of a prior act of racketeering activity. The US Supreme Court has instructed federal courts to follow the continuity-plus-relationship test in order to determine whether the facts of a specific case give rise to an established pattern. Predicate acts are related if they "have the same or similar purposes, results, participants, victims, or methods of commission, or otherwise are interrelated by distinguishing characteristics and are not isolated events." (H.J. Inc. v. Northwestern Bell Telephone Co.) Continuity is both a closed and open ended concept, referring to either a closed period of conduct, or to past conduct that by its nature projects into the future with a threat of repetition.

And...

Under RICO, a person who has committed "at least two acts of racketeering activity" drawn from a list of 35 crimes—27 federal crimes and 8 state crimes—within a 10-year period can be charged with racketeering if such acts are related in one of four specified ways to an "enterprise". Those found guilty of racketeering can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count. In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."

RICO predicate offenses

Under the law, the meaning of **racketeering activity** is set out at [18 U.S.C. § 1961](#). As currently amended it includes:-

- Any violation of state statutes against [gambling](#), [murder](#), [kidnapping](#), [extortion](#), [arson](#), [robbery](#), [bribery](#), dealing in [obscene matter](#), or dealing in a controlled substance or listed chemical (as defined in the [Controlled Substances Act](#));
- Any act of [bribery](#), [counterfeiting](#), [theft](#), [embezzlement](#), [fraud](#), dealing in obscene matter, [obstruction of justice](#), [slavery](#), [racketeering](#), [gambling](#), [money laundering](#), commission of [murder-for-hire](#), and many other offenses covered under the Federal criminal code ([Title 18](#));
- [Embezzlement](#) of [union](#) funds;
- [Bankruptcy](#) fraud or [securities fraud](#);
- [Drug trafficking](#); long-term and elaborate drug networks can also be prosecuted using the [Continuing Criminal Enterprise Statute](#);
- Criminal [copyright infringement](#);

- [Money laundering](#) and related offenses;
- Bringing in, aiding or assisting [aliens](#) in illegally entering the country (if the action was for financial gain);
- Acts of [terrorism](#).

If we just take the most serious crimes committed by Devra Patton West as part of her past **'World Service'** efforts in lifetimes / incarnations **3 & 4** in Montana, we find that there are **NINE** 'Predicate Offenses' that she should be charged under - some of which she has committed multiple times! 
