

Eleven plus years after the failed murder attempt by Devra Patton West, she is still targeting the whistleblower and his family with occult 'under the radar' violence using the same weapon against him that she has used on countless occasions since 1991 against scores of other victims. The reason why so few prosecutions are brought against Devra West is because the victims, hostile witnesses and their family members quickly become targets for occult violence. Devra West continues to target the whistleblower and his family for two reasons.

1. Firstly, she believes that the whistleblower is the source of the information you are reading now. This information, the truth about her past in NM & MT totally contradicts the false 'divine being' narrative which forms the basis of her criminal racketeering business model now operating in AZ.

2. Secondly, after the truth about her criminality was revealed to the Montana public no one believed the 'divine being' routine there forcing her to leave that state. That same truth is now a threat to her multi-million dollar a year criminal racketeering business model currently operating in Arizona.

Below is a copy of an email sent by the whistleblower just days ago, to the three senior members of Devra West's cult / criminal gang i.e. [Geoffrey Reynolds](#), [Julio Williams](#) and ex-husband [Jack West](#). The contents of the square brackets [] are my additions to John Watson's email intended either to clarify or to reference supporting documents below the email.

ANOTHER WARNING TO CEASE AND DESIST

This email is addressed to Geoffrey Reynolds, Julio Williams and Jack West.

Obviously I am aware of the ongoing campaign of occult 'under the radar' violence [1] being directed at me, my wife and children by Devra Patton West obviously you are aware of it too as willing accomplices to her criminal / racketeering business model.

Over the past 12 years my wife and children have been the target of violence directed at them and I by Devra West who I believe to be criminally insane – no sane person would treat other human beings the way she does [2]. I remember when she attended my birthday party on July 12 2002 [3] she confided in me that she felt very alone and distant from the rest of the SAI / cult members [4] in attendance that day. I have come to understand that the obvious reason for her discomfort was that, like a shark in an aquarium, every living thing she saw around her was potential prey [5].

Over the past 12 years since 2006 my wife and children have made numerous visits to hospitals for scans, MRI's with one of my daughters having to have an operation as a result of the violence directed at them by Devra West. There is no doubt in anyone's minds at this end that these ailments and the grievous bodily harm caused was as a direct result of Devra West's attacks; her attempts to intimidate me into not pursuing justice for the crimes committed by her against me and subsequently [against] my family. Let me be clear Devra West can continue to do her worst against me, my wife and children and NOTHING will change. I intend to have justice and as for the harm both physical and mental directed at my children – that account will be settled at some point.

Let me be clear again. I told Devra West at a meeting in March 2003 [6] that she would not screw me over like she had done to scores of victims before me (and since). If I meant it then think how much more I mean it after a 12 year campaign of violence directed at my wife and children. Early next week a copy of this email, a copy of the four statements I have made to the RCMP [in Canada] and a PDF of this week's email bulletin, being sent out by the Euro group, will go in a personalized email from me to the FBI in Arizona, the IRS and be copied to the Sedona & Scottsdale police forces. In case I am being too subtle let me be clear. Once Devra West targeted my wife and children she brought into being what they called in medieval times – a blood feud. Blood feuds are settled with blood or gold. My current definition of 'blood' is Devra West's total financial ruin (via the truth), her

being subject to a criminal trial and after a guilty verdict her long term incarceration in a mental institution or jail (we'll leave that to the men in white coats).

Now you might ask why I am addressing this email to you three. Simple. Where she goes you all go.

Let's deal with Reynolds first. Reynolds did not know me from Adam as our relationship with West was separated by at least three years. Everything Reynolds got to know about my relationship with West occurred post September 2006. Reynolds chose to be complicit in a plot by West to murder me and when that failed he doubled down on his stupidity by choosing to front a conspiracy to bankrupt me by making false statements [7] to a Montana court about me defaming him when in truth he did not know I even existed between 2002 and 2006. Clearly not the brightest bulb on the Christmas tree as he even left his resume up on line [8] which showed he could not have known me between those dates nor by extension ever have been defamed by me. Because he was stupid enough to be manipulated into standing between me and Devra West (in her vendetta against me) he and I are now tied at the hip until a) the \$5,000,000 default civil judgment obtained by his lies is removed and b) he goes to jail for his part in the murder plot and for perjuring himself as part of a conspiracy to bankrupt me. [Motive?] So that my websites would be forced down and Devra West could set up her 'divine being' fraud scam in another western state i.e. Arizona where she now operates [9].

Now Reynolds may feel that even with the testimony's of Constance See, the Bigfork Eagle reporter, and John Nielson, the IRS criminal investigator who she shared the murder threat with, that he is fairly safe from being prosecuted for complicity to commit murder – and he may be right if that was his only error. However Reynolds waited three years from 2007 and then doubled down on his stupidity when in 2010 he agreed to be part of West's criminal conspiracy [10] to bankrupt me. On her [West's] prompting he not only made totally false statements [7] to a Montana court but agreed to front that action leaving Devra West, the slippery serpent, to remain in the shadows. They both did this knowing that I probably would not be able to travel from abroad to the US to defend their frivolous lawsuits. Without repeating myself Reynolds resume shows he is a liar and perjurer – it is all there in the written record.

The motive for my murder and subsequent conspiracy Reynolds took part in to silence me is obvious. Revenge for successfully suing Devra West for fraud and more importantly having worn out her welcome in Montana she could not set up the next iteration of her multi-million dollar a year fraud scam until I was silenced [11]. That's where Reynolds came in not once but twice. Reynolds's goose is cooked it is just a matter of time.

*Let me talk about Julio Williams next. Like Reynolds he has shown that he can be manipulated around Devra West's little finger. First there was his involvement in the defamatory statement put out by doctors Williams, Cole and Cornell [12]. Cornell had the sense to run away and we all know what happened to Cole [13] don't we? Following that there was threatening email to me [from Williams] [14] promising \$2,000,000 for West's legal fees and the, "don't f*ck with me statement." I was never f*cking with you Julio but like Reynolds you were co-opted into f*cking with me. In both Montana and in Arizona you have been used to provide idiotic testimonials for Devra West which she has posted on her website [15]. In Montana you provided [her with] a lengthy gushing testimonial [16] on her website which was a total pack of lies and designed, like your most recent offerings are, to lure people into the cult for brainwashing and conditioning prior to becoming victims of theft, fraud, extortion and violence and even murder. Your testimonial on her website in 2007 was given knowing full well that she was fraudulently using another person's multi-million dollar property [17] to give the impression she was a multi-millionaire or as she stated in court on July 12 2007 a multi billionaire [18].*

More recently you have fronted a campaign for the 'divine feminine' [19] knowing that she brutalizes women which includes fellow physician Dr. Cole MD. More recently you even hired a rental property [20] so that you personally could sponsor 'Sacred Sundays with Rishi.' Which could be likened to Hitler deciding to hold bar mitzvah's for Jews. You know all of this, you know all about the arrest warrants, the convictions for assault, the multiple appearances in court by that serpent as the defendant in fraud related lawsuits, the vicious assaults against Cole, Felder and McGuire [21] and yet you still agree to market this devil as a guru. You recently described this devil spawn as, and I quote, "a virtual wellspring of living divinity [22]." Clearly you are a willing

participant in an organized criminal racketeering gang that uses murder to silence those who go public (like me) or those who might go public (like Lisa Swidler) [23]. Not only that you are on record as having funded organized crime to the tune of \$100,000 in 2007. You are up to your eyes in this Julio.

Finally Jack West. What is there to say except Jack West has been there from the start. Jeremy Samuelsson [24] makes it clear that he [Jack West] was overwhelmed by Devra West who was soon running him. So Reynolds & Williams don't feel too bad you come from a long line of suckers. I am grateful for some of the comments that Jack West shared with me in 2002 during the 6 months I was associated with West and her cult. The first was that people who went against his then wife Devra West had a habit of dying. It did not make much sense then but after Lisa Swidler's death and the attempt on my life and the threats against Cole, Marion Cantwell and Rebecca West [25] it sure made sense then. The other comment I am grateful for was when he confided in me that he, Devra West and young Anna [West] were chased out of New Mexico in the middle of the night by one gun wielding victim (presumably [a victim] of occult attacks) who knew the police could not help him. Is Anna West aware that her mother is targeting her adversary's children?

In summary I am not yet ready to take the law into my own hands to defend myself and my family. Or do unto others as has been done unto me. I am a very patient man and over the last eleven years or so I have laid down a very, very long paper trail both with emails to Mr. Bartlett [West's lawyer], Julio Williams, several written letters to the FBI in Phoenix over the past 7 years with some containing DVD's full of evidence, four written statements to the RCMP in Canada and the occasional personal email and phone calls to the FBI in Phoenix. My daughter's and wife's medical records show them both going down with the same ailments at exactly the same time even though they are separated by hundreds of miles. Could that be coincidence? Not when you add the statements from Rebecca West about Shamanic witchcraft [26], Jamie Haywood's similar comments [27], and West's neighbor's comments [28] also similar. And guess what? In the statement she gave the Whitefish Pilot in July 2007 she states that she studies shamanism??

That serpent Devra West may sit quietly alone targeting her victims in the belief that no one can see her or connect these violent assaults to her but there is a mountain of credible evidence that says otherwise and once some of the many victims I have named get interviewed and it is discovered that West has been doing this for decades you are all screwed. The longer [that] psychopath Devra West has stayed at large and gotten away with an ever increasing amount of crime it seems that the reams of material she drapes around her shoulders also increases in yardage [29]. In the same way the fraudulent claims [for her] to be able to dispense 'divine grace healings' and 'dispense with karma' [30] become ever more ludicrous. But all apparently on offer for a large fee [31]. Whether by my hand, hers or yours there will be an investigation into Devra West criminal racketeering business model.

Reynolds's statement to the Bigfork Eagle reporter in 2007 that I would be dead within 12 months or in jail for what Devra West was going to do to me and my family has not worked out as planned. The murder plot failed and while Devra West has regularly targeted me, my wife and children over the past 11 years it has not brought about the desired result that both West and Reynolds had hoped for. Some 11 years later her vendetta against me continues however it is more and more likely that it will result in ALL of you being jailed for racketeering with your assets seized.

In closing Devra West may continue down the path that she has walked these past 12 years and whatever she does it will make no difference I cannot be intimidated or apparently killed by her so we [will] all continue down this path she has set forth until I get the result I want. The account with my wife and children can be settled later. But where she goes you three go. A sacrifice I am sure she will not lose an ounce of sleep over.

[1] Other victims claiming to be on the receiving end of occult 'under the radar' violence at the hands of Devra West, include her office manager Rebecca West (see email she sent entitled [Help Me](#)), her daughter in law Jamie Haywood (see her harrowing [email](#) asking for help), Devra West's neighbor Michelle Fetveit (listen to her [audio statement](#)) and finally read Devra West's own statement to the [Whitefish Pilot](#) newspaper wherein she states that she studied Shamanism with Native Americans. Finally, listen to Devra West's [own statement](#) to the whistleblower wherein she, unaware that she was being recorded, states that if he takes her to court she will get so down and f*cking dirty etc.

[2] Review last week's [bulletin](#) which lists 21 of the blessings crimes committed by Devra West against victims in Montana. [4] & [5] [A photo](#) of West's cult in the summer of 2002; many in the photo attended John Watson's birthday party and many subsequently became victims of theft, fraud, extortion, violent assaults, attempted murder in the case of the whistleblower and murder in the case of student Lisa Swidler. The property in the background, which was largely paid for by public donation, was stolen from the charity and put in a trust fund for Devra West and her eldest son Rob Meador. That trust fund was broken in 2008, with the contents (which included \$200,000 stolen from student Mike Hendrickson) sold at a [Sheriff's Sale](#) with the funds raised at auction used to pay the \$2,000,000 that Devra West owed her creditors in court fines and interest.

[6] The real Devra West, as she really is when not masquerading as a guru, and over a decade before she declared herself to be '[The Regent of the Spiritual Hierarchy of the Western Hemisphere.](#)' This link will take you to the [full recording](#) of the conversation the whistleblower had with Devra West in March 2003; she was unaware that she was being recorded. [7] & [8] View this [document](#) to reveal the totally false statements that Geoffrey Reynolds, a total stranger to the whistleblower, made to a Montana court as part of Devra West's conspiracy to bankrupt the whistleblower. Reynolds's own resume, still up on his website at the time of his false statements, clearly shows that he was living and working in Cave Creek AZ until he travelled to Flathead Lake to commence his employment with Devra West in September 2006.

While attending court in Montana, to see how much the court were going to award him for his win against Devra West for fraud, both West and her stooge Reynolds [served the whistleblower for defamation](#). The whistleblower was served for defamation even though he was telling the truth about Devra West, and even though the other party Reynolds did not know him from Adam. Unable to afford to travel from the east coast of Canada to defend their lies his websites were forced down and he became the subject of two default (undefended) judgments amounting to \$5,000,000 i.e. \$10,000,000 in total.

This is how criminals behave; if they cannot intimidate you or murder you, they outspend you in court and 'buy' the result they want. This occurred in 2010, and with no information on the internet to contradict Devra West's lies, deceit and propaganda she and the cult moved to Geoffrey Reynolds' old home town of Cave Creek AZ, where she reincarnated herself with a new name, new fake life story and the latest iteration of her 'divine being' criminal business model the [\[www.omniawakening.org\]](http://www.omniawakening.org).



[19] Here is a statement by Williams which West posted her website shortly after reincarnating herself in Arizona as the Ascended Master 'Rishi Devra.' This particular [statement](#) is an appeal by Williams on behalf of Devra West for funds for the 'Divine Feminine.' Williams agreed to front this appeal for public money knowing that Devra West was using his perceived 'respectability' as a doctor and heart surgeon to give her criminal activities credibility amongst the public. In private Williams was obviously aware that Devra West had a propensity for violence especially towards the female members of her cult.

[20] The next image shows just how deeply Williams is aligned with Devra West's criminal activities in that he actually rented a property close by where she was residing so that he could host 'Sacred Sundays with Rishi.' If you have followed this information thus far you will know that there is nothing sacred about Devra West or her motives towards spiritual seekers. Note in the image below the statement that these activities are being hosted in Dr. Julio Williams' home! Also note the sycophantic gushing testimonials from Williams who is clearly a willing accomplice or totally brainwashed by West.



[21] Devra West was the recipient of two arrest warrants in Montana, one for [criminal check fraud](#) and one for [felony theft](#). She was [convicted for assaulting](#) a local female doctor and was the subject of a [Sheriff's Sale](#) to force her to pay her creditors \$2,000,000 in court fines and interest. He was obviously aware of the vicious assault against fellow physician, Dr. Pat Cole MD, as detailed in the [Whitefish Pilot](#) newspaper wherein Devra West repeatedly hit the victim over the head with the heel of her shoe until blood ran down her blouse. He was obviously aware of two earlier vicious assaults against employee [Susannah Felder](#) and student [Beatrice McGuire](#) the former being partially scalped and the other needing plastic surgery to reattach part of her ear after psychopath Devra West ripped it off. All of this occurred between the years 2000 and 2009 and yet in 2014 and beyond Williams is lying to the public as part of his role to procure fresh victims for West and her insatiable appetite for money and control over the lives of others.

[22] See [15] above where Williams describes his cult leader Devra West as a "virtual wellspring of living divinity." Do the facts bear out his description of Devra West or is Williams acting in concert as a willing accomplice with Devra West in what is obviously a criminal racketeering business model that uses murder and violence to achieve its ends.

[23] It is the whistleblower's belief (and many others) that ex-student Lisa Swidler was murdered by Devra West in 2005, after being a witness to Devra West defrauding ex-student Dave Kushner out of \$30,000 and kidnapping, holding captive and extorting tens of thousands of dollars from ex-student Marion Cantwell earlier in 2005. West had motive and opportunity and after all the weapon West uses to murder her adversaries is not regarded as a weapon by legal statute so the sudden death of West's adversaries will appear to be death as a result of 'natural causes.' Only the senior members of West's cult i.e. Reynolds (who predicted John Watson's death ten days before West made her attempt), Williams and ex-husband Jack West know the truth.

[24] [Jeremy Samuelson](#) and Jack West were business partners until Devra West overwhelmed Jack West and started to 'run' him. According to Jeremy Samuelson, Devra West was a pot grower and by definition a drug dealer. The two of them conned him out of \$10,000. Devra West attempted to be a legitimate business woman but after her jewelry business went into bankruptcy she went back to the only career she really excels at which is conning people.

In 1990, she decided to leverage her criminal activities by acquiring occult hidden knowledge at the '**Robert Jaffe School for Energy Mastery**' that she intended to use to feather her own financial nest at the expense of everyone she met. This included a fellow student [Satya](#) also attending the course from whom she defrauded out of \$6,000. After finishing the course in 1991, Devra West declared herself to be an Ascended Master, and since that time, she has led a criminal racketeering gang that has dabbled in countless criminal acts from theft all the way to murder. 

This while inviting single donations from the public of up to [\\$500,000 from her website](#) based on a [fake life](#) story and while charging [hundreds of thousands of dollars](#) for '[divine grace healings](#)' and '[dispensation of karma!](#)' neither of which she can obviously deliver! If she was 'marketing' any other product she would be shut down and jailed but religious freedom laws allow this, at the very least, mail and wire fraud.

[25] Employee Carlida Finch overheard Devra West planning the murder of her business partner / student, Dr. Pat Cole MD; follow [this link](#) to read what Carlida Finch told the authorities about this matter. [Marion Cantwell](#) was kidnapped, beaten, had tens of thousands of dollars extorted from her and when she was eventually released she was told that if she went to the police she would be murdered (like Lisa Swidler was shortly afterwards). Devra West's comment that it was "a good day to die" may seem fairly innocuous until one understands the context of what was going on around her at the time, as spelt out in a [series of emails](#) she sent to the whistleblower that year. The occasional murder by Devra West lets everyone in the cult know what may happen to those who break the vow of silence as did happen to Lisa Swidler and was intended to happen to John Watson.

[26] [27] & [28] Rebecca West's email entitled '[Help Me](#)' references Devra West's use of 'shamanic witchcraft.' Both Jamie Haywood's [email](#) to the whistleblower and her [testimony in court](#) clearly reference Devra West's use of witchcraft against her and her infant daughter, as West sought to intimidate Jamie into giving up her infant daughter to West's porn loving, wife beating son. This ploy did work a few years earlier when West managed to destroy her son's first wife Kendal with the result that the custody / court hearing was totally subverted resulting in the courts awarding West's son with their infant female daughter even though Kendal was squeaky clean and Devra West's son had an [FBI record](#) for forgery, substance abuse and motor vehicle infractions.

[29] The latest images from Devra Patton West. As the years go by and the authorities fail to act against this suspected serial killer her idiotic claims of divinity are matched by her ludicrous wardrobes as she desperately seeks to ape an Indian deity / Greek goddess.

Nowhere on her website and in her fake life story / bio will you find any mention of her multiple arrest warrants, convictions for assault, several appearances in court as the defendant in fraud related lawsuits, the forced sale of her assets to pay her creditors \$2,000,000 in court fines and interest and the multiple acts of violence against female members of her cult. This narcissist has two policies that she always insists upon. The first is that all in her presence adhere to a strict **'protocol'** when interacting with her; remember she believes that her ability to operate outside the law, commit multiple murders without consequence makes her a 'divine being' worthy of worship and respect. More to the point anyone she interacts with must submit to her will or face the consequences which can range from a fine (on a good day) to a violent assault on a not so good day (read statements from AJ White & Debra Coffey as to what happens to those who do not submit to her will. The second policy she has is that when appearing in front of her cult or the various seminars she holds to audition for new victims she dresses up but when having arrest warrant photos taken she dresses down and wears glasses in a vain attempt to disguise herself.

[30] Below an excerpt from [a recent posting](#) from her Facebook page. Part of the barrage of lies, deceit and propaganda (the sales pitch) that would have you believe that this occult thief / suspected serial killer is a 'divine being.'

[31] In 2003, two of West's then employees her secretary Diane Stoner and her housekeeper, Kathleen Francisco, reported that Devra West got very animated after a phone call and announced to the that [she had just earned \\$500,000](#) presumably for either healing a victims nonexistent ailment or after using her occult abilities to make the victim ill and then claiming to cure her after removing the condition she had put there in the first place. This is one of the methods she is currently using to extort millions from victims who she 'blesses' by her presence!

Clearly, Devra Patton West and her accomplices should be prosecuted under the 'Racketeer Influenced and Corrupt Organizations Act' (RICO).

Pattern of racketeering activity requires at least two acts of racketeering activity, one of which occurred after the effective date of this chapter and the last of which occurred within ten years (excluding any period of imprisonment) after the commission of a prior act of racketeering activity. The US Supreme Court has instructed federal courts to follow the continuity-plus-relationship test in order to determine whether the facts of a specific case give rise to an established pattern. Predicate acts are related if they "have the same or similar purposes, results, participants, victims, or methods of commission, or otherwise are interrelated by distinguishing characteristics and are not isolated events." (H.J. Inc. v. Northwestern Bell Telephone Co.) Continuity is both a closed and open ended concept, referring to either a closed period of conduct, or to past conduct that by its nature projects into the future with a threat of repetition.

And...

Under RICO, a person who has committed "at least two acts of racketeering activity" drawn from a list of 35 crimes—27 federal crimes and 8 state crimes—within a 10-year period can be charged with racketeering if such acts are related in one of four specified ways to an "enterprise". Those found guilty of racketeering can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count. In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."

RICO predicate offenses

Under the law, the meaning of **racketeering activity** is set out at [18 U.S.C. § 1961](#). As currently amended it includes:-

- Any violation of state statutes against [gambling](#), [murder](#), [kidnapping](#), [extortion](#), [arson](#), [robbery](#), [bribery](#), dealing in [obscene matter](#), or dealing in a controlled substance or listed chemical (as defined in the [Controlled Substances Act](#));
- Any act of [bribery](#), [counterfeiting](#), [theft](#), [embezzlement](#), [fraud](#), dealing in obscene matter, [obstruction of justice](#), [slavery](#), [racketeering](#), [gambling](#), [money laundering](#), commission of [murder-for-hire](#), and many other offenses covered under the Federal criminal code ([Title 18](#));

- [Embezzlement](#) of [union](#) funds;
- [Bankruptcy](#) fraud or [securities fraud](#);
- [Drug trafficking](#); long-term and elaborate drug networks can also be prosecuted using the [Continuing Criminal Enterprise Statute](#);
- Criminal [copyright infringement](#);
- [Money laundering](#) and related offenses;
- Bringing in, aiding or assisting [aliens](#) in illegally entering the country (if the action was for financial gain);
- Acts of [terrorism](#).

If we just take the most serious crimes committed by Devra Patton West as part of her ‘World Service’ efforts in recent times, we find that there are no less than 9 ‘Predicate Offenses’ she should be charged with some of which she has committed on multiple occasions! Reynolds qualifies under at least 3 ‘Predicate Offenses.’

Let us start with the most serious crimes mentioned in the RICO list of **predicate offenses** mentioned above and work our way down to some of the less serious offenses.

1. The murder of Lisa Swidler. In or around the 2005 timeframe, Devra West committed in quick succession, two serious crimes against two of her students and members of her cult. (See Dave Kushner and Marion Cantwell below here). Another student / cult member, Lisa Swidler, was a witness to these crimes and as a result of what she saw, tried to leave the cult. Shortly after escaping, Lisa died suddenly and mysteriously of internal bleeding.



Lisa was a friend of the whistleblower and his wife and at the time, in 2005, he thought that it was strange, but it was only after he became the subject of a murder attempt by Devra West that he became convinced that Lisa was murdered by Devra West to keep her from going to the police.

2. The threatened murder of Dr. Cole MD. In 2006, a local female doctor was threatened with murder by Devra West if she did not empty her bank account into Devra West’s. [Carlida Finch](#) in her statement to the authorities, states that she overheard Devra West talking about the murder of Dr. Cole MD. View the victim’s comments by reading what she told the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers. These publications also detail other criminal acts underway at the time by Devra West and her gang. Long story short, after a sustained campaign of overt and covert violence against the victim and unfavorable witnesses (designed to [obstruct justice](#)) Devra West succeeded in extorting \$1.3 million from Dr. Cole MD.

3. The attempted murder of the whistleblower. The whistleblower, like many other ‘professionals’ victims of fraud and extortion, was recruited by Devra West into what he thought was employment by a regular corporation. All too late, he found out he was working for a cult / criminal racketeering gang led by Devra West. After being [defrauded](#) out of wages and shares in 2002, the whistleblower sued Devra

West for fraud; a lawsuit he won in 2008. In December 2006, the whistleblower became the subject of a campaign of occult 'under the radar' violence intended to **obstruct justice** by intimidating the whistleblower into calling off his lawsuit. In August 2007, Devra West tried unsuccessfully to murder the whistleblower, something her accomplice in crime, [Geoffrey Reynolds](#), shared with the press two weeks before she made her failed attempt. Doubtless, Reynolds was briefed by West about other murders she had gotten away with, including that of Lisa Swidler two years earlier (see above).



After the failed murder plot, some three years later in 2010, both West and her stooge 'Rat Reynolds' mounted a joint criminal conspiracy to bankrupt the whistleblower for a) successfully suing Devra West for fraud and b) going public about their criminal / racketeering business model.

4. Mike Hendrickson defrauded out of \$200,000. In or around 2004, and after Devra West's charity was struck off for fraud, Devra West stole \$200,000 from the charity's bank account and put it in a personal trust fund for herself and her eldest son, Rob Meador. Because ex-student / cult member Mike Hendrickson had signed a 'note' guaranteeing these funds at the bank, Mike Hendrickson had to cover that note by writing out a check to the bank for \$200,000. Because of the fear of being targeted and murdered, Mike Hendrickson chose not to pursue a court case against Devra West. The [Whitefish Pilot](#) mentions Mike Hendrickson briefly.

5. Dave Kushner defrauded out of \$30,000. In 2005, ex-student / cult member [Dave Kushner](#) phoned the whistleblower to advise that he had been defrauded out of \$30,000 by Devra West. Dave explained that he had agreed to loan \$30,000 to Devra West, on the understanding that it be repaid within two weeks. However, in spite of a written agreement that was signed by Devra West, the money was never repaid and Devra West refused to meet or even discuss the matter with Dave Kushner.

6. Marion Cantwell defrauded out of tens of thousands of dollars. In 2005, ex-student / cult member Marion Cantwell, who had just sold her house, was **kidnapped**, falsely imprisoned and beaten until she agreed to give up part of the sale proceeds of her house to cult leader, Devra Patton West. After making a large 'donation' Marion was released and told that if she went to the police she would be **murdered**.

7. Montana charity defrauded out of several millions of dollars in public donations. While working as a consultant for Devra West between January 2002 and August 2002 the whistleblower, working with and off information given by Devra West's then bookkeeper, Cheryl O'Brien, realized that Devra West and her husband, Jack West, had an elaborate multi-layer fraud in place:-

Level 1. The charity did not have separate bank accounts – all public donations went into a joint bank account owned by Devra & Jack West; most of the money being **stolen** to fund West's extravagant lifestyle, which included buying \$2,000 pearl necklaces at airport shopping malls.

Level 2. Devra West, who did not have any other source of declared income at the time, would hold three seminars a year, on behalf of the Sacred Arts Institute (owned by the charity) which would bring in about \$90,000 gross; about \$50,000 a year net of expenses. Devra West would invoice the charity \$100,000 for her 4 or 5 day appearances at these seminars thus emptying the charities bank account of the \$50,000 profit it acquired for running the seminars and putting the charity \$50,000 in debt to Devra West. Clearly the 'charity' was a charity in name only, whose objective was sucker in public donations for good causes that never came into being because Devra West **stole** all of the money.

Level 3. In January 2004, and after the whistleblower had written to the Secretary of State for Montana revealing the fraud, Devra West's charity was **struck off** for fraud. At this point, Devra West presented all the fake IOU's and claimed the charity's main asset (a property worth \$1,250,000 in 2002) in lieu of cash. Further, \$4,000,000 worth of art work and valuables, as valued in 2002, went missing and turned up ten years later at auction in Cave Creek AZ, and was advertised for sale from her website. Currently these items can be viewed on her website as part of the '**Rishi Collection.**' It is clear that Devra West stole these items from the charity (**theft**) and hid them in a lock up until the statute of limitations for theft had passed. Like then, property, the artwork and valuables were substantially paid for or gifted to the charity.



Above left; Devra West standing next to one of the items she told a court under oath in 2009 did not exist and yet in 2014 these items, worth several million dollars, valuables turned up at auction and on her website for sale. Center; note on Devra West's left arm the gold watch she told the court in 2009 that was stolen. That photo, part of a '[go fund me](#)' campaign to pay for her dental fees even though she is obviously worth many millions!

It is clear that Devra West, while being deposed by the whistleblower's lawyer in October 2009, lied from start to finish about the whereabouts of the missing artwork and valuables owned by the charity. She stated that the items were lost or stolen and that she had given up all personal possessions etc. She was also asked about the whereabouts of an expensive gold watch gifted to her by a wealthy heiress (see above). West replied that it too was stolen, and yet in 2014, it too was seen on West's wrist in a photo taken while she was showing off the millions of dollars in stolen art work and valuables in Arizona.

Above left and right are excerpts from the statement taken from Master Liar Devra Patton West while being questioned by the Montana court about several million dollars of valuables that went missing in 2004. Top right, bottom paragraph, when asked who compiled the list of assets belonging to the charity that Devra West was shown she replied "Esther Michaels." West knew all too well that it was the whistleblower that compiled the list of assets belonging to the charity in 2002. Esther Michaels was the whistleblower's replacement and another professional screwed by Devra West as part of her guru / cult / extortion racketeering business model.

8. Devra West & Geoffrey Reynolds Extortion & Money Laundering. It is obvious from the statements of witnesses trapped inside the cult, that Devra West was operating a criminal racketeering business model disguised as a quasi-religious organization that hid the existence of a cult. What follows is the opening paragraph of one of several emails sent to the whistleblower by Rebecca West (no relation to Devra West) in March of 2007, when Devra West was operating in the Flathead Lake district of Montana as the Ascended Master 'Surya Ma.' Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5

p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available.

With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her. Dr. Cole was forced hand over her home to Devra West and forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating.

I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds CPA] is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

Reynolds was interviewed by the [Bigfork Eagle](#) newspaper on August 9 2007 and, speaking on behalf of his employer / cult leader, made the following statements:-

Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millenium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

It is very clear from Rebecca West's email above, that Geoffrey Reynolds CPA was well aware of the criminality taking place in his place of employment and that, after loaning West \$300,000, he too was obliged to become a senior member in her criminal racketeering gang. It is also very clear that Geoffrey Reynolds knew about the violence meted out by Devra West upon Dr. Pat Cole MD, as part of a campaign to extort Dr. Cole's entire net worth from her estimated to be \$1.3 million which included a property worth \$750,000, in addition to the cash mentioned above. After all, Reynolds was in 2007 desperately trying to force a copy of West's written admission that she had assaulted Dr. Cole MD off the whistleblower's website! That statement, entitled '[The Law of Severity on the Path to Purification](#)' had been emailed to West's entire cult mailing list.

In his statement to the [Bigfork Eagle](#) above, Reynolds makes it clear that he personally **money laundered** \$621,484 through West's business Sacred Environments LLC, making it look like the money was received as part of normal business receipts. He did so after his predecessor resigned rather than be forced to 'manufacture' false invoices!

9. Attempted Fraud of \$30,000,000 in CPEA grant money. In or around the 2006 / 2007 timeframe, Devra West and Geoffrey Reynolds attempted to receive \$30,000,000 in CPEA grant money after filing an application that failed to mention a) the true nature of the entity asking for the monies i.e. that the corporation was a front for Devra West and her cult and that b) as stated in correspondence by [Rebecca West](#) and Devra West's own step mother, [Carol Patton](#), at least \$2,000,000 of the \$30,000,000 applied for was to be diverted to pay off Devra West's debts.

10. Obstruction of Justice in the matter of two custody cases involving the infant children of her son's ex-wives. On July 12 2007, Devra West appeared in court to give statements on behalf of her porn loving / wife beating son, Chris Haywood who as it happens, has an FBI record for forgery, substance abuse and traffic violations – like mother and son. It is clear that Devra West had targeted Chris Haywood's then wife, Jamie Haywood, using occult 'under the radar' violence, in an attempt to intimidate Jamie into giving up custody of her infant daughter to Devra West's son. This is a clear attempt to **obstruct justice**. Go [here](#) to read the harrowing email that Jamie Haywood sent to the whistleblower the day before the custody hearing; note within that email Jamie's reference to being targeted by Devra West's occult witchcraft. Go [here](#) to read the second part of the court transcript where Jamie mentions to the court being the target of West's occult witchcraft and describes her sordid home life with Devra West and her son Chris Haywood. Jamie also confirms that she saw Devra West strike Dr. Past Cole MD.

Devra West and her son failed to get custody of Jamie Haywood's infant daughter, but what the reader should note is that a few short years earlier, Devra West and her son mounted the same strategy against Chris Haywood's first wife, Kendal, only this time it worked. What I am saying loud and clear is that Devra West used a combination of occult 'under the radar' violence against Kendal which, when combined with false witnesses from her cult (Dr. Cole MD), made it possible for her to totally subvert and obstruct justice to get the outcome she wanted.

11. Many other counts of robbery, theft and obstruction of justice by Devra West some aided and abetted by members of her cult. For example, during the fraud lawsuit that the whistleblower took out against Devra West in 2003 and won in 2008, Devra West, in addition to using 'under the radar' occult violence, employed members of her cult to intimidate the whistleblower into withdrawing his lawsuit. The email sent by senior cult member Julio Williams, a short excerpt of which is seen below, being just one example.

In addition to threats, Devra West employed false witnesses from her cult, who were instructed to write totally false statements about the whistleblower that she intended to use against him in court. 

In addition to employing cult members to make threats and create false witness statements, in themselves blatant attempts to 'obstruct justice,' let us not forget that senior cult member Geoffrey

Reynolds CPA also shared Devra West's plan to **murder** the whistleblower with the [Bigfork Eagle](#) newspaper reporter, some two weeks before Devra West made her failed attempt on his life. This is how the latest con works. A series of seminars are announced by the 'divine being' like these currently being advertised.....


A series of 'private sessions' 'private audiences' and 'private intensives' like the dates currently listed below are then offered to lure potential victims into the 'kill zone.'

Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. **Divine Grace Healings.** Victims are convinced that they are suffering from a totally non-existent brain tumor or a cancer, which Devra West guarantees she can cure for a large fee. In reality Devra West, having identified a wealthy target, induces the symptoms of a serious illness in the victim using the same occult knowledge she uses against those who oppose (see above).



2. **Karmic Resolution.** Devra West convinces the targeted individual that she and they were sisters in a former lifetime, during which, the target betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for those nonexistent wrongs). If the target does not agree to pay the target becomes the subject of a campaign of occult attacks designed to convince them to pay!

Devra West has been perpetrating this extortion racket for at least two decades.

The 'Divine Grace Healing Scam.' Two of her admin staff who worked for her in 2002, overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to [two of her admin staff](#), Diane Stoner and Kathleen Francisco talking about one this.

The 'Karmic Resolution Scam.' Devra West uses this scam against wealthy female heiresses like the one below who, having 'donated' millions to her charitable causes. After the heiress' son found out how much money had been given / extorted by Devra West, he phoned Devra West demanding that the money be returned! Please read [this email from Devra West's office manager](#) in 2007 wherein she writes about this matter and many others.



Above: Devra West extracting millions of dollars from a wealthy heiresses who she convinced owed her from a previous lifetime. With others she just promises to remove bad karma for a very large fee!

Remember, Devra West is an Occult Master who can, using Shamanic Visioning, induce illness, injury and even death in those she targets with little chance of the crimes being connected back to her. In the above scam, she ‘induces’ the symptoms of serious illness in those she targets and then miraculously cures them after they go to her ‘Pay Portal’ and make a large six figure ‘donation.’ She got \$500,000 from one victim in 2002 for doing just this!

Step 3. The victims go to the Sage of Sedona’s [‘Pay Portal’](#), recently updated, which is now set up to receive single donations of \$500,000 or more by pressing one or a combination of buttons and empty your bank account into hers. Note her standing there with her hands out saying “give me, give me.”



This well-oiled criminal / racketeering scam has been going on for 27 years right under the noses of the FBI and the IRS. At the very least, it is wire and mail fraud! At the very least, it is illegal for a lay person, even if they are claiming to be a ‘divine being’ to be able to cure / heal

someone. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
