

Subject: Geoffrey Reynolds CPA – Ex-Devra Patton West (Rishi Devra) cult / gang member desperate to leave his criminal racketeering past behind.

### **Geoffrey Reynolds CPA – Ex-Devra Patton West (AKA Rishi Devra) cult / gang member desperately trying to leave his criminal / racketeering past behind.**

Like many others before him (from all over the USA) Geoffrey Reynolds applied for employment with Devra Patton West, believing that he might end up working for a regular corporation. Unfortunately for Reynolds, he found out all too late that he had been duped into giving up his respectable life in Cave Creek AZ in September 2006 to travel to Flathead Lake MT to join a cult / criminal racketeering gang run by Devra Patton West.

West, an ex-bankrupt, pot grower and drug dealer and small time con artist had previously been chased out of New Mexico by one gun wielding victim in 1995, been forced to leave Victor MT, where she was masquerading as the Ascended Master [Devra Ji](#), after her charity was struck off for fraud in 2004. However, after moving north 100 miles and, complete with a new identity and new fake life story, she was soon operating her 'divine being' fraud scam in Flathead Lake MT masquerading as the Ascended Master [Surya Ma](#).

The difference between Geoffrey Reynolds and the whistleblower John Watson, who refused to join Devra West's cult or turn to organized crime, is that Geoffrey Reynolds is both incredibly stupid and

totally corrupt. To demonstrate just how stupid and how corrupt, we need to detail a series of events that occurred before Reynolds travelled from Cave Creek AZ to commence his employment with Devra West in September 2006. In brief:-

1. In 2001, Devra West viciously assaults and partially scalps ex-employee [Susannah Felder](#) who discovered West had stolen \$80,000 from the charity 'The Circle of Divine Unity.'
2. In 2002, West viciously assaults ex-student [Beatrice McGuire](#) in front of an audience resulting in the victim needing plastic surgery to have part of her ear re-attached.
3. In 2004, West charity is **struck off** for fraud.
4. In 2004, West commits a massive fraud against the IRS and the State of Montana by stealing the charity's main asset, a property largely funded by public donations, by claiming it in lieu of a series of fake loans. The property and \$200,000 she defrauded from ex-student Mike Hendrickson both ended up in a personal trust fund for Devra West and her eldest son Rob Meador. Later in 2008 the contents were to become the subject of a Sheriff's Sale. This was part of the massive fraud the whistleblower uncovered in 2002 which led to him being defrauded and constructively dismissed. At the same time Devra West steals \$4,000,000 of artwork and valuables from the charity also largely paid for by public donation and hid them in a 'lock-up' until the statute of limitations expired in 2014 at which time they would reappear as if by magic.
5. Desperate for money to fund her lavish lifestyle Devra West defrauds ex-student [Dave Kushner](#) in 2005 of \$30,000 and kidnaps, holds captive ex-student [Marion Cantwell](#) in 2005 until Marion agrees to 'donate' tens of thousands of dollars to Devra West. When released she is told she will be murdered if she goes to the police.
6. A third student Lisa Swidler, who witnessed the crimes committed against Dave Kushner and Marion Cantwell tries to escape the cult and is murdered by Devra West also in 2005. In truth we cannot say that Lisa was murdered because the weapon used by Devra West to kill her is not recognized as a weapon by legal statute leaving Devra West with a license to kill whoever she pleases.

7. In 2005, with no charity or corporation to act as a 'container' for her criminal / racketeering business model Devra West writes to her brain washed and conditioned students / cult members and informs them that she is having to move from her current location in Victor MT (where she has worn out her welcome) a hundred miles north to Flathead Lake MT. She explains this by saying that because she has moved from the [5<sup>th</sup> dimension to the 7<sup>th</sup> dimension](#) she must move to a more rarefied vibration and that the 'Masters' are preparing Shamballa for her arrival. She also explains that she can only take 12 disciples with her and only those who are prepared to commit [66% of their net worth](#) to her projects (herself).

8. One of those disciples was Dr. Pat Cole MD. Unfortunately for Dr. Cole, she was a little slow in giving up her 66% so Devra West mounted a campaign of violent assaults, both overt and covert, against Dr. Cole which resulted in the police being called on or around the 15 of April 2006. There is zero doubt that Devra West assaulted Dr. Cole MD, as there were many witnesses and the police attended the scene, took statements etc. However, the clincher was that two days later on 17 April 2006, Devra West wrote to her entire mailing list in an attempt to both quell the unease being expressed at the violence and in an attempt to justify the assault without admitting the fact that it was part of a campaign to extort \$1.3 million from Cole which West succeeded in doing. ### *The Law of Severity on the Path of Purification*

Response to the Call of **Master Surya Devi for Review**

April 17, 2006 From Master El Morya of the Shamballa Councils

What must be taken into account in all matters of review on the part of the Shamballa Councils is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:


At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

At around the time Dr. Cole MD was being brutalized, another employee of Devra West's, Carlida Finch, also made statements to the authorities about Devra West's brutality. After she was effectively fired for refusing to join Devra West's cult, she decided to share some of her experiences with the authorities which in the end did not do her much good because Devra West always has at her disposal several cult members who are prepared to provide her with false witness statements making it very difficult for victims to get justice.

Which Devra West succeeds in doing at a cost of a \$500 fine and a 6 month suspended jail sentence.



### Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

**Dr West** was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

Above, there is no 'Dr. West' unless you count the two fake doctorates Devra West says the [Christ gave her in person](#). Also note the comments about "taking a hammer and breaking every bone in her hands." Note the comment from West that she did not care if she "killed Pat." Note that the following day after these comments that Dr. Cole came to work with "bruises on her hands and wrists." And finally, note that the psychopath Devra West refers to her meditation with a group of enlightened beings / Masters about the "altercation with Dr. Cole MD." See point **8**. Above.

On March 23, 2006 at 4:50 PM Devra wrote a letter offering jobs and signed my name to it. She then asked me as I was walking out the door on that Friday evening to post the letter at health food stores and yoga centers over the weekend. I took the flyers and decided that I was very uncomfortable posting jobs in my community that had my name on it. This discomfort came from the fact that according to the financial manager, Betsy Blank there was \$1000.00 in the bank and the promised funding that Devra had been trying obtain was not secured. I was also becoming apprehensive about the entire atmosphere, Devra's verbal abuse of Dr. Pat Cole, the attempt to find funding from viatical securities made me very uncomfortable. I was uncomfortable with the fact that Devra seemed to be creating liabilities for her books based on what she stated her previous non profit organization owed her. I had witnessed her putting together those figures by asking Dr. Cole, who was the president of the non profit, to go within and ask the Masters how much Dr. Cole owed Devra as a result of the dealings of the non profit (Global Guardianship Initiative). The final figure the "Masters" gave was \$18 million. (Please see Devra's website universalteachings.org)

Note above the highlighted portions of this statement. 'And signed my name.' Devra West has a practice of writing letters herself that she attributes to others this includes fake testimonials and fake witness statements. Mention of the then, financial manager **Betsy Blank**, is very important in that she resigned rather than be forced to manufacture false invoices to make it look like the hundreds of thousands of dollars extorted from Dr. Cole MD was received as normal business receipts. Carlida wrote [a separate email](#) to the whistleblower confirming that this was the case. It is also important because **Geoffrey Reynolds CPA** was hired as her replacement and he had no problem with manufacturing false invoices to money launder the proceeds of crime through Devra west's business. Note the comments about the verbal abuse of Dr. Cole MD.

It appears that Devra West was creating liabilities based on what the charity she had defrauded and bankrupted owed her?? See point 4 above. Finally, nothing better illustrates this tyrant's domination and manipulation of others than the final comments by Carlida Finch in the paragraph above. Psycho bitch Devra Patton West, having brainwashed and conditioned Dr. Cole to obey her every command tells Cole to "go within and ask the Masters (how much Cole owes her)." The final figure, after Cole repeatedly comes up with a lower figure, \$18,000,000. If this is not extortion I do not know what is.

Here is another excerpt from Carlida Finch's statement to the authorities.

I have written the above in an attempt to show the atmosphere in which I had been working. **My claim has been denied because I did not show how this affected me. Firstly, it is my understanding that I am protected under the constitution. Employers are bound by the laws of the "state"; I am not obliged to declare religious allegiance in order to keep my job. Secondly, I did not make any attempt at that time to resolve the issue because I had already had a confrontation with her over the job flyers and in light of the "assault" on Dr. Pat Cole that had occurred, I was afraid of Devra .** To further illustrate the working environment I am including a copy of an element of the policies and procedures manual to further illustrate the atmosphere.

As I have explained in previous bulletins based on hundreds of documents and the statements by the whistleblower, neither State nor Federal Laws apply inside Devra West's cult, she is the only law of the land which includes holding the position of both judge and executioner. I have no doubt that Carlida Finch was afraid of Devra West. There is a mountain of evidence to show that at the very least, Devra

West is a dangerous psychopath at the head of a criminal racketeering business model and at worst a serial killer.

**D.** And finally, her letter to the police (dated Nov 13 2006) asking for protection [by going here.](#)

**The important point to establish here is the timeline. Carlida Finch's correspondence with the authorities started in late April 2006, shortly after Devra West's vicious assault upon Dr. Pat Cole which resulted in the police being called and Devra West eventually being convicted of that assault in April 2008.**

**AT THIS POINT, IN SEPTEMBER 2006, ENTER GEOFFREY REYNOLDS CPA WHO REPLACED HIS PREDECESSOR BETSY BLANK WHO RESIGNED RATHER THAN BE FORCED TO 'MANUFACTURE' FALSE INVOICES.**

What follows is a list of very bad choices that Geoffrey Reynolds made shortly after joining Devra West's cult. Choices that may result in Geoffrey Reynolds being the subject of criminal trial, swinging fines and possibly subject to a very long term in jail. (Each single offence tried under RICO statutes is subject to a \$10,000,000 fine and a ten year prison sentence.)



### **1. First and biggest mistake lending \$300,000 to the head of a criminal gang.**

Shortly after commencing his employment, Reynolds swallows Devra West's lies and propaganda about her being an altruistic humanitarian trying to single handedly save the world. As a consequence of his stupidity and gullibility, he decides to lend Devra West his life savings amounting to \$300,000. Just FYI, in spite of raising tens of millions of dollars for so called 'good causes' there is zero proof that any of the funds raised have been used for those good causes. On the contrary, there is a long history of Devra West forcing members of her cult, students, employees and professionals like Reynolds, John Watson and countless others to fund raise for projects that never come to fruition. To be clear, the money all goes into her bank accounts or is spent funding her delusions of grandeur. **Reynolds is on the hook and cannot get free!**

### **2. Failing to report multiple crimes being committed by Devra West against other employees right under his nose.**

A series of emails from ex-employee Rebecca West (no relation to Devra West), who like many others was trapped inside Devra West's cult, show the criminal nature of Devra West's 'business model' as it was in March 2007. Below are two excerpts from a couple of those emails that show clearly that Geoffrey Reynolds CPA was totally under the control of Devra West (because he had loaned his life

savings to her) and willing to turn a blind eye to the criminality that was occurring right under his nose. Here are two excerpt from an email entitled [‘Help Me.’](#)

*This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates etc. etc....*

And...

*Tanmayo's (Coca-Cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.*

And this from another email entitled ‘What is your status at this point?’

*I received partial payment for my massive overtime hours but is far short of what she owes me and also does not include my credit rating damages, telephone charges, etc., etc... My meeting yesterday with the Finance Controller [Geoffrey Reynolds CPA] was to discuss my unemployment issues as he had agreed to put me into a lay-off status, but has since reported to the State that I voluntarily quit! He recently treated a former employee as laid-off after Devra threw a book at her and then fired her. The companies owe large sums of money for WC, and ST, and Fed payroll taxes and was the reason he secretly laid-off Wendy Stuart, without confirming this choice with Devra first. He [Geoffrey Reynolds CPA] was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job.*

*Devra dangles the carrot and since he has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.*

### **3. Geoffrey Reynolds CPA learns to tell lies like a real pro!**

We already know from the above information from Carlida Finch and Rebecca West that Devra Patton West was operating a criminal racketeering business that was disguised as a quasi-religious organization which was in reality operating as a cult. We also note that there was a strict code of secrecy which was enforced by West's ability to use occult hidden knowledge (shamanism) to harm, injure, make ill and if necessary to murder those who oppose her – Lisa Swidler being a recent example. Below is a further excerpt from Rebecca West's harrowing email entitle ‘Help Me’ that makes this point clear.

*“I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?”*

We know from Rebecca West's emails that Geoffrey Reynolds CPA knew that Devra West was committing crime after crime right under his nose, but that he chose to turn a blind eye to save his own ass, his marriage, his life savings and his CPA license. On July 12 2007, the first of two newspaper articles was published by the [Whitefish Pilot](#) (as a result of the information the whistleblower had shared) about Devra West's criminality in both Victor MT and Flathead Lake MT. It came as no surprise, given that Geoffrey Reynolds was totally controlled by Devra West, that he quickly published four statements of denial on her website.



*Rishi Devra has been guiding my life for many years. I am honored that she allows me to help her global awakening move forward.*

Within the emails, apart from berating the victim Dr. Cole MD, Reynolds vilifies the newspaper editor for publishing what Reynolds refers to as 'small town religious bias.'

**It is obvious from the documentation provided above, that 'liar for hire' Geoffrey Reynolds was well aware that Devra West had assaulted Dr. Cole MD, that the police were called and she was the subject of an assault investigation and that she had written to her mailing list [admitting the assault](#).**

Quite by coincidence, and also on July 12 2007 the date the Whitefish Pilot newspaper article was published, Devra West appeared in court as a witness for her porn loving / wife beating son who was fighting for the custody of his infant female daughter from his second wife Jamie Haywood. Just FYI Jamie also reported to the whistleblower in a [harrowing email](#) that she too was the subject of a campaign of occult 'under the radar' violence directed at her by Devra West in an attempt to get Jamie to give up her daughter before the custody hearing! Long story short, Devra West was interviewed by the court and during that interview [denied assaulting Dr. Cole MD](#), asserted that the many ex-employees who accused her of mental and physical abuse were "[fabricated and fictitious](#)."

And finally when asked if her business interests were multi-billion dollar affairs she replied, "Yes." Even though she was in the process at the time of being evicted from two rental properties and had a lien for \$2,263 against her for employment insurance (see [Bigfork Eagle](#) newspaper below here)! Obviously Reynolds who was present in court as a witness for her must have known she was lying about her finances. The point of bringing up the custody hearing is that who should be wheeled in as a 'witness' for Devra West and her son, Chris Haywood (who has an FBI record for forgery, substance abuse and traffic violations)? None other than Geoffrey Reynolds CPA, who at that point had known Devra West for some 10 months since joining her employ in September 2006! You can read the three part custody hearing transcript by going here [1, 2 & 3](#). Part one contains Devra West's testimony to the court which as usual was a pack of lies from start to finish! Part two of the transcript includes Jamie Haywood's testimony wherein she lays out all the dirt about Devra West, her son and their sordid home life.

However, Geoffrey Reynolds was not done lying yet as we can see from the interview he gave the [Bigfork Eagle](#) newspaper on August 9 2007 some three weeks later. Speaking on behalf of his employer he made the following statements.

*A Lakeside woman who claims to communicate with long-dead religious masters will face a jury trial Sept. 18 in Flathead County Justice Court on misdemeanor charges she assaulted a Whitefish doctor. A temporary restraining order against Devra Patton West, a self-styled guru who calls herself Surya Ma, was issued by Judge David Ortleby last October after Dr. Patricia Cole, of Whitefish, requested protection. Cole claims West assaulted her in April 2006 and again in October 2006.*

*Speaking for West, Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault. [1] Reynolds, who is a financial adviser for West, said he has worked as an accountant in Los Angeles, where he dealt with well-known personalities. He is helping West raise several hundred million dollars to purchase and develop three properties around Flathead Lake for VIP spiritual-healing spas.*

*The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when Cole appeared wearing a bloody sweatshirt. [2] The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the roommate said.*

*Cole said she first came to Montana from Minnesota to attend spiritual sessions at Naka Shela, West's facility in Victor, from 2002 through 2004. She moved to Montana to live in 2005 with the idea of combining West's spiritual teachings with medical knowledge. Cole eventually assumed management positions with several of West's for-profit and not-for-profit operations. As business fell in Victor and the Naka Shela property was foreclosed, West moved her business north to Lakeside.*

*Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843. [3]*

*Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.*

**Besides being evicted from her Bayside home in Lakeside, and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees. [4.]**

**Reynolds claims that several people have been stirring up trouble by publishing untrue allegations against West. He points out that former office manager Rebecca West, who is no relation to Devra West, was denied benefits by the Montana Department of Labor and Industry because she was unable to prove a hostile environment existed at Surya Enterprises Unlimited.**

[1] & [2] Above. The police turning up at the crime, the documents from Carlida Finch, Rebecca West and Devra West's own written admission of guilt entitled '[The Law of Severity on the Path to Purification](#)' prove that Geoffrey Reynolds CPA knew that Dr. Cole's injuries were caused by Devra West's vicious assault. Then there were the repeated attempts by Devra West and Geoffrey Reynolds to force the removal of a copy of 'The Law of Severity on the Path to Purification' from the whistleblower's website. The latest of these attempts occurred on November 2007 as evidenced by Reynolds email to the whistleblower's website host demanding copyright of West's written admission of guilt in an attempt to use the Millennium Copyright ACT (MCA) to force its removal from the public domain. Here is a copy of that email.



[3] & [4] Above. Reynolds claims that Cole's bills amounted to \$1.3 million?? And that \$463,750 was owed for an 'internship' and for 'therapy.' Given the back story as laid out by Carlida Finch and Rebecca West, Reynolds just admitted to the world that he, Geoffrey Reynolds, money laundered \$463,750 of funds extorted from Dr. Cole MD through Devra West's business. As a footnote to the above news article. Devra West treats the courts with utter contempt and as stated above did not turn up for her sentencing hearing but instead pretended to be in Mexico filming a documentary – no such documentary was ever published or aired or in fact existed. West took a similar approach with the lawsuit that John Watson the whistleblower brought against her; she did not show up until summary judgment was given against her then she appealed.

#### **4. Geoffrey Reynolds CPA agrees to be complicit in Devra Patton West's plot to murder the whistleblower for exposing her criminality to the public.**

On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper, and during what he thought were 'off the record' comments, [Geoffrey Reynolds CPA](#) announced that the whistleblower [John Watson](#) would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. The reporter for the [Bigfork Eagle](#) Constance See took Reynolds's comments seriously enough to share them with the IRS criminal investigator, John Nielson, who was looking at Devra West's finances at the time. 

**Business partner of Victor Guru wins lawsuit**

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court.

Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment.

The case was heard in Ravalli County because West's home and business operations - the Divine Unity Foundation and the Sacred Archives Institute - were in Victor, where Watson also lived.

Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines.

West did not attend Thursday's hearing. Her business manager, Geoff Reynolds, attended but declined to comment and said West would not comment.

Watson said West was a "crook" who operated a "cult." He said she "brainwashed" people into giving her money - in part by falsely claiming to have a doctor of philosophy degree and a doctor of divinity degree - and turned them into "slaves" who did menial tasks at her bidding.

5. **'Slave' Geoffrey Reynolds CPA agrees to 'front' a conspiracy by Devra Patton West to use the civil courts to bankrupt the whistleblower with the objective of forcing down his websites. This so that Devra West could reincarnate her multi-million dollar a year fraud scam elsewhere (Arizona).**

With the murder plot a failure, West & Reynolds bided their time until they could implement 'Plan B' which they did in 2010. While attending court to see how much he was to be awarded for [winning his fraud lawsuit](#) against Devra West in 2008, the whistleblower was served for defamation by West & Reynolds - for [telling the truth](#). It shows how committed to West's criminality [Geoffrey Reynolds](#) was, that he was prepared not only to go before a Montana judge and make totally false statements about

himself and his relationship to the whistleblower, but that he was also perfectly willing to 'front' the pair of frivolous lawsuits so that Devra West could remain in the shadows.

**Remember, Geoffrey Reynolds traveled from Cave Creek AZ to join West's employ in Lakeside MT in September 2006, and yet, in Reynolds' pleadings to the Montana court below, he states clearly that he was defamed by the whistleblower between 2002 and 2006. Even though this 'liar for hire' did not know that the whistleblower existed until Devra West told him post commencing his employment in September 2006.**

As one can see below from an excerpt of Reynolds' resume taken from his own website (full copy available [here](#)), at the time he made these false claims to the Montana court in 2010, Reynolds did not join Devra West's employ until September 2006, and so did not know that the whistleblower existed until he was briefed about West's vendetta against the whistleblower after September 2016.

So, using the unlimited resources of decades of criminal activity, Devra West was able to neutralize the whistleblower's win in court against her by using her 'liar for hire' Geoffrey Reynolds CPA, to make [false pleadings](#) to the court on her behalf – this is a criminal conspiracy. The civil courts rarely dispense justice; their function is to 'practice' the law. In most cases, as with the whistleblower, the litigant with the most money ends up 'buying' the result they want and in the process the lawyers, judges and others involved in the process earn a good living as is described perfectly by this illustration below.



In Devra West's case, she made it perfectly clear to the whistleblower in March of 2003, that if he took her to court and sued her for fraud, that she would use every dirty trick in the book and that the cost of fighting the lawsuit would come out of his pocket, not hers, because other members of the cult, like Julio Williams who had pledged \$2,000,000 to her legal fees, would pay her costs.

**This is what criminals do. If they cannot intimidate you or murder you - they go to law and use their unlimited financial resources to 'buy' the law they want.**

## 5. A tale of two Depositions with Geoffrey Reynolds featured prominently in both - on behalf of his 'employer?'

On Friday October 9 2009, Devra West attended the offices of John Watson's lawyers where she was deposed. During her statement Geoffrey Reynolds CPA featured prominently in most of her answers in that most questions about West's finances, both personal and corporate, were deflected on to Geoffrey Reynolds. One of the lines of questioning concerned the disappearance of \$4,000,000 (as valued in 2002) worth of artwork and valuables belonging to a Montana charity. Below is an excerpt from two pages of her statement wherein Devra Patton West denies the whereabouts of those items.

Above: Starting at line 5, page 61. Devra West is asked if she has seen this document before and she answers yes. She responds that it was created by some non-profit people then proceeds to lie about the circumstances that resulted the document came into being. In reality the document was a [list of assets belonging to the charity](#) which was drawn up jointly by the whistleblower John Watson and Devra West's bookkeeper Cheryl O'Brien in the spring of 2002. The reason it was drawn up was because the whistleblower found out that Devra West and her husband Jack West were defrauding the charity and, as part of ending that fraud, the whistleblower wanted to separate out the assets and finances of the charity from the Devra and Jack West's personal assets and finances. Clearly, Devra West did not want that and as a consequence fired him without pay which was what led to his fraud lawsuit against Devra West, which he won in 2008.

The point to be made here is that in the following answers on pages 61 & 62 above Devra West states that she 'walked away from all of her possessions,' that the assets mentioned were 'carted off' and that anything of value had been sold or was missing. She goes on to say that she thinks that the document listing the assets was drawn up by somebody 'named Esther Michaels,' and then says she recalls her that she gave the list to her. The whistleblower is 100% certain that Devra West knew it was him that gave her the list not Esther Michaels. Indeed, according to the whistleblower's records Esther Michaels was one of his replacements with her serving for a short period between his and Reynolds' tenure.

Esther Michaels, like Geoffrey Reynolds that followed a year or two later, was totally corrupted by Devra West; here are two examples.

**1. Destroying evidence.** Immediately before the IRS criminal investigator arrived to audit Devra West's and the charity's financials Esther Michaels was tasked with [shredding all of the incriminating documents.](#)

**2. Money laundering.** In 2003, Esther Michaels phoned West's ex-personal secretary Diane Stoner, who had just resigned because of the lack of funds to pay her wages, employment insurance etc., to try to persuade Diane Stoner to return. However because Diane did not answer her phone Esther Michaels left [a long message on Diane's answer service](#) that there was plenty of money to pay her wages but that on Devra West's instructions all the charity's money had been removed from the charity's bank accounts to protect it from the whistleblower, John Watson's, lawsuit against Devra West. One has to ask the question why, if John Watson's fraud lawsuit was against Devra West personally, did she feel the need to remove the contents of the charity's bank account?? The answer of course is that Devra West and her husband were defrauding the charity a fact that became obvious to the authorities who sent in the IRS and who shut down Devra West's 'charity' in January 2004 when its charity status was revoked.

**Back to the missing charity's assets.** After denying the whereabouts of the assets listed on the document she was shown in in court in October 2009 while being deposed how does Devra Patton West explain them all turning up both at auction and as for sale from her website in 2014?



The only logical explanation to account for these items suddenly appearing in 2014 (after they disappeared in 2003/4) is that Devra West had stolen them from the charity and hidden them in a storage unit for ten years until the statute of limitations on theft expired and or the creditors she owed millions to stopped chasing her for payment. Geoffrey Reynolds role was to manage the 'fencing' of millions of dollars of stolen property for Devra West and why not? After all having money laundered

hundreds of thousands of dollars through West's business in 2006, been complicit in a murder plot with West in 2007, and then subsequently fronting a criminal conspiracy to bankrupt the whistleblower in 2010 why not? In for a penny in for a pound.

In page 24 of the [statement](#) that she gave in October 2009 while being deposed by the whistleblower's lawyers Devra West states, in line 01, that she is \$2,000,000 in debt (see below

It is unthinkable that Geoffrey Reynolds was unaware of the contents of the statement she gave in October 2009 as by then, both West and Reynolds were joined at the hip with Reynolds being the 'money man' behind West's criminal racketeering business model and West supposedly living in an RV in his back garden. Reynolds may even have sat next to her when she gave the statement. Therefore it came as no surprise to the whistleblower that, when he was deposed to give a statement under oath in front of West's lawyer, that 'employee' Geoffrey Reynolds would be in attendance with Devra West! 
- 1. Thou shalt not lie.**



[3] Supervised and coordinated organization's operations and made sure employees have the resources needed to do their jobs. [4] Over sees all operations to minimize expenses. Completely responsible financial system and all financial reporting and management reports. Managed all property under control of the company. Negotiated office leases and land purchases. [5] Lead staff of 15.

**It is hard to know where to start with the above which is, for the most part, a total fabrication.**

[1]. As we can see clearly from both Carlida Finch's and Rebecca West's statements above Geoffrey Reynolds totally turned his back on the 'employees' he states that he was acting as HR for? Multiple crimes were being committed right under his nose but to save his ass, his marriage and his CPA license he turned a blind eye. REYNOLDS YOU ARE A LIAR.

[2] He state that he created flexible financial projections for 1, 2, 5, 10, 20 years. Clearly this too is a pack of lies as the two news stories published by the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers clearly show. Here is a short excerpt from the Bigfork Eagle newspaper story published 9 August 2007.

*Out of six businesses mentioned in West's literature, **only one remains active and in good standing** with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.*

[3] As [Carlida Finch's](#) statements to the authorities make clear, as do [Rebecca West's](#) emails, there were no real employees. Everyone, including Geoffrey Reynolds CPA, were trapped inside a cult run by a raving lunatic who converses with the voices in her head and believes that she is an Ascended Master. The evidence clearly shows that Devra Patton West was totally ignoring state and federal laws and to save his own ass, Reynolds did the same. *much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller **[Geoffrey Reynolds CPA]** last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).*

And this....

*I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. **Dr. Cole was severely beaten on several occasions** and proof is available.*

Is the above something this pathological liar should be proud of? If so why are these achievements not being posted as part of his resume on [McSwain & Co's](#) website.

[4] We are very glad that Geoffrey Reynolds has owned up to being completely responsible for all financials and reporting because in the statement Devra West gave while being deposed, she made it clear that Reynolds was the financial mastermind. In that case, Reynolds is clearly responsible for the fraudulent application of some \$30,000,000 in CPEA grant money; both in that the application itself did not declare who the real power was behind any straw man / proxy shareholders Devra West nominated to 'front' that attempted fraud. Further down in his resume he has a section entitled 'Selected Accomplishments.'

## Selected Accomplishments

**Secured funding for company start up.** Newly-formed Surya Enterprises needed funding. Prepared financial projections and developed strategy for five, ten, fifteen and twenty years of operation, and crafted business plan. Working in secondary financial markets, secured \$30M in wrap loans with no expenditure of company equity. [6]

[6] The above statement by Reynolds that he acquired \$30,000,000 in 'wrap loans' appears to be another total fiction as these loans NEVER actually materialized. Below here is another short quote from Rebecca West, Devra West's office manager in 2007, when Reynolds was acting as 'Finance Controller.' This email entitled '[Help Me.](#)'

*I know that unless the **\$30M comes in this week**, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. Dr. Cole was forced to sign a "Quit Claim*

**Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.**

And from this email entitled 'I'm in Danger.'

**Please be advised that the CPEA \$'s obtained with Dr Cole's funds are due into the bank account this week. These monies were supposed to be available over a year ago and **if the transaction is not a fraud then \$30M will be deposited in increments.****

Well the transaction / application was fraud and so the monies never arrived and Devra West's 'still born' plans for a Spa Complex with her using \$2,000,000 of that \$30M to pay off her debts never materialized. As a consequence in 2008, Devra West became the subject of a [Sheriff's Sale](#) to force her to pay her creditors (past victims of fraud) \$2,000,000 in court judgments and interest. Part of the payment was derived by West's personal trust fund being broken open by a judge with the contents she stole from a charity in 2004 being used as part payment. See item **4** at the top of this email.

*Pattern of racketeering activity requires at least two acts of racketeering activity, one of which occurred after the effective date of this chapter and the last of which occurred within ten years (excluding any period of imprisonment) after the commission of a prior act of racketeering activity. The US Supreme Court has instructed federal courts to follow the continuity-plus-relationship test in order to determine whether the facts of a specific case give rise to an established pattern. Predicate acts are related if they "have the same or similar purposes, results, participants, victims, or methods of commission, or otherwise are interrelated by distinguishing characteristics and are not isolated events." (H.J. Inc. v. Northwestern Bell Telephone Co.) Continuity is both a closed and open ended concept, referring to either a closed period of conduct, or to past conduct that by its nature projects into the future with a threat of repetition.*

And...

*Under RICO, a person who has committed "at least two acts of racketeering activity" drawn from a list of 35 crimes—27 federal crimes and 8 state crimes—within a 10-year period can be charged with racketeering if such acts are related in one of four specified ways to an "enterprise". Those found guilty of racketeering can be fined up*

to \$25,000 and sentenced to 20 years in prison per racketeering count. In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."

### RICO predicate offenses

Under the law, the meaning of **racketeering activity** is set out at [18 U.S.C. § 1961](#). As currently amended it includes:-

- Any violation of state statutes against [gambling](#), [murder](#), [kidnapping](#), [extortion](#), [arson](#), [robbery](#), [bribery](#), dealing in [obscene matter](#), or dealing in a controlled substance or listed chemical (as defined in the [Controlled Substances Act](#));
- Any act of [bribery](#), [counterfeiting](#), [theft](#), [embezzlement](#), [fraud](#), dealing in obscene matter, [obstruction of justice](#), [slavery](#), [racketeering](#), [gambling](#), [money laundering](#), commission of [murder-for-hire](#), and many other offenses covered under the Federal criminal code ([Title 18](#));
- [Embezzlement](#) of [union](#) funds;
- [Bankruptcy](#) fraud or [securities fraud](#);
- [Drug trafficking](#); long-term and elaborate drug networks can also be prosecuted using the [Continuing Criminal Enterprise Statute](#);
- Criminal [copyright infringement](#);
- [Money laundering](#) and related offenses;
- Bringing in, aiding or assisting [aliens](#) in illegally entering the country (if the action was for financial gain);
- Acts of [terrorism](#).

If we just take the most serious crimes committed by Devra Patton West as part of her 'World Service' efforts, we find that there are no less than 9 'Predicate Offenses' she could be charged with under RICO with some committed on multiple occasions! Reynolds qualifies to be prosecuted under at least 3 RICO 'Predicate Offenses.'

**Step 2.** Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

**1. Divine Grace Healings.** Victims are convinced that they are suffering from a totally non-existent brain tumor or a cancer, which Devra West guarantees she can cure for a large fee. In reality Devra West, having identified a wealthy target, induces the symptoms of a serious illness in the victim using the same occult knowledge she uses against those who oppose her. Two of her admin staff who worked for her in 2002, overheard her say, after receiving a phone call, that she had just made \$500,000.
