**Re: 2013 Complaint Filed Against Geoffrey Reynolds, CPA Complaint No.A-2013-3097**

Further to the above complaint and [Tina Macgregor's response \[1\]](#) to my complaint dated June 19 2013. My family and I continue to be the subject of intimidation by the cult / criminal racketeering gang that Geoffrey Reynolds was / is still a member of. It appears that the leader of his cult / criminal gang is unhappy with the fact that I am corresponding with the FBI and the authorities as a whistleblower and providing them with evidence about the cult / gang's criminal activities in Montana during the time Geoffrey Reynolds was an active senior member of that cult / gang.

To be clear some five and a half years after I made my original complaint against Geoffrey Reynolds my family and I continue to be subject to the following:-

- 1.** Intimidation at the hands of the cult that he was / is a member of.
- 2.** Continue to suffer directly from the past fraudulent actions of Geoffrey Reynolds.

In brief, Reynolds' actions against me were obviously carried out at the direction of his cult / gang leader Devra Patton West. Actions that amount to perjury, making false statements under oath to a court for the purposes of extorting \$5,000,000 from me. Actions which, because I could not afford to travel to the USA to defend his obvious lies, resulted in a default (undefended) civil judgment against me of \$5,000,000 which was totally based on his false statements to the court.

My wife is American and has family in the USA, but because we are concerned that she / we might be stopped at the border as part of an attempt to collect Reynolds' court award or be refused admission to the USA until the 'debt' is paid she / we have been unable to visit family in the states since 2010. I understand that there is little you can do about item **1.** above as this is a matter for the authorities whom I hope will prosecute Devra Patton West, Geoffrey Reynolds and the other senior members of the cult / criminal racketeering gang under RICO statutes. However in respect of item **2.**

I recently shared Tina Macgregor's letter with a US lawyer who, based on the available evidence, is of the opinion that the CBA was negligent in not censuring / disciplining Geoffrey Reynolds as a result of my original 2013 complaint. In reaching his assessment the lawyer reviewed a copy of [Reynolds' pleadings](#) to the court **[2]** (against me in 2010) and also a copy of Reynolds' resume as posted on his website at the time.

In the opinion of the lawyer if Geoffrey Reynolds' resume is truthful then his statements to the court must necessarily be false! In other words there is cast iron evidence, from Reynolds himself, that he made false statements to a Montana court as his contribution to a criminal conspiracy against me orchestrated by Devra Patton West with the objective of extorting \$10,000,000 dollars from me.

Referring to Tina Macgregor's letter to me the lawyer pointed out that Tina MacGregor had clearly indicated exactly what behavior, on the part of the licensee Reynolds, would lead to his censure i.e. actions that are false, fraudulent or conduct that departs from professional standards. He cannot understand why Reynolds' false statements to the court were not considered to be 'false' or 'fraudulent' especially as they were clearly part of a conspiracy orchestrated by a third party.

Below here is a copy of the third paragraph from Tina MacGregor's letter to me.

**From the information made available, the matter appears to be a civil issue beyond the CBA's immediate jurisdiction. Consequently, unless you can provide documentation directly related to the licensee's actions that are false, fraudulent or otherwise depart from professional standards, there is insufficient evidence of a potential violation. The documentation that you presented refers to actions by others.**

The final sentence in the above paragraph states that I had [only] presented evidence which refers to the actions of others not evidence about the actions of the licensee Geoffrey Reynolds CPA. While I had provided a mountain of evidence to show a) Geoffrey Reynolds lacked integrity, was devoid of morals and b) was part of a cult / criminal racketeering gang between 2006 and 2014 it is untrue to say that I did not supply the CBA with evidence that clearly and unequivocally showed Geoffrey Reynolds' actions to be false, fraudulent and obviously departing from 'professional standards.'

The 'mountain' of evidence I supplied to the CBA concerning the actions of 'others' around Geoffrey Reynolds was merely to give context to his actions in other words to explain why Geoffrey Reynolds went before a Montana court and gave false, fraudulent statements about a total stranger i.e. me as part of a conspiracy to extort \$5,000,000 from me. I am making the same complaint again because the result of Reynolds' false statements to that court are still in play and still having a deleterious effect on our lives. So once more, and in order to show that Reynolds' actions against me were not an isolated incident but part of a wider conspiracy orchestrated by a third party I need to lay out the context in which these actions occurred. In doing so I will demonstrate the 'motive' behind Geoffrey Reynolds actions against me (and others). After doing this I will once again clearly articulate my complaint against Reynolds and give incontrovertible evidence of Reynolds guilt.

**Evidence that should have been acted upon 5 years ago!**

**Here is the background to my complaint and the context and motive for Geoffrey Reynolds dishonest, deceitful and treacherous actions against me (and others).**

As his 'online' resume states [3] Geoffrey Reynolds lived and worked in Cave Creek AZ until he successfully applied for a position as a CPA at Surya Enterprises Unlimited Inc. Reynolds subsequently commenced his employment with that company in the September 2006. Like many 'professionals' before him, including myself, Reynolds was duped into believing that both his employer, Devra Patton West, and his duties at his place of employment would be 'normal.'

In 2002, I joined Devra West's employ as a consultant in much the same way that Reynolds did in 2006; it took me several weeks to realize that Devra Patton West was running a 'quasi-religious' organization, a cult which was itself an elaborate disguise for what later I realized was a criminal racketeering business model. I have no idea how long it took Reynolds to come to that realization but unfortunately for him he did so only after being duped into loaning his life savings of \$300,000 to his 'employer' Devra Patton West. Similar overtures to 'loan' her money were made to me but I resisted the temptation.

**Once on the hook after handing over his life savings and realizing the mess he had got himself into Reynolds' choices were limited. Option one was to resign and fight for the return of his life savings through the courts. Option two was to become a willing accomplice in Devra West's criminal gang in the hope that if he was 'useful' enough to Devra Patton West he might get his life savings back. Option two is the choice that Geoffrey Reynolds made as I shall clearly demonstrate here before, once more, going to the specifics of my complaint.**

Until he moved away from Cave Creek AZ to take up this position in Lakeside MT in September 2006, Geoffrey Reynolds was totally unaware that I existed. Neither was he aware that his future employer, Devra Patton West, was in a lengthy legal dispute with me that would result in my getting judgment against her for fraud in 2008 [4][5][6]. To demonstrate that this was so and to make the point perfectly clear I left Devra West's employ in August 2002 after being defrauded out of wages and salary by her and for my own safety and that of my family we moved to Nova Scotia Canada in July 2005 so our paths, mine and Geoffrey Reynolds', never crossed. However shortly after joining Ms. West's employ, and after Geoffrey Reynolds was duped into loaning Ms. West his life savings amounting to \$300,000, Devra Patton West set about getting her monies worth out of Geoffrey Reynolds and in that regard blackmailed or coerced him into:-

**1.** Taking up 'arms' against those she was in legal disputes with at the time. At the time this principally consisted myself and Dr. Pat Cole MD a Whirlpool heiress Devra Patton West had brutally assaulted as part of a campaign of violence to extort \$1.3 million from her.

**2.** Committing several serious crimes (money laundering and extortion to mention only two) with each count punishable under racketeering (RICO) statutes [7] subject to a \$10,000,000 fine and ten years in prison.

To demonstrate that Geoffrey Reynolds CPA was 'on the hook' and had little choice but to carry out Devra West's bidding, however illegal or immoral, let me share some evidence that came from others trapped inside Devra Patton West's cult / criminal racketeering gang at the exact same time Geoffrey Reynolds had agreed to become Devra Patton West's willing accomplice in organized crime. What follows are several excerpts from lengthy statements given to me by ex-employees of Devra Patton West's who upon finding my website about Devra Patton West's activities wanted to share their experiences with me. I should state that after deciding to sue Devra Patton West for fraud in 2003 I subsequently found out, while researching my lawsuit, that there were literally scores of victims of theft, fraud, extortion, violent assaults and at least one suspicious death at the hands of Devra Patton West. To be clear there was a consistent pattern of criminality that extended back to her time in New Mexico in the 1990's.

Below here are some excerpts from emails sent to me by Rebecca West (no relation to Devra West) who was Devra West's office manager shortly after Reynolds commenced his employment at Devra West's cult / corporation in 2006.

This from an email entitled [‘Help Me’ \[8\]](#):-

**After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).**

And here from the same email:-

**I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds CPA] is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through. Tanmayo's (Coca-Cola heiress) son contacted the finance controller [Geoffrey Reynolds CPA] yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.**

And this from an email entitled [‘What is your Status’ \[9A\]](#):-

**He [Geoffrey Reynolds CPA] was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions.**

**He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job. Devra dangles the carrot and since he has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.**

The above two emails from Rebecca West demonstrate categorically that Geoffrey Reynolds CPA was both aware of the crimes being committed right under his nose by his ‘employer’ / cult leader Devra Patton West and that, because he was ‘on the hook’ for \$300,000 he had decided not to report any of these crimes to the police but instead to chose to do nothing. Rebecca makes it very clear in her comments that Geoffrey Reynolds was “attempting to protect his CPA license by ignoring Devra West’s assault on another employee.” Clearly by aligning himself with his ‘employer’ / cult leader Devra Patton West he hoped that if he carried out her instructions to the letter, however illegal or immoral, he would get his \$300,000 back.

Let me now give you some other well documented examples of Geoffrey Reynolds both 'turning a blind eye' and actively participating in Devra Patton West's criminal racketeering business model.

### **1. The Fraudulent Application of \$30,000,000 in CPEA Grant Money.**

Below is an excerpt from another email from Rebecca West entitled '[Help me with Devra Patton West](#)' [9B] wherein she makes reference to the \$30,000,000 in CPEA grant money that Devra West and Geoffrey Reynolds had fraudulently applied for.

*Please be advised that the CPEA \$'s obtained with Dr. Cole's funds are due into the bank account this week. These monies were supposed to be available over a year ago and **if the transaction is not a fraud** then \$30M will be deposited in increments.*

Well, the transaction was fraud. It was fraud because Devra Patton West's status was never truthfully declared. It was obvious that the 'directors' of her corporation were directors in name only, and had no power to make decisions being appointees by Devra West from loyal members of her cult. To be clear, they were 'straw' men taking instructions from a 'hidden' third party.

The other reason the application for grant money was fraudulent stemmed from the fact that Devra West promised to repay her huge personal debts from the grant money. Indeed, a collection of [Rebecca West's emails](#) [10] make that much very clear. Similarly Devra West's step mother Carol Patton (whom Devra West had defrauded out of \$30,000) was also promised that she too would be repaid out of the grant money once it arrived. Follow [this link](#) to review Carol Patton's email [11] to me on this subject.

At that time all of this was occurring right under Reynolds' nose, Devra Patton West owed \$2,000,000 in court fines and interest to her creditors who were past victims of crime at her hands. However, when the grant application was declined and Devra West failed to obtain the \$30,000,000 in grant money, she would become the subject of a [Sheriff's Sale](#) [12] to force her to pay the monies owed to her creditors. It is unlikely that Devra West's controlling interest in her 'corporation' (cult) was properly declared, or if it was, that she intended to use over \$2,000,000 of that money to pay off her substantial debts. Clearly Geoffrey Reynolds was well aware of all of these facts and declined to make the information available to the authorities when applying for the funds.

### **2. Money Laundering of \$470,000 extorted by Devra West from Whirlpool heiress Dr. Pat Cole MD.**

In early April 2006 (some six months before Geoffrey Reynolds moved from Cave Creek AZ to take up his position as 'Finance Controller' with Devra Patton West) Devra Patton West viciously assaulted Dr. Pat Cole MD as part of a campaign of violence whose objective was to extort \$1.3 million from her. The police were called, photos taken and Devra West was subsequently convicted of assault in April 2008 after accepting a plea deal that saw her being fined \$500 and given a 6 month suspended jail sentence. This all occurred six months before Reynolds joined West's employ / cult in September 2006.

Additionally, when Geoffrey Reynolds took up his employment in September 2006, he was totally unaware that his predecessor, Betsy Blank, had resigned rather than be forced to 'manufacture' false invoices to make it look like the \$463,000 received as cash by Devra West from Dr. Cole MD was received as part of 'normal' business activities rather than as a result of organized crime.

Below is a short excerpt from [an email](#) [13] sent to me by another ex-employee of Ms. West's, Carlida Finch. Within her email Carlida explains why Betsy, who she calls the "controller" resigned.

*I think Devra asked the 'controller' to do some "accounting" that she was uncomfortable with...perhaps the creation of invoices for what Pat "owed" her from the non-profit.*

Here is a link to [Betsy Blank's resignation](#) [14] letter where she comments on the fact that there was \$140,000 due in past debt and no verifiable revenue generation strategies in place. However, once Reynolds replaced Betsy Blank, and after he was firmly under the control of Devra West, money laundering or the creation of or 'manufacturing' of false invoices, was obviously not a problem for Geoffrey Reynolds CPA. Below is an excerpt from some of the statements that Reynolds made, speaking on behalf of his employer, while being interviewed by the [Bigfork Eagle](#) newspaper [15] on August 9 2007.

*Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.*

What 'guru' would charge a total of \$463,000 for an "internship" and "therapy fees?" What 'guru' would charge \$1.3 million in fees for a two year period? Answer. No respectable guru would because they are not primarily interested in money. However a dangerous psychopath masquerading as a guru while hiding a criminal racketeering business model behind a 'quasi-religious' outer shell would - and did!

### **3. False and fraudulent statements in respect of Devra Patton West's assault on Dr. Pat Cole MD in an attempt to both pervert the course of justice and deceive the public.**

As mentioned above, Devra Patton West in 2006, owing \$2,000,000 to her creditors in court fines and interest, decided to 'harvest' (thieve, defraud and extort) money from the wealthier members of her cult chief amongst them was Dr. Pat Cole MD. To that end, and as part of a campaign of violence directed at Cole, Devra West in early April 2006 viciously assaulted Dr. Pat Cole MD with such severity that it shocked the other members of her cult who were present when the assault occurred.

A statement from ex-cult member [Debra Coffey](#) [16] explains how Devra West coordinates the senior members of her cult to participate in what are bullying, intimidating, shaming and brutalizing sessions which are designed to 'break the will' of the target as a prelude to brainwashing and conditioning by Devra West which leaves the individual compliant and totally submissive to West's will. In the case of Dr. Cole MD this strategy was designed to extract \$1.3 million from her so that Devra West could pay her court fines! At the same time this was happening another of Devra West's employees, Carlida Finch, overheard Devra Patton West talking about the potential murder of Dr. Cole MD. Carlida herself was trapped inside Devra West's cult and was given the choice by Devra West of joining her cult as a low paid or no paid slave or be fired. Carlida chose to resign. In the days following her resignation Carlida gave several statements to the labor board as part of her claim for employment insurance these statements make it very clear that the working environment in Devra West's corporation was both toxic and dangerous. Here are links to three of the statements that [Carlida Finch](#) [17] [18] [19] made to the authorities about this matter.



Carlida's statements totally corroborate what Rebecca West and others had said about the dangerous working environment that prevailed at the time Geoffrey Reynolds was employed as 'Finance Controller'. Although I know from experience when I had the role between January 2002 and August 2002, that Geoffrey Reynolds had no discretion to make decisions, as every detail was micro managed by Devra Patton West who was then calling herself the Ascended Master 'Surya Ma.' Below is an excerpt from the 'Statement of Fact' [17] that forms part of Carlida's submission to the authorities.

### **Left Employment Due to Dissatisfaction with Working Conditions**

What working conditions were you not satisfied with?

**Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.**

Note the comments above attributed to Devra Patton West; in particular her contention that she (West) did not care if she killed Pat Cole because as an enlightened being she had no ego so could spend her life in a prison as easily as in a \$6 million dollar mansion. Of course it would not occur to a dangerous psychopath like Devra West that enlightened beings do not kill people!

Days after the assault against Dr. Pat Cole MD occurred in early April 2006, and to quell the unrest in the cult amongst the rank and file members who were shocked at what they saw, Devra West issued a lengthy statement to everyone on her cult mailing list. That statement, an attempt to justify the assault on Dr. Cole MD, was entitled '[The Law of Severity on the Path to Purification](#)' [20]. Nothing illustrates more than this missive the vile and despicable nature of Devra Patton West who, in an attempt to placate the rank and file members of her cult, pretended to receive a channeling, a message from the voices in her head, which she then published as some kind of message from God.

Below are a couple of excerpts from that statement.

## *The Law of Severity on the Path of Purification*

Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

A couple of the choice (depraved psychotic) comments from Devra Patton West are:-

1. That although the beating administered was severe it was delivered at all times with grace!
2. She asserts that because Dr. Cole MD was a NAZI in the WWII death camps in another lifetime the beating was not only deserved but long overdue.

Notice there is no mention of the \$1.3 million extorted from Dr. Cole MD - the true motive for the campaign of violence against her. Only a psychopath could make statements like this let alone carry out a vicious assault like the one administered to Dr. Cole MD. Here is how Dr. Cole MD described the assault to the [Whitefish Pilot](#) [21] newspaper 15 months later in July of 2007.

*Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.*

Do these seem like the actions of a guru?



Now back to Geoffrey Reynolds role in these crimes. It is clear from Carlida Finch's statements, which were faxed to me in May 2006, and Rebecca West's emails, that were sent to me in March 2007, that Geoffrey Reynolds was well aware of the crimes being committed by Devra Patton West right under his nose during his tenure. And although the assault on Dr. Cole MD occurred some six months before he joined West's employ in September 2006 it is clear from Rebecca West's emails that Reynolds knew that the assault had taken place, that the police were involved and that there was an ongoing court case about that matter.

Further proof of his awareness of the assault on Dr. Cole MD comes in the form of his emails to the service provider of my website the following being just one of those emails.

As explained earlier while researching my lawsuit against Devra Patton West I discovered that I was one of scores of victims of theft, fraud, extortion and, in an attempt to counter the lies, deceit and propaganda being put out by Devra West and the senior members of her cult (including Reynolds), I decided to post all of my research on-line on a website dedicated to the purpose of sharing what I had learned about Devra West's criminal racketeering business model. Chief amongst the many documents I had posted on-line included a copy of Devra West's own written admission that she had assaulted Dr. Cole MD entitled '[The Law of Severity on the Path to Purification](#)'[20]. Geoffrey Reynolds CPA was obviously aware of this document and its contents because he had made a couple of attempts at trying to force the removal of this statement (see above) from my website. The most recent attempt was made under the auspices of the Millennium Copyright Act (MCA) which had just come into force at the time. Geoffrey Reynolds' email above proves two things **a)** Devra West did assault Dr. Cole MD and **b)** that Geoffrey Reynolds was not only aware of this but was, on behalf of his employer / cult leader, desperately trying to force a written copy of her admission of guilt off my website.

Given the seriousness of the crimes being committed against so many victims, and the cries of help coming from Rebecca West and others still trapped inside the cult, I decided to share my research with two local newspapers, the [Whitefish Pilot \[21\]](#) and [Bigfork Eagle \[15\]](#), both of whom published stories about West's criminality on the 12 July 2007 and the 9 August 2007 respectively. Within days of the first newspaper article appearing in the Whitefish Pilot [21] newspaper, the senior members of Devra West's cult including Geoffrey Reynolds CPA, each published statements of denial from her website even though each had read, and was in possession of her written admission that she had committed the assault, which was sent a year earlier.

And so, in spite of the desperate attempts by Geoffrey Reynolds to force the removal of her written admission of guilt from my website, and in spite of knowing the contents of that statement, Geoffrey Reynolds still published four statements of denial on his cult / gang leaders' website. In posting no less than four statements of denial (that sought to deny that Devra West had assaulted Dr. Cole MD) on Devra West's websites Geoffrey Reynolds made it obvious he was collaborating in a conspiracy to perpetuate the criminal activities of Devra West then masquerading as the Ascended Master 'Surya Ma.' Criminal activities that relied upon the public remaining totally ignorant of the true nature of Devra Patton West's criminal racketeering business model. Criminal activities that relied on the public continuing to swallow the 'divine being' rhetoric which is the basis of Devra West's criminal 'business' model.

Reynolds' statements were aimed at the local press who Reynolds attempted to vilify because they printed stories about the leader of his cult that were actually true! However it gets much worse than that. While being interviewed by the [Bigfork Eagle](#) newspaper [15] Geoffrey Reynolds confided in the reporter Constance See that John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to me and my family. In spite of the fact that this threat was taken seriously by Constance See who passed it on to an IRS Criminal Investigator looking into West's finances at the time I have not listed this as one of Geoffrey Reynolds' 'crimes' as it is hard to prove.

That said Devra Patton West constantly uses the threat of murder as a way of keeping the members of her cult in-line. In fact two years earlier in 2005, ex-student [Lisa Swidler](#) died suddenly and mysteriously after witnessing Devra West commit two serious crimes against other cult members of her cult namely [Dave Kushner](#)[27] and [Marion Cantwell](#)[28]. The former, being defrauded out of \$30,000, and the latter, being kidnapped, held captive, beaten and only released after agreeing to make a sizeable donation to the \$2,000,000 in court fines and interest that Devra West owed her creditors!

It is clear to me, that Devra West had briefed Geoffrey Reynolds on her ability to commit murder (and get away with it). Why else would Reynolds so confidently announce my impending murder to the press reporter? Indeed, after the failed attempt to murder me, which occurred just two weeks after Reynolds' prediction, my family and I became the subject of a campaign of intimidation designed to have me react in a way that would end up with me going to prison. Again, this occurred just as Reynolds had predicted and these provocations continue to this day, some 12 years after they first started.

**4. Geoffrey Reynolds' participation in a criminal conspiracy designed to bankrupt me. The clear motive being to force down my websites thereby allowing his 'employer' Devra Patton West to reincarnate herself anew in a third western state without the FACTS up on the web to contradict her 'divine being' narrative.**

After the publication of three newspaper articles in the [Whitefish Pilot](#) [21], [Bigfork Eagle](#) [15] and [Ravalli Republic](#) [6] in Montana, the failed murder plot and with my website still up in Montana, Devra Patton West's criminal racketeering business model was dead in the water, as potential victims tend not to walk into a trap if they know it is there! However, Devra West and her stooge Geoffrey Reynolds were not finished yet, and were in fact waiting to implement their plan 'B.'

In 2010, I was again forced to travel from Nova Scotia, on the east coast of Canada, to Montana to attend a court hearing, whose purpose was to determine how much I was to be [awarded in costs and damages](#) for the [fraud lawsuit I had won](#) against Devra West in 2008 [4,5,6]. While waiting to go into court a representative of West (and Reynolds's) lawyer had me served with two defamation lawsuits one each from Devra West and her accomplice Geoffrey Reynolds. The truth is an absolute defense against defamation but only if you have the financial resources to defend the lawsuits.

In my case I was being sued for telling the truth about Devra West's criminal activities and Geoffrey Reynolds, who I had never met and certainly had never defamed, had been coerced into issuing an a similar, in fact identical, lawsuit against me. Both West & Reynolds lawsuits were entirely frivolous in nature and they both gambled that I would not be able to afford to travel backwards and forwards to defend them - which turned out to be the case. One has to understand that in the US, as elsewhere in the western world, it is not necessarily the merits of one's case that wins the day but often the deciding factor is who has the most money to spend!



Lawsuits are fought on a court just like tennis is, there is a judge just like in tennis, two combatants in a lawsuit knock the arguments back and forth just as in tennis where a ball is knocked backwards and forwards and in both cases there is a 'racket' involved. As the above illustration makes clear, often the only beneficiaries of lawsuits are the lawyers. In my case, Devra Patton West made it perfectly clear to me when attending a meeting at my home in March 2003 (some three and a half years before Reynolds was recruited by her), that if I sued her, she would get so down and f\*\*king dirty, huge expenses coming out of my pocket and not hers!

Not coming out of her pocket because cult members of hers like Julio Williams, who pledged \$2,000,000 for her legal fees, would pay. Below are some statements that Devra West made to me during our meeting in March 2003, unaware that I was recording the meeting on a digital tape recorder.

In 2004, after being defrauded by her in 2002, I had caused her charity to be struck off for fraud by the Secretary of State for Montana - follow this link to review the [Revocation Certificate \[29\]](#). I had also caused an IRS investigation into her criminal activities which resulted in Devra West [instructing her employees to shred \[30\]](#) much of the documentation that was incriminating. I had caused no less than three newspaper articles to be published about her criminal activities. In 2007, when it looked like my lawsuit against her was going to succeed, Devra Patton West was out for revenge and using her stooge, Geoffrey Reynolds, who was still firmly on 'the hook' blackmailed / coerced him to be a part of her vendetta against me. Before getting to the specifics of my complaint, let me ram it home to you just how controlled by Devra West Geoffrey Reynolds was. ### Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.


Justice of the Peace David Ortleby issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

**On Page 54, line 13.** Devra West states that Geoffrey Reynolds even provides money for Devra West's children if they need a few hundred bucks!

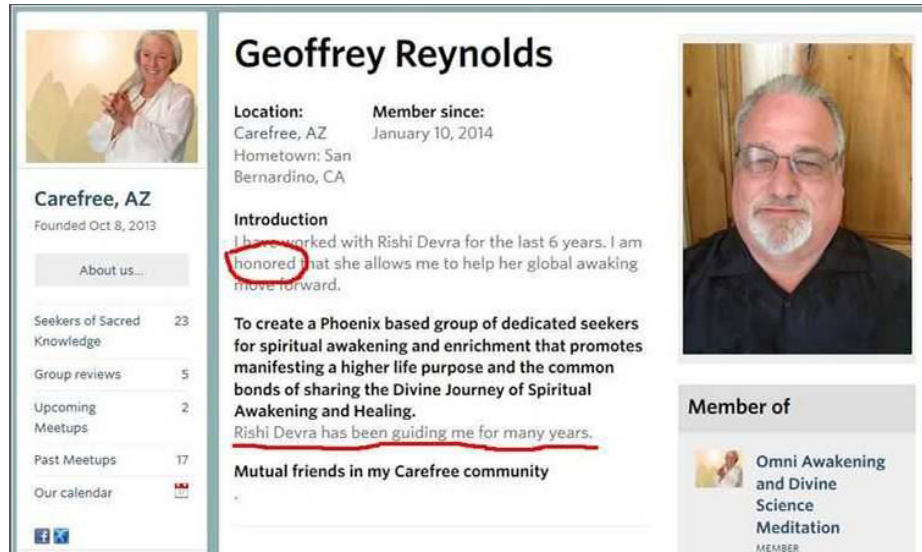
**On Page 56, line 21.** Devra West states that she comes from a generation where the men handle the money and goes on to say that she does not handle it or relate to it! She makes it clear once more that Geoffrey Reynolds oversees everything.

**On Pages 60 & 61.** Devra Patton West is questioned as to the whereabouts of \$4,000,000 worth of artwork and valuables. She was shown a list of those assets which I and her ex-bookkeeper, Cheryl O' Brien, drew up in 2002 as part of the process of separating the charity's assets and bank accounts from Devra & Jack West's personal assets and bank accounts. West acknowledges the existence of the document but goes on to discredit it by saying it was "pretty far-fetched" and something to do with insurance. West goes on to say that she gave up all possessions and that the items on the list were lost or stolen or carted away. Below is a statement that Reynolds published on a Social Media 'Meet Up' site in 2014, showing very clearly that he was still very much involved with Devra West and her cult / criminal gang.



In the image above, Reynolds states that he is 'honored' that she (Devra West) allows him etc., and that 'she has been guiding his life for many years.' The latter statement is certainly true, as I have gone to great lengths to demonstrate in this document! It is clear that Geoffrey Reynolds is a pathological liar, as is Devra Patton West, who he worked for between 2006 and 2014. A close look at Reynolds' current online resume reveals this, as he has both lied about his past achievements (while employed by Devra West) and padded his resume to make it look better than it really is.

Let me reveal one example of 'padding' and another of dishonesty. Below is an excerpt from his online resume.

## SELECTED ACCOMPLISHMENTS

**Secured funding for company start up.** Newly-formed **Surya Enterprises** needed funding. Prepared financial projections and developed strategy for five, ten, fifteen and twenty years of operation, and crafted business plan. Working in secondary financial markets, **secured \$30M in wrap loans with no expenditure of company equity.**

This is not true the \$30M in loans he applied for were never forthcoming with the result that Devra Patton West became the subject of a [Sheriff's Sale](#) [12] to force her to pay her creditors the \$2,000,000 she owed them in court fines and interest. As for developing a strategy for five, ten, fifteen and twenty years for Surya Enterprises this too is utter rubbish. As the [Bigfork Eagle](#) [15] newspaper article below makes clear most of Devra West's businesses were either involuntarily dissolved (including Surya Enterprises), involuntarily revoked or never registered. Additionally, at the time the article was published (when Reynolds was discussing my impending murder) Devra West owed \$2,287 in unpaid employee insurance.
