

Subject: Rishi Devra AKA Devra Patton West – Criminally Insane, a Pathological Liar and Serial Killer Masquerading as a Guru

Dear FBI, IRS and Sedona & Scottsdale police departments.

We ask two questions. Does Devra West have immunity against prosecution? Has the latest iteration of her cult / criminal gang or the territory it sits on been granted immunity from prosecution? We ask these questions because Devra West's past (and presumably present) total disregard for state and federal laws can only be explained in two ways. Either Devra West has immunity from prosecution or believes herself to be totally safe from prosecution because a) the victims and witnesses of crime were / are too afraid to report the crimes to the authorities or b) when they do Devra West has shown herself capable of mobilizing so many false witnesses as to make it near impossible to achieve a successful prosecution against her.

This would explain why [Dave Kushner](#) after being defrauded out of \$30,000 did nothing. This would explain why [Mike Hendrickson](#) being defrauded out of \$200,000 did nothing. This would explain why [Marion Cantwell](#) after being kidnapped, falsely imprisoned and relieved of tens of thousands of dollars and told she would be murdered if she went to the police did nothing. This would explain why both [Rebecca West](#) and [Carlida Finch](#) both ex-employees of West's and both given the ultimatum to join her cult or be fired both made unsuccessful complaints against Devra West. This would explain why Dr. Pat Cole MD had \$1.3 million extorted from her by Devra West but was too afraid to complain to the police. This would explain why accomplice [Geoffrey Reynolds CPA](#), while being interviewed by the [Bigfork Eagle](#) newspaper, virtually admitting that he money laundered a large part of those funds through West's criminal business model as 'normal' business receipts. After the murder of [Lisa Swidler](#) in 2005 and the attempted murder of whistleblower John Watson in 2007 no wonder most victims are too afraid to come forward to the authorities.

Devra West has shown time and time again that not only can she operate outside the law, but when she is forced to engage in the process, she is capable of 'throwing,' 'undermining' and perverting the course of justice by intimidating victims and witnesses with impunity. Just as she did with the two custody cases involving her son's attempt to get custody of two infant children from two ex-wives, who were both subject to violent intimidation. A strategy which worked on the first wife but failed on the second. The same strategy is used when individuals bring civil lawsuits against her after becoming victims of theft, fraud, extortion and violent assault. Is it no wonder that 99% of victims just walk away empty handed? There is a mountain of evidence to back up what we are saying but no one seems to be interested in bring forward a prosecution against her and her accomplices under RICO statutes. As a result this con-artist is now operating in Arizona where she is offering 'divine grace healings' to wealthy victims for 6 figure sums. We could point out, based on her [fake life story](#) etc. and her appeal for cash donations based on that fiction, that at the very least this is 'wire and mail' fraud but since she is immune from prosecution perhaps this is a moot point.

No wonder Devra West believes herself to be a God. No wonder she dresses like one and behaves like one. No wonder she demands that everyone submits to her will. Hence our two questions about immunity from prosecution. On the assumption that Devra West is not immune from prosecution, and that she and her cult are subject to state and federal laws, these emails form the basis of a very compelling case for racketeering against Devra West and cult / gang members Geoffrey Reynolds and

**In the last bulletin we gave incontrovertible evidence that Devra Patton West was criminally insane. The main evidence of her insanity came from her own mouth.**

**Beatrice McGuire.** In front of forty or so witnesses at a Montreal seminar, psychopath West violently attacked Beatrice McGuire, a student of hers that had challenged her on one of her many lies in front of West's audience. Devra West's response in front of tens of witnesses was to viciously attack Beatrice, partially ripping her ear off which needed plastic surgery to repair. Witness Debra Coffey saw the assault and gave the whistleblower a statement about it; [Debra Coffey wrote in her statement](#) that Devra West often denied the assaults she made on others, saying that God did it. Devra West paid for the victim to have plastic surgery, though in a [later email](#) Devra West stated that her recollection of the events around the assault was different from the victim's. West's personal secretary of four years, Barbara Costantino, confirmed in a [letter to the whistleblower](#) that Devra West always lied after the event to deflect blame away from herself. When the whistleblower brought up the assault at a meeting with Devra West in March of 2003, she denied she assaulted Beatrice [saying that someone else did it](#). When John Watson said but you paid her to have plastic surgery West replied, obviously lying, "Yes because in a roundabout way someone else scraped her." Devra West then stated that Beatrice McGuire was mentally ill.

## CONFIRMATION THAT DEVRA PATTON WEST IS BOTH CRIMINALLY INSANE AND A PATHOLOGICAL LIAR.

**John Watson.** Devra West defrauded the whistleblower in August 2002, in a way that made it obvious that he was not the first victim but one of many. After he announced that he was going to sue her for fraud in March of 2003, Devra West demanded a meeting with the whistleblower. At the meeting, Devra West admitted she had defrauded him but said she did not see herself paying him the \$50,000 she owed him. She then asked him if he was a good listener while constantly screaming at him! She then said that she had a point of view that he was unable to hear. She said that not paying him what he had promised her was her truth and that if he sued her he would be f\*cking over a spiritual seeker. She stated that if he went to court to recover the monies owed, she would get so down and f\*cking dirty, huge expenses coming out of his pocket but not hers, as cult member Julio Williams would pay her legal fees. Williams later sent a threatening letter to the whistleblower, saying he was going to give West \$2,000,000 for her legal fees. An obvious attempt to intimidate John Watson into dropping his lawsuit against West.

These humanitarian causes are never meant to be enacted or come to fruition; their only objective is as a focus for the cult's fundraising efforts. In spite of 27 years of fundraising, during which tens of millions of dollars have been raised, not a single cent has gone to the good causes espoused. Instead, all of the money ends up in West's personal bank accounts in the US and offshore or is used to fund her lavish lifestyle.

Before going any further, the reader has to understand that when inducted into West's cult new recruits, be they students or employees, are quickly brainwashed and conditioned to submit to Devra West's will. Those who do not submit are quickly gotten rid of. This harrowing email, entitled 'Help Me' from an employee makes it clear that Devra West had a 'revolving' door policy to employees; they submit to her will and join her cult within the first 90 days or they are fired. In Dr. Cole's case the brainwashing and conditioning was total. After Devra West's Victor MT charity was [struck off for fraud](#) in January 2004, and fearing the charity's assets might be sequestered by the Montana government, Devra West enacted a series of fake loans and defrauded the charity of its main asset ([a property worth \\$1,250,000 in 2002](#)) which she put it in a personal trust fund for herself and her son Rob Meador. In

2008 a judge took the property out of the trust fund and forced Devra West to use it as part payment of \$2,000,000 in court fines and interest she owed to other victims of crime! The property was auctioned at a [Sheriff's Sale](#) in 2008.

With her Victor Montana ashram (cult headquarters) gone, and facing bankruptcy for the second time, Devra West told the members of her cult, including Dr. Cole MD, that her difficulties were caused by her ascendancy [from the 5<sup>th</sup> dimension to the 7<sup>th</sup> dimension](#) (not her impending bankruptcy)! Furthermore, she stated that she could only take 12 disciples with her to Shamballa and only those [willing to donate 66% of their net worth](#) to her needs! In reality, Shamballa was a rental property on Flathead Lake which was 100 miles north of where the Victor MT property was located.

## **CONFIRMATION THAT DEVRA PATTON WEST IS BOTH CRIMINALLY INSANE AND A PATHOLOGICAL LIAR.**

In early 2006, and tired of waiting for Dr. Pat Cole MD to 'donate' 66% of her net worth to her, Devra West made Dr. Cole the target of a campaign of violence (both physical and mental) the objective of which was to force Cole to hand over hundreds of thousands of dollars. The violence was organized by Devra West and delivered by her and the other members of her cult in a fashion [described by student Debra Coffey](#) who later admitted taking part in similar sessions, the purpose of which was to break the will of the person targeted. Early in April 2006, Devra West got impatient for Cole's money with the result that the victim Dr. Cole was viciously assaulted after which the police were called, West was interviewed and charged by the police. Here are some FACTS to consider in respect of Devra West's mental health and her pathological ability to tell lies about what happened.

1. This is how the victim described the assault to the [Whitefish Pilot](#) newspaper on July 12 2007.

***"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand.***

***"She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.***

2. Witness Carlida Finch, an employee who resigned rather than be forced to join West's cult, overheard Devra West planning Cole's murder. According to Carlida, she overheard Devra West talking to another employee saying that she did not care about murdering Dr. Cole because as an enlightened being, she could just as easily live in a 6' X 6' jail cell as she could in a \$6,000,000 mansion. Of course being criminally insane, Devra West could not possibly know that enlightened beings do not commit murder! 3. Within days of Devra West's assault on Dr. Cole, and hearing about the gossip of those in attendance during the assault who were shocked at the violence, Devra Patton West decided to try and limit the dissent by issuing a written statement to the rank and file members of her cult. Accordingly on April 17 2006, just days after the assault, and in an attempt to justify the assault crazy bitch Devra Patton West

penned a missive entitled [‘The Law of Severity on the Path to Purification.’](#) No other document better illustrates Devra Patton West’s insanity than this one. In short order within the missive she:-

**3a.** Devra Patton West declares herself to be an Ascended Master and asks for her actions to be reviewed by another long dead Ascended Master that she refers to as ‘El Morya.’ Though she moved from Victor MT to Flathead MT (not to Shamballa) as if to add meat to her delusions Devra West refers to El Morya as belonging to the ‘Shamballa Counsels’ a mental construct not existing anywhere outside her psychosis. Here is the title of that insane document.

*The Law of Severity on the Path of Purification*  
Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

**3b.** Unsurprisingly (because El Morya does not exist except in her psychosis ridden mind) El Morya proceeds to state that although the assault meted upon Cole was severe it was administered with grace by Surya Ma (West’s identity in MT prior to her arriving in AZ and calling herself ‘Rishi Devra’). West, talking to herself but attributing her lunacy to long dead El Morya, continues by saying that because the victim Dr. Cole MD was a Nazi in the WWII death camps the beating was not only appropriate but long overdue. Here is another excerpt from page 2 of that document.

*Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable*

Nowhere does Devra West mention the \$1.3 million that she successfully extorted from Dr. Cole MD Included in that total was Dr. Cole’s home worth \$750,000 which she was forced to vacate and sign over to Devra West. Devra West did not need to mention the money having convinced the brainwashed members of her cult that Cole was a Nazi (in another lifetime) and therefore deserving of the beating she got.

**4.** Quite by coincidence on the very same day that the Whitefish Pilot newspaper story was published, some 15 months after the assault on July 12 2007, Devra West was in court giving evidence for her porn loving wife beating son in a custody battle against his estranged wife Jamie Haywood. When questioned by counsel about the assault on Dr. Cole MD Devra West denied the assault. You can review all of her answers by going here to page 29 of [Part 1 of the Trial Transcript](#). Responding to the question, “Did you assault Dr. Cole MD?” pathological liar Devra West replied :-

Q. And you assaulted that person?

A. Absolutely not. No way, no how -- absolutely

not.

4a. At the same hearing, on July 12 2007, West was asked by counsel if her business was a multi-billion dollar concern to which pathological liar Devra West responded:-

Q. Okay. On the last page of this exhibit -- first of all let me ask you some questions. Is it fair to characterize your company as a multi-billion dollar enterprise?

A. Correct.

You can read that answer by going to page 10 of the trial transcript mentioned above. It should be noted that on the very same day that pathological liar Devra Patton West was declaring her business interests as being multi-billion dollar affairs the following comments appeared in the Whitefish Pilot newspaper:-

*Here in the Flathead, West ran into problems over several properties where she lived. On June 1, she was evicted from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. She then moved into another Lakeside with her son and daughter-in-law. "All she got out of the house was her cat," said Larry Phillips, a Realtor with Land Rush Realty. According to court documents, West is behind in payments on the second home. The issue has not yet been resolved, according to one of the homeowners, Larry Brazda.*

And this from the pathological liar...

*A third Lakeside property, the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy, is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."*

And these comments appeared in the [Bigfork Eagle](#) newspaper on August 9 2007 less than a month later:-

*Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute. Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.*

## CONFIRMATION THAT DEVRA PATTON WEST IS BOTH CRIMINALLY INSANE AND A PATHOLOGICAL LIAR.

The only difference between despot Devra Patton West and other despots like Hitler and Stalin is the scale of their crimes. Both Hitler and Stalin had absolute power to do as they please and mass murder was the result. In Devra West's case it is likely that she is a serial killer but because the 'weapon' she uses to murder those who oppose her is not regarded as a weapon by legal statute her victim's deaths are ruled as death by 'natural causes.' Senior cult members Reynolds, Williams and ex-husband Jack

West know about the use of murder as a weapon to silence opposition but just as with Hitler and Stalin there are always low life scum who are prepared to do what the psychopaths ask of them.

It is obvious to any observer that Devra Patton West did assault Dr. Pat Cole MD – the pathological liar even admitted it in writing herself in the missive entitled [‘The Law of Severity on the Path to Purification’](#) that she sent out to all cult members. Clearly cult / gang member Reynolds knew she was guilty as hell as apart from anything else he was desperately trying to remove a copy of that document, West’s written admission of guilt, that had found its way on to John Watson’s website. Here is a copy of the email that Reynolds sent to the service provider of the whistleblower’s website in an attempt to force it off his site by claiming copyright of the document on behalf of psycho bitch Devra Patton West. **In April 2008, Devra West finally accepted the plea deal the district attorney had offered her in 2007 and accordingly, she was found guilty of assault; as the newspaper article below makes clear.**

After the above newspaper article was published, Devra Patton West posted a statement on her website wherein she denied that she had been convicted of assault and stated that she was the victim of an extortion scam by the victim, Dr. Pat Cole MD.

**Court Rules to Dismiss Bogus Assault Case:**

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

**TRUTH:** Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. *With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, **as she has no money left after Devra extorted more than \$700,000 from her***



**Murder as a weapon to silence dissent.** Shortly after the whistleblower agreed to be a business consultant for Devra West's charity in January 2002, and while doing some volunteering work with her husband Jack West, he mentioned that those who opposed his wife ended up dying suddenly.

**The murder of Lisa Swidler.** In 2005, student Lisa Swidler negotiated a short term bridging loan of \$30,000 for just two weeks with student [Dave Kushner](#). After receiving the money, Devra West refused to repay the loan, even though Dave Kushner had an agreement that West had signed promising to repay the money. At about the same time another student, [Marion Cantwell](#) who had recently sold her home, was kidnapped by West, held captive and beaten until she agreed to donate tens of thousands of dollars to Devra West. Shortly after witnessing these two events student Lisa Swidler tried to escape the cult and died shortly afterwards of internal bleeding. The coroner ruled her death as by 'natural causes.' The whistleblower and others believed that [Lisa Swidler](#) was murdered to keep her quiet.

**The attempted murder of John Watson the whistleblower.** After he was defrauded in 2002, the whistleblower decided to sue Devra West for fraud; a lawsuit he won in 2008 (see [Ravalli Republic](#) newspaper article). He also notified the Secretary of State that Devra West and her husband, Jack West, were defrauding their charity by stealing hundreds of thousands of dollars in public donations to finance their lifestyle and the costs of Devra West's son's legal costs in a custody battle. The result was that the Secretary of State for Montana [removed their charity from the register](#). There followed an IRS investigation into the West's finances which they thwarted by [moving money into other bank accounts](#) and [shredding documents](#) ahead of the investigation. ## **WE BELIEVE THAT DEVRA PATTON WEST IS CRIMINALLY INSANE, A PATHOLOGICAL LIAR AND A SERIAL KILLER.**

After John Watson ignored the written threats from senior cult member Julio Williams, wherein Williams told Watson not to f\*ck with him or else, and went on to state that he was personally giving West \$2,000,000 towards her legal fees, Devra West decided that she was going to murder John Watson. While being interviewed by the [Bigfork Eagle](#) newspaper on August 9 2007 senior cult member Geoffrey Reynolds confirmed this by stating to the reporter, in what he thought was an 'off the record conversation' that Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. A few days later, Devra West tried to murder John Watson and failed however since then John Watson and his family have been the subject of a daily / nightly campaign of occult 'under the radar' violence whose objective is either to kill him, intimidate him into silence or have him react in a way that lands him in court and then jail.

We explain in a previous bulletin how Devra West uses her occult weapon to intimidate and murder those who oppose her or go public about her reign of terror. Julio Williams MD a member of West's cult / criminal gang since 2000. Williams posted a defamatory statement about the whistleblower in 2005, sent him a threatening letter in 2007 promising to fund West's legal fees to the tune of \$2,00,000. Dr. Julio Williams promotes and supports her claims to be able to deliver 'divine grace healings' and even pays for venues where she interviews those prepared to pay her \$500,000 for a fake cure!

The only way Reynolds could have possibly predicted that the whistleblower was going to be killed by Devra West, is if she told him prior to making her failed attempt on his life. The only way that Reynolds could possibly know that West intended to provoke John Watson into reacting to what Devra West was going to do to him, his wife and children, was if Devra West told him. The only way Reynolds would believe that Devra West was capable of doing either of those things was if Devra West had shared information about previous successful murders (i.e. Lisa Swidler?) or previous 'under the radar' campaigns of occult violence directed at others.

Like the campaign of occult violence directed at West's daughter-in-law Jamie Haywood, who West hoped to intimidate into giving up her infant daughter to her son Chris Haywood. This campaign had worked a few short years earlier against [Kendal Haywood](#) who West targeted relentlessly day and night, for months leading up to the custody hearing. Although Devra West failed to murder Kendal Haywood, she did manage to damage her sense of well-being; so much so, that she sought psychological help. Not realizing that she was the subject of occult attacks which manifested as insomnia, severe migraines, partial paralysis, nightmares, demonic attacks, banshee screams poor Kendal was made out to be mentally ill which was exactly what was intended by Devra West and her son.

**How else was Devra West going to convince the courts to take away an infant female child from a squeaky clean young mother and give that infant female child to her porn loving / wife beating son who had [an FBI record](#) for forgery, substance abuse and traffic violations?**

Kendal Haywood lost custody of her infant child, but a few years later, the same strategy failed against Jamie Haywood. However, as Jamie makes clear in her [email to the whistleblower](#) and in [the statement she made in court](#) Devra West did target her and her infant child with occult attacks. Just as Devra West targeted Dr. Cole's friend Rebecca West (no relation to Devra West) in an attempt to intimidate her into withdrawing her witness statement in the matter of West's assault against Dr. Cole MD. Here is a short excerpt of what Rebecca wrote in a harrowing email to the whistleblower in March of 2007:-

*I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. **I need support in how to deal with her shamanic witchcraft. Can you tell me more?***

Reynolds and Williams know what is going on they are aware that West is committing crime on an industrial scale but believe that the authorities are totally unable to do anything about it.

## **WE BELIEVE THAT DEVRA PATTON WEST IS CRIMINALLY INSANE, A PATHOLOGICAL LIAR AND A SERIAL KILLER.**

Whether with Hitler, Stalin, Pol Pot or countless other despots, history shows that absolute power corrupts absolutely. Devra Patton West, because of her childhood, started out as a psychopath with her brother ending up dying in a mental institution. Prior to 1990, she was a small time con artist, drug dealer and bankrupt conning individuals like [Jeremy Samuelson](#) and [Satya](#) out of several thousand dollars apiece. Only after acquiring occult knowledge in 1991, did Devra Patton West's psychosis come full to the fore. Prior to that she was more likely to end up in jail for her crimes; after all, if she had used a gun to murder someone, the gun and bullet embedded in the victim, could be used as evidence against her.

However, after attending the Robert Jaffe School for Energy Mastery between 1990 & 1991, Devra West acquired a murder weapon that was not regarded as a weapon under legal statute.

So by virtue of a gap in the law, and by virtue of Devra West being a self-serving asshole with no soul, she could commit murder after murder without consequence. Hence Reynolds' announcement to the Bigfork Eagle newspaper predicting the murder of the whistleblower, an announcement that made it clear that this was not the first time West had committed murder, that it was routine and that Reynolds was quite happy about the prospect. So happy that when the 2007 murder plot failed, Reynolds waited for three years until 2010 to be part of a conspiracy with West to extort \$10,000,000 from John Watson! You get some idea of how corrupt and scum-like Reynolds is, when you realize that he had never met John Watson but just was happy to go along with murder and then criminal conspiracy. Julio Williams is no better. Over the past 4 years, the whistleblower has sent his 300 to 400 emails detailing West's ongoing campaign of occult 'under the radar' intimidation that is still being directed at him and his family. Williams does not respond nor does he share the emails with the police or the authorities, as to do so would result in him and the cult coming under investigation, which is the purpose of these emails.





**Step 1.** Those identified as wealthy targets are invited to attend a ‘Private’ Sessions or a ‘Private’ Intensive’ as advertised on her website below.




**Step 2.** Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them! Listen to [two of her admin staff](#), Diane Stoner and Kathleen Francisco talking about one this.

**Remember, Devra West is an Occult Master who can, using Shamanic Visioning, induce illness, injury and even death in those she targets with little chance of the crimes being connected back to her. In the above scam, she ‘induces’ the symptoms in those who do not believe or do not pay and then miraculously cures them after they go to her ‘Pay Portal’ and make a large six figure ‘donation.’**

**Step 3.** The victims go to the Sage of Sedona’s [‘Pay Portal’](#) which is set up to receive single donations of up to \$500,000 or more by pressing a single button or a combination of buttons. In this way the target receives an imaginary cure and in return [The Regent of the Spiritual Hierarchy of the Western Hemisphere](#) gets to empty the targets bank account into hers. Note her standing there with her hands out saying “give me, give me.”



This has been going on for 27 years right under the noses of the FBI and the IRS. It is illegal for a lay person to assert that they are able to cure someone of a health condition. Apparently not so for Devra West! At \$500,000 a go, it is no wonder she can afford the trappings, clothing, lifestyle and home of a multi-millionaire even though she claims to be penniless and the funds she extorts from victims are nowhere to be seen, let alone declared to the IRS as income in her tax returns.
