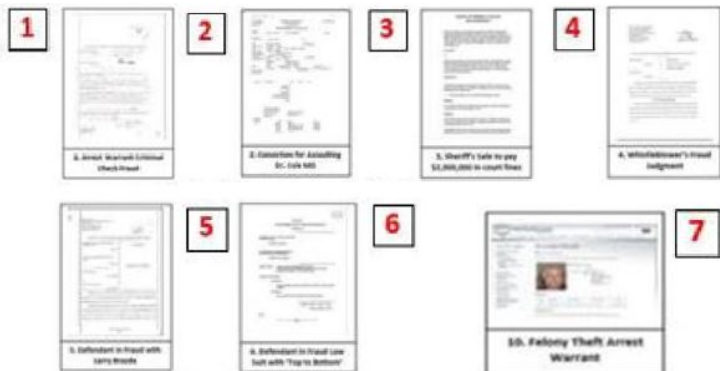

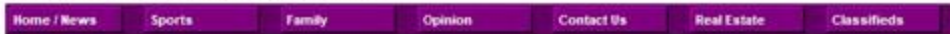

Spiritual leader has plans for healing center in Whitefish

1. Devra Patton West, currently calling herself the Ascended Master Surya Ma, faces **criminal charges** stemming from an alleged assault on a Whitefish doctor.
2. West is facing allegations ranging from **black magic** to **fraud, extortion** and **breach of contract**.
3. A temporary **restraining order** against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection.
4. Cole claims West **abused her verbally and physically**. "She has told me that she has the 'spiritual' power and authority to **'take me out,**' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at

her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

5. Michael and Lori Hendrickson, of Colorado, worked with West in Victor and paid off a promissory note for West's foundation in 2005 to prevent foreclosure. They are now suing West, the Sacred Archives Institute, West's husband and Dr. Cole for **breach of contract**, claiming West moved the money out of the foundation to a personal trust.

6. Here in the Flathead, West ran into problems over several properties where she lived. On June 1, **she was evicted** from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. According to court documents, **West is behind in payments on the second home**. The issue has not yet been resolved, according to one of the homeowners, Larry Brazda.

7. A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently **misrepresents her involvement with our house**, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' **For two years, she claimed she was going to buy our home**. **She wrote a bad check for several million dollars** to the Realtor, and that was our experience with her."

8. Her former business consultant and stockholder in Millennia Mind, John Watson, is **suing her for fraud, constructive termination and breach of contract**. Watson claims he was not paid for the services he provided, including setting up stock in Millennia Mind. "She is an evil and dangerous woman." According to Watson, when he demanded payment and threatened to sue, West psychically **attacked him and his family** by sending migraine headaches from Lakeside to their home in Nova Scotia.

Trial scheduled in Lakeside assault case

1. A Lakeside woman who claims to communicate with long-dead religious masters will face a **jury trial** Sept. 18 in Flathead County Justice Court on misdemeanor charges **she assaulted a Whitefish doctor**. A temporary **restraining order** against Devra Patton West, a self-styled guru who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, **requested protection**. Cole claims West assaulted her in April 2006 and again in October 2006.

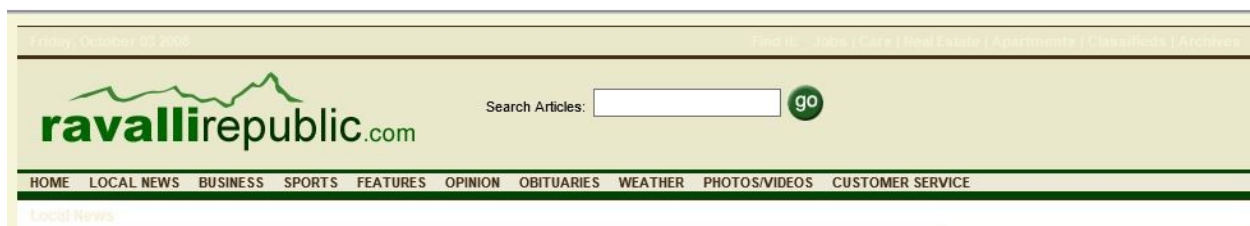
2. Speaking for West, [**senior cult member and 'liar for hire'**] Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault. Reynolds told these lies knowing that West had admitted the assault in writing in a missive she had sent her cult mailing list on April 17 2006. The missive was entitled '[The Law of Severity on the Path to Purification](#).' In the missive psycho bitch West **admitted the assault** but asserted that as the victim was a Nazi in the WWII death camps **in another lifetime** the beating was long overdue. Additionally 'liar for hire' Reynolds, at the same time he was denying the assault, was busily writing [emails](#) to the service provider of John Watson's website desperately trying to remove a copy of that written admission of West's guilt from that website.

3. The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when **Cole appeared wearing a bloody sweatshirt**. The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said **West hit her on the head with a shoe**, the roommate said.

4. Reynolds claims Cole owes West \$753,484 and that colors Cole's allegations. Cole's bills for 2004-2006 totaled \$1.3 million, including \$250,000 for an "internship" under West and \$213,750 in "therapy fees" for eleven months last year. Cole managed to pay West \$621,484, but it didn't come easy. At one point, Cole cashed out her IRA and paid West \$293,843.
5. Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.
6. Besides being evicted from her Bayside home in Lakeside, and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.
7. Rebecca West claimed she left her job because she was afraid for her safety and did not want to become a victim of physical abuse by Devra West.

***Business partner of Victor Guru wins lawsuit

1. The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court. Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages. Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment.
2. Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines. West did not attend Thursday's hearing. Her business manager, [senior cult member and 'liar for hire'] Geoff Reynolds, attended but declined to comment and said West would not comment.
3. Watson said West was a "crook" who operated a "cult." He said she "brainwashed" people into giving her money - in part by falsely claiming to have a doctor of philosophy degree and a doctor of divinity degree - and turned them into "slaves" who did menial tasks at her bidding. "She trolls for people who are spiritually confused and looking for a guru," Watson said. "She has some spiritual abilities and a pretty extensive record of charisma and the ability to capture people's attention. She's very believable. That's how I got sucked in."
4. West also has been involved in criminal and civil legal cases in Flathead County, including filing a libel suit against Watson. West pleaded no contest earlier this year to assaulting a Whitefish doctor who also was a former business partner. West was sentenced to a six-month deferred jail term and a \$500 fine.
5. But six months after becoming partners, West said God had given her another message - "that shareholders and corporations were a thing of the past" - and that she wanted to dissolve Millennia Mind, Watson said.
6. Watson's attorney, Dave McLean of Missoula, played a tape recording of a March 2003 meeting between Watson and West that ended in a profane tirade by the self-styled clairvoyant and spiritual healer. Watson, who taped the meeting, was heard telling West she couldn't simply walk away from a contractual agreement. Watson told her that she disposed of "a lot of people like Kleenex" and "you will not do that to me."

Here are excerpts from that March 2003. Decide for yourselves if this sounds like a guru or a gangster! Listen to "the light behind leaders and world servers" basically affirming that she is criminally insane.

1. Victim of Murder at the hands of Devra West - Lisa Swidler. After Devra Patton West was allegedly defrauded by another con-artist out of \$650,000 in 2005, (follow [this link](#) for details) she decided to harvest funds from several of the wealthier members of her cult. Accordingly, she arranged a 14 day bridging loan of \$30,000 from student [Dave Kushner](#), which she never repaid. At about the same time she kidnapped, falsely imprisoned and beat student [Marion Cantwell](#) until Marion agreed to 'donate' part of the proceeds of the sale of her home to Devra West. Lisa Swidler, witnessing these two crimes tried to escape the cult and died shortly afterwards. Dead men tell no tales and as a confidant of Devra West, Lisa knew where many of the skeletons were hidden so she was murdered by Devra West to silence her. However, because the murder weapon is not regarded as a weapon under legal statute, Devra West did not even get a visit from the police; though she had plenty of motive to silence Lisa and plenty of opportunity.

2. Victim of Extortion, Kidnapping, Assault and False Imprisonment – Marion Cantwell. After being forced to share the proceeds of the sale of her home with Devra West, Marion Cantwell was told that if she went to the police she would be murdered. Clearly, Devra West uses her ability to commit murder, without fear of being held accountable, as a 'tool' to both leverage her criminality and additionally to ensure that both victims and witnesses do not go public about what happened to them. This is why 90% of victims do not seek redress through the courts or the police. As a foot note, some months after her ordeal Marion Cantwell relocated to California to start a new life there. At which time her new prospective employer, having discovered that Marion used to be involved in Devra West's cult after an internet search, contacted the whistleblower via his website for a reference. The employer wanted an assurance that Marion was a victim of the cult and in no way part of the criminals running the cult. The whistleblower was happy to give that assurance.

3. Victim of Extortion, Multiple Violent Assaults and the subject of a Planned Murder – Dr. Pat Cole.

In the two years following Devra West's vicious assault on Dr. Cole MD, as part of a campaign of violence to extort \$1.3 million from the victim which, with the help of accomplices she succeeded in doing, Devra West vehemently denied the assault. She did so both [in court](#) when appearing as a witness for her son in his custody battle for his infant daughter and from [her website](#). In the posting she made on her website, she claimed that she had not been found guilty of the assault but that the "victim's bogus claims" had been dismissed by the court and went on to accuse the victim of being part of an extortion scam against her! The facts are that Devra West was found guilty of the assault, a fact corroborated by a news article that appeared in the Whitefish Pilot newspaper in [April 2008](#). Germane to these statements is the fact that one of West's employees, Carlida Finch, overheard Devra West planning the murder of Dr. Pat Cole MD. 4. Victim of Fraud, Intimidation, False Witnesses, Occult Under The Radar Violence, a Failed Murder Attempt and a Conspiracy to Extort \$10,000,000 from Him – John Watson AKA the Whistleblower.

In 2002, acting as a business consultant, and after completing the tasks set him, Devra Patton West, then calling herself the Ascended Master Devra Ji, announced that she was not going to pay John Watson the monies she had agreed for the 6 months work that he had just completed. Long story short, she defrauded him. At a meeting at his property in March 2003, a meeting she asked for after John Watson announced he was going to sue her for fraud, she admitted defrauding him and told him that if he sued her for fraud she would get [so f*cking down and dirty](#) – huge expenses coming out of his pocket and not hers. In the 5 years between launching his lawsuit in 2003 and winning it in 2008, Devra West used senior cult member Julio Williams to first [defame him](#), and then in 2007 attempt to intimidate him [via email](#). She forced her employees to write [false statements](#) about him that she intended to use against him in court. She mounted a campaign of 'under the radar violence' against him and his family members, conspired with Geoffrey Reynolds to murder him and when that failed, conspired with Geoffrey to bankrupt him using a pair of frivolous defamation lawsuits against him (for telling the truth) which she knew he could probably not afford to defend.

THE VICTIMS OF THEFT, FRAUD, EXTORTION AND VIOLENT ASSAULTS SAY OTHERWISE...

Incidents of Extreme Violence. Below are three female cult members who were viciously assaulted by Devra Patton West. These incidents were well documented, as each violent assault was witnessed by several other members of the cult.

1. Susannah Felder. In July 2001, employee to the charity Susannah Felder challenged Devra West about an \$80,000 donation she had stolen from the charity to pay for her son's legal fees, in respect of a custody battle he was fighting with his ex-wife over their infant daughter. Upon being challenged Devra West grabbed hold of Susannah's hair and ripped a clump of it from her scalp. Ex-board member of the charity AJ White in [her notarized statement](#) describes the assault against Susannah, describes Devra West's angry outbursts towards others and also describes how, the following day, then husband Jack West sought to blame the victim for being attacked. Devra West believes, ignoring state and federal law, that all the cash donations to the charity from the public were hers to do as she pleased with them! In spite of the fact that donors were told the fund raising was to buy land or pay off the charity's mortgage.

2. Beatrice McGuire. Student (to West's unaccredited school The Sacred Archives Institute) Beatrice McGuire while attending a seminar in Montreal, challenged what she thought was an obvious lie by Devra West. In front of a large audience, Devra West attacked Beatrice ripping part of her ear away and necessitating Beatrice to have plastic surgery to repair the damage. Student Debra Coffey's [written account](#) of what happened makes harrowing reading as not only did she and tens of others witness the incident but as Debra states this level of violence was a regular occurrence with West often denying she was at fault saying that it was "God who did it." Devra West later agreed to pay for Beatrice to have plastic surgery but denied she was at fault stating in a letter that her recollection of events was different from Beatrice's (and presumably tens of other witnesses?). In March 2003 John Watson, later to turn whistleblower about Devra West's criminality, challenged Devra West about her assault on Beatrice McGuire. Showing yet again that she was a pathological liar, Devra West denied the assault saying that Beatrice was mentally ill – when in reality it is Devra West who is criminally insane. 3. Dr. Pat Cole MD. After Devra West's charity was [struck off](#) for fraud by the Secretary of State for Montana in January 2004, she was forced to move her criminal racketeering business model from Victor MT to Lakeside MT. On the way, she changed her name from Devra Ji to Surya Ma and had a series of corporate 'containers' many of which were involuntarily revoked or dissolved. Announcing her move 100 miles north from Victor MT to Lakeside MT, she told the members of her cult that she could only take 12 disciples and only those who would [donate 66% of their net worth](#) to her good causes. Dr. Pat Cole was one of the 12 disciples who agreed to donate their wealth to Devra West in exchange for being allowed to accompany her to 'Shamballa.' However, Cole was slow in handing over her wealth so Devra West, conspiring with members of her cult as described by student Debra Coffey [in her statement](#), mounted a campaign of overt and covert violence against Cole which ended up in the police being called and Devra West being charged with assault.

There were several witnesses to the assault including [Carlida Finch](#) who overheard West planning Cole's murder. The police were called and Devra West was charged with assault. Days later on April 17 2006, Devra West wrote a lengthy missive entitled [The Law of Severity on the Path to Purification](#) wherein she admitted the assault and admitted it was severe though sought to justify the attack by asserting the victim was a Nazi in the WWII death camps in another lifetime! However, when news of the assault broke in the [Whitefish Pilot](#) newspaper in July of 2007, Devra West and the senior members of her cult all vehemently denied that Devra West had assaulted Dr. Pat Cole MD. 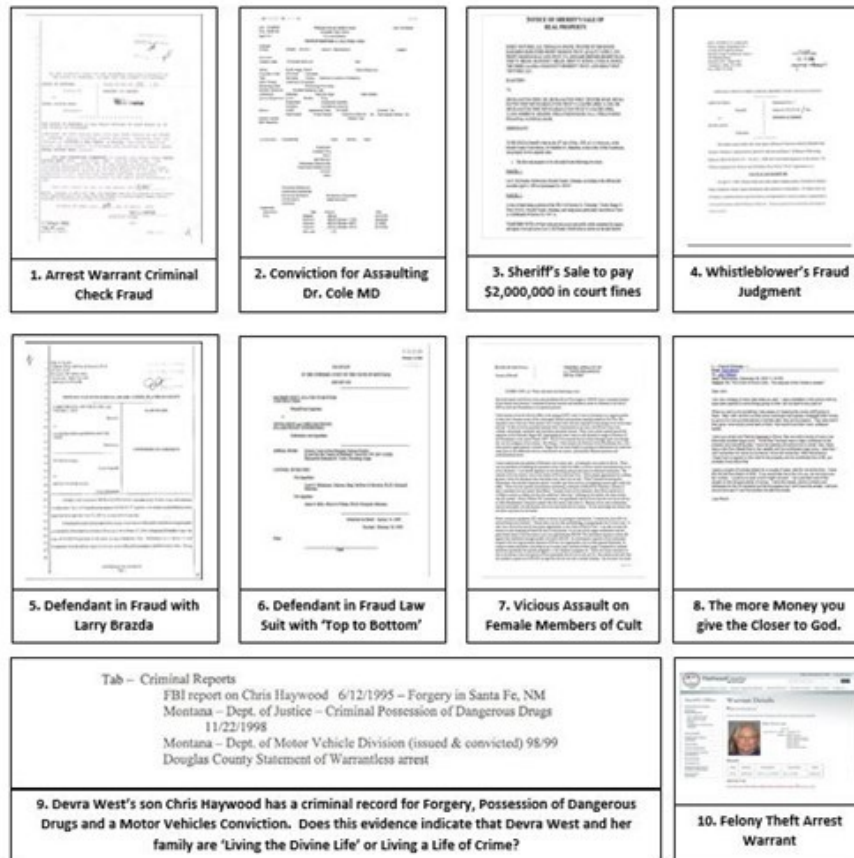

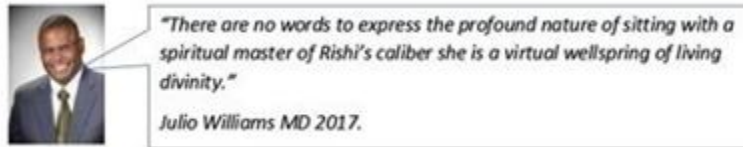

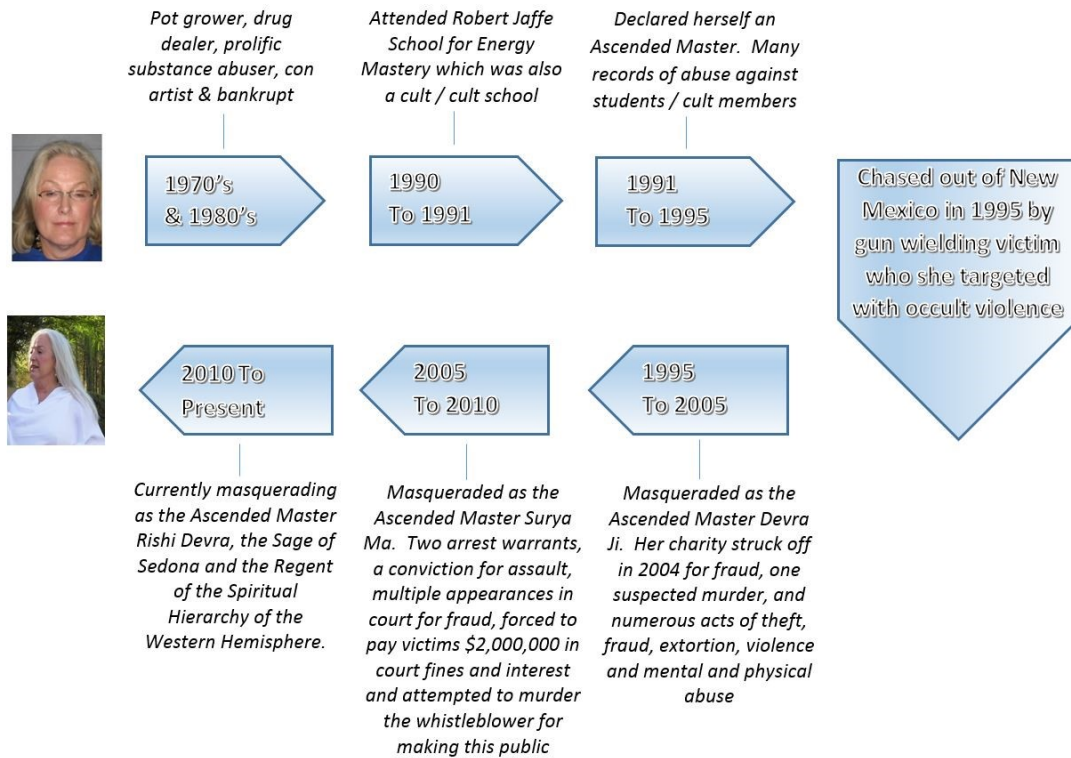

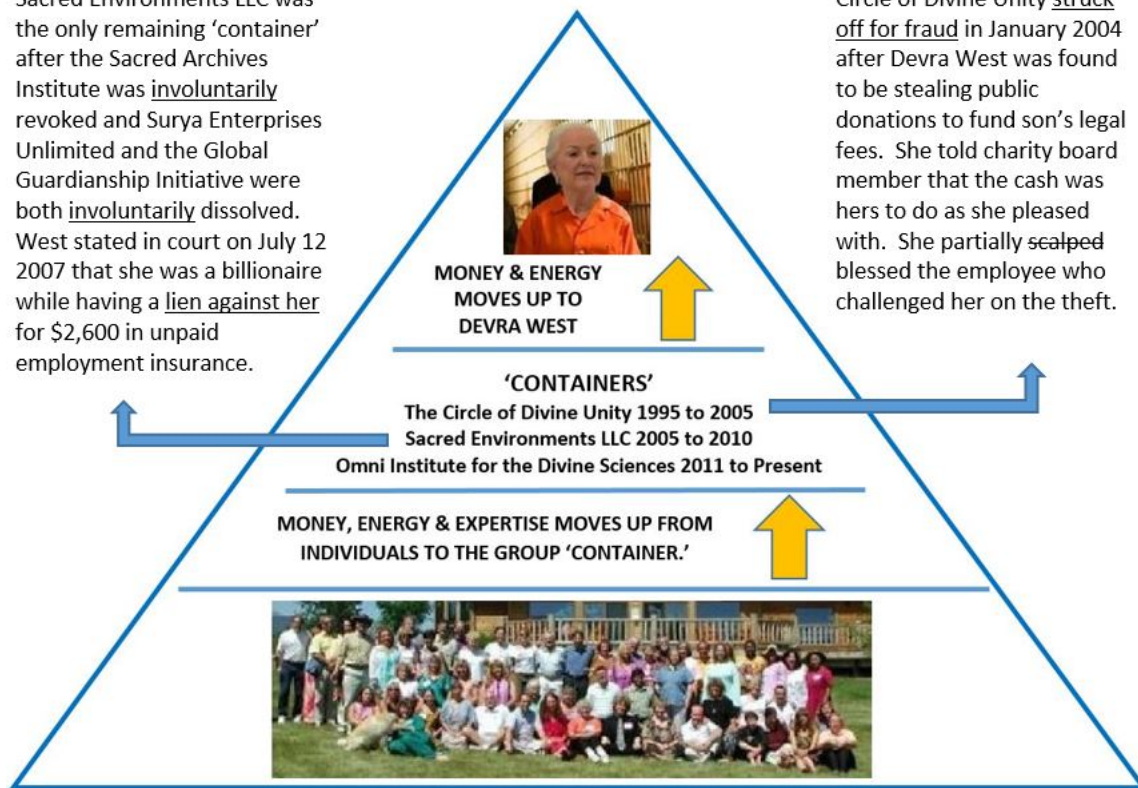

Sacred Environments LLC was the only remaining 'container' after the Sacred Archives Institute was involuntarily revoked and Surya Enterprises Unlimited and the Global Guardianship Initiative were both involuntarily dissolved. West stated in court on July 12 2007 that she was a billionaire while having a lien against her for \$2,600 in unpaid employment insurance.

Circle of Divine Unity struck off for fraud in January 2004 after Devra West was found to be stealing public donations to fund son's legal fees. 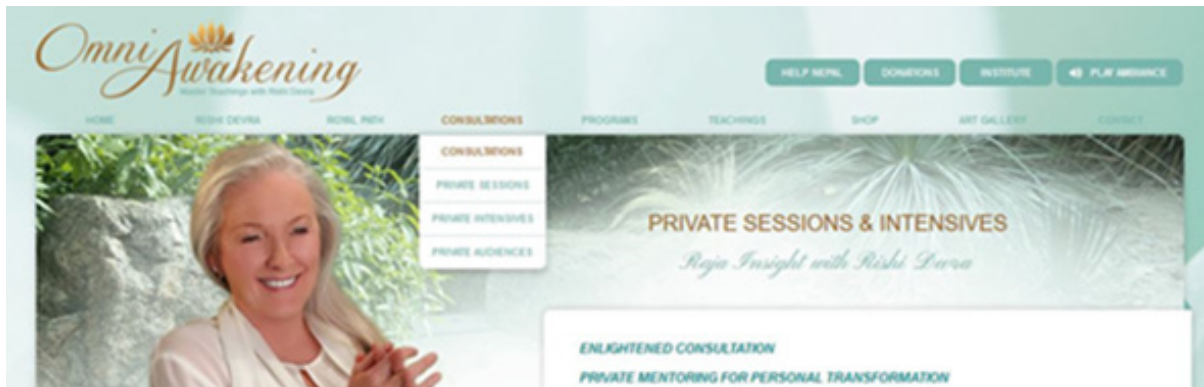

Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

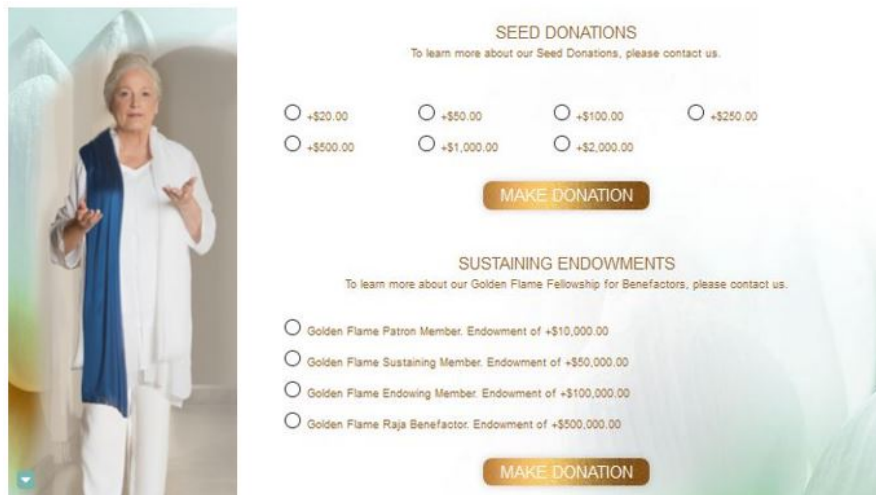
1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
