

The [Whitefish Pilot](#) newspaper article laid bare Devra Patton West’s criminal racketeering business model in Montana. It made the public aware that Devra Patton West was the defendant in several fraud related lawsuits and was at the time, being prosecuted for assaulting a local female doctor who West was in the process of extorting \$1.3 million from. Then there was the matter of West knowingly and wilfully fraudulently

misrepresenting a multi-million dollar home belonging to Robert & Tabby Ivy, as belonging to her. In fact, for two years West showed images of the property in her brochures and on her website, implying that she was the owner. The real owners repeatedly asked West not to use their home in this way, but West, a Satanist and dangerous psychopath, ignored their requests.

Three weeks later, a second newspaper article was published in the [Bigfork Eagle](#) newspaper which made it clear that Devra Patton West, while masquerading as a billionaire while giving evidence in court for her son on July 12 2007, was in fact nearly bankrupt (for the second time). The second newspaper article showed that West had a lien against her for \$2,600 in unpaid employment taxes and had been evicted from two rental properties in quick succession. It was also clear from statements given by senior cult member Geoffrey Reynolds, that he had money laundered \$460,000 that had been extorted from Dr. Pat Cole MD. On October 2 2008, an article appeared in the [Ravalli Republic](#) newspaper detailing how Devra West had defrauded John Watson who, while researching his lawsuit, found that there were literally scores of victims of theft, fraud and extortion. Some 90% of the victims were members of her cult who, having been brainwashed and conditioned, were reluctant to go to the police or seek justice through the civil courts as they knew they would be targeted by West and risked illness, serious injury or death.



Above. **Lisa Swidler** murdered by Devra West after she tried to leave the cult. Lisa arranged a \$30,000 two week bridging loan with cult member Dave Kushner – once in receipt of the money, West refused to repay it or even speak to Dave Kushner, even though West had signed an agreement to repay the money. As West told John Watson in March of 2003, [her agreements are worthless](#). **Marion Cantwell** was kidnapped, held captive and beaten By West until Marion agreed to give up a large part of the sales proceeds of her house. Dr. Pat Cole MD was a student of West’s and her business partner in West’s latest greatest ‘save the world’ fund raising scheme. Cole was repeatedly beaten as part of a campaign of violence, whose objective was to separate the Whirlpool heiress from her fortune. West succeeded in doing that but was convicted of misdemeanor assault and fined \$500 and given a 6 month suspended jail sentence. The April 24 2008 newspaper article speaks to Devra West’s conviction for assault which she and the cult [denied had occurred!](#)

John Watson was a consultant that Devra West had hired to help with her latest and greatest save the world scheme which in reality, were just fundraising exercises that resulted in all the monies going into West’s pocket. If West could defraud or extort money from consultants or employees, then that was a bonus. In March 2003, John Watson announced he was going to sue Devra west for fraud. In the time between that announcement and him getting judgment against West in 2008, he became the subject of a series of dirty tricks designed to force him to drop his lawsuit against Devra West. These dirty tricks included defamation from the cult, threats from the cult, his family became the subject of a campaign of ‘under the radar’ violence from Devra West, and he became the subject of a failed murder plot in 2007. Then in 2010, he became the subject of a conspiracy to bankrupt him.

Witness tampering is punishable by up to 20 years in jail if physical force was used, attempted or threatened.


FBI TAKE NOTE. In the United States, the crime of witness tampering in federal cases is defined by statute at [18 U.S.C. § 1512](#), which defines it as "tampering with a witness, victim, or an informant." The punishment for such an offense is up to 20 years if physical force was used, attempted, or threatened. The tampering need not have actually been successful in order for it to be criminal.

Therein lies the problem, as Devra Patton West does not have to use 'physical' force. As an occult master trained in Shamanic 'visioning' she can direct a campaign of occult 'under the radar' violence at victims and witnesses with the intention of causing severe illness, injury or even death.

Devra West is not a guru, Devra West never was a guru. She is and always was a vicious criminal who chose to masquerade as a guru because doing so gives her a place to hide in plain sight.

Devra West's early criminal life – 1970's & 1980's.

If we look at Devra West's pedigree, we see that prior to acquiring occult (hidden) knowledge in the early 1990's, she was already a common criminal operating outside the law. As witness / victim Jeremy Samuelson relates, in the [statement](#) he sent the whistleblower John Watson in 2007, Devra West and her husband Jack West were pot growers / drug dealers who had defrauded him out of \$10,000. In 1991, Devra West defrauded [Satya](#), a class mate of hers at the 'energy mastery' school, out of \$6000. In other words, West's desire to manipulate, rob, defraud and extort money from others was already ingrained in her before she decided to announce her ascendancy to the status of an Ascended Master.




As a consequence of acquiring occult (hidden) knowledge while attending [The Robert Jaffe School for Energy Mastery](#) between 1990 & 1991, Devra West achieved two important objectives.

1. As a narcissist who thought she was superior to everyone else, Devra West now had some tricks up her sleeve which she could use to convince spiritual seekers that she was a 'divine being,' a Master Teacher to be worshipped and obeyed.

2. After acquiring a certain level of skill at Shamanic visioning, she was able to exponentially leverage her criminal tendencies. She could do this because the Shamanic skills she had acquired, could be used as a weapon to manipulate the sheeple (spiritually confused persons who cannot tell a devil from an angel) into doing her bidding. It could also be used to facilitate theft, fraud, extortion and to intimidate victims and witnesses into silence or murder her victims and witnesses, all with plausible deniability. Below are a couple of links. One explains how she uses the occult to intimidate victims and witnesses and murder those who challenge her. The other is a link to her Brazilian counterpart 'John of God' who was recently arrested for child sex trafficking and a range of other offenses. Note with him, the use of occult knowledge at the time of his arrest and how afraid victims were to come forward until after he had been arrested. We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path. Jaffe responded months later and threatened that I could become sick and die from something like cancer for leaving. That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it.

We know from witnesses, that Devra West took the Robert Jaffe playbook and adapted it for her own use. After completing her training in 1991, she declared herself to be an Ascended Master stating that anyone disagreeing with her was 'blocking the energies.' Very quickly, she formed a personality cult around herself and proceeded to do what all narcissists / psychopaths do, which is to assert their divine right to rule over the lives of others while

harvesting the energy and the finances of those trapped in the cult to better themselves. We also know that Devra West used the threat of murder as a way of intimidating victims, witnesses and the members of her own cult into remaining silent about her criminal acts. A document entitled '[Pats Records](#)' which was given to the Flathead police department in 2007 references the fact that Devra West mentally and physically abused several of the members of her New Mexico cult. Until one day she targeted the wrong person, who literally chased her out of the state in the middle of the night with a large loaded gun!





Note that in 2014 Julio Williams was well aware of all the crimes Devra West had committed in Montana including the two arrest warrants, conviction for assault, her being the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest. Second left: [This image](#) contains an excerpt from a statement Williams posted on Devra West's website in 2005. The statement defamed John Watson decision to sue Devra West for fraud. Williams went on to stake his reputation that Devra West was a good humanitarian etc. Below the excerpt of his statement is a 2009 arrest warrant for Devra West in respect of felony theft. So much for Williams' reputation! The third left image shows [a statement Williams posted](#) on West's website in 2007, basically asserting that she was some kind of divine being who graciously allowed him to call her Surya Ma. Williams made this statement knowing that West was being investigated for assaulting Dr. Cole MD, knowing that West was being sued for defrauding John Watson and knowing that West was fraudulently misrepresenting a multi-million dollar property belonging to someone else as belonging to her. The [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) newspapers give the details of these crimes and much more.

The [fourth left image](#) is a statement that Williams posted on West's website in 2014 wherein he asked for donations for West who was raising money for the 'Divine Feminine.' Williams agreed to do this knowing that Devra West regularly assaulted the female members of her cult and was about to be convicted of assaulting Dr. Pat Cole MD. The [fifth left image](#), like the second image, was Williams stating his reputation that Devra Patton West was a humanitarian and that she was being maligned by John Watson who was suing her for fraud. This image shows Williams' statement attached to a notice announcing a Sheriff's Sale of all of West's assets to pay her creditors \$2,000,000 in court fines and interest. The [far right image](#) is of a recent posting on West's Facebook page wherein she announces that she is a blessing to all souls in the Sedona & Scottsdale cities and that as an instrument or mercy she is able to deliver 'divine grace healings' and 'dispensation of karma' (for a large fee).

The [left hand image](#) shows Devra West dressed as a Greek Goddess with the text below inviting potential victims of extortion to attend a 'Sacred Sunday with Rishi' at Dr. Julio Williams home. Upon arrival Williams will affirm that the leader of his cult is indeed a divine being and is capable of delivering 'divine grace healings' if the victim can afford \$500,000. The [second left image](#) is yet another example of Dr. Williams staking his reputation that Devra West is not only honest but a divine being. In this example his words are attached to a newspaper article announcing Devra West's conviction for assault in April 2008. The [third left image](#) is a statement written by Dr. Julio Williams in July of 2007 denouncing the press for printing an article about Devra West's vicious assault on Dr.

Pat Cole. Williams, of course, denied that the assault ever occurred and demanded a retraction of the statement and an apology. (West was convicted in April 2008).

The [fourth left image](#) was an excerpt from a statement that Devra West sent to her mailing list circa 2004, after her charity was struck off for fraud. Instead of admitting the fraud and the need to move away from the area, Devra West, then calling herself Devra Ji, announced that she was moving from the fifth dimension to the seventh and that, as a result of the discomfort caused by the dimensional shift, she needed to move 100 mile north to Shamballa. Clearly, Reynolds and Williams are not 'normal' employees, colleagues or just friends of Devra Patton West. Their actions are the actions of members of a cult / criminal gang who are carrying out the instructions of their cult /

gang leader. It is obvious that apart from being complicit in Devra West's attempts to murder the whistleblower John Watson, they are employed by her to [intimidate witnesses](#) (witness tampering). In the United States, the crime of witness tampering in federal cases is defined by statute at [18 U.S.C. § 1512](#), which defines it as "tampering with a witness, victim, or an informant." The punishment for such an offense is up to 20 years if physical force was used, attempted, or threatened. The tampering need not have actually been successful in order for it to be criminal.




Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.
