

Subject: Gang members Geoffrey Reynolds & Julio Williams both willing accomplices in a plot to murder the whistleblower to hide Devra Patton West's criminal past in Montana.

Dear FBI, IRS and Sedona & Scottsdale police departments,

We make the case once again that you launch an investigation into Devra Patton West's criminal racketeering business model that is currently targeting the spiritual / metaphysical communities of Sedona and Scottsdale Arizona. Prior to 1990 Devra Patton West and her husband Jack West were small time crooks, drug dealers who were defrauding individual victims out of several thousand dollars each one at a time. After acquiring occult knowledge between 1990 & 1991 Devra Patton West used that knowledge to leverage her criminal tendencies with the result that she was soon netting millions of dollars a year from theft, fraud and extortion with victim's too afraid to go to the police for help.

The current con (modus operandi), which takes full advantage of religious freedom laws, has con artist Devra Patton West declaring herself to be a minor deity capable of delivering 'divine grace healings' and 'dispensation of karma' to those who are stupid enough and wealthy enough to believe the outright lies and propaganda on her current website. Using the lies posted on her website she draws potential victims into attending 'private sessions' with her where the wealthy amongst them are then targeted for extortion. Using the occult knowledge she acquired between 1990 & 1991 West makes the victims ill and then offers to cure them for hundreds of thousands of dollars. Those who pay, by making huge donations via her website, are miraculously cured. Those who do not pay become subject to a campaign of occult 'under the radar' violence until they do pay. Several victims have gone to the police only to be told that because the 'weapon' being used by West is not regarded as a weapon under legal statute there was nothing they could do.

Devra Patton West has been doing this right under the authority's noses for 27 years and by our estimates has extorted some \$50,000,000 from victims. We did not pluck this figure out of thin air as one victim in 2002 paid Devra West \$500,000 to be 'cured' of an apparently fatal condition that West gave them in the first place. Devra Patton West has built a personality cult around her ability to run rings around law enforcement, subvert criminal and civil court cases and literally get away with multiple murders. So blasé have the senior members of the cult become that, when in 2007, whistleblower John Watson caused two newspaper articles to be published about West's criminality in Montana, senior cult member Geoffrey Reynolds actually announced to the press that John Watson would be dead within 12 months. During the same interview Reynolds announced that Watson, his wife and children would become the subject of a campaign of violence. This strategy was intended to have Watson react to the violence being directed at his wife and children in a way that would send him to jail and not Devra Patton West and her accomplices. That campaign of violent intimidation is now in its 13<sup>th</sup> year. In 2010, having failed to murder Watson, Reynolds fronted a conspiracy orchestrated by West to bankrupt Watson via two frivolous lawsuits that had no merit. In Reynolds case, coached by Devra Patton West, he made totally false statements to a Montana court as part of West's conspiracy. He made false statements because he did not know Watson and had never met him. His lies resulted in a \$5,000,000 default undefended judgment which he immediately signed over to West.

**This is what criminals do if they cannot murder you or intimidate you they 'buy' the law they want by outspending their victims.**

For the past four years Watson has sent twice weekly emails to another senior member of Devra West's cult criminal gang Dr. Julio Williams MD. Williams has been a student of Devra Patton West's unaccredited school for occult studies for 19 years, Williams was tasked by West to defame Watson in 2005 and then threaten him via email in 2007. Neither Reynolds nor Williams knew John Watson however as senior members of Devra Patton West's cult both became involved in Devra Patton West's conspiracy to murder Watson, bankrupt Watson and in Williams case cover up the ongoing campaign of violence against Watson and his family.


**What we want you to understand is that Watson and his family are just one set of victims however this has been going on for 27 years! We estimate that at least \$50,000,000 has been extorted from perhaps hundreds of victims. We estimate that she may have murdered 5, 10 or 15 victims or more. 

The [Whitefish Pilot](#) newspaper article laid bare Devra Patton West's criminal racketeering business model in Montana. It made the public aware that Patton West was the defendant in several fraud related lawsuits and was at the time being prosecuted for assaulting a local female doctor who West was in the process of extorting \$1.3 million from. Then there was the matter of West knowingly and willfully fraudulently misrepresenting a multi-million dollar home belonging to Robert & Tabby Ivy as belonging to her. In fact, for two years West showed images of the property in her brochures and on her website implying that she was the owner. The real owners repeatedly asked West not to use their home in this way but West, a Satanist and dangerous psychopath, ignored their requests.

Three weeks later, a second newspaper article was published in the [Bigfork Eagle](#) newspaper which made it clear that Devra Patton West, while masquerading as a billionaire while giving evidence in court for her son on July 12 2007, was in fact nearly bankrupt (for the second time). The second newspaper article showed that West had a lien against her for \$2,600 in unpaid employment taxes and had been evicted from two rental properties in quick succession. It was also clear from statements given by senior cult member Geoffrey Reynolds that he had money laundered \$460,000 that had been extorted from Dr. Pat Cole MD. On October 2 2008 an article appeared in the [Ravalli Republic](#) newspaper detailing how Devra West had defrauded John Watson who, while researching his lawsuit, found that there were literally scores of victims of theft, fraud and extortion. Some 90% of the victims were members of her cult who, having been brainwashed and conditioned, were reluctant to go to the police or seek justice through the civil courts as they knew they would be targeted by West and risked illness, serious injury or death.



**Lisa Swidler** murdered by Devra West after she tried to leave the cult. Lisa arranged a \$30,000 two week bridging loan with cult member Dave Kushner – Once in receipt of the money, West refused to repay it or even speak to the Dave Kushner, even though West had signed an agreement to repay the money. As West told John Watson in March of 2003, [her agreements are worthless](#). **Marion Cantwell** was kidnapped, held captive and beaten By West until Marion agreed to give up a large part of the sales proceeds of her house. **Dr. Pat Cole MD** was a student of West’s and her business partner in West’s latest greatest ‘save the world’ fund raising scheme. Cole was repeatedly beaten as part of a campaign of violence whose objective was to separate the Whirlpool heiress from her fortune. West succeeded in doing that but was convicted of misdemeanor assault and fined \$500 and given a 6 month suspended jail sentence. The April 24 2008 newspaper article speaks to Devra West’s conviction for assault which she and the cult [denied had occurred!](#)

**John Watson** was a consultant that Devra West had hired to help with her latest and greatest save the world scheme, which in reality, were just fund raising exercises that resulted in all the monies going into West's pocket. If West could defraud or extort money from consultants or employees then that was a bonus. In March 2003, John Watson announced he was going to sue Devra West for fraud in the time between that announcement and him getting judgment against West in 2008, he became the subject of a series of dirty tricks designed to force him to drop his lawsuit against Devra West. These dirty tricks included defamation from the cult, threats from the cult, his family became the subject of a campaign of 'under the radar' violence from Devra West, and he became the subject of a failed murder plot in 2007 and then in 2010 became the subject of a conspiracy to bankrupt him.





Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them!
