Dr. Julio Williams MD is physician / thoracic surgeon currently working for [Essentia Health](#) in Fargo ND and at [Hendrick Medical](#) Center in Abilene TX. Williams grew up in the Dominican Republic where Voodoo is a recognized religion, so joining a Satanist Death Cult in the year 2000 run by a fair haired woman, must have been all his dreams come true at once. The big question is this. Would patients of the two hospitals mentioned above be happy knowing they would be operated on by a pathological liar who is a 20 year member of a Satanist Death cult? Probably not (see evidence below). Geoffrey Reynolds, not the brightest bulb on the Christmas Tree, was recruited by West in September 2006, was immediately duped into loaning her \$300,000 and then fell totally under her control hoping that joining her in a life of crime would see the return of his life savings. Reynolds is currently working for [McSwain & Co.](#) accountants in Olympia WA, where I seriously doubt his experience in money laundering, complicity to commit murder criminal conspiracy and other serious crimes will be useful (see evidence below).

For 27 years, since declaring herself an Ascended Master in 1991, Patton West has been operating her guru / cult / extortion business in three western states right under the authorities noses with apparent impunity. She chooses western states because the authorities either do not understand 'white collar' crime or choose not to prosecute it. For the past 3 years, that is 150 plus weeks, we have sent weekly bulletins to the FBI and local police forces in Arizona and yet this occult thief / suspected serial killer is still at large – why? We have provided a mountain of evidence to the authorities which indicates that there have been many victims of theft, fraud, extortion and mental and physical abuse. In addition, there has been one suspicious death (and according to West's ex-husband many more) and the well-documented case of Patton West's attempt to murder the whistleblower, John Watson, in Montana to hide her criminal past before she relocated to Arizona in 2011. Nothing brings home the fact that Patton West is a dangerous criminal more than the emails sent to the whistleblower by her victims.

**We are going to share below here just ONE of those emails that ex-employee Rebecca West (no relation to Patton West) sent to John Watson, the whistleblower. This email makes it clear that Patton West is a dangerous psychopath and not a guru. It also makes it clear that both Williams and Reynolds are accomplices in racketeering. The color coding for Reynolds and for Williams shows their complicity. The square brackets and insertion of images are mine.**

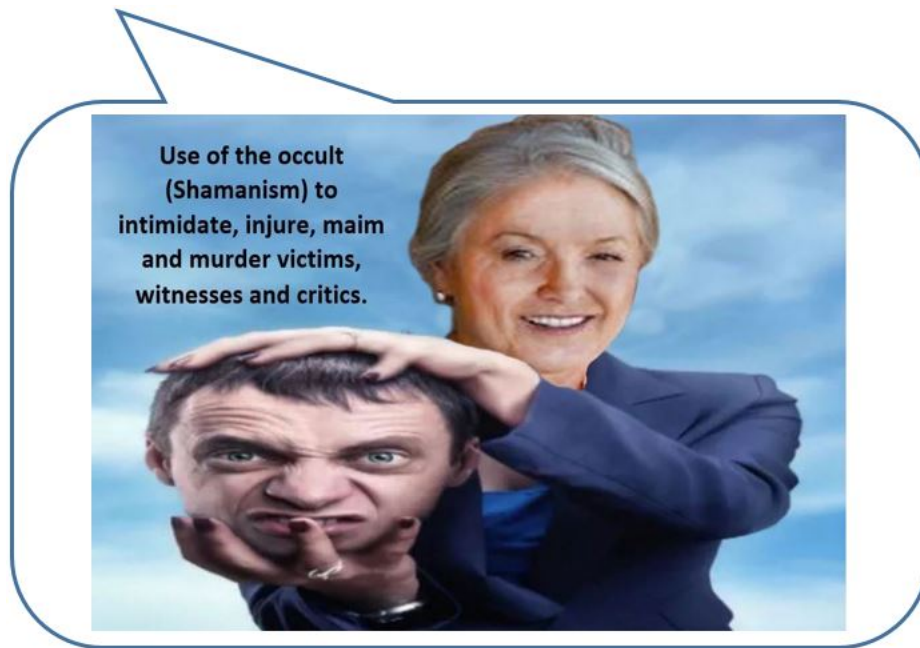
After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. [01] Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant). [02]

I have written her a letter that I have been hesitant on sending her, as I know it will create a wave of violent behavior and I have little to protect myself. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! I have been hiding in my home for many days now, afraid to go anywhere. This whole situation has been a horrible drain on my relationship with my partner, as he is having a very difficult time trying to understand what I am going through. In fact most "men" think it is no big deal, "if she comes after you "you can kick her ass!", what are you so afraid of?" This attitude is pervasive and includes her current finance controller, [Geoffrey Reynolds CPA] whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back while she relentlessly screams at me and publicly humiliates me before, during and after work, and advises if she comes after me, I should just kick her ass!

[03] My meeting yesterday with the Finance Controller [Geoffrey Reynolds CPA] was to discuss my unemployment issues as he had agreed to put me into a lay-off status, but has since reported to the State that I voluntarily quit! He recently treated a former employee as laid-off after Devra threw a book at her and then fired her. The companies owe large sums of money for WC, and ST, and Fed payroll taxes and was the reason he secretly laid-off Wendy Stuart, without confirming this choice with Devra first. He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said

that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job. Devra dangles the carrot and since he has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.

[04] I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her **shamanic witchcraft**. Can you tell me more?

I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available. [05] Again the crux is finding a law firm willing to take the case without a hourly payment of services. With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her.

I am aware that the only person still financially supporting Devra (the finance controller is out of money), is Dr. Julio Williams and he gave her \$100,000 last week. [06] Devra spends money so fast that this funding will not last long. I know she has hoarded all her expensive jewels, artwork and artifacts and in addition I contemplate how much money/jewels she has stashed in order to bail herself out in the event you are able to take her down completely, or if the funding does not come through.

Tanmayo's (Coca-Cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000. [07]

You can see that I, Dr. Cole and many others have much to lose and confidentiality between us is very important. I tried to talk to Dr. Cole about you and she feels you took your case too far...I will not pass judgment until you show me otherwise and beg of you to realize the vulnerable position I am in by living only 5 miles from her! I am more

than willing to talk to your Attorney to support the situation, all I ask is for your assistance in attempting to get my hard earned monies owed me through the MT ST Wage and Labor Board. I am aware there are several other former employees that filed claims with the MT ST Wage and Labor Board and any documentation or advice to support me in this endeavor would be greatly appreciated.

I know that unless the \$30M comes in this week, the Naka Shela Retreat Center is lost to foreclosure along with the house that Dr. Cole bought in Lakeside, which is where Devra lives (in the basement) with her son Che, his wife Jamie, and their newborn and 7-year daughters living upstairs. [08] Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month.

I just spoke with the finance controller [Geoffrey Reynolds CPA] this morning, and he is telling me that unless I talk to Devra today, I can forget about the monies owed me. I reminded him that a missing paycheck and overtime are due me even if she calls it a "Bonus" and that several other people have taken her to the labor board and I would be no different. [09] I have asked him to lay me off and to explain to her the repercussions of not paying me before I am forced to file a claim. I also told him I had no intentions of talking to her as I had already sent her a letter requesting the monies owed me, before I would be willing to talk to her. She responded a couple days ago by sending an e-mail to my private address where she stated she would not read my letter. It is obvious that she is afraid of me or she would have fired me already! I know too much, am a local resident, and have worked extensively with local law enforcement as a former Administrator of Emergency Services.

Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it! Until last week Dr. Cole thought she was all alone and was happy just to have a normal life again. Upon contacting her for the first time last week, (since the court hearing last November), she realizes and accepts the fact that there are many other victims, including myself and it is unfair for her not to come forward in an effort to stop Devra from continuing her deceit and corruption of innocent people. Unfortunately, it always comes back to a money issue and the fact that she has hidden her assets in her home which is about to be foreclosed on. (This very much alarms me as this may be the only way to get some of the money back to those she has robbed).

I have followed the \$30M CPEA funding issue closely and although the monies are earmarked for a 3-Tier Business Plan to develop Spas is the very way to pay off her debt to all of us. [10] If she thought for a moment that she could buy her way out would do so in a heartbeat even though she vindicates herself through the Masters as needing to prove she has done nothing wrong. According to the Masters, Dr. Cole and all the others got their due punishment and their reputations need to be destroyed in the interest of saving ourselves from their evil.

I know that I can never be in the same room with her again, due to her ability to read my mind. I am not sure how she does this and would greatly appreciate any light you can shed on her abilities. I must continue filling out a job application, so I will end for now. You can trust me and I pray you will do the same for us by keeping this information confidential. We are awaiting an answer from the Attorneys as to whether they will take this case without monies being paid up front. If not, would Jennifer Lint be willing to take our cases based on the additional 30+ people who have suffered? She must have a wealth of knowledge due to the many years of her involvement. It is too bad she quit working for you, and if it would help for me to talk to her, I would be willing to do so, but at this point only if the local attorneys are unable to do so, (we will know tomorrow).

If you align with Hendrickson's [11] Attorney instead, would he be willing to help us? I have the ability to bring to you 30+ former employees and with your 40 former students/employees statements maybe we can stop her! Devra checks your website daily so be careful for our sake. In addition, she has her computer technician check your site daily and at this point he has turned coat, although he has been my friend for 25 years! This only goes to show everyone how powerful her web of influence has on people!

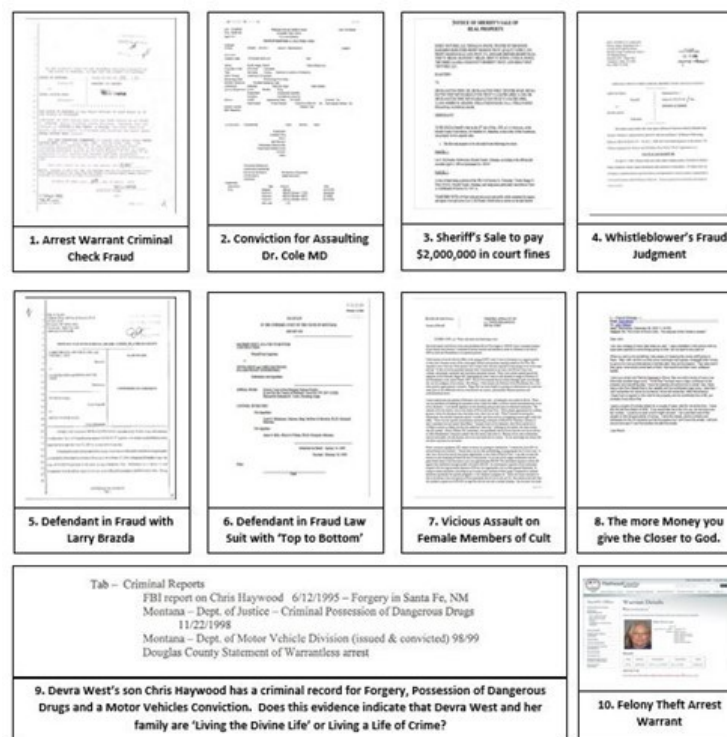

**[02].** Missing paychecks, overtime, overdraft charges and a promised bonus for the hundreds of hours of overtime I incurred. Told to attend a meeting at which I would be demoted to a lower position.

All of these actions break state and federal employment laws and yet, when Rebecca West went in front of an employment tribunal to complain about these matters, Patton West won the hearing due to the number of cult members she put forward as false witnesses. Below is a statement she posted on her website which makes a mockery of Montana state law employment laws.

**Labor Board Rules in Dr. Devra West's Favor:**

Even though the state of Montana is a pro-employee state on employment issues, the board ruled against the disgruntled employee's claim of workplace harassment, finding no such claims to be valid. The conspiracy scam to fraud state officials with false claims against Dr. West was duly exposed.

**TRUTH:** Devra Surya Ma's company Surya Enterprises operates at the highest levels that would be expected of a Master Teacher. A beautiful and harmonious office environment is operative without exception, as personally stated and supported by all of our employees.

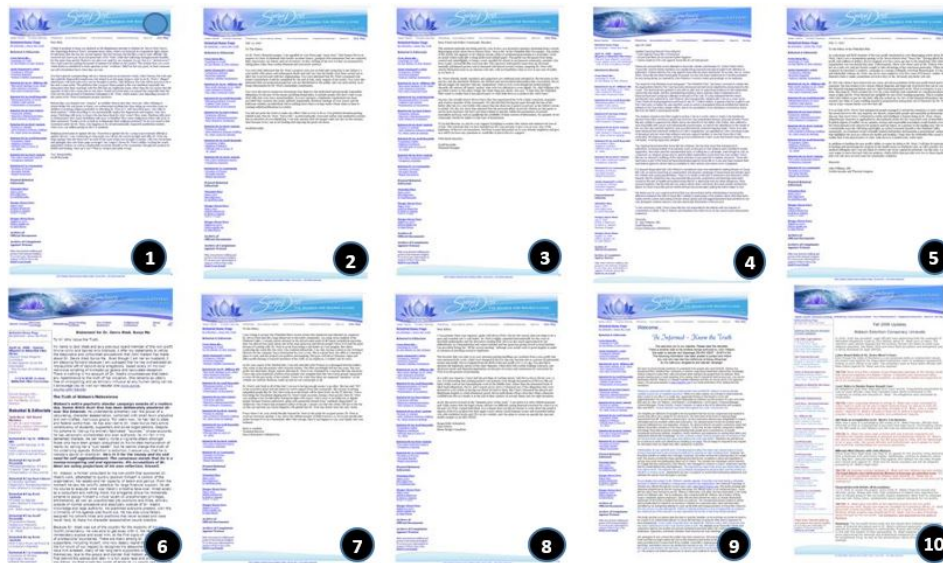

As proof that the above statement is a pack of lies and propaganda, a conspiracy to keep the public believing that Patton West is a guru and not the head of a criminal racketeering gang, we supply an excerpt from a [Statement of Fact](#) supplied by Carlida Finch. Carlida was another employee who was given the choice to resign or join Patton West's cult as a low paid or no paid slave. Carlida gave [this assessment](#) of Patton West

On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.</p> <p>Were the conditions temporary or permanent? <b>Permanent</b> Please explain how the working conditions affected you:</p>	<p>Dr. West believes that the rest of the world operates out of the "lesser" mind, as opposed to the "Christ conscious" enlightened mind. Unless willing to submit to Dr. West destroying the lesser mind through her techniques of Transpersonal psychology and eastern traditions she felt her employees had no value. It is disconcerting to be forced to adopt your employer's philosophy as modus operandi for your own life and discouraging to have 35 years of experience in the work place denegated for the same reason. Devra recently stated, after hiring Ray Solanki as her business manager that she would only hire disciples as execs for the corp, leaving those who don't join her with no chance for advancement. Mr. Solanki introduced himself as "from another planet" at the first staff meeting at which he was present. Devra was unhappy with the way employees treated her, we did not stand each time she entered or left the room. In the past she had rose petals spread at her feet by disciples</p>

In respect of her submission to the labor board, follow the links to read their ['Notice of Determination'](#) (the labor board's decision based on Patton West's submission and the submission of false witness statements by cult members) Carlida's ['Request for Redetermination.'](#) Let us not forget that Joseph Costantino, another employee of Patton West's, also made a claim for \$20,000 owed in wages by Patton West. He eventually settled for half that amount. This is [a letter](#) the whistleblower wrote to Pat Daniels at the labor board in his support. Then there is the matter of ex-employee [Susannah Felder](#) partially scalped by Patton West after Susannah challenged Patton West about a \$80,000 donation she stole from her charity to pay for her son's legal fees. Then there is the matter of Patton West's assault upon ex-student [Beatrice McGuire](#) in front of scores of witnesses. The vicious assault partly detached the victim's ear which needed plastic surgery to reattach; surgery that Patton West paid for but later [denied she was responsible](#) for the incident.

Then there is the vicious assault on Dr. Pat Cole MD for which Patton West was [found guilty](#) and sentenced to a 6 month suspended jail sentence and a \$500 fine. There is also evidence via [‘Pat’s Records’](#) (evidence given to Flathead Police) of many victims of mental and physical abuse, when Patton West operated in New Mexico between 1991 & 1995, before being chased out of that state in the middle of the night by a victim wielding a loaded gun who knew the police were powerless to help with Patton West’s occult ‘under the radar’ violence. Finally, [to read](#) or [to listen](#) to what Patton West’s Montana employees really thought of Patton West follow the previous two links. On July 12 2007, four short months after Rebecca West wrote this email, scum bag [Geoffrey Reynolds](#), Witch Doctor [Julio Williams](#) and other cult members posted the following statements on Patton West’s website in response to a newspaper article published by the [Whitefish Pilot](#) newspaper. The newspaper article led with Patton West’s vicious assault on Dr. Pat Cole MD, but also listed several other crimes being committed by Patton West at the time. There can be no doubt that Dr. Julio Williams knew about the 2006 assault but instead of coming to the aid of a fellow physician, he joined in the campaign of denials from other senior members of the cult.

These statements may well have been written by Devra West but attributed to the members of her cult. They all seem to have one author. No one would have the nerve to complain, lest they too become targets. Is it any wonder that victim’s attempts to get justice are thwarted by Patton West’s ability to garner so many false witnesses? A month later, while being interviewed by the [Bigfork Eagle](#) newspaper, scum bag Geoffrey Reynolds claimed that, and I quote, “Several people have been stirring up trouble by publishing untrue allegations against West.”

Clearly, Patton West’s claims that a *“a beautiful and harmonious office environment is operative without exception as personally stated and supported by all of our employees”* is a pack of lies that Julio Williams & Geoffrey Reynolds were happy to support as senior cult / gang members.



**[03]. A number of statements from Rebecca West show beyond reasonable doubt that Geoffrey Reynolds was turning a blind eye to organized crime being committed by Patton West against her employees right under his nose.**

Statements like these taken from her email and shaded in light blue above.

- 1. This attitude is pervasive and includes her current finance controller, [Geoffrey Reynolds CPA] whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children.*
- 2. He recently treated a former employee as laid-off after Devra threw a book at her and then fired her.*
- 3. He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot!*
- 4. I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back.*
- 5. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and **he will not tell the truth unless specifically asked** for the sake of keeping his job.*
- 6. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.*

**[04]. There is absolutely no doubt that Patton West is using the occult knowledge she acquired between 1990 & 1991 while attending the '[Robert Jaffe School for Energy Mastery](#),' itself a cult, to facilitate organized crime and murder.**

In a statement she gave to the press on July 12 2007 she stated, and I quote:-

*West claims to have been trained in [shamanic visioning](#) and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.*

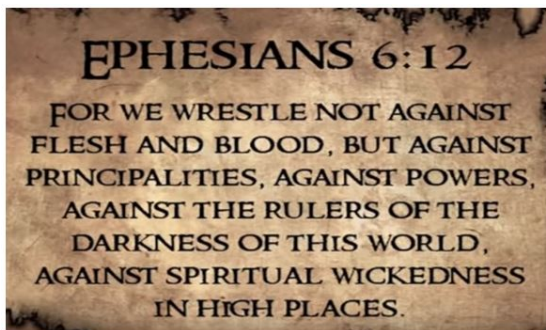
The statement made by Patton West in the last sentence of her interview above, reads like the statement from an egomaniac not a healer. It follows that if Patton West is capable of healing she is also capable of using the same knowledge to make those she targets ill. According to Rebecca West in her statement shown above, that is exactly what was happening to her and several other victims (all hostile witnesses to Patton West's vicious assault on Dr. Pat Cole MD). These victims, and the whistleblower John Watson, even phoned the Flathead police department to complain about the occult 'under the radar' violence being directed at them by Patton West. The [advice from the Flathead police](#) was for the victims to launch an 'intent to cause harm' lawsuit. Patton West's clear objective being to intimidate those she was targeting into withdrawing their hostile witness statements against her. The police, though accepting the complaints were genuine, stated that there was nothing they could do as the weapon being used by Patton West was not regarded as a weapon under legal statute.

Read the [email](#) sent to John Watson early in July 2007 by Patton West's own daughter in law, Jamie Haywood, who after becoming estranged from Patton West's porn loving, wife beating son, Chris Haywood, became the target of occult attacks by Patton West with the intention of forcing Jamie Haywood to give up her infant daughter to Chris Haywood. While attending the child custody hearing, Jamie Haywood mentioned the occult nature of the intimidation being directed at her by Patton West in the [statement she gave](#) to the court. This strategy of occult 'under the radar' violence was used successfully three or four years earlier against Chris Haywood's first wife Kendal. On that occasion, Patton West succeeded in convincing the court (by driving the mother almost mad) that her son, who had an [FBI record](#) for forgery, substance abuse and traffic violations, was better suited to bring up an infant child than the mother who had no criminal record. This is the same son that made an insurance claim after asserting that he was injured as a result of a car accident only to be seen [by a neighbor](#) wake boarding up the lake shortly after the alleged injury. The same neighbor, Michelle Fetveit, who after getting into a water dispute with Patton West started to be woken up at 3.00 am every morning fully aware that she was under occult attack. In addition to subverting and undermining court cases, Patton West has also used her 'weapon' to murder those who oppose her or go public about their experiences. According to a statement Jack West made to the whistleblower in 2002, those who oppose his wife had a habit of dying suddenly. This explains the sudden mysterious death of ex-student Lisa Swidler who died suddenly after trying to leave the cult in 2005. Lisa had

witnessed serious crimes committed by Patton West (two counts of extortion, kidnap and false imprisonment) against two of her students. Shortly after leaving the cult she died, with the coroner pronouncing her death as a result of 'natural causes.'

Finally, there is the planned murder of the whistleblower John Watson, that Geoffrey Reynolds CPA announced to the press while being interviewed on August 9 2007. In what scum bag Reynolds thought was an 'off the record' comment he announced that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children. **[05].** There are scores of written and audio statements from ex-employees and students. The statements that Rebecca West refers to can be [read](#) and or [listened](#) to by following the respective links.

Dr. Cole was beaten many time but the vicious assault that was reported to the police and the assault for which Patton West was convicted for was described in a statements by Cole to the [Whitefish Pilot](#) newspaper on July 12 2007. Here is an excerpt from that newspaper article:-

*Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.*

A list of statements denying that Patton West had assaulted Cole and published by senior cult / gang members Reynolds & Williams on Patton West's website are posted in the answer to point **[2]** above. In addition in January 2007 witch doctor and senior cult / gang members Julio Williams sent the whistleblower John Watson a threatening expletive laden [email](#) obviously intended to intimidate the whistleblower into dropping his fraud lawsuit against Patton West. This is called witness tampering. Williams even promised to provide the leader of his Satanist coven \$2,000,000 for her legal defense fund out of his personal fortune. Later that same year, scum bag Reynolds was desperately trying to remove a copy of Patton West's April 17 2006 [written admission](#) that she had [assaulted Cole](#) from the whistleblower's website. **[06].** Yes the only person giving Patton West money at the time was senior cult / gang members and co-conspirator Dr. Julio Williams MD who donated \$100,000 to fund Patton West's criminal racketeering business model.

As mentioned in the previous paragraph, Dr. Julio Williams is key to Patton West's criminality in that in addition to using his perceived respectability as a physician to market her as a healer and guru he also funds her criminality to the tunes of millions of dollars. Below is an excerpt of the email Williams sent the whistleblower John Watson in 2007 in an attempt to intimidate Watson into withdrawing his lawsuit against Patton West.

Watson won his lawsuit in 2008 however Williams, unable to stop Watson's win, funded two further lawsuits with the express objective of neutralizing the fraud lawsuit Watson won. Watson was awarded \$763,000 by a Montana



court which Patton West had no intention of paying. Patton West told Watson in a private interview, in March 2003, that if he sued her for fraud she would get so f\*cking down and dirty huge expenses coming out of his pocket but not hers as Williams would pay for her legal fees. On the subject of other celebrities Patton West wrote to the 'Dallas' actress Linda Gray hoping to suck her into the cult and suck her dry financially. **[07]. The \$30,000,000 grant money applied for was fraudulently applied for and failed to materialize. However before addressing that let me comment on Dr. Pat Cole's \$750,000 home that Patton West extorted from her along with \$463,000 in cash.**

The crimes against Dr. Pat Cole MD are addressed at length in the newspaper articles published by the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. In the Bigfork Eagle newspaper article scum bag Geoffrey Reynolds CPA asserted that Cole owed Patton West \$463,000 for an 'internship' and for 'therapy.' In reality Reynolds had made a decision to money launder those funds, obtained by extortion, through Patton West's business as normal receipts. Who on earth pays \$463,000 for an internship and for therapy? No one! Who on earth cashes in their IRA to pay for an internship and therapy? No one. Additional to the sums mentioned here Dr. Cole was also forced to ['borrow' \\$50,000](#) from a wealthy aunt. Who does that for an internship or for therapy? No one! To ram the point home that Reynolds is [as corrupt bottom feeding scumbag](#) the bookkeeper working under Reynolds resigned rather than be forced to 'manufacture' false invoices. As a fellow employee pointed out in [an email](#) to the whistleblower. Can you say MONEY LAUNDERING THE PROCEEDS OF CRIME! The campaign of violence against Dr. Pat Cole was also well documented in statements from ex-employees [Rebecca West](#), [John Mark Young](#) and [Jenny](#).

The \$30,000,000 grant money was fraudulently applied for however had it been granted at least \$2,000,000 plus of it would have been diverted to pay off Patton West's huge debts including \$2,000,000 she owed previous victims of crime in court fines and interest that would become the subject of a [Sheriff's Sale](#) in 2008. It is extremely doubtful whether Patton West or Geoffrey Reynolds (the latter was probably the one who completed the paper work for the grant money) told the grant committee that the corporation applying for the grant was in fact a cult. This point is clearly important because the grant committee were relying on the fact that the directors of the corporation, applying for the grant, were all real and jointly and severally liable for telling the truth. What they were not told is that the directors were all cult appointees of Patton West's and had no discretion to make decisions other than to carry out her instructions.

On the latter point, Patton West's own step mother Carol Patton told the whistleblower (via his lawyer) that Patton West had [promised to repay a \\$30,000 loan](#) to her out of the millions in grant money. Additionally, Rebecca West (Patton West's office manager) clearly stated in [one of her emails](#) that if Patton West got the grant money (and it was not fraud) that all the unpaid bills, unpaid wages and overtime would be paid off. Clearly, the application for the \$30,000,000 in grant money was a massive fraud overseen by that bottom feeding scum bag Geoffrey Reynolds. It gets worse for Reynolds in that although the grant money was denied and never materialized, pathological liar Reynolds states in his [private online resume](#) that one of his 'achievements' was to acquire those funds!

## Selected Accomplishments

**Secured funding for company start up.** Newly-formed Surya Enterprises needed funding. Prepared financial projections and developed strategy for five, ten, fifteen and twenty years of operation, and crafted business plan. Working in secondary financial markets, secured \$30M in wrap loans with no expenditure of company equity.

In reality, as the [Bigfork Eagle](#) newspaper article points out Surya Enterprises (Unlimited) was involuntarily dissolved. Indeed, out of the 6 corporations Patton West had tried to breathe life into two were involuntarily dissolved and one was involuntarily revoked. Of course these big lies will not appear on his entry in [McSwain & Co.'s](#) website as they have completely 'sanitized' his resume to remove all mention of his membership of Patton West's cult / gang between 2006 & 2014. Clearly, Reynolds' criminal past from the public. The final nail in Reynolds's coffin comes from [a statement](#) Patton West made herself when being questioned by a Montana court in October 2009. During questioning she repeatedly deferred to answer most of the financial questions stating that Geoffrey Reynolds was the 'money man' who dealt with all the finances. In the same statement Patton West admits to being [\\$2,000,000 in debt](#) and [living in an RV in the back of Reynolds's garden](#) having her life style costs funded by Reynolds and his wife.

Have the controlling partners of McSwain & Co. considered the public relations nightmare that is going to ensue when their clients find out that in spite of numerous warnings about Reynolds character he still remained an employee with access to confidential client records. There have been too many serious crimes against too many victims over too many years for this not to go public when Reynolds and his accomplices go to trial.

**[08]. The \$30,000,000 grant money never materialized and so the \$750,000 home owned by Dr. Pat Cole but stolen from her by Patton West went into foreclosure. Dr. Cole was forced to sign a "Quit Claim Deed" by Patton West effectively transferring ownership of her home to Patton West.**

Living in the basement was Patton West and son Chris Haywood, his wife Jamie Haywood, their new born baby daughter and the 7 year old daughter from Chris Haywood's marriage to Kendal. To give you an idea of just how sordid Patton West's home life is as compared to the lies and propaganda she posts on her website under the '[Rishi's History](#)' tab I urge the reader to review the [first](#) and [second](#) parts of the 12 July 2007 custody hearing transcript. I have already explained how Patton West launched a campaign of occult attacks at Chris Haywood's first wife Kendal effectively making her out to be psychologically unbalanced with the result that her son, with an FBI record for forgery, substance abuse and traffic violations, obtained custody of their daughter. That daughter is the 7 year old being referred to in Rebecca West's email in point [08] above. The infant daughter of Jamie Haywood and Chris Haywood, as already mentioned, would be the subject of another custody hearing only on this occasion in spite of launching the same 'under the radar' campaign of occult violence at the mother Patton West failed to subvert the custody hearing and Jamie got to keep her daughter.

**To be clear, Patton West sought to subvert and overthrow the judicial process to obtain an infant child for her son TWICE. She succeeded the first time and failed the second time. She uses the same playbook every time anyone launches a court case against her after they have been robbed, defrauded or were the victim of extortion.**

**[09]. As explained in [02] & [08] whether victims seek restitution at the labor board or in court Patton West plays dirty by getting members of her cult to make multiple false statements about the victim while at the same time getting cult members to publish statements of denial on her website as shown in [02] when news of Patton West's assault on Dr. Cole went public. This makes it very hard for victims to get justice.**

Below are some recorded excerpts of Patton West laying out her approach to lawsuits, the labor board etc.

At no time was I privy to the details of the private discussions between John Watson and Ms. West, and therefore any statements I made should have no bearing on the case

**[10]. As explained in [07 & 08] the \$30,000,000 in grant money was fraudulently applied for and never materialized. Patton West is criminally insane and she uses the 'masters' as her 'get out of jail' card. Here are two examples of how that works.**

1. Patton West, always desperate for other people's money to finance her luxurious lifestyle manufactured a message that she asserted was channeled to her by the Ascended Master El Morya (her favorite long dead minor deity). It comes as no surprise that the message, entitled '[Financial Form Building](#),' extols Patton West to fill her financial coffers (at the expense of everyone else around her). Having got a message from god that exactly matched Patton West's narrative (give me your money) she then proceeds to bully and brainwash the members of her cult into fund raising for her.

2. After viciously assaulting Dr. pat Cole MD as part of a lengthy campaign of violence that successfully extorted Cole's entire net worth from her estimated at \$1.3 million, Patton West had some bridge building to do with the rank and file cult members who witnessed her brutality towards Cole. No problems. Patton West wheels out yet another channeled message from El Morya which sought to assert that Patton West's actions in viciously assaulting Cole were justified. The channeled message, entitled '[The Law of Severity on the Path to Purification](#),' acknowledges the beating was severe though states that it was at all times administered with grace. The message also states that because Cole was a Nazi in the WWII death camps (in another lifetime) that the beating though severe was long overdue! There is no mention of the \$1.3 million Patton West extorted from Cole, but then why mention it? The earlier message from the 'masters' entitled '[Financial Form Building](#)' already told Patton West to fill her financial coffers.

As Rebecca stated, Patton West uses the 'masters' to justify her cruelty and violence towards others. '[The Law of Severity on the Path to Purification](#),' is reason enough on its own to have Patton West sectioned for mental health reasons and confined for the rest of her life in a mental institution for the protection of the public. Did I say there was a history of mental illness in Patton West's family?

**[11]. Mike Hendrickson was the Business Manager that proceeded John Watson, who later turned whistleblower. Mike Hendrickson warned John Watson about the rampant fraud in the charity and stated that when he brought it to Patton West's attention, he was dismissed from his position, told to leave the cult and not**



**come back until he accepted that Patton West had the right to do what she liked with the cash donations coming in from the public.**

After the whistleblower was constructively dismissed by Patton West for pointing out that he uses of charity finances was illegal and fraud he reported the fraud to the Secretary of State for Montana which resulted in Patton West's charity being [struck off](#). Unfortunately for Mike Hendrickson, a wealthy partner in a Colorado accountancy firm, this resulted in him having to find \$200,000 to cover the charity's bank overdraft after Patton West emptied the bank account and put the money into a personal trust fund for her and her eldest son Rob Meador. The [Whitefish Pilot](#) newspaper article mentions this briefly. Rebecca West refers to some 30 plus former employees that would be in addition to the 40 or so former employees and students mentioned above in point [01]. Patton West, while appearing for a witness for her son Chris Haywood, was questioned by counsel in court on July 12 2007 about John Watson's website. When asked about the many employees mentioned who had grievances against her Patton West referred to the employees as being [fictitious and fabricated](#). In the next breath she [denied assaulting Dr. Cole MD](#) (though she had admitted it in the '[Law of Severity](#)' missive that she had previously sent to her mailing list on April 17 2006). She also described her business interest as being [multi-billion dollar](#) affair however when a newspaper article published by the [Bigfork Eagle](#) appearing on August 9 2007 it made it clear that Patton West had been evicted twice in quick succession from rental properties and owed \$2,600 in unpaid employment insurance.

After all the bad publicity caused by three newspaper articles ([Whitefish Pilot](#), [Bigfork Eagle](#) & [Ravalli Republic](#)) and multiple appearances in court as the defendant in fraud related lawsuits Patton West and her cult were forced to leave Montana for fresh hunting grounds. However, before [Patton West](#), [Williams](#) & [Reynolds](#) could resurrect their criminal racketeering business model elsewhere they needed to force down the whistleblower, John Watson's websites, so that the truth would not be available to the public to contradict Patton West's a new identity and new fake bio / life story. Williams' treachery goes much further. As a 20 year student of Patton West's occult school, Williams, after 20 years of study under her, would be well versed in shamanic visioning. Indeed, in her 2007 interview with the Whitefish Pilot newspaper Patton West mentioned training doctors to do what she can do. Williams is one of those doctors. [5], [6] & [7]. Apart from an old circa 2001 photograph of West gate crashing a peace protest in Israel (where she has offshore bank accounts) for a photo opportunity there is zero evidence that Patton West attends leadership groups, humanitarian groups in regions of conflicts let alone international think tanks. The whistleblower John Watson set up the Peace Promise Initiative in 2002 that non-profit did not exist in the year 2000. A review of the [last page of the Bylaws](#) clearly show them being signed and dated [May 03 2002] the Bylaws also show the Secretary of States for Montana's date stamp showing May 15 2002. Note Devra Patton West's signature at the top and the whistleblower John Watson's underneath hers. Like all the other initiatives and businesses containers Patton West gets involved with they quickly become a total financial disaster as she drains

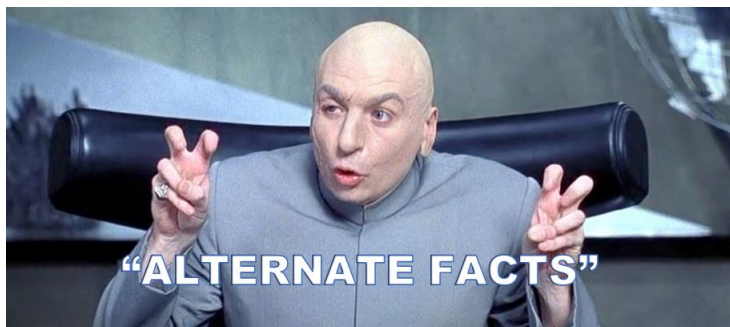


them of all finances to fund her lavish lifestyle. The newspaper article published by the [Bigfork Eagle](#) newspaper in August 2007 shows two of her 'businesses never being registered, two of them being involuntarily dissolved and one involuntarily revoked.



[8]. The only regions of conflict that Patton West has spent any time in is her home and business environment. The second part of the [custody hearing transcript](#) held on July 12 2007 makes it clear that Patton West's home life is a war zone. And her work life is no better. Carlida's [Statement of Fact](#) was part of a submission to the authorities about her unsafe working environment. Finally there is a statement that Dr. Pat Cole gave the [Whitefish Pilot](#) newspaper in July 2007. Cole stated that Patton West repeatedly beat her over the head with the heel of her shoe until blood ran down her blouse. Then there is Patton West's attack on her student Beatrice McGuire that left the victim needing plastic surgery which West paid for. Then there is the vicious attack on employee Susannah Felder that left Felder partially scalped. Yes Patton West's knows a lot about 'regions of conflict.'

[9]. If you believe Patton West's lies she was immersing herself ever deeper in the divine while, robbing, defrauding, extorting, beating both employees and students to her unaccredited school for occult studies. While immersing herself in the divine she picked up an arrest warrant for [criminal check fraud](#) in 2008, was forced to sell all her assets (those not hidden) at a [Sheriff's Sale](#) to make her pay past victims of crime \$2,000,000 in court fines and interest. 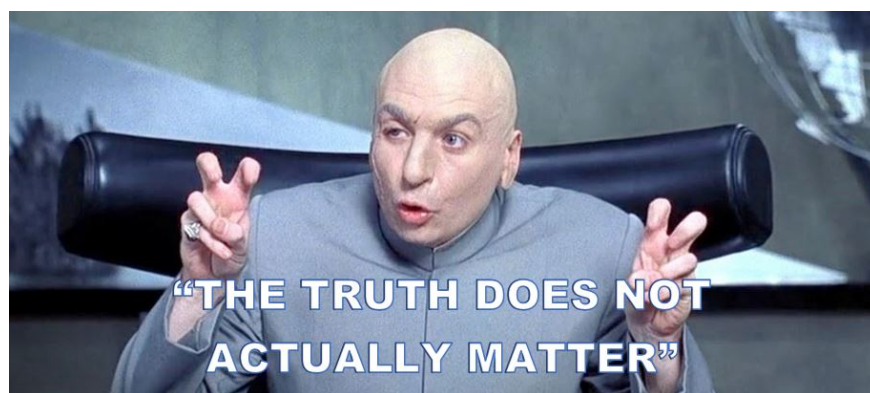

The reader can get a sample of that profound eloquence and divine grace by listening to just three excerpts of a 45 minute conversation that Patton West had with the whistleblower in March 2003 after he announced he was going to sue her for defrauding him a lawsuit he won in 2008. **WARNING** - eloquent and divinely graceful self-appointed deity dropping the F bomb more than once. Example 1 ([I feel f\\*cked up the arse](#)). Example 2 ([You are f\\*cking over a spiritual teacher for Christ sake](#)). Example 3 ([I'll go so f\\*cking down and dirty](#)) if Watson sues her for fraud after she admits in the same conversation that she did defraud him but does not see herself writing out a check for the money she owes him!

[11]. Many books could be filled about her criminal racketeering business model that has operated so far in three western states. States that either do not understand white collar crime or do not have the resources to prosecute it successfully. Patton West would not get away with her crimes in the eastern states; Martha Stewart went to jail for far less.

[12]. Patton West is a dangerous psychopath and suspected serial killer. Point [4] above speaks to the sordid home life; the fact that her son has an [FBI record](#) for forgery, dangerous drugs and motor vehicle offenses is a testimony to West's mothering skills. The apple does not fall far from the tree! As far as grandchildren are concerned there is evidence that Patton West has

targeted both of her son's ex-wives in an attempt to intimidate them into giving up their female infant children to West's son Chris Haywood. Her campaign of occult 'under the radar' violence succeeded in subverting the custody case involving Haywood's first wife Kendal (she lost her daughter to West's son) but did not succeed a second time against Chris Haywood's second wife Jamie who [wrote an email](#) about it to the whistleblower. She also mentioned the occult attacks in [her testimony](#) at the custody hearing. She went on to assert that as the victim was a Nazi in the WWII death camps (in another lifetime) that the assault was long overdue. Did I say that Patton West is criminally insane? No mention of the \$1.3 million she extorted from Dr. Pat Cole. Example 2. When appearing in court as a witness for her son on July 12 2007 West was asked by counsel if she had assaulted Dr. Cole. [Patton West replies](#) No way no how No! Example 3. While in court she was asked by her lawyer if her business was a multi-billion dollar enterprise. West replied yes. Three weeks later on August 9 2007 a newspaper article was published by the [Bigfork Eagle](#) newspaper which showed that Patton West had just been evicted from two rental properties in quick succession and had a lien for unpaid employment insurance against her in the amount of \$2,287 and had just bounced a check for deposit on the purchase of a property. Example 3. The [Whitefish Pilot](#) published a news article on July 12 2007, the very same day that Patton West was telling lies at the custody hearing for her son Chris Haywood. The article reveals that Patton West was fraudulently using images of a multimillion dollar lakeside property owned by Robert & Tabby Ivy in both her brochures and on her website. She was doing this in spite of the fact that the real owners had for 2 years being asking her not to do so. Patton West's criminal business model works on many levels when operating as Devra Ji in Victor MT she had the cult constantly fund raising for donations to fund her latest greatest save the planet scheme when in reality the money went straight in her pocket. The whistleblower knew this and when he tried to fix the problem she constructively dismissed him which led to his lawsuit. About a year earlier employee [Susannah Felder](#) caught Patton West stealing \$80,000 from her charity and when she challenged Patton West she was viciously assaulted and partially scalped. When the whistleblower reported the fraud the Secretary of State for Montana he struck her charity off the register by [revoking its status](#). Patton West, losing her source of income stole the charity's main asset (worth \$1,250,000 in 2002) and put it in a personal trust fund for herself and her eldest son Rob Meador. In 2008 a judge forced the breakup of the trust to make Patton West sell those assets at a [Sheriff's Sale](#) to force her to pay her creditors \$2,000,000 in court fines and interest. In addition to the property that she stole from the charity \$4,000,000 (as valued in 2002) worth of art work and valuables were stolen and hidden in a lock up for 10 years until the statute of limitations on theft expired. In 2009, while being deposed by the whistleblower's lawyer, Patton West was questioned about these items. In her [statement](#), taken under oath, Patton West denies knowing the whereabouts of these items, acknowledges that they did exist but suggests they were stolen or hauled off. She further stated that she had given up all physical possessions.
