If one travels to McSwain & Co.'s website and navigates to the webpage entitled '[Our People](#)' one will find an entry for every employee working for the firm including Geoffrey Reynolds CPA.

If one then scrolls down to the bottom of that same webpage one will find the following heading:-

OUR HISTORY AND PHILOSOPHY

Which contains this statement:-

'In order to meet these objectives all employees must be professional in what they do. The firm expects only high quality work, fairness and honesty between the Firm's employees and with the Firm's clients etc.'

The problem that McSwain & Co. have is that **Geoffrey Reynolds CPA is clearly not an honest person** and is in fact, a pathological liar (which is the least of his sins). While an 'employee' of a cult / criminal gang between 2006 & 2014, in addition to demonstrating that he was a pathological liar over and over again, there is ample evidence to prove that Reynolds (on the promise of \$300,000) agreed to participate in the following crimes.


1. Money launder the proceeds of organized crime for the cult / criminal gang he was a member of.
2. Agree to be complicit in the gang leader's 2007 plot to murder a victim of fraud at the hands of the cult / gang leader who turned whistleblower about the cult / gang. So sure was Reynolds that the murder of the whistleblower would occur that he announced the imminent death of the victim to the press days ahead of the failed attempt by the cult / gang leader.

3. When the murder plot failed Geoffrey Reynolds CPA and the cult / gang leader waited until 2010 to put plan 'B' into operation which involved Reynolds 'fronting' a criminal conspiracy to bankrupt the whistleblower. Reynolds part in this was to make totally false statements to a Montana court that resulted in him being awarded \$5,000,000 for telling lies to the court.

The motive for these actions, by Debbie Patton West the leader of cult criminal gang, was that as long as the whistleblower's websites were up warning the public about her criminal racketeering business model she was losing millions of dollars a year from organized crime.

Patton West was chased out of New Mexico in 1995, by one gun wielding victim who realized that the police could not help him and, after negative news stories in three Montana newspapers ([Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#)) Patton West was forced to leave Montana in 2010. She was forced to leave because the public no longer believed the 'divine being' propaganda that sits at the heart of guru / cult / extortion business model. However, before she could reincarnate herself as a divine being in Arizona she had to remove all the negative publicity from the internet and force down the whistleblower John Watson's website. The loss of millions of dollars a year by Patton West was the motive for the 2007 murder plot and when that failed the 2007 criminal conspiracy to bankrupt Watson with Reynolds front and center in both the murder and the criminal conspiracy.

When we made this information available to McSwain & Co. their first response was to sanitize Reynolds' online resume to remove all mention of his 'employment' with the cult / criminal gang between 2006 & 2014 and then later to remove Reynolds' photograph from their website. The current entry is what you see near the top of this website. It is not for us to impugn McSwain & Co.'s motives for sanitizing Reynolds' resume entry on their website but the result is to hide Reynolds' criminal past from the public and existing clients.

As you will see, Geoffrey Reynolds CPA, in addition to being totally corrupt, is not the brightest bulb on the Christmas tree witness the fact that his actual, factual, resume is still posted on his [personal website](#) which clearly shows the information that he and McSwain and Co. appear to be hiding from the public and their existing clients.

Senior Financial Manager, Surya Enterprises Unlimited, Inc., 2006 to 2014. Directs financial, legal, HR, IT and day-to-day operations. Securing funding and managing banking relationships. Set up and maintains accounting and computer systems. Created financial procedures and checks to secure and manage all assets. Created flexible financial projections for 1, 2, 5, 10, 20 years. Envisioned company's future and implement plans, strategies and policies to guide and direct employees to achieve it. Supervised and coordinated organization's operations and made sure employees have the resources needed to do their jobs. Over sees all operations to minimize expenses. Completely responsible financial system and all financial reporting and management reports. Managed all property under control of the company. Negotiated office leases and land purchases. Lead staff of 15.

Having established that Geoffrey Reynolds did work for Patton West's cult / criminal gang, let us now review some of the documents that prove that he was a willing accomplice in organized crime and complicit in a plot to murder the whistleblower John Watson and when that failed played a leading role in the criminal conspiracy to bankrupt the whistleblower for the motive given earlier. To remove details of Patton West's criminal past from the internet so that she could launch her criminal business model in Arizona with a completely fake life story.

REYNOLDS EARLY HISTORY WITH CULT / CRIMINAL GANG. Shortly after joining Patton West's 'employ' in September 2006, Geoffrey Reynolds swallowed Patton West's lies and propaganda about wanting to save the world etc. hook line and sinker and was duped into loaning her \$300,000. This was the same approach that was used against countless other employees and consultants including the whistleblower John Watson who was defrauded out of pay and shares in 2002. This was Reynolds' undoing as Patton West, realizing that she had Reynolds totally on the hook, manipulated him into doing her bidding however immoral or illegal. Proof of this comes from a witness close to both Geoffrey Reynolds and Patton West; that witness was Rebecca West (no relation to Devra Patton West) who was Patton West's office manager at the time and who worked alongside Geoffrey Reynolds CPA. The following excerpts from emails that Rebecca West sent the whistleblower John Watson makes it clear that Geoffrey Reynolds was either being manipulated, blackmailed or chose to turn a blind eye to the crimes being committed right under his nose by his 'employer' Patton West which made him a willing accomplice.

In the excerpts below, Rebecca West makes it absolutely clear that Geoffrey Reynolds was trying to cover his own ass in an attempt to protect his CPA license and that he will not tell the truth for the sake of keeping his job. This attitude is pervasive and includes her current finance controller, [Geoffrey Reynolds CPA] whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children...

And....

He [Geoffrey Reynolds CPA] was attempting to protect his CPA license and as of last night pretends not to remember that we [Rebecca & Geoffrey Reynolds] both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the fourth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job. Devra dangles the carrot and since he has loaned her his life savings, plans to keep playing her game until it is played out or he is eventually running her property management company. He has not been paid the \$300,000+ owed him and provides excuses that although he has had only four employers in his lifetime, most rich people are eccentric and in his experience their behavior can be much worse than Devra's.

Now let us review some of Geoffrey Reynolds' more premeditated lies and the evidence that shows he went way beyond mere lies when he agreed to be complicit in a 2007 murder plot, a campaign of violent intimidation against one of Patton West's victims and later in 2010 criminal conspiracy. Let me now set out some of the facts that support these claims. Facts we have passed on the McSwain & Co. already.

FACT 1 - IN 2007 GEOFFREY REYNOLDS AGREES TO BECOME A PATHOLOGICAL LIAR FOR \$300,000.

In early April 2006 Patton West viciously assaulted Pat Cole MD her business partner who was also a student of Patton West's. In brief the whistleblower John Watson reported West's charity to the authorities and after a brief investigation by the IRS it was [struck off for fraud](#) in January 2004, Ex-board member [AJ White's statement](#) makes interesting reading. This resulted in Patton West losing the property her 'ashram' was located on. Short of money to fund her expensive lifestyle, but rich in brainwashed and conditioned members of her cult, she wrote to them all stating that she had just been elevated from the [fifth dimension to the seventh dimension](#). As a consequence it was necessary for her to move from Victor MT to Shamballa (Flathead Lake MT) a location more suitable for a budding planetary regent. Patton West, who had just changed her name from Devra Ji to Surya Ma, also stated that she could only take 12 disciples with her and only those willing to [give up 66% of their net worth](#) to her good causes! Long story short, Dr. Pat Cole MD did not give up her 66% fast enough so Patton West, in a move described by another student [Debra Coffey](#), proceeded to beat the crap out of Dr. Cole until she did give up the funds. In early April 2006 the police were called after one particularly vicious assault and Patton West was charged with assault and two years later [convicted of assault](#), fined \$500 and given a 6 month suspended prison sentence. This matter was covered at length in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspaper articles published July and August 2007 respectively. Patton West has a long history of violence towards other women especially those in her cult who she regards as no better than serfs or slaves. In 2001 she partially scalped employee [Susannah Felder](#) who challenged Patton West about an \$80,000 donation that Patton West had stolen from the charity. In 2002 Patton West partially ripped the ear off of [Beatrice McGuire](#), one of her students, who challenged Patton West on a lie in front of tens of other students at a public event.

We know 100% that Patton West had assaulted Dr. Pat Cole MD because of all the large number of witnesses that were present when the assault occurred. However the best piece of evidence came from Patton West herself who on April 17 2006 wrote to all of her students admitting that she had assaulted Dr. Pat Cole MD and that the assault meted by her was severe. Indeed, Patton West repeatedly hit Cole over the head with the heel of her shoe until blood ran down the victim's blouse and in an attempt to calm the unease within the cult Patton West, a pathological liar with no equal, told her 'follower' stated that the Ascended Masters had sanctioned the assault. It is my firm belief that Patton West is either criminally insane or is so despicably evil as to not have any hope of redemption in this life or any other. The following short excerpts from the missive she posted to the members of her cult entitled ['The Law of Severity on the Path to Purification'](#) certainly lends credence to my assertion.

The Law of Severity on the Path of Purification

Response to the Call of [Master Surya Devi for Review](#)

April 17, 2006 From Master El Morya of the Shamballa Counsels

What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

Above: Masquerading as the Ascended Master 'Surya Devi' Patton West, talking to the voices in her head, gets to justify the vicious assault on Cole by having the 'voices in her head' assert that Cole was a Nazi in the WWII deaths camps. Because of this, Patton West states that the assault was long overdue and though meted with seeming severity was administered with grace!

However 15 months later, from April 2006, in July of 2007 when story went viral in the Montana newspapers Patton West and the senior members of her cult vehemently denied that Patton West had assaulted Cole. Chief amongst those deniers was 'liar for hire' [Geoffrey Reynolds CPA](#). Before we go any further, it is worth pointing out again that Geoffrey Reynolds did not commence his employment until September 2006 and yet when questioned about the assault by the [Bigfork Eagle](#) newspaper Reynolds maintained that Cole's injuries were caused by an earlier incident when Cole fell down the steps at her condo. Reynolds told this outrageous lie knowing that another person attending the event at which Cole was assaulted, and staying at the same rooms, saw Cole coming back from the event covered in blood. What follows is from the [Bigfork Eagle](#) newspaper article:-

Speaking for West, Geoff Reynolds claims the charges are untrue. He said photos of the first alleged assault were taken on a different date, and the bloody clothing in the photos resulted from Cole falling down a stairs at her Cherry Creek condo in Lakeside, not from an assault. The man who took the photos, however, tells a different story about the alleged assault. He came from out-of-state and was sharing the condo with Cole while he attended sessions with West. He said he was meditating when Cole appeared wearing a bloody sweatshirt. The man said they cleaned some of the blood off Cole's scalp and then took photos so Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the roommate said.

Geoffrey Reynolds, speaking on behalf of his 'employer' (who he hoped to receive \$300,000 from) was telling outright lies to the press. At the very same time Reynolds was also making desperate attempts, using the Millennium Copyright Act (MCA), to force a copy of Patton West's written admission of guilt off Watson's website! Remember '[The Law of Severity on the Path to Purification](#)' referred to above? Well both Reynolds & Patton West decided the best way to force a copy of that document off Watson's website was to claim copyright over it.

Yes you read that right. While Patton West and Reynolds were denying the assault on Cole had ever happened they were claiming copyright of a written statement by Patton West that not only admits that she did assault Cole but that Patton West is a psychopath and a pathological liar. Below is a copy of Reynolds' email which he sent on behalf of Patton West to the whistleblower's website service provider.



The above was the third attempt by Reynolds to force '[The Law of Severity on the Path to Purification](#)' off the internet. While doing that behind the scenes, and in an attempt to earn that \$300,000 Patton West was dangling in front of his eyes, Reynolds lead the publicity campaign of denials intended to persuade the public that Patton West was innocent (though knowing full well she was guilty as hell). What follows are a series of statements that appeared on Patton West's website all at once, as if by magic, days after the Whitefish Pilot news article appeared in July 2007.





Note above that 'liar for hire' Geoffrey Reynolds led the propaganda campaign by publishing four statements. Julio Williams was and still is a senior member of Patton West's criminal gang who we will get to later on in this bulletin. Jack West is Patton West's ex-husband and the longest serving cult member. Bret Jahola and Dani Osborne were both supposed to be 'employees' like Reynolds. However, what kind of employee to what kind of organization gets involved with their employer's legal disputes? It only happens in family businesses or in cult's which is what Patton West's business was a cult.

On 24 April 2008, the Whitefish Pilot newspaper published another brief news article announcing that Patton West had been found guilty of assault:-



Above: Patton West found guilty of assault. An assault that she admitted in writing to on April 17 2006, and then vehemently denied throughout 2007 because the truth about her violent behavior undermines the 'divine being' narrative.

Patton West has never made any attempt to hide her contempt for the public, donors to her good causes (herself) or the police and judicial system. In fact in a 2003 interview with the whistleblower, John Watson (that he recorded with a digital tape recorder) she openly admitted defrauding him but did not see herself paying him. 2. [West agrees she has defrauded John Watson but does not see herself paying him!](#)

In keeping with Patton West's mantra that the truth does not actually matter if she (and Reynolds) can persuade the public that her lies are their truth, we show you below how she responded to two announcements in the Montana press in 2008. And the second announcement in the [Ravalli Republic](#) newspaper that Patton West had been found guilty of defrauding John Watson in 2002. In response to her conviction for assault Devra West posted the following statement:-

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

In response to her conviction for defrauding John Watson Devra West posted the following statement:-

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Above: Devra West claims that her conviction was a 'technical error.' She goes on to claim that she is not going to enable an extortion scam by John Watson when clearly the courts ruled that she had defrauded him!

Geoffrey Reynolds was front and center in this massive fraud which was a blatant attempt by Patton West, Reynolds and the rest of the cult to deny what was obviously true. The reason is clear - if the truth got out it would adversely affect the income of Patton West's criminal racketeering business model which we know from discovery in Watson's lawsuit pulled in millions of dollars. A clear motive for murder.

Before moving on to Reynolds' complicity in Patton West's plot to murder the whistleblower, we would touch on another incident where Reynolds, in his capacity as Patton West's stooge and 'liar for hire,' acted as a false witness for Patton West. On the very same day, July 12 2007, that the Whitefish Pilot newspaper article was published about Patton West's criminality in Montana Patton West's son Chris Haywood was appearing in court in a custody battle for his infant daughter against his estranged wife Jamie Haywood. Again we remind the reader that Reynolds had only started his employment in September 2006 and yet he was wheeled in as a character reference for Patton West's porn loving wife beating son Chris Haywood after being an 'employee' for nine months. We have covered this matter in other bulletins which we link to here and here suffice to say that Chris Haywood like his mother was no stranger to the police and had an [FBI record](#) for forgery, substance abuse and traffic violations.

To get an understanding of just how sordid Patton West's home life was (as compared with the 'divine being' propaganda) we suggest the reader review the transcript of the custody hearing which makes harrowing reading and, along with the audio recordings of Patton West shared above demonstrates that this woman is pure evil. As a down payment go to [this link](#) where Patton West's daughter-in-law describes how Patton West got into a fight with her son Chris Haywood who then grabbed his mother by the throat and held her up against the wall. Patton West's response was to lick her son's face from top to bottom. The custody hearing transcript comes in three parts with Patton West and Geoffrey Reynolds giving their statements (lies) to the court in [Part 1](#), Jamie Haywood and Rebecca West giving their testimony in [Part 2](#) with the court summing up in [Part 3](#).

Patton West's statements from start to finish during the proceedings, were a pack of lies. We have dealt with this [elsewhere](#) but two of the biggest lies came when she was asked:-

Q1. Whether she assaulted Dr. Pat Cole MD

Q2. Referring to the whistleblower's website, and the many statements from ex-employees and ex-students of Patton West's who claimed they were mentally and physically abused, counsel, addressing Patton West, said that the website was about her wasn't it?

A1. In answer to question about assaulting Dr. Pat Cole MD, and bearing in mind that she had written to 50 plus people in her cult on April 17 2006 admitting the assault, Patton West responded:-



In closing this section, Geoffrey Reynolds was totally aware that Patton West was telling lies to the court even though she was under oath (which of course means nothing to a card carrying Satanist). Reynolds knew full well that Patton West had assaulted Cole and, at the time the custody hearing was being held, Reynolds was busily trying to force a copy of Patton West's written admission entitled ['The Law of Severity on the Path to Purification'](#) off Watson's website! However, as 'liar for hire' Reynolds had made clear to Rebecca West in March 2007, some four months before the custody court case:-

He [Geoffrey Reynolds CPA] was attempting to protect his CPA license and he will not tell the truth unless specifically asked for the sake of keeping his job.

We maintain that if you go into a court of law and swear on the bible that you are telling the truth, the whole truth and nothing but the truth then you are being asked to tell the truth by the court! As we shall see later, Reynolds graduated from not telling the truth to actively telling lies to the court by making pleadings to the court that he knew to be totally false.

After several appearances in court as the defendant in fraud related lawsuit, two arrest warrants (one for criminal check fraud and another for felony theft), after being forced to sell her assets (those she had not hidden) at a Sheriff's Sale and after three negative newspaper articles in the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) newspapers her criminal business model was finished in Montana. However before this con artist, violent convicted criminal and suspected serial killer could reincarnate herself in another western state where they ignore 'white collar' crime Patton West had to silence the whistleblower and force the removal of his website off the internet. Only after Watson was silenced could Patton West reincarnate herself (in Arizona) with yet another totally fake life story / bio which sought to assert through lies and propaganda that she was a divine being. This was the center piece of her criminal business model and what was used by her to ensnare wealthy spiritual seekers.

We have explained elsewhere at length how, after attending the ['Robert Jaffe School for Energy Mastery'](#) between 1990 & 1991, Patton West obtained occult (hidden) knowledge that has been used by Shaman for millennia – mostly for the good of their tribes. However in the hands of a psychopath / criminally insane person like Patton West this knowledge is often used by the individual to control, manipulate others and for financial gain.

There is a mountain of evidence that Patton West has been doing exactly that since she declared herself to be a minor deity in 1991. There is also some evidence that she has used this knowledge to murder those who do not pay up or who go public or threaten to go public. When the whistleblower was employed by Patton West between January 2002 and August 2002 he was told by Patton West's then husband that those who oppose Patton West had a habit of dying suddenly. These 'sudden' deaths could not be traced back to Patton West and were all written down as deaths as a result of natural causes. An example of this occurred in 2005 when ex-student / cult member Lisa Swidler witnessed Patton West defrauding student / cult member [Dave Kushner](#) out of \$30,000 and simultaneously had kidnapped, falsely imprisoned and robbed student / cult member [Marion Cantwell](#) out of tens of thousands of dollars. Lisa decided to flee the cult and shortly after leaving died suddenly and mysteriously leaving two small children under ten years behind. Lisa was a friend of the whistleblower John Watson and his wife and though they thought the death was strange, they did not think it was murder at the hands of Patton West. All that changed in 2007, largely thanks to Geoffrey Reynolds CPA.

FACT 2 - GEOFFREY REYNOLDS AGREES TO BE COMPLICIT IN A MURDER PLOT FOR \$300,000.

While being interviewed by the Whitefish Pilot reporter Constance See, Geoffrey Reynolds confided, in what he thought was an 'off the record' conversation that the whistleblower John Watson would be:-

- 1.** Dead within 12 months.
- 2.** Or in jail for reacting to what Patton West was going to do to him and his family.

Within a matter of days of Reynolds giving that prediction to the reporter (who passed it on to an IRS Criminal Investigator looking into Patton West's finances at the time) a very credible attempt was made on John Watson's life by Patton West.



SPIRITUAL LEADER HAS PLANS FOR HEALING CENTER IN WHITEFISH

What we can say for sure is this Constance See, the reporter for the [Whitefish Pilot](#), does exist and one can access many of her news articles by going [here](#). What we can also say is that after Reynolds shared Patton West's plans to murder John Watson Constance passed the threat on to John Nielson who was investigating Patton West's finances at the time.



While both these witnesses may not understand the occult or believe it is possible for someone like Patton West to violently assault or murder someone remotely (at a distance) both are credible witnesses. When a criminal trial is convened Constance See will repeat what she was told by Geoffrey Reynolds and John Nielson will repeat what he was told by Constance See. Added to their testimony will be statements from countless other victims and witnesses like [Rebecca West](#) and [Jamie Haywood](#) who will also attest to being on the receiving end of violent occult 'under the radar' assault by Patton West. Prior to the assault on Cole in April 2006 employee Carlida Finch heard Patton West discussing Cole's murder with another employee. After being given the choice to either join Patton West's cult and become a low paid, or no paid slave, or be fired, Carlida Finch lodged a complaint with the labor board. You can read Carlida's Statement of Fact wherein she states that she heard Patton West planning Cole's murder by [going here](#). Let me see, we have Patton West's ex-husband Jack West stating that those who opposed his wife had a habit of dying suddenly, we have Lisa Swidler, after witnessing two serious crimes, dying suddenly in 2005. Then we have Carlida Finch overhearing Patton West talking about the murder of Dr. Cole MD in 2006; Cole was apparently allowed to live after 'donating' \$1.3 million to Patton West.

And we have Patton West sending an email to Rebecca West in March 2007 telling Rebecca that it was a [good day to die](#) (after Rebecca West sent dozens of documents to John Watson which he posted on his website. Then we have the well documented attempt to murder John Watson in 2007 that Geoffrey Reynolds shared with the press in August 2007.



Above: If murder was not used regularly by Patton West to silence her critics, how come Reynolds so nonchalantly announced Watson's impending death to the Bigfork Eagle newspaper reporter? Why did Jack West say that those who oppose his wife have a habit of dying suddenly (like Lisa Swidler did in 2005)? Was Cole allowed to live after 'donating' \$1.3 million?

Just how many murders has Patton West committed right under the authorities noses and got away with?

During the summer of 2007, while Patton West was trying to intimidate Dr. Pat Cole MD into withdrawing her assault complaint, several hostile witnesses complained to the police that they were being targeted by Patton West in the way described above. The whistleblower's advice to them was to make a formal complaint to the police which is what they and the whistleblower did however during a phone call to Constable Jeanne Landis of the Flathead police the complainants, several in number, were told that there was nothing the police could do because the weapon being used by Patton West was not regarded as a weapon under legal statute

The advice given by the police was for the victims to launch a private lawsuit on the basis of Patton West's 'intent to cause harm' and the whistleblower [sent an email](#) with that information to Rebecca West in April 2007. Of course Patton West, who has been using this weapon since 1991, knows that the police can do nothing and relies upon that fact. Indeed so sure is Patton West that the police and the law courts are totally impotent that she long ago abandoned all caution to commit crime on an industrial basis that she is unlikely ever to be successfully prosecuted. We have listed some of the victims above in this bulletin. Whether operating in New Mexico between 1991 & 1995 or Montana between 1995 & 2010 or Arizona from 2011 to present the same well-oiled tried and tested [criminal business model](#) is used which involves Patton West hiding her criminal past and declaring herself to be a modern day messiah. The lies and propaganda, all allowed under religious freedom laws, are used to suck in spiritual seekers like moths to the flame often with the same result with victims unable to get justice either because the police do not believe their stories or if they do, as in the case of the police in Flathead MT, they cannot act because the weapon being used is not regarded as weapon under legal statute.

FACT 3 - GEOFFREY REYNOLDS AGREES TO BE COMPLICIT IN A CRIMINAL CONSPIRACY, LED BY PATTON WEST TO FORCE DOWN THE WHISTLEBLOWER'S WEBSITES USING TWO FRIVOLOUS (WITHOUT MERIT) LAWSUITS.

After the 2007 murder plot failed, and after the whistleblower refused to be provoked into acting in a way that would have landed him in jail (as Reynolds predicted) Patton West and Reynolds had to wait to put plan 'B' into operation. Their opportunity arose when in 2010 John Watson had to fly from Nova Scotia Canada, where he had lived since 2005 (after Lisa Swidler's murder).

While attending court in Montana to see how much the court was going to award Watson for winning his fraud lawsuit (against Patton West) Watson was served with two defamation lawsuits; one by [Patton West](#) and another by [Geoffrey Reynolds CPA](#). If one follows the two preceding links, one will see that Reynolds' pleadings are a photocopy of Patton West's pleadings. Above: Having failed to murder Watson, Patton West and Geoffrey Reynolds put Plan 'B' into effect which is to outspend Watson in court by issuing a pair of multi-million dollar lawsuits against Watson that they assumed he could not afford to defend because he lived abroad. Senior cult member Julio Williams provided Patton West with \$2,000,000 for her legal fees.

PERJURY. Juries and judges often base their verdicts, sentences, or other important decisions on sworn [testimony](#) and signed documents. Statements given under oath and certain legal documents are presumed to be truthful, or at least made in good faith. But how do we know for sure that witnesses and other parties involved in a legal matter are telling the truth? We can't always be certain, but those who are caught knowingly misleading a court face serious criminal charges of [perjury](#). To "perjure" yourself is to knowingly make misleading or false statements under oath or to sign a legal document you know to be false or misleading. This crime is taken very seriously because the foundation of the legal system depends on trust and credibility. After all, just one sworn statement has the power to tip the scales of justice and dramatically alter someone's life. Perjury is considered a crime against justice, since lying under oath compromises the authority of courts, grand juries, governing bodies, and public officials. Other crimes against justice include [criminal contempt of court](#), [probation violation](#), and [tampering with evidence](#).

The evidence makes it perfectly clear that:-

1. After Watson caused an IRS criminal investigation to be launched in 2004.
2. After having her charity struck off for fraud in 2004 as a result of John Watson's submission to the authorities.
3. After Watson caused three newspaper articles to be published about Patton West's crimes in Montana, the [Whitefish Pilot](#) & [Bigfork Eagle](#) in 2007 & the [Ravalli Republic](#) in 2008.

Stranger or not on Patton West's instructions Williams [defamed](#) Watson in 2005, sent an expletive laden [threatening email](#) to Watson in 2007 and funded Patton West's two frivolous lawsuits against Watson providing \$2,000,000 for her legal expenses. The courts are **not there to administer justice**, they are there to 'practice the law.' Watson, in answer to Patton West and Reynolds' frivolous lawsuits, sent 300 documents to the court in Montana which if admitted by the court would have cleared Watson of defamation and sent Patton West and Reynolds to jail for a long time. However, because his submission exceeded the 28 page maximum allowed, his evidence was not accepted. In summary, and having successfully conspired with Geoffrey Reynolds and Julio Williams to 'buy' victory in court by outspending Watson, Patton West both neutralized the [\\$736,000](#) the courts had awarded Watson for being defrauded by Patton West and forced his websites down.

About a year earlier employee [Susannah Felder](#) caught Patton West stealing \$80,000 from her charity and when she challenged Patton West she was viciously assaulted and partially scalped.
