

Subject: The Rishi AKA Patton West. Why is this F*CKING IDIOT not in jail for Racketeering & Murder?

The above F*CKING IDIOT'S [website](#) is much flashier than the one she had in Montana up until 2010 but her criminal business model continues to operate the same way it has since 1991. Under the apparent 'protection' of religious freedom laws Patton West makes the most outrageous claims about herself which are obviously lies. The motive for the lies and propaganda are twofold:-

1. *Fraud. We estimate she has netted \$30 to \$50 million from organized crime since 1991.*
2. *This F*CKING IDIOT has a history of mental illness in her family her brother was detained in a mental institution for many years before passing. Due to the massive abuse Patton West received as a child she has made it her life's work to abuse everyone else. This insane narcissist insists on being worshipped as a god by the 'sheeple' trapped in her cult.*

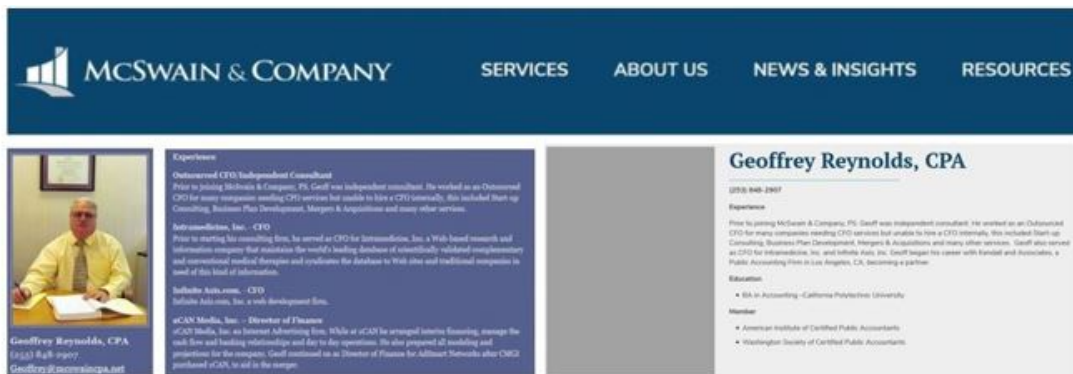
The guru disguise is an act, a front for organized crime. Her cult has hidden scores of victims of theft, fraud, extortion and several violent assaults and perhaps as many murders. The two best documented victims of fraud and extortion in Montana were Dr. Pat Cole MD and John Watson a business consultant who later turned whistleblower about the cult. Watson was a victim of fraud at Patton West's hands who in 2003 decided to sue her for fraud and in 2006 decided to share his research about Patton West's crime spree in Montana on-line via a dedicated website.

He also shared his research with two newspapers the [Whitefish Pilot](#) & the [Bigfork Eagle](#). His website and the newspaper articles effectively shut down her criminal racketeering business model in Montana in 2007. (A third newspaper article was published by the [Ravalli Republic](#) in 2008.) In response to the fraud lawsuit, the two newspaper articles and his well-documented website Patton West decided to murder Watson. To assist her in the murder she recruited two other F*CKING IDIOTS, both senior members of her cult, they Geoffrey Reynolds CPA & Dr. Julio E Williams MD.

INTRODUCING F*CKING IDIOT GEOFFREY REYNOLDS CPA.



Above: Geoffrey Reynolds CPA currently employed by McSwain & Co. accountants in Olympia WA. When we shared details of Reynolds involvement in racketeering and murder with McSwain & Co. they 'sanitized' his on-line resume and then completely removed it from their website. There is enough documentary evidence about Reynolds to show he is an 'undocumented criminal' who will at some point go to trial therefore he should definitely not have access to confidential client files.

While being interviewed by the [Bigfork Eagle](#) newspaper on August 9 2007 F*CKING IDIOT Reynolds let slip, in what he thought was an 'off the record conversation' that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his family. There is a word in the English language for a person like Geoffrey Reynolds and the word is 'scum.' The [Miriam Webster](#) dictionary defines the word thus:-

'a low, vile, or worthless person.'

The reporter took the threat seriously enough to share it with the authorities who briefed Watson. Several days later a failed attempt was made on Watson's life by Patton West just as predicted by Reynolds. Also, just as Reynolds predicted, a campaign of occult 'under the radar' violence was launched against John Watson, his wife and children.



This campaign of violence was intended either to intimidate Watson into dropping his lawsuit against Patton West or intended to provoke Watson into taking direct action against Patton West in self defense of his family. Had Watson taken the bait, as Patton West and Reynolds intended, he would have been jailed for taking the law into his own hands when clearly the 'law' is totally impotent against a vile and despicable creature like Patton West and her accomplices.



In 2002 [Jack West](#) confided in John Watson that he, his then wife Patton West and their young daughter Anna West were chased out of New Mexico by a gun wielding victim who knew the police would not believe what Patton West was doing to him and his family. And, even if the police did believe that victim they would not be able to prosecute Patton West because the [Secret Weapon](#) being used by her was not recognized as a weapon by legal statute. 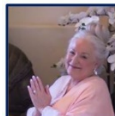

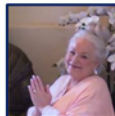

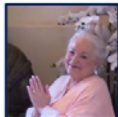
