

Subject: POST SCRIPT - The Rishi AKA Patton West. Why is this F*CKING IDIOT not in jail for Racketeering & Murder?

Further to our previous email sent on Friday 17 April 2020, and in response to increased levels of intimidation from Patton West.


As you are aware from previous correspondence, John Watson, a resident of Montana between 2001 & 2005, was a victim of fraud at Patton West's hands in 2002. He launched a fraud lawsuit against her in 2003. While researching his lawsuit against her, he discovered that there were literally scores of victims of fraud, theft, extortion and violent assaults and at least one suspected murder. In 2006 Watson turned whistleblower. He did this to counter the lies and propaganda being posted by Patton West and members of her cult on Patton West's website, and to warn others of the dangers of associating with Patton West.

After several employees of Patton West's contacted Watson via his website asking for help alleging they were the victims of theft, fraud, extortion and were being mentally and physically abused Watson chose to share his research with a local newspaper. After the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers published their stories, Patton West's criminal business model was effectively dead in the water, meaning she had to move to another western state where they do not understand white collar crime or choose not to prosecute it. It is obvious to anyone reviewing the facts, that Patton West is not a guru but a dangerous psychopath / suspected serial killer masquerading as a guru.

Why do we keep sending these emails? Because the whistleblower and his immediate family have been subject to a campaign of violent intimidation for the past 14 years. Which is ongoing. But Watson and his family are not alone. There are scores of victims of intimidation, mainly victims and witnesses of organized crime.

For 29 years, the FBI and law enforcement have not acted to investigate Patton West and her '~~World Service~~' Criminal Racketeering Business Model. After 29 years of literally getting away with murder, Patton West is now convinced that she cannot be prosecuted for her crimes. Because even if all the victims had the courage to come forward, the weapon she uses to intimidate and murder her victims is not recognized as a weapon under legal statute. Until the FBI and others get their heads around the fact that this weapon **DOES EXIST** and that it has been wielded by a criminally insane narcissist for the past 29 years, nothing you read about this lunatic is going to make sense.

More importantly, without immediate action, more people are going to be robbed, defrauded, become the victims of extortion and maybe murder.



Above: Lies are Patton West's stock in trade. Whether it is her fake biography / life story, her claim to be single handedly holding open the gates of time or her assertion that the Christ gave her two doctorates in person. Lately it's 'Mother of Ten Thousand Suns' and 'Divine Mother' and Regent of the Western Hemisphere.' Patton West is criminally insane.

Let us give three examples of what does not make sense unless you accept the fact that Patton West has hidden a way of manipulating, intimidating and controlling people's behaviour. The word 'occult' means hidden from view.

1. Scores of Victims of Organized Crime.

As the [opening paragraph](#) of an email sent to the whistleblower in March 2007 makes clear, Patton West has a revolving door policy to employees which are recruited from all over the USA and either forced to join her cult or dismissed before the 90 day mark, after which she would have to pay employment insurance. The strategy of offering [Fake Career Opportunities](#) was used to good effect by her in Montana and is currently being used in Arizona, where she is targeting the spiritual community in Sedona.



Above: The narcissist occult thief Patton West. Is she criminally insane believing she is a god on a mission to lead humanity? Or just a very clever and resourceful criminal whose unique criminal racketeering business model has allowed her to operate for 28 years right under the authorities noses? Either way the victims of organized crime are real as are her lies and propaganda.

Why would employee Susannah Felder, after a frenzied attack by Patton West which left her partially scalped, not go to the police? *Answer: he was afraid of being targeted by Patton West for violent intimidation and or murder.*

Why would [Mike Hendrickson](#), a member of Patton West's cult, not go to law to recover the \$200,000 that he was blatantly defrauded out of? *Answer: he was afraid of being targeted by Patton West for violent intimidation and or murder.*

Why would [Marion Cantwell](#) not go to the police after being kidnapped, falsely imprisoned, beaten and was the victim of extortion? *Answer: she was afraid of being targeted by Patton West for violent intimidation and/or murder. In fact, Marion was told, after giving up tens of thousands of dollars from the sale of her home, that if she went to the police she would be killed.*

Why did [Dave Kushner](#) not go to law after he was defrauded out of \$30,000 by Patton West? Kushner even had a legal agreement signed by Patton West who promised to repay the money within 2 weeks. *Answer: he was afraid of being targeted by Patton West for violent intimidation and or murder.*

A score or more of [employees and students](#) to her unaccredited school for occult studies were robbed, defrauded, were the victims of extortion and were mentally and physically abused by Patton West and yet, none of them chose to go to law? Why is that, when the crimes against them were well documented and their statements were posted on the whistleblower's website showing a clear and consistent pattern of behavior by Patton West? A pattern of behaviour that was also exhibited by Patton West when she operated her 'World Service' in [New Mexico](#) between 1991 & 1995, before she arrived in Montana. *Answer: they were all afraid of being targeted by Patton West for violent intimidation and or murder.*

When Patton West attended court on July 12 2007 as a witness for her son, she was asked by counsel about the whistleblower's website and asked if the person referred to in that website was her. She responded that it was her but that the employees mentioned on that website were [fabricated and fictitious](#). Follow [this link](#) and scroll down the page until you reach a list of the employee's names, then read every employee's statement about their treatment at the hands of pathological liar Patton West. Patton West left New Mexico in 1995, because she was literally chased out of the state by one victim who knew the police could not or would not help him. Patton West was forced to leave Montana in 2010, because the publicity caused by Watson's website and the two newspaper articles that he caused to be published made it impossible for her criminal racketeering business model to work there any longer.

2. Murder used as a Weapon to Intimidate Victims of Crime or Silence them Permanently.

That Patton West uses murder to silence those who oppose her is not in doubt. Shortly after joining Patton West's 'employ' in January 2002, Watson was told by Patton West's then husband [Jack West](#), that those who opposed Patton West had a habit of dying suddenly. Senior cult member [Lisa Swidler](#), who was witness to the kidnapping, the beating and the extortion of funds from Marion Cantwell and the defrauding of funds from Dave Kushner, decided she had witnessed enough and in 2005, tried to escape from the cult. Lisa died shortly afterwards of internal bleeding. The coroner ruled Lisa's death as the result of 'natural causes' even though Lisa was a young healthy mother of two small children. John Watson decided to sue Patton West for fraud in 2003. John Watson decided to go public in 2006 via a website, after discovering scores of other victims of crime at Patton West's hands. In 2007, John Watson caused two newspaper articles to be published after sharing his research.

Because of this, Patton West decided to murder Watson. The motive? Revenge for destroying her criminal business model and the loss of millions of dollars a year from organized crime.

However, Patton West did not plan and execute the attempted murder of Watson in a vacuum. She had two accomplices. Enter Dr. Julio E Williams & MD Geoffrey Reynolds CPA, both senior members of her cult and both complicit and accessories in what was supposed to be Watson's murder in August 2007.

Williams' & Reynolds' involvement in Patton West's conspiracy is spelt out in detail [here](#), with a detailed account of Patton West's [murder weapon here](#). Suffice to say, Williams sent Watson a [threatening email](#) in January 2007, in which he made it clear his intentions to destroy Watson and committed \$2,000,000 of his own money to the project! On August 9 2007, while being interviewed by the Bigfork Eagle newspaper reporter, Geoffrey Reynolds shared Patton West's intention to murder Watson with the reporter. Reynolds stated, in what he believed to be an 'off the record' conversation, that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his family. A few days later, a credible but unsuccessful attempt was made on Watson's life by Patton West; details of which can be reviewed by [going here](#). Just FYI, Patton West had murdered Lisa Swidler in 2005 and was overheard by employee Carlida Finch [planning Dr. Pat Cole's murder](#) in early 2006.

Not only did Reynolds predict the attempt on Watson's life, but he also accurately predicted the campaign of occult violence directed at Watson, his wife and children which continues to this day. Either Reynolds is a great clairvoyant, or he much more likely was privy to Patton West's plans to murder Watson and was also privy to the 14 year campaign of violence to be directed at Watson and his family.

For the past several years, Watson has documented these violent attacks against himself and his family members. He has done so to lay down a 'paper trail' to be sued in a criminal court alongside other victim's testimony. Watson had, between 2012 & 2016, sent 300 plus emails to Patton West's lawyer cataloguing these attacks. Between 2016 & 2020, Watson has sent some 400 plus emails cataloguing these attacks to Dr. Julio E Williams MD who has refused to pass them on to the police because to do so would implicate him in murder and racketeering.

3. Patton West's use of her Secret Weapon to Subvert and Overthrow Court Cases including two Child Custody Cases involving her Son Chris Haywood.

It is clear from Jamie Haywood's [testimony](#) given under oath on July 12 2007, and the harrowing [email](#) she sent to John Watson days earlier, that she too was the victim of intimidation by Patton West. Unseen and undetectable by others, and just as she had done against scores of other victims, Patton West had launched a campaign of occult 'under the radar' violence against her own daughter-in-law. Patton West's motive for targeting Jamie was to force her to give up her infant daughter to Patton West's son. On this occasion, Patton West's plans to subvert the court custody hearing failed.

She succeeded in doing that against one of them! The same strategy is used to subvert all court cases brought against her by victims. She is so certain of the eventual outcome that she does not turn up for the initial hearings but instead chooses to fight them on appeal.


However, this same strategy was used with great success a few years earlier against her son's first estranged wife, Kendall Haywood. After weeks and months of sustained violent attacks by Patton West, poor Kendall sought psychological help because she did not understand what was happening to her (being done to her).

How does a porn loving, wife beating man (Patton West's son Chris Haywood) with a criminal record for forgery, substance abuse and traffic violations, get custody of a female infant child? Simple. You make the mother look a worse bet than the father!

Basically, Patton West destroyed Kendall Haywood's mental health. She also put up a senior member of her cult, Dr. Pat Cole MD, as a professional witness and as a result, Kendall lost her daughter to Patton West's son. And to top it all, Patton West stole an \$80,000 donation from her charity to fund her son's legal fees. When questioned about the theft of the money by an employee of the charity, Patton West, in a frenzied attack on the employee partially scalping her. This is explained in a [notarized statement](#) given by AJ White, an ex-board member of the charity.

As a footnote. Years later in 2010, the whistleblower John Watson was deposed by Patton West's lawyer, who asked Watson if he knew that Kendall had mental issues. At the time, Patton West was sitting across from Watson and just smiled knowing she had totally destroyed Kendall's life, took away her daughter and had every intention of destroying Watson's life the same way.


The three points above, give a hint at just how big this criminal conspiracy is. And it has been going on for 29 years. How many victims of financial crimes? How many victims of violent crimes? How many murders passed off as natural deaths? It is time to find out!

In closing, since 1991 Patton West, a former pot grower, drug dealer, con artist and ex-bankrupt, has used occult knowledge to leverage her criminal tendencies. For the past 29 plus years, Patton West has robbed, thieved, defrauded and extorted from scores of victims suckered into joining her cult on the promise of 'enlightenment.'

Those victims who go public or go to law, like Watson, first become the subject of threats, dirty tricks, false witnesses and if that fails, a campaign of hidden violence and or murder. When Jack West told the whistleblower in 2002, that those who opposed his then-wife had a habit of dying, he was not joking or bragging. He was telling the truth. When Geoffrey Reynolds told the newspaper reporter on August 9 2007, that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his wife and children, Reynolds was serious. The reporter believed the threat, which is why she shared it with a federal agent, who shared it with Watson.



Examples of 'CONCIOUS FISCAL MASTERY' in Montana included thieving, defrauding and extorting money from individuals and defrauding her 'charity' out of a mansion on 20 acres that was largely paid for by public donations. By a series of fake loans from her to the charity Patton West was able to steal the property from the charity after her corruption bankrupted it.

How many victims of crime that 'opposed' Patton West have been murdered by her? How many murders were classified as 'death by natural causes?' Why do you think that scores of victims of theft, fraud, extortion and violent crimes have been too afraid to go to the police or to law for restitution?

Patton West is currently masquerading as a Goddess, the Mother of ten Thousand Suns, Divine Mother and insists that she has been planning to lead humanity for thousands of years. Part of her behaviour is down to her mental illness and part down to her attempts to attract new victims of theft, fraud , extortion and mental and physical abuse.

In spite of the scores of victims of theft, fraud, extortion and mental and physical abuse Patton West, a card carrying psychotic, insists that she is a blessing to all souls and an instrument of mercy. Apparently lies and propaganda are all allowed under religious freedom laws even if the obvious motive is mail and wire fraud, racketeering and murder.

Another variation of this has Patton West targeting wealthy spiritual seekers who attend her 'Private Intensives' & Private Audiences.' Having identified the wealthy amongst her attendees, she chooses her target and, using the same knowledge she uses to intimidate and murder those who oppose her, she makes the targeted individual seriously ill. She then offers the targeted individual a cure for a six figure sum. This is why the '[Pay Portal](#)' on her website is set up to receive single contributions of \$500,000. Patton West has been planning this for decades. Back in 2007, she told the [Whitefish Pilot](#) newspaper that she was teaching doctors to cure cancer. The only physician she has in her cult is Dr. Julio E Williams MD, who is a full accomplice in defrauding cancer patients out of millions of dollars for fake cures.

Why else would Dr. Julio E Williams MD threaten Watson in writing, go along with the murder of Watson and when that failed, put up \$2,000,000 of his own money to destroy Watson's life? Motive – Millions of dollars a year lost if Patton West's credibility is undermined by Watson publishing the truth about her criminal past.

We, as a pressure group, have been banging on the FBI's door for several years trying to get you to investigate these matters. Right under your noses for nearly thirty years, Patton West has been using the 'protection' of religious freedom laws as cover for her lies and propaganda, whose motivation is obviously fraud. Dr. Julio Williams, a cardiothoracic surgeon, has joined the Essentia Health-32nd Avenue Clinic in Fargo, North Dakota.



There is enough documentary evidence about Reynolds to show he is an 'undocumented criminal' who will at some point go to trial therefore he should definitely not have access to confidential client files.

Given that Reynolds was a total stranger to Watson, you might want to ask why it was that Reynolds came to announce Watson's murder to the press on August 9 2007. Then ask him how he came to announce the campaign of violent intimidation that Patton West was going to launch against Watson, his wife and children which 14 years later is still ongoing. Then after the murder plot that Reynolds announced failed, you might like to ask Reynolds why in 2010 he made totally false statements to a court, about a stranger he never met, that led to Reynolds being awarded \$5,000,000 default undefended judgment. Then get Reynolds to explain why he signed that judgement over to Patton West, proving that he was part of a criminal conspiracy orchestrated by Patton West against Watson.

We make the case that the real reason that scores of victims of serious crime have walked away empty handed is because they do not want to become victims of violent intimidation or become victims of murder at Patton West's hands. This is exactly what happened to Watson and his family. Just as Reynolds announced, he became the target of attempted murder. Just as Reynolds announced, Watson, his wife and children, became the victims of violence which continues to this day. This makes Reynolds & Williams accessories in murder and racketeering. This has been going on for 29 years. Time to do something about it before one of the victims acts in self defense and decides to take the law into their own hands.
