

Dear FBI, IRS and Sedona & Scottsdale police departments,

We write again specifically to the FBI in the hope that you will launch an investigation into Devra Patton West and her criminal racketeering business model. We feel sure her activities fall under your purview as they involve serious crimes in multiple states and, if the whistleblower and her ex-husband Jack West are to be believed, multiple murders. Given that these activities have occurred over 29 years and involve scores of victims of theft, fraud and extortion it is our hope that she will be prosecuted under RICO statutes. While the 'weapon' she uses to facilitate these crimes is not regarded as a weapon and while her lies and propaganda appear to be 'protected' under religious freedom laws we feel sure that once you comprehend the sheer volume of criminal activity an avenue under which to successfully prosecute Patton West will emerge.

We suggest two avenues of investigation that should bear fruit; a) have a forensic accountant look at the movement of money in and out of her business and personal bank accounts. More specifically the role the \$2,000,000 he gave Patton West played in 'silencing' the whistleblower after her plot to murder him failed. All this so that Patton West could relocate to Arizona (without the inconvenient truth of her criminal past up on the internet). She is now targeting Sedona as the 'Regent of the Western Hemisphere.'
- 3. [Regarding Geoffrey Reynolds CPA](#)** and his role in her criminal business model and specifically his role in 'silencing' the whistleblower. This involved Reynolds announcing Watson's murder a week before Patton West made her failed attempt on his life. It involved him making totally false pleadings to a Montana court as part of Patton West's conspiracy to bankrupt Watson into silence. 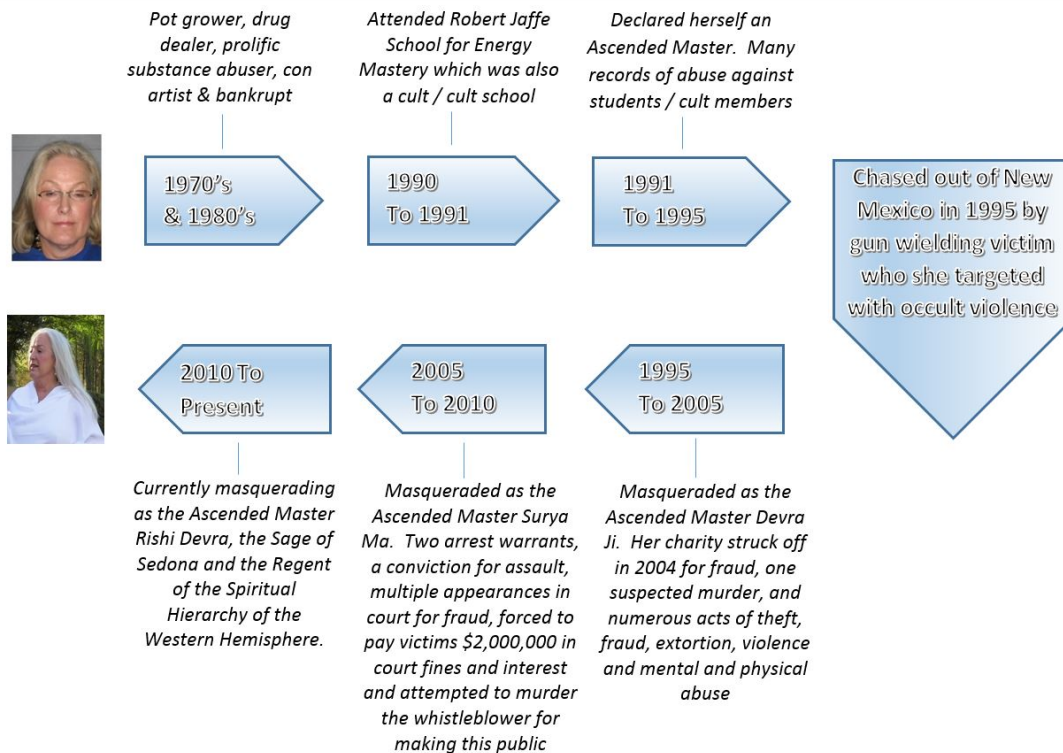

We have dealt with Patton West's criminal history on innumerable occasions in other past bulletins which can be viewed by going to this [web address](#). However a short summary of her distinguished career as a con artist and violent convicted criminal might be useful for new readers.



Prior to 1990's Patton West (along with her husband Jack West) was drug dealer, pot grower and con artist defrauding individual victims like [Jeremy Samuelson](#) out of, in his case, \$10,000 at a time. After going bankrupt Patton West decided to become an Ascended Master and in that regard attended the [Robert Jaffe School for Energy Mastery](#) itself a cult and a cult training school, where Patton West defrauded one of her fellow students, [Satya](#), out of \$6,000. Below here is an excerpt from a website entitled '[Cult Education Institute](#)' by following the link you can review statements given by those who escaped from that cult. Here is an excerpt from one ex-cult member who decided to leave The Robert Jaffe School for Energy Mastery.



**We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path. Jaffe responded months later and **threatened that I could become sick and die from something like cancer for leaving.** That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it.**

We know from witnesses that Devra West took the Robert Jaffe playbook and adapted it for her own use. After completing her training in 1991 she declared herself to be an Ascended Master stating that anyone disagreeing with her was 'blocking the energies.' Very quickly she formed a personality cult around herself and proceeded to do what all narcissists / psychopaths do which is to assert their divine right to rule over the lives of others while harvesting the energy and the finances of those trapped in the cult to better themselves.

Several of those featured in the 'class of 2002' photo above (top left) would become victims of theft, fraud, extortion and violent assault. These include John Watson (fraud and attempted murder), Dr. Pat Cole MD (extortion and violent assault), Marion Cantwell (kidnap, false imprisonment and extortion), Dave Kushner (fraud) and Mike Hendrickson (fraud). Lisa Swidler was murdered by Patton West. We also know that Devra West used the threat of murder as a way of intimidating victims, witnesses and the members of her own cult into remaining silent about her criminal acts. A document entitled '[Pats Records](#)' which was given to the Flathead police department in 2007 references the fact that Patton West had mentally and physically abused several of the members of her New Mexico cult. Until one day she targeted the wrong person who literally chased her out of the state in the middle of the night with a large loaded gun!

The cult as a criminal business model had huge benefits to Patton West the following being some:-

- 1.** She had a ready supply of 'sheep' who could be brainwashed and conditioned into fund raising for her.
- 2.** When needed she could manipulate the wealthy members of her cult into 'donating' their wealth to fund her huge lifestyle costs and funding her legal costs when the victims of theft, fraud and extortion fought back.

3. Persons with influence and perceived respectability such as Dr. Julio Williams MD could be shamelessly used by Patton West to market herself to the public as a messianic figure capable of delivering miracle health cures.

4. When threatened by a victim of crime seeking justice via the courts she could mobilize members of her cult against the threat by putting them into the fight between herself and the victim. This is exactly the role Dr. Julio E Williams performed for her when a victim of fraud at her hands went to law.

### **Dr. Julio E Williams' role in Patton West's conspiracy to intimidate, murder, and when that failed, bankrupt John Watson into remaining silent about Patton West's criminal past.**

After business consultant John Watson announced he was going to sue Patton West for fraud in 2003 she insisted on meeting with Watson in private to try to persuade / threaten him not to go to law. WARNING FOUL LANGUAGE FROM CRIMINALLY  
INSANE WANNA BE PLANETARY REGENT

1. [West agrees she has defrauded John Watson but does not see herself paying him!](#)
2. [West acknowledges that she is a control freak and admits to disposing of people like used Kleenex.](#)
3. [West goes berserk and in an expletive laden tirade accuses the whistleblower of exploiting her vulnerability! This behavior proves beyond doubt that Devra West is criminally insane.](#)
4. [West says that if Watson sues her she'll get so f\\*cking down and dirty huge expenses coming out of his pocket and not hers because Williams will pay her legal fees.](#)
5. [The truth does not matter \(if she can convince the public that her lies are their truth\).](#)

The important 'take away' from this conversation is that Patton West admitted defrauding Watson but did not see herself paying him. Further, if he took her to law, she would employ dirty tricks against him and outspend him. This entire conversation was posted on the web in 2006 so Dr. Williams must have known Patton West was guilty of defrauding Watson.

In 2005 Dr. Julio Williams's was given a chance to show his loyalty to Patton West by joining her vendetta against John Watson. Though a total stranger to Watson Dr. Julio E Williams MD agreed to publish a defamatory statement about Watson on Patton West's website. The statement sought to portray Patton West as a guru and a 'world server' and Watson as a villain. This was the first of many fake 'testimonials' that Williams published on behalf of Patton West, the leader of his cult. Below here is an excerpt from Dr. Julio E Williams' statement. In January 2007, with Watson about to win his lawsuit against Patton West, Williams (doubtless at Patton West's request) sent a lengthy expletive laden email to Watson which was obviously a clumsy attempt at trying to intimidate Watson into dropping his lawsuit against Patton West. ## *Spiritual guru pleads guilty in assault*

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortleby issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.



Patton West was the subject of a Sheriff's Sale in 2008. This was to force her to pay past victims of organized crime \$2,000,000 in court fines and interest.

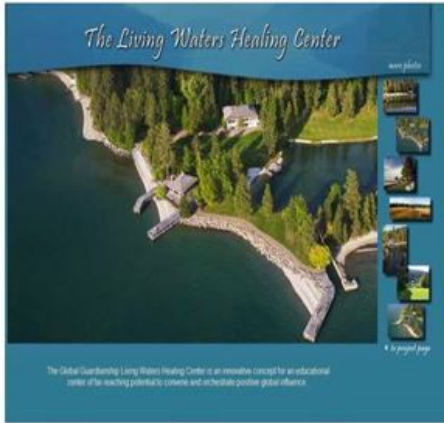

On the left, we have an image of a multi-million dollar property belonging to Robert & Tabby Ivy that Patton West was fraudulently using in her brochures and on her website as part of the illusion (fraud) that she was a wealthy mover and shaker amongst the world's elite. Below is what the real owners of the property had to say when interviewed by the [Whitefish Pilot](#) newspaper about Patton West's wrongful use of images of their home.

*A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."*

Dr. Julio Williams MD knew that Patton West did not own that property or had any rights to use it in her marketing material and yet his own 'testimonial' appeared on an adjoining web page. He knew in 2007 that Patton West was fraudster masquerading as a wealthy woman. In reality, Patton West was at that time in the process of being evicted in quick succession from two rental properties. According to one of Patton West's employees, Dr. Julio E Williams MD [donated a \\$100,000](#) in early March 2007 to cover some of Patton West's living expenses.



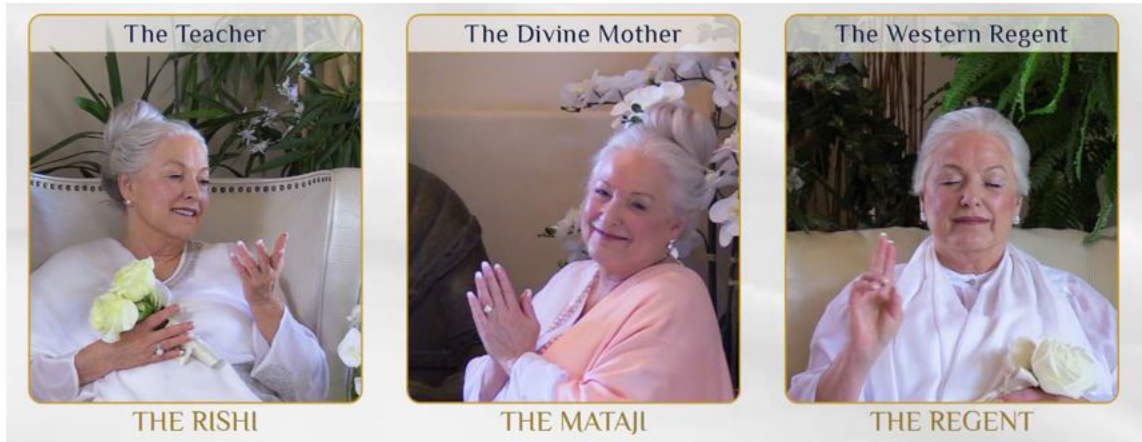

After repeated visits to court as the defendant in fraud related lawsuits and after two arrest warrants and a conviction for assault and after three very negative articles were published by the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) newspapers Patton West's criminal business model was dead in the water in Montana.



However, before she could relocate to Arizona where she is now targeting Sedona & Scottsdale Watson's website had to be forced down and Watson silenced for good. [Murder was tried first](#) and after that failed Patton West conspired with Dr. Julio E Williams & Geoffrey Reynolds to bankrupt Watson into silence. And below is another posting inviting prospective victims to attend 'Sacred Sundays with Rishi.' Note the venue is at Dr. Julio E Williams' own home! I guess by holding her 'private sessions' at Dr. Julio E Williams' home, she knows she will have on hand a totally brainwashed and conditioned physician to verify her credentials as a Planetary Regent and Mother of Ten Thousand Suns.

In January 2018, Dr. Julio E Williams posted yet another statement on the internet in support of Patton West the leader of his cult / criminal racketeering gang. This one was in response to two websites that contained thousands of documents about Patton West's criminal activities in Montana. The information contained on those two websites was a direct threat her criminal business model which relies on the public swallowing her lies and propaganda whole. In the above paragraph, Williams seeks to portray Patton West as the victim of cyber-slander. He does so knowing the arrest warrants are real, he does so knowing the conviction for assault is real, he does so knowing that the Sheriff's Sale at which Patton West was forced to sell her assets to pay past victims of crime \$2,000,000 in court fines and interest was real. He does so knowing that John Watson, a victim of fraud, attempted murder and criminal conspiracy to bankrupt him (that Williams funded and was a part of) was just one of a score of victims of theft, fraud, extortion and violence.
