

Dear FBI, IRS and Sedona & Scottsdale police departments,

We write again specifically to the FBI in the hope that you will launch an investigation into Devra Patton West and her criminal racketeering business model. 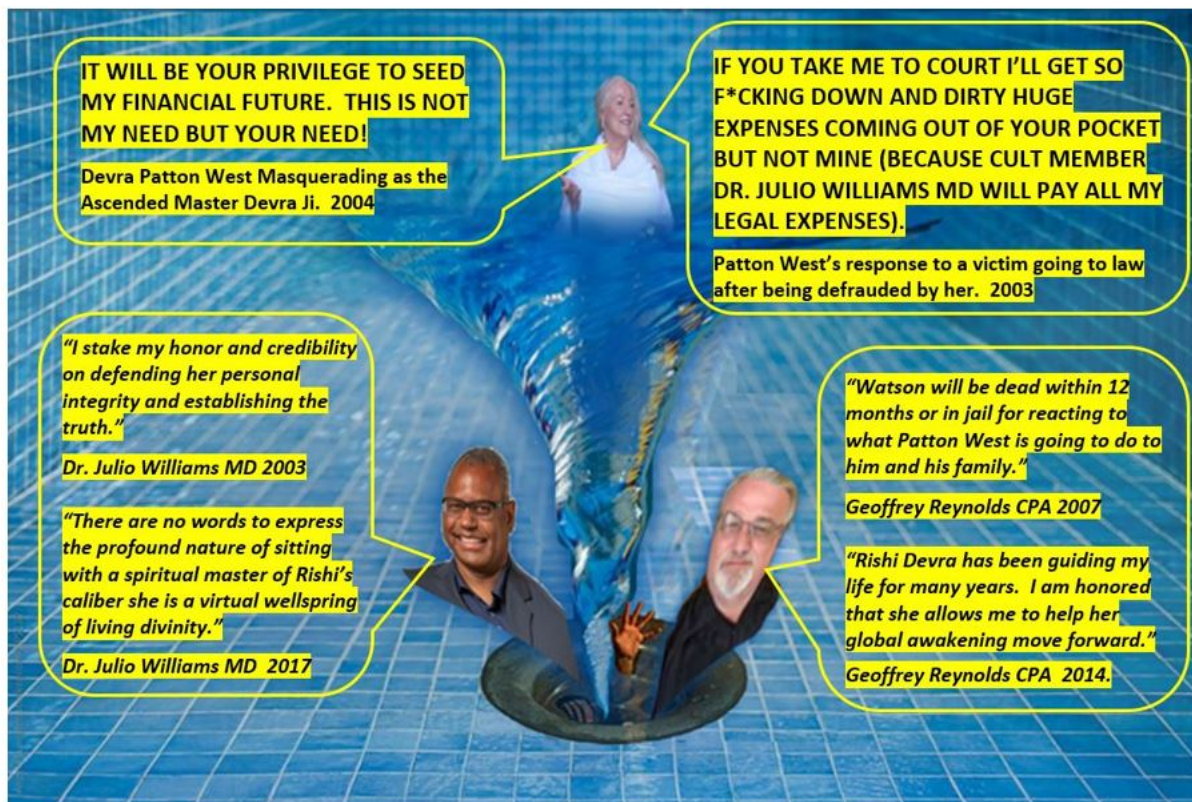


The problem that McSwain & Co. have is that **Geoffrey Reynolds CPA is clearly not an honest person** and is in fact a pathological liar (which is the least of his sins). While an ‘employee’ of a cult / criminal gang between 2006 & 2104, in addition to demonstrating that he was a pathological liar over and over again, there is ample evidence to prove that Reynolds (on the promise of \$300,000) agreed to participate in the following crimes.

- 1.** Money launder the proceeds of organized crime for the cult / criminal gang he was a member of.
- 2.** Agree to be complicit in the gang leader’s 2007 plot to murder a victim of fraud at the hands of the cult / gang leader who turned whistleblower about the cult / gang. So sure was Reynolds that the murder of the whistleblower would occur that he announced the imminent death of the victim to the press days ahead of the failed attempt by the cult / gang leader.

The Urban dictionary defines the word 'scum' thusly:-

**(adj.) Possibly the worst word you can have your name associated with.**

**It is hard to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life. "Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often just referred to as genitalia.**

**REYNOLDS EARLY HISTORY WITH CULT / CRIMINAL GANG.** Shortly after joining Patton West's 'employ' in September 2006, Geoffrey Reynolds swallowed Patton West's lies and propaganda about wanting to save the world etc. hook line and sinker and was duped into loaning her \$300,000. This was the same approach that was used against countless other employees and consultants including the whistleblower John Watson who was defrauded out of pay and shares in 2002. This was Reynolds' undoing as Patton West, realizing that she had Reynolds totally on the hook, manipulated him into doing her bidding however immoral or illegal. Proof of this comes from a witness close to both Geoffrey Reynolds and Patton West. That witness was Rebecca West (no relation to Devra Patton West) who was Patton West's office manager at the time and who worked alongside Geoffrey Reynolds CPA. The following excerpts from two emails (1) & (2) that Rebecca West sent the whistleblower John Watson makes it clear that Geoffrey Reynolds was either being manipulated, blackmailed or chose to turn a blind eye to the crimes being committed right under his nose by his 'employer' Patton West' which made him a willing accomplice.



To protect my job, my CPA license, my marriage and in hopes of getting my \$300,000 back Geoffrey Reynolds CPA, agreed to join Patton West's conspiracy to murder John Watson who was suing her for fraud.

When the murder plot failed, which Reynolds announced to the media ahead of time, he agreed to make false pleadings to a Montana court, as directed by Patton West, as part of her conspiracy to bankrupt Watson and force down his websites which contained the kind of information you are reading here!

This attitude is pervasive and includes her current finance controller, [Geoffrey Reynolds CPA] whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children...

His resume clearly shows that his employment did not start until 2006 – September 2006 to be precise and yet, Reynolds claimed in his pleadings to the court in Montana that he had been defamed between 2002 & 2006. His lies resulted in a \$5,000,000 award (an undefended default judgment) which he promptly signed over to Patton West. This [document](#) sets out the scale of Patton West's criminal activities in Montana and why Patton West was so desperate to hide her past from the public in Arizona.
