Either this statement is true or it is false.

We suspect that the above statement is false and just part of the barrage of propaganda aimed at convincing the Arizona public that her lies are their truth. Her criminal racketeering business model only works if Patton West can convince the community she is embedded within, that she is the sanctified 'Regent of the New Americas,' that she is the 'Revered Executor of the Divine Plan' and that she has been 'Preparing to lead Humanity for Thousands of Years.' Any truth about her criminal past in Montana and New Mexico, is a direct threat to her multi-million dollar a year criminal racketeering business model. Justification for murder and the constant barrage of lies to drown out the truth.

We would ask you to review the web page entitled '[Patton West's International Arrest Warrant.](#)' We would especially draw your attention to the following two paragraphs posted on that webpage:-

*We challenge Patton West to get her 'International Arrest Warrant' served NOW. Watson is more than happy to cooperate with the authorities in this matter. We believe that the FBI (the lead agency in interstate racketeering / murderers and suspected serial killers) will follow the evidence to where it leads. We have the evidence. Watson has made it clear that if being arrested is what it takes to get a career criminal, a murderer, a suspected serial killer and her accomplices into a criminal court let's get on with it!*

*John Watson is ready to co-operate with the authorities in the US. Patton West and her accomplices, have his email address, so the authorities can contact him for an initial interview. Upon being formally interviewed, Watson's only request would be that he is connected to a polygraph / lie detector to prove that he is telling the truth.*

**If the 'International Arrest Warrant' Patton West refers to in her posting exists, then Watson has asked that it be served immediately. We trust that investigators will follow the evidence to where it leads.**

However if, as we suspect, the arrest warrant does not exist, then the FBI and other law enforcement agencies in Arizona should consider reviewing all of internet postings made by Patton West and her accomplices. The entire contents of her [website](#) is a pack of lies and can be easily proven as such.

The online statements and the contents of her website are the public face of a much larger fraud / extortion scam that we believe has netted Patton West tens of millions of dollars over the past three decades. When it becomes obvious that Patton West is a career criminal and not the next Messiah, she moves on to another western state. While operating in New Mexico, Montana and now Arizona, Patton West has used 'religious freedom' laws to get away with the most egregious lies, even though it is obvious from the facts that fraud and extortion are her motivation. Anyone telling the truth becomes a target for violent intimidation and murder. Watson and his family have been on the receiving end of a campaign of intimidation for the past 15 plus years, in an attempt to keep the truth hidden.

The people behind [Cult Watch Sedona](#) allege that Patton West is currently under investigation for committing serious crimes in Arizona. Defrauding the government out of Covid Relief funds and using that money to pay her rent arrears and other outstanding bills being one. Another alleged crime concerns extorting tens of thousands of dollars from the trust fund belonging to a 'disciple's' disabled mother. Patton West was recently evicted from her mansion for unpaid rent amounting to \$80,000. These arrears allegedly paid using Covid Relief Funds. None of this information shows up in her online statements or in her website. The truth is bad for business (see bulletin below).

It is our belief that Patton West is a vicious career criminal, a murderer and a suspected serial killer. Patton West's failed attempt to murder fraud victim turned whistleblower, John Watson, is well documented. His intended murder was even shared with a local newspaper reporter a week in advance by cult / gang member, Geoffrey Reynolds. According to Patton West's ex-husband, people who oppose his wife had a habit of dying suddenly. This was expected to be Watson's fate. When the murder plot failed, another member of Patton West's cult / criminal racketeering gang pledged \$2M so that Patton West could outspend Watson in court and 'buy the injunction she needed to force his websites down. Since obtaining the injunction, Patton West and her accomplices have misrepresented it to the public as something it is not. And, as more of the truth has become available, she has apparently spent more money on civil court action to leverage her gag order.

**This is what serious criminals do. If they cannot intimidate you or murder you, they 'buy' the result they want by outspending their victims in civil court actions. Which is exactly what happened to Watson after he won a fraud lawsuit against Patton West in 2008. Her criminal business model only works if the public do not have access to the truth.**

These are serious allegations. After 31 years of literally getting away with murder, it is high time the FBI and other law enforcement agencies took some statements from victims and witnesses. Watson believes that the only way to stop the intimidation being directed at him and his family, is to make this matter a criminal investigation under RICO statutes. In that regard, if Patton West's 'International Arrest Warrant' does exist, then we want it served immediately. Once the mountain of evidence against Patton West is delved into, it should not take long for the FBI or other law enforcement agencies to determine where the truth lays.

Prior to 1991, Patton West was a pot grower, drug dealer, bankrupt and a con artist picking off individual victims one at a time for several thousand dollars a piece. Victims like [Jeremy Samuelson](#) and [Satya](#). Between 1990 & 1991, Patton West attended the ['Robert Jaffe School for Energy Mastery.'](#)

During her tenure there, she acquired occult (hidden) knowledge which, in the hands of a service to self entity like Patton West allowed her to convince others that she was a minor deity that should be worshipped by 'ordinary' folk. Upon leaving the school in 1991 Patton West immediately declared herself to be an Ascended Master. For the past 31 years, Patton West has used occult knowledge to leverage her criminal career.

**John Watson – Attempted Murder.** Watson was defrauded in 2002, launched a lawsuit against Patton West in 2003 which he won in 2008. In August 2007 senior cult / gang member Geoffrey Reynolds announced Watson's impending murder by Patton West one week before she made a failed attempt on his life. Reynolds is complicit in the ongoing campaign of violent intimidation being directed at Watson and his family.

**Marion Cantwell – Threatened Murder.** in 2005 Marion was kidnapped, held captive, beaten and only released after agreeing to 'donate' tens of thousands of dollars to Patton West from the recent sale of her home. Upon release Marion was told that if she went to the police she would be murdered.

**Dave Kushner – Blatant Fraud.** In 2005 Dave was defrauded out of \$30,000 by Patton West. Even though he had a signed agreement by Patton West that she would repay the loan Dave never got a single cent back from Patton West. Fearing he would be murdered he walked away empty handed as so many before and since have done.

**Lisa Swidler - Murdered.** As a member of Patton West's inner circle Lisa was aware that Marion Cantwell was the victim of kidnap, false imprisonment and extortion. Lisa also brokered a 14 loan between Patton West and Dave Kushner only to learn after Patton West got the funds that she had no intention of honoring the agreement she signed to repay the loan. Lisa escaped the cult with the intention of helping Kushner & Cantwell. Before she could act she died of internal bleeding. One minute Lisa was a healthy young mother of two children under the age of 10 and the next she was dead. Many in the cult believed that Patton West had murdered Lisa Swidler to keep her quiet. The fact that Patton West could murder with impunity was a lesson and warning to others in the cult who might be tempted to go public.

**Dr. Pat Cole MD – Planned Murder.** Cole was a senior student and business partner of Patton West's when she was masquerading as the Ascended Master Surya Ma in Montana. In 2006, Cole was too slow in handing over her entire net worth to Patton West.

In response, Patton West launched a campaign of overt and covert at Cole whose obvious objective was to intimidate Cole into handing over everything she had to Patton West. Another employee, Carlida Finch, overheard Patton West talking about murdering Cole unless she caved and transferred all her wealth to Patton West. Cole got a reprieve from murder when she signed every penny she had over to Patton West that included vacating her \$750,000 home and signing that over to Patton West.



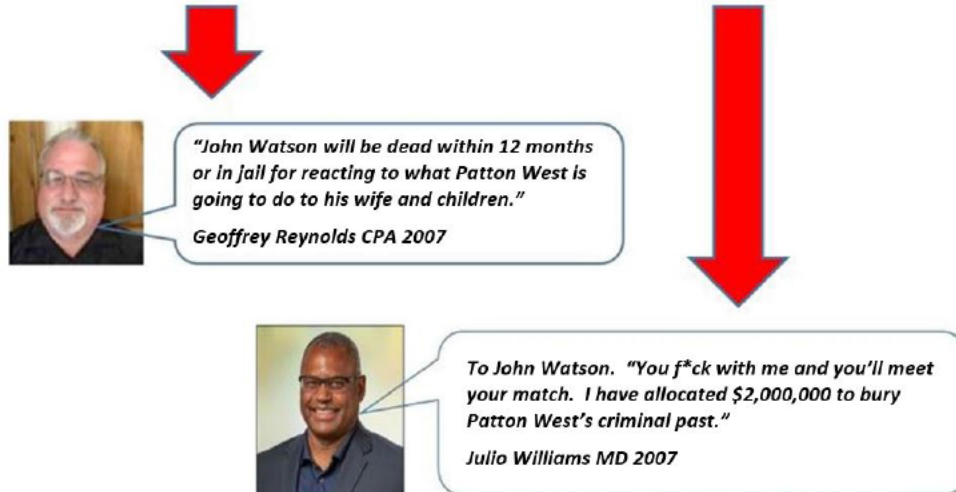
**Conclusion.** In 2002 Jack West, the then husband of Patton West, told John Watson that those who oppose his wife had a habit of dying suddenly. The use of the word 'those' infers more than one and that was before 2002. His comments appear to be born out by subsequent events. Such as the successful **murder** of Lisa Swidler in 2005. 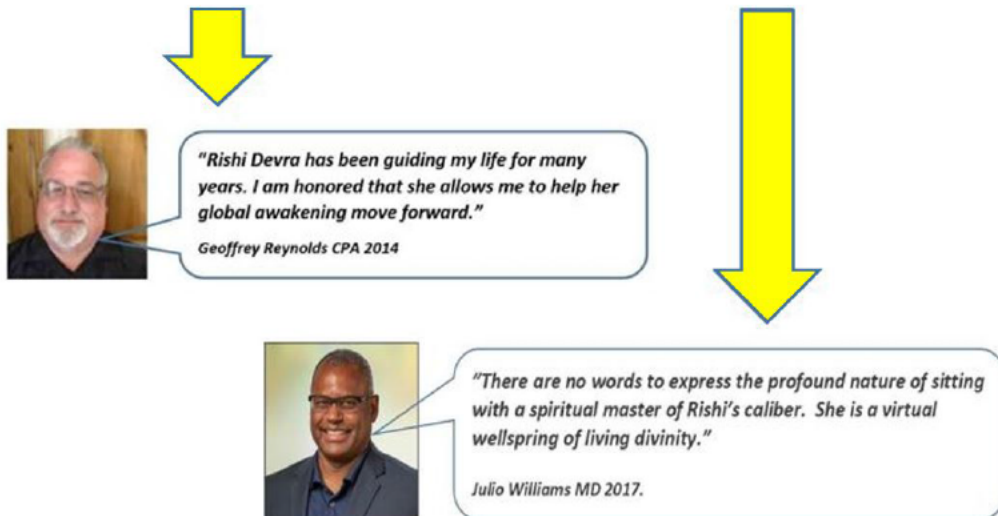

Reynolds and Williams were total strangers to Watson and had no motive in 2007 to want to Watson or, when the murder plot failed, conspire with Patton West to bankrupt Watson into silence. The only person with a motive was Patton West. After all, Watson had successfully [sued her for fraud](#), had directly caused three newspaper articles to be published about her to add to the many publicized visits by Patton West to court for mainly fraud related civil lawsuits. 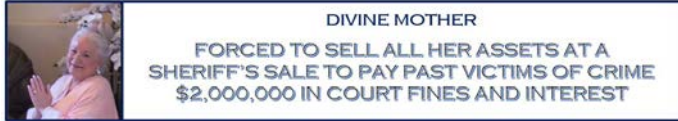

## MORE DETAILS OF PAST 'WORLD SERVICE!' ....

While operating her criminal racketeering business model in Montana, Patton West represented herself to the public as a wealthy business woman. It was all illusion and all a massive fraud. Between 1995 to 2004, Patton West operated her cult / criminal racketeering business model out of compound in Victor MT. During this time, she was calling herself the Ascended Master [Devra Ji](#). Two of her most memorable statements from this period of time were that she was [single handedly holding open the gates of time](#) and that her two (fake) doctorates were awarded to her [by the Christ](#) in person.

Above center: The class of 2002. Members of her cult were routinely bullied and mentally and physically abused. CIA mind control tactics were used by Patton West to 'force' students and employees to submit to Patton West's will and then after they became 'compliant' each were 'harvested' for their money and for their energy. The public thought that the cash donations were being used to pay for Na Ka' Shela (above left) the property owned by the charity. In reality most of the money was going into Patton West's pocket to fund her luxurious lifestyle. Many of the individuals featured above were the victims of theft, fraud, extortion and violent assault. One victim was kidnapped and held captive and beaten until she agreed to make a large 'donation' to Patton West out of the proceeds of her home which she had recently sold. 4. Instead of declaring that she was close to bankruptcy (for the second time) Patton West declared that she was moving her operation from Victor MT to Shamballa. Shamballa being Flathead Lake MT just 1000 miles north of Victor MT. Being cash strapped she also announced that she could only take 12 disciples to Shamballa and only those prepared to commit [66% of their net worth](#) to her. 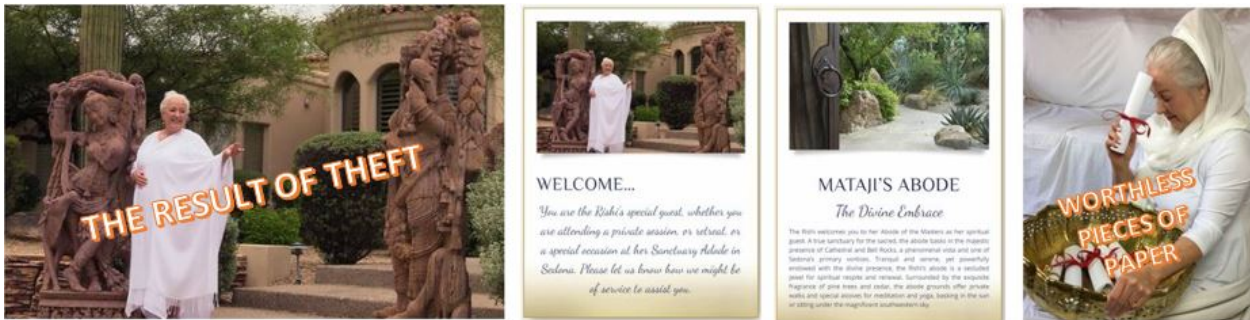
One of the lawsuits Patton West lost during this time frame was the fraud lawsuit that business consultant, John Watson, brought against her in 2003 and [won in 2008](#). From 2003 to 2008, Watson countless examples of defamation by Patton West were posted on her website. Watson was the victim of threats, false witness statements (that Patton West pressured her employees and students to write), and was the subject of a campaign of intimidation by Patton West (which is ongoing).
